These five bold women took their sledgehammers and broke right through the barriers trying to keep them out of the building business: Sashe Ivy of Pink Hard Hatz Construction, Robin Thorne of CTI Environmental, Dudly Etienne-Harvard of Dudly's Professional Services, LLC, Bridget Booker of Reign Construction Inc. and Amber Lawson of Aspire Construction.

The construction industry is highly competitive, and Black women are severely underrepresented in it. The U.S. Bureau of Labor Statistics reports that only 10.9 percent of people working in con-

struction are women, and only 6.7 percent are Black. These companies are working on shifting those numbers.

# 1.) Pink Hard Hatz Construction

Pink Hard Hatz Construction is based in Chicago and is owned by Sashe Ivy. The founder has over 15 years of experience in construction, as well as a background in real estate. After sitting in on too many meetings that were all men, the entrepreneur decided to lead the way in the changes she wants to see in the industry, and Pink Hard Hatz Construction was born.

Ivy told ABC7 NY that certain clientele prefers female contractors. "I always have work coming because what I'm finding out is that people, especially women and seniors, want to see a woman. They're tired of being taken advantage of," explained the CEO.

Pink Hard Hatz Construction handles full home renovations, remodeling projects, home improvements and commercial remodeling and improvements.

# 2.) CTI Environmental

CTI Environmental is owned by chemical engineer and businesswoman Robin Thorne, who has more than 15 years of experience in regulatory compliance. The firm has branches in Long Beach, CA, Atlanta and Philadelphia. They have two primary divisions – regulatory compliance and construction management – and have relationships with several regulatory parties including the California Division of Occupational Safety and Health, as well as many fire departments.

# 6 Keys to Better Construction Communication

Effective communication is vital to the successful completion of any construction project. Good communication can improve teamwork and lead to better project collaboration. Poor communication can result in misunderstandings, delays, and issues down the road.

Communication is simply the exchange of information in order to convey a message and good communication involves being able to transmit your message so it is received and understood by the intended recipients. Seems simple enough, right? If you've ever played the Telephone Game you know it's not always that easy. The game involves communicating a message to a large group of people.

The trick to the game is that the message must be passed by whispering it into the ear of the next person in line who whispers it into the next person's ear, and so on until everyone has heard it. The messenger cannot repeat the message and the last person in line must say aloud what they heard.

The message usually gets misheard a few times, so by the time it gets around the room, "I like lazy Sunday afternoons the best" gets turned into something like "I saw an alien walking my neighbor's dog yesterday."

The Telephone Game is a great way to demonstrate how poor and ineffective communication can lead to misunderstandings and confusion. Being a good communicator is a skill that can be improved upon with practice and training. Here are some simple tips to improving your communication skills:

# 1. Establish a Communication Chain of Command

It's important to determine a chain of command for communication on a construction project. These are typically spelled out in the contract documents and usually require the owner and general contractor to communicate with each other through the architect.

The architect is responsible for communicating with its consultants and the general contractor is responsible for communicating information to the suppliers and subcontractors. The superintendent on a project is typically the main point of contact for the general contractor.

The contract documents, including the drawings, specifications, change order forms and requests for information establish the basis for all construction communication. It is important that any direct communication not out-

# **Construction Industry Trends to Watch for in 2024**

The construction sector remains consistently strong and steady despite the country's economic and social challenges. The coming year promises to be no different – though construction will face challenges through 2024, there are numerous opportunities for industry growth and change.

This article will discuss some top construction trends driving the construction industry throughout 2024 and beyond.

### The state of the industry

On paper, it appears as though construction fared better than most other industries over the past year. Construction spending remained steady from the previous year, while output grew over 2022.

However, consistent inflation makes these numbers appear better than they are – the growth reflects cost increases rather than actual construction volume.

Construction was challenged by the cost and the supply of labor, material price fluctuation, and economic challenges that made building a greater risk for owners.

Though some experts believe material costs will level out sometime in 2024, many of this year's challenges are likely to continue into the next. However, they may be offset by funding in manufacturing and infrastructure that bolsters the demand for building projects.

The construction market also stands to benefit from technological products and advances that will increase contractors' efficiency and resiliency on their projects.

# Technology's answer to post-Covid challenges

Though the crises Covid-19 pandemic caused are largely in the past, the world is still coping with the after-effects of a global pandemic.

Virtual meeting software became critical to business operations during global lockdowns and continues to challenge business owners to balance remote and in-person work options for their employees.

Similarly, safety regulations put in place during 2020 have changed the safety game forever, including new guidelines teams can use in the case of another virus outbreak.



Labor and materials supply chain challenges that came to a head during 2020 and 2021 are still in play, counteracted by the efficiency and preplanning offered by construction and inventory management software options.

# What's new in construction technology trends

While technology's influence on the construction industry has been growing for some time, but as digital capabilities grow, contractors will be able to design, plan, schedule, and manage construction projects better.

# Accessible designs

Technology has revolutionized the way construction professionals design buildings. Building Information Modeling (BIM) leads to better project outcomes, including fewer changes to the design, better client understanding of the design team's vision for the proposed building, and improved relationships between the client and the design team.

Through 2024, BIM's use will be impacted by the emerging capabilities of 3D printing, augmented reality technology, and improved sharing and communication through cloud frameworks. These innovations will further improve BIM's ability to ensure owners, designers, and builders understand one another.

# Computer-assisted construction and prefabrication

Artificial intelligence (AI) is not exactly new, but the technology that drives it is improving with incredible speed. AI can be used to run scheduling scenarios to reduce risk, bid more accurately, and develop contingency plans for when things change mid-build.

Construction robotics have come a long way, too, with machines that can lay bricks alongside masons, reprint drawings directly onto jobsite surfaces, or excavate trenches. Robots can help improve job safety and alleviate labor shortage woes and often work with other popular technologies like BIM.

Construction experts vary on their opinion of how far prefabrication can take off in the construction industry. Still, one thing is for sure: more and more construction elements are being constructed off-site in manufacturing facilities and trucked to the construction site ready for installation. Prefabrication can improve the efficiency and quality of construction, while offering safer indoor working conditions that appeal to many laborers.

# Focus on sustainable construction and green building

Construction firms are facing increasing pressure to build sustainable and efficient buildings. Construction businesses must track and comply with continually evolving environmental regulations and respond to client interest in sustainability while simultaneously controlling costs.

Luckily, lower carbon footprint-building materials and cleaner-running equipment are becoming easier for contractors to access.

Technology is a big part of the sustainable building landscape. Construction management software helps contractors avoid wasteful errors, prefabrication can reduce construction material inputs, and BIM can lead to better construction outcomes the first time.

# Marketing strategy

In addition to technological advancements in construction processes, digital marketing for home services is becoming an indispensable tool for firms to reach and engage with their target audiences. As more homeowners turn to online platforms to find construction and renovation services, companies must adapt by developing

lined in the contract documents receives proper authorization and any changes to the scope or schedule that need to be made are documented and reported through the proper channels.

I overheard a conversation a while back between a superintendent and a subcontractor. Apparently, the subcontractor was not going to be able to start work on a project the following week as scheduled. Some issue or another had arisen and it would probably be a month before they could start on that project, and insisted they had told "someone" at the general contractor's office.

The superintendent was understandably upset by this news, not only would this cause a major delay in the project, but the subcontractor had not followed the established communication chain of command.

I don't know what the final outcome of the conversation was, but it's probably safe to assume that the superintendent had to scramble around to find another subcontractor to do the work and that the initial subcontractor probably won't be invited to work with the contractor again.

Establishing a clear line of communication that includes identifying points of contact with contact information for key team members is vital to ensuring that information is getting to the right people in a timely manner.

# 2. Choose the Right Communication Method for the Message

We communicate in a number of ways every day, both verbally and nonverbally and construction communication is no different. We text, we talk on the phone and in person, we send emails and some of us in this digital age inexplicably still use the old fax machine. On the construction site, we communicate through signs, drawings,

hand signals, and meetings. We compile daily reports, take photos, create requests for information (RFIs) and review change orders.

All methods of communication have their advantages and disadvantages. Choosing the right method of communication can expedite and simplify the exchange of information. Sometimes a quick email is all that's necessary while other instances may call for a meeting of all key personnel on the project.

Items like RFIs, change orders and daily reports are usually laid out in the contract documents with their own specific forms and submittal procedures that have to be followed. For example, if you can't communicate your email message in one or two short paragraphs, or if there ends up being a lot of back and forth, it may be time to pick up the phone or schedule a quick face-to-face meeting.

There is also a host of project collaboration soft-ware solutions available that will allow you to quickly share and disseminate information to all stakeholders on a project. All changes and project documentation can easily be stored and updated so everyone has access to the most up-to-date information. These software solutions and mobile applications can be a great tool for effective communication as long as all stakeholders have access to it, have been properly trained, and are committed to using it.

Methods of communication for specific tasks and information sharing should be established early on in the project and agreed upon by all stakeholders.

in the workforce. According to the Bureau of Labor Statistics, only 9.9% of construction professionals are women.

In regard to race, 30.7% of professionals in the industry are Hispanic or Latino, 6.2% are black, and a staggering 2% are Asian.

While the US does not collect data of LGBTQI+ representation in the workforce, we can use data collected by the UK for reference. Across the pond, only 2% of the construction workforce are members of the LGBTQI+ community. What makes this statistic even more sobering is that over half of them reported they felt their identity kept them from progressing in their careers. Also, 71% of them said they "heard repeated LGBT-oriented insults at work."

# Governor Hochul Announces \$30 Million Awarded for Supportive Housing

Empire State Supportive Housing Initiative Complements Governor Hochul's Landmark \$1 Billion Plan to Strengthen New York's Mental Health Care System

Governor Kathy Hochul today announced \$30 million in supportive housing funding to serve older adults, survivors of domestic and genderbased violence, veterans and chronically homeless families, and individuals with a mental illness or substance use disorder. Administered by the State Office of Mental Health, the eighth round of funding through the Empire State Supportive Housing Initiative resulted in 122 awards, which will provide conditional funding for services and operating expenses for up to 4,839 units of supportive housing.

"Supportive housing plays a critical role in our efforts to strengthen New York's mental health care system and ensure all New Yorkers can live successfully within their community," Governor Hochul said. "The Empire State Supportive Housing Initiative provides the funding needed to provide the services vulnerable populations can rely on to live safely in independent settings."

Since its inception, the Empire State Supportive Housing Initiative has provided operating funding for more than 8,400 units serving vulnerable populations. View a full list of awards from the eighth round.

This initiative provides operating funding for supportive service providers serving homeless veterans and their families; survivors of domestic and gender-based violence; older adults who are disabled or frail; young adults with a history of incarceration, homelessness, or foster care; chronically homeless individuals and families; individuals with intellectual or developmental disabilities; individuals reentering the community from prison; and those living with HIV or AIDS, serious mental illness and/or substance use disorders. The state Office of Mental Health serves as the lead procurement agency for the funding, which is dispersed by an interagency workgroup of eight state agencies serving vulnerable New Yorkers.

Funding may be used for rental assistance and services to eligible target populations to ensure their housing stability. Permissible uses include rental subsidies and other occupancy costs; services or staff to identify and locate eligible individuals that need housing; primary and behavioral health services; employment and vocational training; educational assistance, parenting skills development and support; child care assistance counseling and crisis intervention; children's services, including educational advocacy,

support and counseling; and costs associated with services that help individuals and families remain stably housed.

Projects may receive up to \$25,000 per unit per year for service and operating funding needed to operate permanent supportive housing units. Awards are conditional and are contingent on a project securing capital funding for new construction, the adaptive reuse of non-residential property, or the rehabilitation of unregulated residential property to create integrated affordable supportive housing.

Research has shown that permanent supportive housing reduces the demand for shelters, hospital beds, emergency rooms, prisons, and jails, in addition to having a positive effect on employment, school attendance, and mental and physical wellbeing. Supportive housing projects can also positively impact neighborhoods through new construction or by rehabilitating existing buildings.

The initiative complements Governor Hochul's landmark \$1 billion multi-year plan to strengthen the state's mental healthcare system and drastically reduce the number of individuals with unmet mental health needs throughout the state. Adopted as part of the FY 2024 budget, the plan also includes funding for 3,500 new residential units for New Yorkers struggling with mental illness, dramatically expands outpatient services, and closes gaps in insurance coverage for behavioral health services, prohibiting carriers from denying access to medically necessary, highneed, acute and crisis mental health services for both adults and children.

Office of Mental Health Commissioner Dr. Ann Sullivan said, "Governor Hochul has long been an advocate for supportive housing and understands the need to establish more capacity throughout the state. Her commitment has helped thousands of individuals and families to receive the services they need while living in their own homes. Safe and dignified housing will give people living with mental illness and substance use, our veterans and many others dealing with critical life issues the stability and support they need for a successful recovery."

Office of Addiction Services and Supports Commissioner Chinazo Cunningham said, "Supportive housing for individuals impacted by addiction can have a strong impact on their health and well-being and is an important part of the continuum of addiction services available here in New York State. Thanks to Governor Hochul's ongoing efforts, this initiative continues to support vital expansions to supportive housing across New York State, helping individuals and their families who have been affected by addiction find the help and resources that they need. We look forward to the continued benefits this will bring to New Yorkers."

disputes faster and more favorably.
