# **2025 Small Business Outlook for the Construction Sector**

2024 will be remembered for many things. One on hand: strong consumer spending and stock performance; low unemployment; rate cuts; an artificial intelligence craze; the election. On the other: high house prices and mortgage rates; stagnant wages; labor shortages. Both the positives and negatives tell stories about the health of the U.S. economy, and both will have a huge impact on small businesses in 2025 and for years to come.

The key question for small businesses in the construction sector is how the economy will change in 2025 and, more specifically, how the political and economic changes that have been promised by the new administration will impact inflation, interest rates, unemployment, taxes and tariffs. Will these changes be a net positive for small business owners?

#### INFLATION

The Federal Reserve has calmed inflation without spurring a recession, a feat many experts deemed unlikely when inflation peaked at 9% in June of 2022. Unemployment remained low throughout the tightening cycle, and wage growth is helping consumer purchasing power catch up to prices which, today, are rising more slowly. The Federal Reserve switched to a loosening bias in the fall of 2024 and has indicated its intention to continue loosening so long as the economy does not grow too fast and inflation remains low. Inflation now sits at 2.7% and is expected to drift lower throughout 2025, barring a major policy intervention or significant changes to Fed policy.

The current shortage of affordable housing in the U.S. should be a catalyst for construction industry growth in 2025. However, some are concerned that interest rates will remain high throughout the year as the Fed is forced to scale back anticipated rate cuts due to inflation.

While many of the new administration's proposals appear to be starting points in a negotiation rather than settled policy, if certain new policies were to be enacted in their proposed form specifically tariffs—the U.S. economy would almost certainly experience another inflation shock. The business community, fresh on the heels of the last inflation shock, will be watching these policy changes closely and are prepared to act quickly should inflation return.

#### THE GLOBAL SUPPLY CHAIN

The global supply chain today is functioning better than it was several years ago during and immediately following the pandemic. However, critical issues continue to challenge small businesses sourcing materials and selling overseas. During 2024, persistent disruptions in the global supply chain stemming from wars, pirating, strikes, infrastructure failures and inclement weather combined to disrupt the global flow of trade. Now, the threat

### 8 Black Inventors Who Made Daily Life Easier

Most people have heard about famous inventions like the light bulb, the cotton gin and the iPhone. But there are countless other, often overlooked inventions that make our daily lives easier. Among the creative innovators behind these devices are African American inventors. From the traffic light to the ironing board, see a list of products that have sprung from the minds of Black inventors. Improved Ironing Board, Invented by Sarah Boone in 1892

The ironing board is a product that's used possibly just as much as it's overlooked. In the late 19th century, it was improved upon by Sarah Boone, an African American woman who was born enslaved. One of the first Black women in U.S. history to receive a patent, she expanded upon the original ironing board, which was essentially a horizontal wooden block initially patented in 1858. With Boone's 1892 additions,

## How to improve women's retirement security in 2025

Saving for old age is challenging for most people, but recent data suggest women are less likely than men to consider their retirement savings on-track. Nearly half of women find making retirement savings decisions to be complicated and confusing and nearly six in 10 women feel they do not earn enough to save for retirement. It's not surprising that women have these concerns, as they continue to provide more care for family members of all ages, earn less than men even when working full-time and year-round and live longer on average. Among women and men ages 50 and older, women report 77 cents in wealth (\$165,691) for every dollar of wealth reported by men (\$213,948). That's one of many reasons why it's so important for women to plan for their lifetime financial security, and for policymakers and employers to support their efforts.

### Step 1: Increase women's access to retirement plans

More than four in 10 working women have no access to an employer-based retirement plan. Some 37% work for an organization that doesn't offer retirement plans to any employees and 7% work for organizations that offer retirement plans the women are not eligible for. Women may be ineligible because they work part-time or because they

haven't worked long enough at the organization, often as a result of family caregiving responsibilities, and this is despite typically shorter vesting periods in defined contribution plans than under traditional defined benefit plans.

It doesn't have to be this way. Options for saving plans, such as 401(k)s and IRAs, exist even for those who are self-employed or running small businesses. Policymakers could also provide access through alternative plans, like federal or state-sponsored savings programs that automatically enroll individuals not covered by an employer-sponsored retirement plan or a state-facilitated retirement plan. Employers and policymakers should aim to increase the share of workers who are eligible for a retirement plan by expanding plan coverage and broadening eligibility.

# Step 2: Encourage participation among the 15% of women who are eligible for a retirement account but did not participate in the past year

At least one in seven working women has the option to participate in an employer-based retirement plan but is not enrolled. Employers can encourage participation regularly, including during annual benefit enrollment periods, or by adding automatic enrollment to their plans. They can also offer to match at least some employee contributions to retirement savings to encourage

increased participation. Employer-employee cooperation could lead to an increase in the participation rate and improved lifetime economic security for women. Saving even small amounts can help build future security – especially when women start earlier working lives. Step 3: For the 42% who have a retirement plan... can they save even more?

Women who work full-time and year-round are paid less than comparable men, so that they are

### **Smart Tax Goals for Small Business Owners**

He or she is going to take a year's worth of income statements, expense reports, deduction lists, receipts – and so much more – and make sense of it all, and then file it accurately so your business complies with all the necessary IRS requirements. The more you can do to make your tax preparer's life easier, the better job they'll be able to do for you and your business.

"Whether you opt to file your own tax returns or hire someone to help you, it is a good idea to keep separate books and records for your business and personal expenses," recommends SCORE mentor Richard Kroger. "That way there are no surprises when you review expenditures months or even a year later as part of the tax filing process."

#### Stop Storing Receipts in Shoeboxes

Streamlining your business practices has a lot to do with helping you remain organized all year long. Eliminating as much paper from the process as possible is one of the best ways to do this. The IRS accepts digital copies of receipts, so there's no longer a reason to hold onto paper ones. There are several cloud-based tools out there to help you make the leap and leave paper receipts behind.

#### **Organize Your Paper Records**

Even after digitizing your receipts, it's hard to go completely paperless – think of your original copies of important documents like signed contracts and other agreements. Start by keeping the number of hard copies you store to a minimum and organize paper documents in a portable file box. This will help you keep only what you need. Bring these paper documents to your accountant's office when you meet at tax time.

of significant tariffs on large U.S. trading partners is forcing wholesalers, retailers, manufacturers and many other business owners to reexamine their supply chains and develop sourcing strategies that reduce the cost of tariffs while still ensuring the timely delivery of goods.

Small businesses in the construction sector have learned from previous disruptions the benefits of shorter supply chains and greater onshore production. These benefits are amplified by the proposal of potential tariffs. As a result, small construction businesses can expect to see continued growth in domestic manufacturing and the integration of new technologies that promote automated production. While the growth in U.S. manufacturing and automation should vield net positives for the U.S. economy, there is potential for the pace of this change to be highly disruptive to the global supply chain if changes are not implemented in a gradual and deliberate manner

THE POLITICAL ENVIRONMENT

The Trump Administration assumed office in January, proposing measures for lower taxes, less regulation, smaller government, higher tariffs on imported goods and tighter immigration standards. Lower taxes and less regulation will clearly be embraced by the business community while additional tariffs would raise the cost of building materials significantly, especially tariffs on Canada (lumber), Mexico (appliances) and China (iron and steel). The long-term effects of the other initiatives will be revealed with time. What is clear is that business owners will be watching these developments closely as they will impact inflation, the cost of capital, the cost of goods sourced overseas and overall economic demand

# What the Steel & Aluminum Tariff Could Mean for Construction

In an effort to protect America's steel and aluminum industries, on February 11, President Trump signed proclamations to close loopholes, restoring a "true" 25 percent tariff on steel, raising the tariff from 10 to 25 percent on aluminum. As quickly as President Trump addressed these tariffs on what are vitally imported construction materials, it didn't take long for anyone to start to wonder how this new policy could affect contractors and concrete construction.

The focus of the announced tariffs so far has been on imported steel and aluminum as well as products from Canada and Mexico – which includes a percentage of lumber and cement.

According to their February 3 statement, Portland Cement Association (PCA), stated that Canada and Mexico account for 27 percent of U.S imports - nearly 5 million metric tons of cement and 2 million metric tons from Mexico (2023 data). In their official response, Mike Ireland - president and CEO of the PCA stated: "While the U.S. cement industry agrees with the President's objectives of bolstering American manufacturing, increasing border security, and advancing the country's energy independence, the industry believes 25% tariffs on cement imported from Canada and Mexico could adversely affect energy and national security while delaying infrastructure projects and raising their costs.

They added that having cement and concrete affordable is vital to the expansion of the country's infrastructure and both our northern and southern neighbors play a crucial role in that supply. Adding their appreciation that the Administration is open to further negotiations and that they look forward to working with them to avoid "unintended consequences."

However, the U.S. still imports a decent amount of steel rebar and imported alumina as part of the recipe for concrete. "Even if we're domestically producing the concrete or the cement in the US versus importing, some of the components, like the aluminum...are going to add to the cost of even domestically producing it," says Brian Kassalen, CPA, CFF, principal and the construction industry leader for Baker Tilly - a large accounting and advisory firm. He works with contractors to ensure they are up to date on the latest information they need to know about the industry.

According to US Census Bureau, the U.S. imported about 915,000 metric tons of reinforcing bar in 2024 (down from 1.3 million tons in 2023). "We import probably about 25 percent of our steel from other countries," says Kassalen. Considering the work in key construction areas like the infrastructure, roads, bridges, data centers, warehousing and more – a lot of concrete will be needed for those projects and that number will continue to expand in the future.

"I think the tariffs will probably have some people step back and relook at budgets or relook at time frames," says Kassalen. "I don't see where it's going to slow down – it's unfortunately going to be one of those things: contractors now have just one more thing to have to factor into their bidding and estimating process to figure out how they can be competitive." In a way, at least most contractors will be in the same boat.

Communication with material suppliers will be key moving forward. Have those conversations with suppliers to discover the source of the materials. If you don't already know, Kassalen recommends to talk with suppliers and get a better understanding where they're getting their materials from. There may be a chance to work with them and determine if there's an opportunity to source some of the material from elsewhere.

The big question on many minds: will US-based producers increase their prices? There's a chance they may as the country can only produce so much steel, aluminum, cement, etc. Much like other price fluctuations the industry regularly handles, the cost will also likely be passed down to the end user. The construction sector already works with thin margins and only so much they can absorb.

Even though it's unsure at what levels and when the negotiations will ultimately conclude, one of the big challenges facing contractors is managing that unknowable cost. While projects with materials already committed may not see any potential increase, it can become a real issue for the more recent estimations and bids.

Construction companies already have a stressful challenge of the amount of risk they shoulder on a daily basis – let alone executing the project itself – but adding the chaos of tariffs and the unpredictability of what they may mean to business is an extra level of challenges. Having a good estimating team in place, notes Kassalen, will help to manage and kickoff any impacted projects.

#### What's the Upside?

It's a comparison of short and long term effects. "When you think of the whole point of tariffs, a lot of it is to try to make the playing field more level for domestic producers and increase jobs in those sectors in the U.S.," says Kassalen. "If you think about before Trump's first term as President, a lot of steel that was imported in the US was from China. Now we import very little steel from China because the amount of tariffs... it made it more economical to not use Chinese imported steel."

The challenge is time. It will likely take time for the market to respond and plants to return to capacity; it's not a switch to flip or lever to pull. He reminds that, "You can't turn on capacity in the U.S. or just start opening up new plans because it takes time to get those plants set up...the end goal would be that it helps to get more production the US but that is going to take time. That's not an overnight fix."

The cost of construction materials has always been impacted by market fluctuations. Its early so there's a lot of speculation on the effect of tariffs. A lot of contractors are waiting for the dust to settle a bit to see what's going to happen and add to the ever-changing definition of "new normal."

"When we think about where construction fits into the life cycle of our economy, construction is always going to be busy," notes Kassalen. "When we talk to our contractors, their backlog is good. There's always going to be projects."

As the construction industry faces continued uncertainty due to tariffs, contractors with ongoing projects may struggle with unexpected cost increases, potentially impacting budgets and timelines. Moving forward, many in the industry are likely to place greater emphasis on contract terms, proactively including escalation clauses to mitigate the financial risks associated with fluctuating material costs. Additionally, we may see a shift toward alternative sourcing strategies, bulk purchasing agreements, and closer collaboration with suppliers to navigate these economic challenges more effectively.

### What is Prefabricated Construction?

This strategy uses components made off-site in a factory, which are then transported put together onsite to create a structure.

#### **The Pros of Prefab**

Because prefab methods are implemented indoors in a factory, construction professionals do not have to worry about delays and interference from the weather, vandals, intruders, or other complicating factors. This is a controlled, safe environment which allows owners to streamline the construction process and cut down on waste.

#### This makes prefab cost effective.

In many cases, prefab also reduces environmental impact. It can lessen air, water, and noise pollution caused by a construction project.

Prefab is especially helpful to projects with a high degree of redundancy. This means that the building has many rooms that are similar or identical. Some examples are student housing, hotels, hospitals, and institutional buildings.

As the industry struggles to deal with a talent shortage, prefab can help you manage to complete a project with a smaller crew. Because most of the work in done indoors with less strain, fewer people can get more done. These sites are also considered safer for workers than traditional sites.

#### Modular v. Prefab

Even though modular construction is often conflated with prefab, they are not one in the same. In fact, modular construction is a category of prefabricated construction. In the same way all poodles are dogs but not all dogs are poodles, all modular construction is prefab but not all prefab projects are modular.

Modular construction entails building entire sections of a project before shipping those pieces



to a site. This includes plumbing, electric, and everything else needed for a function unit.

This method requires the least amount of on-site work, and the most specificity. It's difficult to change course with any kind of prefab, but it's especially important that a modular project is carefully planned out beforehand. There is not much wiggle room once a project is underway.

#### Panelization

This is another form of prefab, but it requires a bit more work on site. Panelization involves walls, floors, and roofs being constructed in a factory before being transported to the build site. Those elements are then attached to the structure that already exists on-site. Plumbing and other infrastructure is installed afterwards.

drawing from a smaller 'pot' when they do save for retirement. On average, women who work at least part of a calendar year contribute 6.4% of their earnings to retirement savings, compared to 6.7% for employed men. But because women tend to be paid less, their average contribution amounts only total \$4,521, compared to \$6,103 for men (this includes their own savings as well as any employer matches).

Hispanic women's annual contributions are lower (an average of \$2,167), due to the fact that they are both paid less on average and contribute only 3.7% of their modest earnings. Black women have a similar rate of contributions as a percentage of earnings to white women (6.8% and 6.9%, respectively), but a \$1,500 difference in the amount they contribute (\$3,604 and \$5,109, respectively), driven by the fact that Black women are paid substantially less on average.

These numbers illustrate the need for women, especially women of color, to 'catch up' in terms

of saving for retirement. Women's longer life expectancy can mean more years spent in retirement – yet another reason it's critical to start saving early, especially for women who have lower average earnings.





### 8 Black Inventors Who Made Daily Life Easier

Before security systems became a fixture in homes, an African American nurse Marie Van Brittan Brown, devised an early security unit for her own home. She spent many nights at home alone in Queens, New York while her husband was away, and felt unsafe with high rates of crime in her neighborhood. On top of that, the police were unreliable and unresponsive. So she created a device that would help put her mind at ease.

In 1966, Brown invented a system that used a camera that could slide into and look through four peepholes in her front door. The camera's view would then appear on a monitor in her home so she could survey any potentially unwanted guests.

She added other features to the system, including a microphone to speak to anyone at the door, a button to unlock the door, and a button to contact the police. She and her husband took out a patent for the system in the same year, and they were awarded the patent three years later in 1969. Home security systems commonly used today took various elements from her design.

### The Three-Light Traffic Signal, Invented by Garrett Morgan in 1923

With only an elementary school education, Black inventor (and son of an enslaved parent), Garrett Morgan came up with several significant inventions, including an improved sewing machine and the gas mask. However, one of Morgan's most influential inventions was the improved traffic light. Morgan's was one of the first three-light systems that were invented in the 1920s, resulting in the widespread adoption of the traffic lights we take for granted today.

Thanks to the successes of his other inventions, Morgan bought and car and, as a motorist, he witnessed a severe car accident at an intersection in his city of Cleveland, Ohio. In response, he decided to expand on the current traffic light by adding a "yield" component, warning oncoming drivers of an impending stop. He took out the patent for the creation in 1923, and it was granted to him the following year.

### Refrigerated Trucks, Invented by Frederick McKinley Jones in 1940

If your refrigerator has any produce from your local grocery store, then you can credit African American inventor Frederick McKinley Jones. Jones took out more than 60 patents throughout his life, including a patent for the roof-mounted cooling system that was used to refrigerate goods on trucks during extended transportation in the mid-1930s. He received a patent for his invention in 1940 and co-founded the U.S. Thermo Control Company, later known as Thermo King. The company was critical during World War II, helping to preserve blood, food and supplies during the war.

#### Automatic Elevator Doors, Invented by Alexander Miles in 1887

The use of elevators in everyday life keeps people from facing long climbs up several flights of stairs. However, before the creation of elevator doors that close automatically, riding a lift was both complicated and risky.

Before automatic doors, people had to manually shut both the shaft and elevator doors before riding. Forgetting to do so led to multiple accidents as people fell down elevator shafts. As the story goes, when the daughter of African American inventor Alexander Miles almost fatally fell down the shaft, he took it upon himself to develop a solution. In 1887 he took out a patent for a mechanism that automatically opens and closes elevator shaft doors and his designs are largely reflected in elevators used today.

## Electret Microphone, Co-Invented by James E. West in 1964

Even for those who aren't quick to pick up the mic during karaoke, microphones are used every day to communicate over distances far and wide. And the vast majority of microphones used today, including the microphones used in phones and cameras, use a microphone co-invented by a Black man. Dr. James E. West was tasked with creating a more sensitive and compact microphone while working at Bell Labs in 1960.

Along with his German colleague Gerhard Sessler, West invented the foil electret microphone, which was considerably less expensive to produce than the typically used condenser microphones. Two years after it was invented, the final model of the microphone was developed and in 1964 they patented the landmark invention. Only four years later, the new microphone was in wide production and was being used in hearing aids, tape recorders, most telephones and baby monitors.

# Carbon Light Bulb Filament, Invented by Lewis Latimer in 1881

The light bulb itself was perfected by Thomas Edison, but the innovation used to create longer-lasting light bulbs with a carbon filament came from African American inventor Lewis Latimer. Latimer, the son of formerly enslaved people, began work in a patent law firm after serving in the military for the Union during the Civil War. He was recognized for his talent in drafting patents and was promoted to head draftsman, where he co-invented an improved bathroom for railroad trains.

His successes would garner him further attention from the U.S. Electric Lighting Company, putting him at a company in direct competition with Edison, in 1880. While there, Latimer patented a new filament for the light bulb, using carbon instead of more combustible materials, like bamboo, that was commonly used for filaments. The addition of the carbon filament increased the life span and practicality of light bulbs, which had previously died after just a few days. In 1884, he went on to work with Edison at the Edison Electric Light Company.

#### Color IBM PC Monitor and Gigahertz Chip, Co-Invented by Mark Dean c. 1980 and 1999

Before flat screens and high-definition LCD monitors were the norm, PC displays were limited to screens with no color that was tethered to computers with limited processing power. That all changed thanks to Black inventor and engineer Mark Dean. Dean began working for IBM as a chief engineer in the early 1980s, making up a team of 12 people who would develop the first IBM PC. In addition to helping create IBM's original machine in his early years with the company, he also worked to develop the first gigahertz processor. The massive chip, built in 1999, would allow for higher processing rates at faster speeds within PCs.



## The Future for California High-Speed Rail Just Got Even More Uncertain

U.S. Transportation Secretary Sean Duffy announced the review on Thursday in Los Angeles, saying the administration intends to determine whether California is living up to the letter of its federal funding agreements.

"We can't just say we're going to give money and then not hold states accountable to how they spend that money," Duffy said. "We in the Trump administration are going to take a look at whether this project is worthy of continual investment."

In recent months, the inspector general for the California High-Speed Rail Authority has expressed doubts both about whether the agency can line up all the funding needed to build the system's initial 171-mile segment from Merced to Bakersfield and whether it can meet its time-table for launching service by 2033.

The current cost estimate for the Merced-Bakersfield link is between \$32 billion and \$35 billion. Even with \$4.3 billion in grants promised by the Biden administration that are now under review, the state would need to find as much as \$6.5 billion more to finish the Central Valley segment.

That section is just the first piece of a statewide network stretching from San Francisco to Orange County that was envisioned in a 2008 ballot measure that provided \$10 billion in bond funding. The measure outlined a system that would be completed by 2020 and carried an estimated price tag of as much as \$40 billion. Though the full route has now received all its environmental approvals, there's no current schedule for completing it, and the latest cost estimates for the full north-south network range from \$89 billion to \$128 billion.

Republican lawmakers, who have been hostile to the project since its inception three decades ago, argue that the price of the first segment is too high for a service with an unproven market and have introduced new legislation to curtail further funding.

In Congress, Rep. Kevin Kiley (R–Rocklin) has put forward a bill that would ban future federal aid for the rail line.

AB 267, by Assemblymember Alexandra Macedo (R–Tulare), would cancel the state's \$1 billion annual appropriation for high-speed rail for the next two years. That funding, which comes from California's cap-and-trade program, would be shifted to new water projects and wildfire mitigation.

Democratic legislators, including state Sen. Scott Wiener (D–San Francisco), say the project's expected environmental benefits and the need to modernize California's passenger rail network make it imperative for the state to move ahead with the project.

Wiener has introduced SB 445, a bill that would speed up rail construction by requiring local governments and utilities to hasten permit approvals and power and water line relocations.

Appearing at L.A.'s Union Station, Duffy's remarks on Thursday highlighted both the partisan nature of the review and his own personal distaste for the state's high-speed rail effort. "President Trump has thought about this project. He's talked about the project," Duffy said. "And I think he was very kind when he said this project has been mismanaged. I would agree it has been more than likely mismanaged. And the president has called for an investigation."

Several dozen protesters who had turned out for Duffy's press conference jeered his remarks, prompting him to snap: "If you want to go protest somewhere; if you want to shout at someone; go to the governor's mansion. Go talk to Democrats in the Legislature who have brought us this crappy project."

In an interview with KQED on Thursday, Wiener blamed Republicans for the bullet train delays.

"The people who are most vocal in criticizing high-speed rail for delays and cost increases, the Republicans, are some of the very people who have caused those delays and cost increases," he said.

Wiener said he was confident that spending by the California High-Speed Rail Authority will stand up to the new federal scrutiny.

"If this investigation is fair and objective, then it will show a project that is underway, that's happening, and that has been slowed down by permit problems, and that needs to be sped up," he said.

In a statement, the high-speed-rail agency said it has been subject to multiple federal and state audits and that "every dollar is accounted for."
