# The Future of Autonomous Construction Equipment

People are excited about autonomous cars and wonder if they'll forever change passenger transportation. However, the promise of autonomous machines is also making waves in the construction sector. How might it facilitate improvements in this industry soon?

# Various Possibilities Exist for Autonomous Machinery

When people think of autonomous equipment, the options that take humans out of the picture entirely often come to mind. Those would undoubtedly address factors like the labor shortage. However, many high-tech construction machines are semi-autonomous, which means they still need humans to assist with safe operation.

One example is a new semi-autonomous bull-dozer. Humans operate the machine, but it automatically collects terrain data while moving

around a site. It uses that information to independently decide how to handle materials or otherwise accomplish tasks. When the machine analyzes the data, it learns whether to spread or fill material. The bulldozer also stores information about the surrounding area and uses it when returning to a site later to do more work.

Also, some efforts to advance autonomous equipment involve traditional machines acting as guides. A small technology developer in Pennsylvania recently planned a live demonstration on a Florida highway. The company offers an autonomous control system that enables a traditionally driven vehicle to act as the leader while a driverless one follows. The technology works with any standard fleet vehicle, including line stripers and maintenance trucks.

As these kinds of advancements and experiments continue, the number of companies offering solutions should go up. Some of the options are still in the early stages, so it's impossible to tell at this point how long it might be before autonomous construction equipment hits the mainstream. The entities that adopt it early could be ahead of the curve compared to their competitors.

# **Embracing the Trend Could Prove Easier Than Anticipated**

Many decision-makers in the construction industry may show interest in equipment automation developments but believe that implementing them would be too costly. They likely assume that the only way forward is to replace the machinery they have. Fortunately, that's not the only option.

For starters, construction companies often notice a wide assortment of benefits when choosing to rent equipment instead of buying it. One of them is a reduction in overall expenses. Statistics show that the costs of owning a commercial truck can add up to roughly \$8,500 annually. If a company instead rents its equipment, it gets the opportunity to test the machine and assess gradually whether the return on investment is worth the cost if the company eventually purchases it.

The option to rent autonomous construction equipment helps professionals feel more at ease. They have time to get accustomed to the technology and see how it could help their companies prosper. Change can be scary, even when the outcomes are likely positive. If construction companies rent autonomous machines at first, they can stay competitive by using new technology without the potential barriers of high upfront investments.

Companies are also working on solutions that allow construction professionals to make their existing equipment autonomous. One of them is Built Robotics, which wants to provide a manufactureragnostic solution to clients that wants to automate their machines. The company has so far identified about 1,000 pieces of heavy equipment that could suit its technology. A customer could then make their machinery autonomous without sacrificing manual operating capabilities.

EquipmentShare is aiming for something similar with its Machine Automation Portal. That

# Statement from the National Association of Asian American Professionals on Xenophobia and Racism in Response to Coronavirus

The National Association of Asian American Professionals (NAAAP) is issuing the following statement in response to the racism and violence that have resulted from heightened fear over COVID-19—also known as the Coronavirus Disease—in the United States:

(The Small Business Exchange will be follow- The United States has a long and painful history of associating individuals of Asian descent with contamination and disease. From the Chinese Exclusion Act of 1882, to the Yellow Peril of the early 20th century, racist fears of "filthy yellow hordes" have been deeply entrenched in American society for centuries.

> Sadly, the reports this week of violence against the Asian and Asian American communities illustrate that these malevolent narratives are not simply a thing of the past, but an ugly reality

of the present-day. NAAAP is deeply disturbed by stories of students being bullied in schools, citizens being harassed or accosted on the street, and active disinformation campaigns slandering Asian and Asian American businesses. NAAAP condemns these acts of violence as well as the calls to boycott Asian cultural events and epicenters across the country.

Finally, NAAAP encourages the media to discontinue the casual use of photographs depicting people of Asian descent wearing facemasks in its

coverage of the virus. These photos frequently feature people who are not known to have the virus, and locations entirely separate from the focus of the story. These practices reinforce the racist association between the disease and Asian communities, and have the potential to both directly and indirectly incite hostility and violence toward our communities.

NAAAP's thoughts are with those suffering because of the virus—and because of the response

# Federal Agencies Encourage Banks, Savings Associations and Credit Unions to Offer Responsible Small-Dollar Loans to Consumers and Small Businesses Affected by COVID-19

Five federal financial regulatory agencies today issued a joint statement encouraging banks, savings associations and credit unions to offer responsible small-dollar loans to consumers and small businesses in response to

The statement of the Board of Governors of the Federal Reserve System, Consumer Financial Protection Bureau, Federal Deposit Insurance Corporation, National Credit Union Administration, and Office of the Comptroller of the Currency recognizes that responsible small-dollar loans can play an important role in meeting customers' credit needs because of temporary cash-flow imbalances, unexpected

expenses, or income disruptions during periods of economic stress or disaster recoveries. Such loans can be offered through a variety of structures including open-end lines of credit, closed-end installment loans, or appropriately structured single payment loans.

The agencies state that loans should be offered in a manner that provides fair treatment of consumers, complies with applicable laws and regulations, and is consistent with safe and sound practices.

For borrowers who experience unexpected circumstances and cannot repay a loan as structured, banks, savings associations and credit unions are further encouraged to consider workout strategies designed to help borrowers to repay the principal of the loan while mitigating the need to re-borrow.

This statement follows other actions taken by the agencies to encourage financial institutions to meet the financial services needs of their customers and members who have been affected by COVID-19.

For example, the federal banking agencies issued a joint statement on March 19 informing institutions that the agencies will favorably consider retail banking and lending activities that meet the needs of affected low- and moderate-income individuals, small businesses, and small farms for Community Reinvestment Act purposes, that are consistent with safe and sound banking practices and applicable laws, including consumer protection laws.

In addition to today's statement, the agencies are working on future guidance and lending principles for responsible small-dollar loans to facilitate the ability of banks, credit unions, and saving associations to more effectively meet the ongoing credit needs of their customers, members, and communities.



# **Carranza Implements Automatic Deferment on Existing SBA Disaster Loans Through End of 2020**

U.S. Small Business Administration Administrator Jovita Carranza announced changes to help borrowers still paying back SBA loans from previous disasters. By making this change, deferments through December 31, 2020, will be automatic. Now, borrowers of home and business disaster loans do not have to contact SBA to request deferment.

"The SBA is looking at every option and taking every action to cut red tape to make it easier for small businesses to stay in business. Automatically deferring existing SBA disaster loans through the end of the year will help borrowers during this unprecedented time," said Administrator Carranza. 'Today's announcement adds a list of growing actions the SBA is taking to support small businesses. These actions include making it easier for states and territories to request a declaration so small businesses statewide can now apply for economic injury disaster loans, and changing the terms of new economic injury loans to allow for one-year deferments. We are working around the clock to find ways to assist small businesses and today's action is one step in this process."

# Tips On Operating Your Business During Equipment Maintenance

One concern I often hear when talking to our customers is how they can better work preventative maintenance (PM) and predictive maintenance (PdM) into their operations without creating a lot of machine downtime. Normally, I have a pretty simple answer for that—schedule your PdM and PM into your everyday operating procedures.

When you run a manufacturing business, you have delivery and ship dates that are usually driven by customer need, so you need to have a production plan, which should include your capacity. Capacity is what you can manufacture with the staff and machine hours available to you. For example, if you have five machines and run them 40 hours per week, your capacity would be 200 hours. If it takes one hour to make a part, you can manufacture 200 pieces.

When you set your capacity schedule, start by subtracting the hours needed for normal PM and PdM. Let's say each of those five machines needs one hour of PM work and 15 minutes of PdM work per week. You need to subtract 5 hours of PM time and 1 hour and 15 minutes of PdM time from your 200-hour weekly capacity to ensure you can maintain your equipment, which leaves you 193 hours and 45 minutes capacity or 193 parts per week. You shouldn't commit to more production than that.

#### Here are a few tips for reducing the impact of required maintenance to your capacity:

Schedule PM and PdM during planned downtime

- Schedule maintenance on off shifts
- Schedule maintenance over the weekend
- Perform maintenance during seasonal shutdowns or times of lower demand

This will give you additional production hours. If you don't have off-shift hours and operate seven days a week, these options are not available to you. In that case, you would need to go back to your capacity plan and remove the needed maintenance hours. Remember, scheduled hours are better and more controllable than hours lost due to catastrophic failure.

# In 'Alice Street,' Oakland Artist-Activists Build Power By Bridging Communities

Throughout last year, the steel and concrete frame of a new building in downtown Oakland grew to obscure a sprawling mural. Protesters with picket signs disappeared from view, along with dancers, drummers and martial arts practitioners, leaving the faces of centerpieces Malonga Casquelourd and Ruth Beckford, pillars of the city's black performing arts tradition. To passersby today the entire artwork is imperceptible behind an incoming housing development.

Alice Street, a forthcoming documentary by Spencer Wilkinson, shows how the Universal Language mural's creation and erasure alike catalyzed a multiracial anti-gentrification coalition with significant, ongoing effects on real estate development and city planning in downtown Oakland. Set in just a few city blocks, it's a story about intractable loss as well as collective refusal, depicting artists' role in grassroots activism that builds power by bridging communities.

Wilkinson, 44, an Oakland filmmaker whose first feature, One Voice (2018), focused on the Oakland Interfaith Gospel Choir, did not anticipate filming for five years when he started chronicling the mural's design as part of a work-trade deal in 2014. Now he's submitting the 70-minute Alice Street documentary to film festivals and arranging screenings in other cities grappling with gentrification.

Wilkinson expects to announce more Bay Area screenings in the coming months.

Alice Street begins with Destiny Muhammad reciting a poem at the corner of 14th and Alice streets in downtown Oakland to subtle, vaguely religious music by Micah Berek. "An intersection of traditions, ancient rhythms, culture keepers and urban oracles," she says. A montage shows the neighborhood's cultural diversity and changing built environment. The credits roll, framed by cranes. Imposed on aerial footage of the low-slung flatlands are sharply rising housing costs.

The film shortly settles on aerosol artist Desi Mundo and studio painter Pancho Pescador of the Community Rejuvenation Project embarking on their largest mural yet: Four walls around a parking lot at Alice and 14th streets. For inspiration, they look directly across the street to the Malonga Casquelourd Center for the Arts, a historic city-owned hub of Afrodiasporic drumming and dance, and also to the Chinatown senior apartments and community center Hotel Oakland.

The story has no single conflict or antagonist. The challenge at first appears to be the muralists' desire to represent two communities to which they're admitted outsiders, and the project's most outspoken opponent is an elderly white woman who objects to its exclusion of white people. As soon as the mural is designed and painted to the satisfaction of most neighborhood stakeholders, though, a housing development proposal threatens to render it totally invisible.

"People in the Bay Area are starting to see the benefits of Oakland," says Maria Poncel of Bay Development, explaining to Mundo and Pescador that the mural will continue to exist behind the planned 16-story tower. "We're going through sort of a second renaissance." It's one of several awkward remarks from developers, property owners and elected officials (has Mayor Libby Schaaf retired "secret sauce"?) that Wilkinson seems to highlight for their evident shallowness.

Halfway through the documentary, then, the mural intended to celebrate cultures at risk of displacement itself confronts disappearance, multiplying its symbolic potency. And the Malonga-Hotel Oakland bloc strengthened through the mural's development acquires political power that Wilkinson—using interviews and historical flashbacks about racist city planning practices and housing discrimination in Oakland—casts in a longer lineage of racial solidarity.

The goal of the new coalition isn't immediately evident in the documentary. Theo Williams, leader of Malonga tenant SambaFunk, says at a meeting that he doesn't necessarily oppose the development, yet no one in the film persuasively argues on its behalf. Complicating the narrative are new problems: Noise complaints resurface concerns about intolerant new neighbors to the Malonga, and the activists crash a city planning process, demanding meaningful representation.

Unsurprisingly for grassroots activism, it's a dizzying cycle of setback and success. A subplot about Jerry Brown's early 2000s attempt as Oakland mayor to shutter what was then the Alice Arts Center is a welcome rejoinder to recent hagiography, but it creates some narrative whiplash. Still, the story regains focus when the coalition formally appeals the building's planning commission approval in order to negotiate a community benefits agreement with the developer.

The coalition secured funds for the Malonga and for a replacement mural (now being designed for the wall of the Greenlining Institute nearby). It also modeled a strategy since used by the coalition to extract concessions from developers worth an estimated \$20 million, organizer Eric Arnold says in the film—including 90 affordable homes. With this tactic the same activists recently won a raft of benefits for arts groups in the Kaiser Convention Center redevelopment.

"Resilience" is too often a buzzword that serves to normalize communities' capacity to withstand abuse, especially from the mouths of powerful people in media and politics. It's also too flat for the dynamic artist-activists shown in Alice Street, who dance in the streets and navigate city bureaucracy with equal

Here are some ideas for limiting downtime:

- Don't perform all your PM and PdM in the same scheduling week-spread them out over multiple weeks whenever possible
- Schedule maintenance during planned downtime, such as breaks or training ses-
- Consider outsourcing some work—just enough to give you time to do your maintenance
- Buy additional equipment
- Have your maintenance team and all parts ready before starting the PM or PdM work so you don't add more lost time than needed to complete the task

Don't schedule to 100% capacity. Sometimes things happen—people get sick, material arrives late, people take vacations, etc. A good rule of thumb is to schedule your equipment to run at 85 -90% capacity. For example, if you operate a machine 24 hours a day, 7 days a week, you have 168 hours at 100%. If you use 85% capacity, you would only plan on running 143 hours, which gives you time to perform maintenance.

software option allows connecting traditional construction equipment to make it autonomous. It will soon show off the technology at a trade show by using it to operate two trench rollers. The company says its technology boosts productivity by helping users get more done.

#### Autonomous Equipment in Construction **Could Boost Safety**

The construction industry is filled with dangers. Even when people receive proper and ongoing training, risks exist on any jobsite. Autonomous construction equipment could minimize them,

Startup SafeAI recently raised \$5 million in funding by capitalizing on the safety potential associated with autonomous machines. It wants to deploy technology on construction and mining equipment that operates without a human driver.

SafeAI has already applied its solution to skid loaders. The company will use the results from those early and ongoing efforts to improve its technology and prepare it to potentially enter the market. Even though people cannot buy SafeAI's

technology yet, the company's small-scale realworld tests could find out where shortcomings exist. That will assist the business in learning how to most effectively promote what it offers to interested persons at the right time.

In a related instance that spotlights applying the technology to machines in authentic settings, Harsco Environmental will soon start a year-long pilot in Sweden of battery-electric autonomous haulers. Although that company did not explicitly bring up safety in its reasons for going ahead, it is eager to get feedback from participants about how to make the machines better. The first tasks for them involve repetitive transport.

When construction workers engage in duties that require lots of repetition, the chances of them getting fatigued goes up. Risks can also become greater if a construction company has to scale up its operations without increasing the size of the labor force. Then, the faster pace and longer hours could introduce more dangers.

Harsco Environmental falls outside of the construction sector but deals with materials processing. The insights from this pilot phase could

spark new ideas that make time on the job safer for construction workers and others.

#### **Promising Developments on the Horizon**

Many of the developments here are not yet ready for widespread adoption. However, there are still plenty of reasons to feel excited about autonomous construction equipment. It could increase productivity while reducing accidents. An even more appealing aspect for many potential customers is the ability to update their machines or rent them instead of buying new ones.

The advantages here are not the only ways construction equipment will get more advanced. However, they're worth staying abreast of as progress happens. More machines will likely become autonomous in the future, and companies will want to stay on the cutting edge to be suc-
