

## Biden-Harris Administration Takes Major Step to Boost Domestic Manufacturing in Transportation, Create Good-Paying American Jobs

The U.S. Department of Transportation's Federal Highway Administration (FHWA) announced a Notice of Proposed Rulemaking (NPRM) today to discontinue its general waiver of Buy America requirements for manufactured products used in federal-aid highway projects. In the rulemaking, the agency proposes discontinuing the waiver and creating standards that would apply to manufactured products if the waiver is discontinued. This rulemaking will change outdated policy and bolster American manufacturing while creating good-paying jobs. This proposed rule is a result of the FHWA's review of the general waiver for manufactured products under the Bipartisan Infrastructure Law's Build America, Buy America (BABA) Act, which will boost domestic manufacturing, bolster critical supply chains, and support the creation of good-paying union jobs.

"For decades, America's highway projects were allowed to use taxpayer dollars to purchase products manufactured in other countries, but the Biden-Harris administration is setting out to change that," said U.S. Transportation Secretary Pete Buttigieg. "As we rebuild America's infrastructure, this new rule would require federal highway projects to use products manufactured here - in keeping with President Biden's Investing in America agen-

da that has helped create 800,000 manufacturing jobs across the country."

"We're proposing to do away with a policy that did not incentivize restricted American-based manufacturing. This policy supports the Administration's commitment to create good-paying jobs within the U.S., allowing domestic manufacturing to grow," said Federal Highway Administrator Shailen Bhatt. "American businesses now have a long-term incentive to tap into the broader federal government market."

The Buy America Requirements for Manufactured Products NPRM calls for the elimination of the previous Manufactured Products General Waiver, a general applicability waiver in existence for more than four decades that waived the Buy America requirement for manufactured products. The proposed rule aims to maximize the use of domestically produced manufactured products permanently incorporated in federal-aid highway and bridge projects and asks for comment to outline standards for manufactured products covered under Buy America requirements. The proposed rule is consistent with existing BABA standards for manufactured products implemented by the Office of Management and Budget.

Buy America was enacted in 1983. At that time manufactured products were used in insufficient quantity on highway construction projects to



incentivize domestic manufacturing, so there would be little benefit to applying the protections afforded under Buy America.

The proposed rule responds to President Biden's Executive Order, "Ensuring the Future is Made in All of America by All of America's Workers." The Executive Order sets forth a policy that federal agencies should maximize the use of domestic products and strengthen the U.S. manufacturing sector - while seeking to promote private sector investment and opportunity for small

businesses, bolster the domestic supply chains, and create jobs.

BABA represents a unique governmentwide market opportunity to expand the domestic manufacturing base. By placing greater value on domestic manufacturing for highway construction, the proposed rule is expected to encourage investment in this sector. It seeks to protect and expand domestic manufacturing, as required un-

## Wall Street is betting big on AI. California consumers must be protected

Artificial intelligence may soon replace financial advisors, and that's just the start. While one algorithm predicts stock price, another decides what to disclose to regulators. Chat GPT-style language models could soon hallucinate your mortgage application or life savings, and you won't even know it.

I spent several months combing through the U.S. Patent and Trademark Office to see how the world's most powerful investment banks are incorporating artificial intelligence, and it's a scary glimpse into the future.

JPMorgan has applied for a trademark called "Index GPT" that would give financial advice, and one that would match companies with investors. Goldman Sachs is seeking to patent AI that will combine all the data a trader would need to predict stock prices, and another to predict a hedging portfolio. Already, ING Group is screening for potential defaulters.

There is even AI to translate "Fedspeak" so banks can tell if statements by regulators are "dovish" or "hawkish."

Banks are pouring billions of dollars into AI research, patents and financing without adequate safeguards. A lot of attention is devoted to tech companies developing artificial intelligence, but Wall Street banks are just as interested. Financial services spending on AI is larger than any other industry, exceeding even the tech industry.

There is still little we know about generative AI. Even engineers and coders don't understand how AI works. Unlike previous models, OpenAI decided not to disclose the training data of GPT-4. ChatGPT has scraped the Internet for over 300 billion words, and there are concerns that it has sucked up personal information along the way. In addition, OpenAI says its language model has a "high risk of economic harm" due to a "tendency to hallucinate," and should come with "a disclaimer."

Despite these concerns, JPMorgan said that data and AI will be "critical" to the company's future success. It currently has more than 300 use cases for AI in production.

But the lack of transparency surrounding AI and its potential for bias means mysterious AI could push risky investments and loans, or hallucinate bad advice on managing debt without a consumer even knowing it was AI.

Without sound regulation, the next financial crisis could be caused by AI, igniting in the mortgage or equity market due to a handful of banks relying on the same algorithms. Don't just take it from me. Much smarter people like Gary Gensler, chair of the U.S. Securities and Exchange Commission, predicted that within 10 years AI will be responsible for some sort of financial crisis.

The major concerns are algorithmic complexity, a lack of transparency and biased or false information. For example, Goldman's AI could be used to create and price out a new type of derivative. These complicated financial instruments enabled Wall Street to gamble with billions of dollars on the housing market. As a result, 6 million Americans lost their homes during the Great Recession.

How else can AI impact our lives financially? AI can also start to "drift," meaning it can deviate from its intended use and perpetuate bias. An

AI could start thinking a certain race or address equals bad credit and deny loans based on that. This has already happened.

Thankfully, California is trying to rein in AI. Right now the California Privacy Protection Agency is drafting automated decision-making rules under the California Consumer Privacy Act, which would safeguard against AI's risks and biases regarding personal data. For example, a business would have to tell consumers that it uses automated decision-making, details about the algorithm's logic and give a chance to opt out of the decision, especially if it involves finances.


And for the first time, there are rules dedicated to generative AI and training data. Businesses using language models will have to disclose if those models use personal information to train AI, and consumers will be able to opt out.

America is falling behind on AI regulation. It cannot be slow to act like it was regarding social media when both sound regulation and innovation are possible.

## L.A. promised to hire 200 Black workers from a job training program. That hasn't happened.

Tekoah "TK" Flory was thrilled to receive a job offer from the Los Angeles Bureau of Street Lighting last September. Flory had been directing traffic at Dodger stadium, a seasonal job that would be coming to an end soon.

After taking on a series of minimum wage jobs, Flory, 31, was looking forward to starting a career in a city job Flory believed would pay \$40,000 to \$60,000 a year.

"I was so excited, elated, ready to budget for the year," said Flory, who uses they/them pronouns. "I was excited to have a career in this city instead of just working a job, instead of being just above broke or just making enough to eat."

But in January, the city rescinded the job offer. Flory was back where they started.

Flory applied for office work in the street lighting bureau through the city's Workforce Equity Demonstration Program, a partnership between the Los Angeles Black Worker Center and the L.A. Department of Public Works. Participants who get several weeks of training at the Black Worker Center can apply for positions in Public Works without having to take a civil service exam, often a barrier for applicants.

The partnership contract signed in 2022 promised the city would hire 200 Black workers trained by the Black Worker Center. Trina Traylor, campaign director for the center said the city

agreed to hire them by June 2024.

But so far only 49 of the 83 people trained have been hired. Besides Flory, one other applicant had their job offer rescinded.

"We are nowhere near that (200) number for different reasons, some that are not clear or satisfactory to us," said Yodit Semu, a program specialist at the L.A. Black Worker Center's Ready to Work program.

While organizers are pleased that some program participants were placed, they fear the slow pace of city bureaucracy is hindering opportunities for other Black workers.

Meanwhile, as the city faces a 17.5% job vacancy rate, Mayor Karen Bass is moving to cut vacant jobs to deal with a budget deficit.

"It is vital that Black workers have access to jobs offered by the city and across the city and the mayor will continue work to make sure the current economic picture does not roll back that commitment," Zach Seidl, a spokesperson for the mayor, said in an email.

The public works department did not grant interviews and said they would send a written response to questions. They did not by deadline.

A promise of city jobs for Black workers

Since the Reconstruction Era, when the U.S. Postal Service first hired formerly enslaved Black workers, the public sector has long been a source of good jobs for Black people, according to a 2020 report by the UCLA Labor Center.

One in 5 Black workers in Los Angeles County works in government, compared to 1 in 10 non-Black workers, the report says. In L.A. County, Black workers in the public sector make 46% more than counterparts working in the private sector. And about 44% of Black public sector workers owned homes, as opposed to 28% of Black private sector workers.

"There's this general saying in Black communities of, 'Get you a good government job,'" said Déjà Thomas, the report's coauthor. "The data affirmed that. Black workers in the public sector were faring better when it came to income, insurance, home ownership — all those metrics of socioeconomic status."

And Black government workers enjoy better job benefits and protections than workers at other jobs, because those are union jobs that include built-in raises.

Now Black workers are retiring at high rates, with no pipeline to replace them, said Thomas, who also is a program manager for UCLA's Center for the Advancement of Racial Equity at Work.

The COVID-19 pandemic worsened employment opportunities for Black workers.

Black workers lost jobs at higher rates than other demographic groups during the pandemic and have not recovered them to the same extent as other groups, said Sarah Bohn, a labor economist with the Public Policy Institute of California.

Unemployment among Black workers is 7.4% compared to 5% for the state overall, Bohn said.

"The discrimination piece is a really important one to think about, because it's not just educational attainment and where you live or where the jobs are," Bohn said. "There's a lot unexplained in comparing people with similar education levels and backgrounds."

From 2000 to 2018, the percentage of Black workers in public sector jobs declined from 27% to 22%, Thomas said.

In response to shrinking government job opportunities for Black workers and job loss during the pandemic, the L.A. Black Worker Center created the 1000 Strong coalition of unions and labor groups to push the city and county of Los Angeles to create more pathways to city jobs.

The Workforce Equity Demonstration program launched in 2022. It's similar to the city's Targeted Local Hire and Bridge to Job programs, which recruit, hire and train local workers from disadvantaged and low income communities.

### Ready to work

A friend told Flory about the opportunity to get a city job through the L.A. Black Worker Center. Flory signed up for the center's workforce development program, Ready 2 Work, which trains participants over five to seven weeks on various skills they may need to find a quality job.

Participants get training on resume building, financial literacy, leadership, interview prepara-

### Following Advancement of Historic Kensington Expressway Project, Governor Hochul Unveils Details of Phase Two Study to Begin This Year

Following federal approval for the historic Kensington Expressway project to move forward, Governor Kathy Hochul today announced that an upcoming study for a phase two on potential future enhancements along the Kensington Expressway corridor in East Buffalo will also examine options for a reimagined Scajaquada Expressway in Buffalo. The State Department of Transportation will begin work on the study later this year, assessing the traffic and environmental effects of any potential changes to both highways. The study will also include an analysis of the work advanced by the Greater Buffalo-Niagara Regional Transportation Council for the Scajaquada Expressway corridor, also known as State Route 198. Governor Hochul first announced the study in February 2024 to ensure that the historic progress being made to reconnect the neighborhoods of East Buffalo advances beyond the current scope of the Kensington Expressway project, which will begin construction this fall.

“From the beginning, the Kensington Expressway project has been about righting the wrongs of the past, and after decades of talk and indecision, we are finally delivering the results this community deserves,” Governor Hochul said. “By commencing a study for a second phase, we are committed to exploring new ways to reconnect the community along the Kensington and advancing a greater vision that includes the linked Scajaquada Expressway corridor, enhancing it for residents, visitors and motorists.”

In February, Governor Hochul directed the State Department of Transportation to commence a study on additional potential enhancements along the Kensington Expressway corridor, all the way up to the Scajaquada Expressway and Delaware Park, including a new vision for a

reimagined Humboldt Parkway. That study will now also include an evaluation of the concepts produced by the Greater Buffalo-Niagara Regional Transportation Council (GBNRTC) in January of 2023 for a reimagined Scajaquada Expressway.

The GBNRTC’s report, which was funded by the NYS Department of Transportation, was the result of a collaborative planning process that began in 2019, evaluating several possible scenarios and articulating a preferred option that calls for the reconfiguration of the Scajaquada Expressway into a two-lane, at-grade roadway that removes all existing ramps to and from the expressway, creating a new parkway extending from Niagara Street to East Delavan Avenue.

As part of its study, the State Department of Transportation will conduct a detailed traffic analysis and identify effects on the surrounding road network and potential mitigation measures. Economic and environmental effects, including air quality and noise, will also be studied. The State DOT will continue to engage with community members and listen to their concerns to ensure the best outcome for corridor users and the residents who call it home. The State Department of Transportation will lead the study, which is expected to begin later this year and be completed by the end of 2027, in coordination with GBNRTC.

New York State Department of Transportation Commissioner Marie Therese Dominguez said, “Governor Hochul’s vision is literally rewriting the history books of the long and complicated saga of the Kensington Expressway for the better. The State Department of Transportation is working day and night to ensure we are ready for a shovel in the ground this fall on the Kensington Expressway project, but our work is far from over. This new planning study will help us chart a path forward and it is important that the future

# How Bridges Can Be Protected From Ship Collisions

*The MV Dali, a 984-foot, 100,000-ton cargo ship, rammed into the Francis Scott Key Bridge when leaving Baltimore harbor on March 26, 2024, causing a portion of the bridge to collapse.*

*In an interview, University of Michigan civil engineer Sherif El-Tawil explained how often ships collide with bridges, what can be done to protect bridges from collisions, and how a similar disaster in Florida in 1980 – just three years after the Key bridge opened – changed the way bridges are built.*

This is not the first time a ship has taken out a bridge. What's the history of ship-bridge collisions?

This is an extremely rare event. To my knowledge, there are about 40 or so recorded events in the past 65 years that involved similar type of damage to a bridge caused by a ship. So they

seem to occur on average about once every one and a half to two years around the world. When you consider that there are millions of bridges around the world – and most of them cross waterways – you can imagine how rare this is.

The most influential case was the 1980 Sunshine Skyway Bridge collision in Florida, which prompted the federal government to take action in terms of developing guidelines for designing bridges for ship collision. By the early 1990s the provisions were developed and incorporated into the bridge design code, the AASHTO specifications. The American Association of State Highway and Transportation Officials produces the design code every bridge in the United States must conform to.

**What was different about the Sunshine Skyway Bridge disaster from previous bridge collisions?**

There were casualties. The fact that a crash could bring down a bridge, just like in the Baltimore situation, prompted the concern: Can we

do something about it? And that something was those specifications that came out and eventually became incorporated in the national design document.

What those specifications say is that you either design the bridge for the impact force that a ship can deliver or you must protect the bridge against that impact force. So you must have a protective system. That's why I was surprised that this bridge did not have a protective system, some type of barrier, around it. I have not examined the structural plans of this bridge. All I could see is the pictures that were published online, but protective systems would be very visible and recognizable if they were there.

The Sunshine Skyway Bridge disaster in 1980 prompted improvements in bridge safety.

**What is currently mandated for new bridge construction, and is it sufficient to handle today's massive cargo ships?**

I estimate, based on the published speed and weight of the MV Dali, that the impact force

was in the range of 30 million pounds. This is a massive force, and you need a massive structure to withstand that kind of force. But it is doable if you have a huge pier. That might dictate the design of the bridge and what it could look like. Most likely it could not be a truss bridge. It may be a cable stay bridge that has a very large tower that is capable of taking that load.

If you cannot design for that load, then you have to consider other alternatives. And that's what the specifications say. They're very clear about this. And those alternatives could be to build an island around the pier or a rock wall, or put dolphins – standalone structures set in the riverbed – adjacent to it, or put on fenders that absorb the energy so the ship doesn't come in so fast. All of these are ways you can mitigate the impact.

tion and workers' rights, as well as how to use Microsoft Word and Excel.

Flory said the Ready 2 Work program was "where I was able to find myself again and recognize that I have a lot of strengths and I have a lot of talents I can share with my community."

The most impactful element of the program, Flory said, was being able to build a community of Black women and non-binary folks to support each other. That element of community, organizers said, is essential for succeeding in often discriminatory or challenging work environments.

"I feel like in that space, we were able to cultivate a loving community environment where we each felt safe, seen, heard, respected and empowered," Flory said.

When the Workforce Equity Demonstration program was created, the L.A. Black Worker Center had provisional offer letters from the city's sanitation department that guaranteed nearly all of the Ready 2 Work graduates that year had jobs, Thomas said.

Since then, things have been a lot more challenging, organizers said.

The city has assigned Kevin Gresham as a coordinator to the L.A. Black Worker center to help navigate the Workforce Equity Demonstration program. "Kevin has faced so many obstacles," Traylor said. "Nobody returned his phone calls. The other departments don't even respond to him when he requests meetings."

Sanitation so far has been the most helpful department in Public Works, Traylor said; it has taken most of the 49 workers the city hired through the program. Other departments with hundreds of open positions have not been as cooperative, she said.

Engineering, for instance, has 218 open positions, sanitation has 786, street lighting has 112, contract administration has 104 and street services has 404 open positions.

City officials did not grant CalMatters interviews with Gresham or anyone in the public works or sanitation departments.

der BABA, to increase reliance on U.S.-made products and strengthen the resiliency of our nation's supply chain.

The proposed rule will not change the Buy America requirements that currently apply to iron or steel products. Nor will the proposed rule

change BABA requirements that apply to products classified as construction materials or excluded materials (cement and cementitious materials; aggregates such as stone, sand, or gravel; or aggregate binding agents or additives).

FHWA will also issue a Request for Information (RFI) on the domestic availability of spe-

cific manufactured products commonly used in FHWA-funded projects, which will help guide FHWA implementation, should the waiver be rescinded.
