More Power, More Water: Solar-Over-Canal Projects Are Coming to California

WHAT YOU NEED TO KNOW: California is pioneering innovations to generate clean electricity while conserving water, and we're teaming up with the Biden Administration to advance another pilot project that could deliver a major new source of clean power and transform the state's water system.

MERCED COUNTY – California's Central Valley is not just home to the breadbasket of the world, it's now home to the big ideas that could tackle our biggest challenges: using innovation to generate clean electricity while conserving water.

Governor Gavin Newsom invested \$20 million in a solar over canals pilot project in Turlock, and today the Governor joined the Biden Administration to celebrate new federal funding for another solar over canals pilot project outside of Los Banos. Solar over canals projects involve installing solar panels over water canals to help reduce evaporation and generate clean electricity.

WHAT GOVERNOR NEWSOM SAID: "California is pioneering innovations to tackle our biggest challenges, and here in the Central Valley we're addressing two big challenges

Mayor Bass, Senator Padilla and Los Angeles Leaders Highlight Nearly \$900 Million in Federal Funding to Bolster L.A. Transportation Infrastructure Ahead of 2028 Olympic Games

Los Angeles Mayor and Metro Chair Karen Bass, U.S. Senator Alex Padilla joined local leaders to highlight new transportation infrastructure funding. Leaders gathered outside the Los Angeles Memorial Coliseum to highlight nearly \$900 million in recent federal investments to LA Metro to improve mobility and upgrade transportation infrastructure ahead of the 2028 Olympic and Paralympic Games.

LA Metro received \$709.9 million from the Bipartisan Infrastructure Law and the Fiscal Year 2024 transportation spending law, which will go toward the D Line (Purple) Subway Extension Project and the East San Fernando Valley Light Rail Transit Project. The Los Angeles region will also receive \$160 million in new federal grant funding for street and transit infrastructure, traffic safety and to improve connections between neighborhoods. This includes \$139 million that will directly improve transportation mobility access during the 2028 Olympic and Paralympic Games and create lasting enhancements for communities.

"These investments are going to help transform Los Angeles," said Mayor Karen Bass. "I want to thank Senator Padilla for continuing to deliver crucial resources, especially as we prepare to host the World Cup and 2028 Olympic and Paralympic

"As Los Angeles prepares to host the Olympic Games, we have a responsibility not just to make the Games run smoothly, but to make investments that will benefit communities long after the Olympics are over," said Senator Alex Padilla. "For too long, highways and inadequate transportation infrastructure have cut communities across California off from quality educational, healthcare, and job opportunities. That's why I'm glad to announce that over \$139 million from this new funding will specifically help reconnect our communities."

Mayor Bass yesterday joined leaders to announce the successful completion of tunnel mining operations on all three sections of the Metro Purple (D) Line Extension Project. The City of Los Angeles, Metro and the Los Angeles Department of Transportation (LADOT) also recently celebrated the opening of 5.6 miles of new bus priority lanes on Sepulveda Boulevard this week as part of ongoing citywide efforts to save transit customers time and increase the reliability of bus service.

California Investing Nearly \$1 Billion in Bicycle and Pedestrian Infrastructure Over Next Four Years [Article originally appeared in https://dot.ca.gov]

Caltrans will spend approximately \$930 million over the next four years to improve bicycle and pedestrian infrastructure throughout the state, according to a plan approved by the California Transportation Commission (CTC) this week. This includes 265 miles of new and improved bike lanes on state highways and the addition of more than 1,300 safety elements by mid-2028.

The CTC also approved a series of transportation projects totaling approximately \$1 billion in continuing a historic push to improve the vital transportation infrastructure through rural and urban projects throughout the state.

The latest allocations include nearly \$375 million from the federal Infrastructure Investment and Jobs Act of 2021 (IIJA) and \$276 million via Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017.

The bicycle and pedestrian infrastructure spending plan is part of the 2024 State Highway Operation and Protection Program (SHOPP). Funding over the next four years will improve access and safety for bicyclists and pedestrians using the state highway system. Of the 265 new and improved bike lanes, 203 miles are a combination of Class 1, 2, and 4 variety, and 62 miles are designated Class 3. Safety elements featured in the plan include more visible and separated bike lanes, ADAaccessible curb ramps, better signage, and upgraded signalization.

The following projects are among those that will focus on improvements in bicycle and pedestrian infrastructure:

- A \$36 million project in Imperial County on State Routes 115, 111 and 86 to fix existing sidewalks and add new sidewalks, Class II bike lanes, and Class IV separated bikeways. Improvements include ADA curb ramp upgrades, lighting systems, traffic signal system upgrades, and overhead sign structure rehabilitation.
- A \$19.6 million project on the Pacific Coast Highway (SR-1) in Santa Cruz County to repair 8.3 miles of pavement, guardrail, crosswalks, sign panels, and Class II bike lanes. This project includes new bike guide striping and enhanced signage. The finished product will all be brought up to the standards of the Americans with Disabilities Act (ADA).

IIJA, known as the "Bipartisan Infrastructure Law," is a once-in-a-generation investment in our nation's infrastructure to improve the sustainability and resiliency of our energy, water, broadband, and transportation systems.

Who Are California's Workers?

California's workers are demographically diverse



California's workers power the economy.

- Most of California's 19 million workers earn wages or salaries (89%), but a sizeable share are self-employed (11%). More than two-thirds (70%) usually work at least 35 hours a week for 50 or more weeks a year.
- About one in ten (8%) workers are full time for just part of the year, while 22% work part time year-round. In 2022, 47% who worked part time would have preferred to work more hours.
- The median full-time, year-round worker in California earns about \$27 an hour, or \$56,000 a year. A third of all workers (33%) have low-wage jobs (which pay less than \$18 per hour).

Californians work in a variety of occupations and sectors.

- The most common employment sectors defined by their key products or services are health care and social assistance, retail trade, manufacturing, and professional, scientific, and technical services. The San Francisco Bay Area differs from other regions in that a large share of its workers are in professional services.
- Nearly 40% of all workers in California are employed in four occupations: management, office and administrative support, sales, and transportation. Workers sharing an occupation do similar tasks day to day.
- Management is the top occupation in many parts of the state, but workers in the Sacramento area and Los Angeles County are more likely to have office and administrative support jobs, and those in the San Joaquin Valley, Sierras, and Inland Empire are more likely to work in transportation.
- In a number of occupations, workers are primarily members of a single demographic group. For example, 69% of childcare workers are women of color, 74% of farmworkers are immigrants, and more than 95% of workers in construction and installation are men.

California's workforce is demographically diverse.

- Like the state's population, workers in California are predominantly Latino (39%) or white (34%), with Asian/Pacific Islander, Black, and workers of other race/ethnicities comprising the other quarter. As many as half of workers under 35 and those in the central or southern parts of the state are Latino.
- The average California worker is younger than in the rest of the US, and two-thirds are 25–54—prime working ages. But the state's workforce is aging. The share of workers 55 and older has increased 39% since 2005.
- Women make up 45% of the workforce, up from 32% in 1962—but growth has slowed since the mid-1980s.
- Nearly a third of workers are immigrants, a three-fold increase since 1960. The largest share of foreign-born workers are from Mexico (38%); 9% come from Central America, 9% are from China, and 8% are from the Philippines. Newly immigrated workers are more likely to be from Asia (39%) than Latin America (12%).

Educational attainment is rising among workers, but most do not hold four-year degrees.

- About one in four workers in California holds a bachelor's degree, and another 15% hold a higher degree. This combined share (39%) is up from 31% in 2005.
- A third (32%) of workers have high school diplomas or less, while 21% have some college and 8% have associate degrees. Workers in California are more likely than those elsewhere in the US to have less than a high school diploma (12% vs. 8%), although the share without diplomas has declined 28% since 2005.

Most workers live in a household with at least one other working adult.

- The vast majority of workers (76%) live in households with at least one other working adult: with adult roommates, siblings, or extended family (30%), in multigenerational households with grandparents, grandchildren, or adult children (23%), or with a spouse or partner (23%).
- Among the 24% who are sole earners, 58% support children and other adults, while 42% live alone. Black women (20%) and white men (18%) are especially likely to

be sole earners supporting multi-person households.

• Family and/or personal needs factor into work intensity. Women are less likely than men to work full time (64% vs. 75%); they also spend more time on caregiving than men do, on average.

Wages vary substantially across regions and demographic groups.

- Wages vary substantially across the state, as does the cost of living. The Bay Area has the highest median wage (\$33 an hour); median wages are lowest in the Central Valley, Sierras, and northern region—about \$20 an hour.
- Eight percent of working adults are in households classified as poor by the California Poverty Measure. Full-time workers are relatively unlikely to be poor (5%), while single working parents are especially likely to be living in poverty (28%).





at the same time – generating clean electricity and conserving water. Companies are coming to California because we're embracing innovation and we have the talent and infrastructure to foster new technologies that will solve not only California's, but the world's, biggest challenges."

These pilot projects will:

- Demonstrate the feasibility of installing solar panels over canals
- Reduce water evaporation
- Improve water quality
- Provide renewable power generation
 - Demonstrate scalability

UC Merced will study the Turlock project to determine how much clean energy could be generated, how much water could be conserved, and analyze how this could be scaled statewide. Initial findings show that if these projects are scaled statewide they would:

- Save California over 60 billion gallons of water every year – enough for 2 million people;
- Generate 13 gigawatts of clean power more than half the projected new solar capacity needed by 2030 to meet the state's decarbonization goals.

8 essential steps for effective project cost estimation and budgeting

To say that winning bids is the key to success in construction is a half-truth. Estimating project costs correctly and managing the budget accordingly are just as vital.

Subcontractors getting awarded a contract spells financial disaster if the bid is too high to be competitive or too low to be profitable. Submitting a price within the Goldilocks zone can be challenging. You must have domain expertise and foresight to calculate how much everything will cost, avoid charging too little and spend funds properly.

All subcontractors make project cost estimation and budgeting errors. You can learn from your mistakes and get wiser with experience and insight. However, only some businesses can afford to commit too many faults to keep the lights on. Follow these eight essential steps to estimate project costs and budget funds effectively to prevent grave miscalculations.

1. Study the project details

Understand the construction project's specifications and requirements during the bid solicitation phase. Paying close attention to these details can help you determine whether you're qualified for the job and should submit a proposal.

Bidding on projects you have yet to gain experience in can broaden your horizons. However, trying to be a specialty contractor for everyone can backfire. Concentrating on jobs that fit with your business has merits.

Establishing a solid reputation for specific projects can increase your hit ratio. Property owners can find your credentials impressive and confidence-inspiring when you've been around the same block a few times. Finding your niche can benefit your brand, gaining repeat business from general contractors and design-build construction firms.

For example, focusing on green projects in your county where recycled and carbon-neutral materials are paramount can make you the local authority in sustainability. Zeroing in on historic restoration jobs is another way to differentiate yourself from the competition.

In contrast, trying your luck on any project coming your way can lower your chances of winning a contract. Construction project stakeholders expect you to self-regulate and reflect on whether you're up to the task. Even experienced subcontractors can seem like novices when bidding on jobs outside their areas of expertise.

You may underestimate the job's scale and complexity if you outbid others when you're unqualified. Biting off more than you can chew can put you in a bad light.

2. Perform a material takeoff

Conducting a material takeoff is a sound practice to identify and address discrepancies early. General contractors can review all available construction documents or the bill of quantities the property owner or project engineer prepared. Subcontractors can do a separate takeoff based on the general contractor's specs to verify material and equipment quantities and ensure an accurate count before contacting suppliers and vendors.

3. Solicit pricing information

Request quotes from various sources and study their pricing structures. Consider how much savings you can get when ordering large quantities. Buying slightly more than needed may entitle you to bulk pricing discounts.

Factoring material waste into the equation can reveal how many additional supplies you should procure to prevent delay. This task may involve guesstimation, although your life will be easier if you track this information through construction software. Digital data lends itself to analytics. It enables you to evaluate your past projects and have a concrete basis for the amount of extra materials you should order.

Quality must take priority over price. Although almost any product has a budget-friendly option, finer materials contribute to functionality, aesthetics, safety and longevity. Skimping on supplies can save you money once. However, investing in quality items can keep you in business for a long time. It can help you build a reputation for excellence and ensure counterparty satisfaction consistently.

Ask about quote expiration, too. Suppliers and vendors rarely wait forever. Determine whether their offers are valid until you snag the contract to see if you can count on them.

Regarding tools and machines, renting what you seldom use for projects is smart. It spares you from maintenance and storage duties.

4. Calculate labor costs

Labor costs include worker wages, taxes, insurance premiums, retirement contributions, vacation and sick leaves, and union dues. These expenses multiply for every extra person you have on staff.

Know the exact roles the project requires and the hours needed to complete the job to build the right crew.

If you don't have enough employees, use independent contractors to round out the team. They can reduce your labor-related expenses since they're not entitled to the federal minimum wage and overtime pay.

Sadly, many construction businesses purposely misclassify their employees as independent contractors to slash their payroll costs by up to 50% and shrink bids by 25%. The financial advantages may be enticing, but decide against it to avoid getting sued.

5. Determine indirect expenses

You must estimate insurance, bonds, indirect field expenses and overhead costs. Insurance and bonds particularly matter because they mitigate risks for all stakeholders and make you a safer party to do business with.

Integrating overhead expenses into estimates accurately is simple. Discerning estimators determine the business's expected annual revenue and overhead cost when assigning a specific percentage of the overhead to a project.

6. Prepare for contingencies

Unknown and unforeseen events can lead to budget overruns, so setting aside a contingency fund is necessary. Gleaning insights from past projects can help you determine a reasonable amount to add to your estimate and keep from pulling a number out of thin air.

Sometimes, property owners have contingency limits. For example, the Washington State Department of Transportation bars contractors from allocating more than 4% of the contract amount for contingencies.

7. Take target profit into account

Determine a suitable profit margin to make the project worth your while without turning off property owners. On average, remodelers net 4.7% before taxes. Regardless of how you feel about this figure, it's an excellent reference point for deciding how much you should charge.

The construction bidding process is only a meritocracy occasionally. Charging too much is a losing strategy if you bid on public projects because government rules generally favor the lowest bidders.

On the contrary, commercial property owners are more keen on hiring contractors with stellar project experience, scheduling philosophies and safety records, even if it means paying more.

8. Technologize budget management

Responsibly spending funds is a different skill. Ensuring the project costs as close to the estimate as possible is the ultimate goal. Preventing unnecessary expenses within your control is a must.

Tracking how much money goes out of your account manually isn't the most efficient method. Instead, use a construction management program to stay on top of your budget. Cloud-based tools designed to keep tabs on invoices and compare actual spending against the budget are indispensable. They can help you economize in every area, finish the job on schedule and get paid ASAP.

Underestimating estimation and budgeting errors is costly

Estimates are no guarantees of cost overrun avoidance. What's certain is getting them wrong can put you out of business sooner or later. Let the above steps guide you and trust the process.
