Why Do People Celebrate Cinco de Mayo?

Cinco de Mayo—or the fifth of May—is a holiday that celebrates the date of the Mexican army's 1862 victory over France at the Battle of Puebla during the Franco-Mexican War (1861-1867). A relatively minor holiday in Mexico, in the United States Cinco de Mayo has evolved into a commemoration of Mexican culture and heritage, particularly in areas with large Mexican-American populations.

Cinco de Mayo History

Cinco de Mayo is not Mexican Independence Day, a popular misconception. Instead, it commemorates a single battle. In 1861, Benito Juárez—a lawyer and member of the Indigenous Zapotec tribe—was elected president of Mexico. At the time, the country was in financial ruin after years of internal strife, and the new president was forced to default on debt payments to European governments.

In response, France, Britain and Spain sent naval forces to Veracruz, Mexico, demanding repayment. Britain and Spain negotiated with Mexico and withdrew their forces.

France, however, ruled by Napoleon III, decided to use the opportunity to carve an empire out of Mexican territory. Late in 1861, a well-armed French fleet stormed Veracruz, landing a large force of troops and driving President Juárez and his government into retreat.

The Battle of Puebla

Certain that success would come swiftly, 6,000 French troops under General Charles Latrille de Lorencez set out to attack Puebla de Los Angeles, a small town in east-central Mexico. From

his new headquarters in the north, Juárez rounded up a ragtag force of 2,000 loyal men—many of them either Indigenous Mexicans or of mixed ancestry—and sent them to Puebla.

The vastly outnumbered and poorly supplied Mexicans, led by Texas-born General Ignacio Zaragoza, fortified the town and prepared for the French assault. On May 5, 1862, Lorencez gathered his army—supported by heavy artillery—before the city of Puebla and led an assault.

How Long Did the Battle of Puebla Last?

The battle lasted from daybreak to early evening, and when the French finally retreated they had lost nearly 500 soldiers. Fewer than 100 Mexicans had been killed in the clash.

Although not a major strategic win in the overall war against the French, Zaragoza's success at the Battle of Puebla on May 5 represented a great symbolic victory for the Mexican government and bolstered the resistance movement. In 1867—thanks in part to military support and political pressure from the United States, which was finally in a position to aid its besieged neighbor after the end of the Civil War—France finally withdrew.

The same year, Austrian Archduke Ferdinand Maximilian, who had been installed as emperor of Mexico in 1864 by Napoleon, was captured and executed by Juárez's forces. Puebla de Los Angeles was renamed for General Zaragoza, who died of typhoid fever months after his historic triumph there.

Cinco de Mayo in Mexico

Within Mexico, Cinco de Mayo is primarily observed in the state of Puebla, where Zaragoza's unlikely victory occurred, although other parts of the country also take part in the celebration.

Traditions include military parades, recreations of the Battle of Puebla and other festive events. For many Mexicans, however, May 5 is a day like any other: It is not a federal holiday, so offices, banks and stores remain open.

Why Do We Celebrate Cinco de Mayo in the United States?

In the United States, Cinco de Mayo is widely interpreted as a celebration of Mexican culture and heritage, particularly in areas with substantial Mexican-American populations.

Chicano activists raised awareness of the holiday in the 1960s, in part because they identified with the victory of Indigenous Mexicans (such as Juárez) over European invaders during the Battle of Puebla.

Today, revelers mark the occasion with parades, parties, mariachi music, Mexican folk dancing and traditional foods such as tacos and mole poblano. Some of the largest festivals are held in Los Angeles, Chicago and Houston.

Confusion With Mexican Independence Day

Many people outside Mexico mistakenly believe that Cinco de Mayo is a celebration of Mexican independence, which was declared more than 50 years before the Battle of Puebla.

Independence Day in Mexico (Día de la Independencia) is commemorated on September 16, the anniversary of the revolutionary priest Miguel Hidalgo y Costilla's famous "Grito de Dolores" ("Cry of Dolores," referring to the city of Dolores Hidalgo, Mexico), a call to arms that amounted to a declaration of war against the Spanish colonial government in 1810.

Governor Newsom announces new AI tool for building permits.

Leveraging the power of private sector innovation, Governor Gavin Newsom today announced the launch of a new artificial intelligence-driven software to aid Los Angeles City and County in accelerating the approval process for rebuilding permits to help communities recover more quickly from the Eaton and Palisades fires.

The software, created by Archistar, will be provided free of charge to the local governments and to users through a partnership between the state and philanthropic partners including LA Rises and Steadfast LA with contributions from Autodesk and Amazon.

"Bringing AI into permitting will allow us to rebuild faster and safer, reducing costs and turning a process that can take weeks and months into one that can happen in hours or days," said Steadfast LA Chairman Rick Caruso. "Working with our coalition partner Mike Hopkins and Amazon, I'm proud Steadfast LA identified Archistar as the right company to develop and apply this game-changing technology. Now we can work with great philanthropic organizations, including LA Rises, to provide this critical tool at no cost to taxpayers. We will continue bringing forward new technology and ideas to cut through red tape and expedite this recovery."

While the state has no direct role in the local permit approval process, Governor Newsom has worked aggressively to cut red tape, remove obstacles, and provide every available resource to local governments so they can fast-track permits and rebuild quickly.

The software uses computer vision, machine learning, and automated rulesets to instantly check designs against local zoning and building codes in the assessment process for building permits. This technology will allow property owners to pre-check their building plans before submission to ensure they submit valid plans,

thus avoiding frustrating delays and expediting the review process once received by city or county staff.

Once fully implemented by local leaders, this e-check tool will improve efficiency, accuracy, transparency, and speed of the rebuilding process from the Eaton and Palisades fire while also improving the experience for disaster survivors.

"Getting residents home quickly and safely is my top priority," said Los Angeles Mayor Karen Bass. "Last week, I signed an Executive Directive to spearhead an AI pilot program to streamline the permitting process for Palisades residents. With the announcement of this AI solution, we're infusing new technologies into City Hall processes to ensure nothing stands in the way of families getting home – and to keep our recovery effort on track to be the fastest in modern California history. I thank Governor Newsom and our County partners for their collaboration on this exciting effort."

The County of Los Angeles has also committed to using the software and passed a Board Resolution to establish a unified permitting authority for the Altadena one-stop recovery center.

"I'm excited to see Los Angeles County embrace innovative technology like Archistar to accelerate the rebuilding process in Altadena and neighboring communities recovering from the Eaton Fire," said Los Angeles County Board of Supervisors Chair Kathryn Barger "This AI tool has the potential to save homeowners valuable time by helping them submit code-compliant plans from the start. I appreciate Governor Newsom's stewardship of this opportunity and SoCal Grantmakers for their fiduciary support. Their help—along with collaboration from our County's permitting departments—helped make this opportunity possible. Our collective work will help ensure we're delivering real, efficient solutions to

those working hard to rebuild their lives. Our wildfire survivors deserve nothing less."

"Together, government and philanthropy are standing with our community to ensure a safe, swift, and lasting recovery from the Palisades and Eaton Fires," said Supervisor Lindsey P. Horvath. "With new AI-powered tools and LA County's One-Stop Permitting Centers, we're cutting red tape to help residents rebuild and return home sooner. I'm grateful to Governor Newsom, Steadfast LA, and LA Rises for their investment in our recovery."

The technology is already being used by more than 25 forward-looking municipalities across the United States, Canada, and Australia, including cities like Vancouver, Austin, Houston and Seattle as well as states like Colorado, British Columbia (Canada) and New South Wales (Australia). In addition to providing the software free of charge in Los Angeles, the tool is now available on a statewide contract that any local government can now access quickly to streamline their own plan review process.

Today's announcement is part of a broader effort to cut red tape and harness innovation in the LA fire recovery process.

Cutting red tape

Governor Newsom issued an executive order to streamline the rebuilding of homes and businesses destroyed — suspending permitting and review requirements under the California Environmental Quality Act (CEQA) and the California Coastal Act. The Governor also issued an executive order further cutting red tape by reiterating that permitting requirements under the California Coastal Act are suspended for rebuilding efforts and directing the Coastal Commission not to issue guidance or take any action that interferes with or conflicts with the Governor's executive orders. Additionally, he signed an executive order to cut more red tape and continue streamlining rebuilding, recovery, and relief for survivors. The Governor also issued an executive order removing bureaucratic barriers, extending deadlines, and providing critical regulatory relief to help fire survivors rebuild, access essential services, and recover more quickly.

Efficient, engaged, effective

Since the start of his administration in 2019, Governor Newsom has made efficiency and engagement a top priority, implementing new technologies and practices that make government more efficient and responsive to the people it serves. In 2019, the Governor established the Office of Data Innovation to help advance this important work.

As the birthplace of tech, California is at the forefront in the study and implementation of AI in government. In 2023, Governor Newsom issued an executive order directing state agencies to utilize Generative AI technologies to improve state services and help solve important issues. Since that time, the state has integrated AI and other efficiency solutions to make state government work faster and even more effective.

To help provide the Los Angeles community with a stronger voice in the rebuilding and recovery efforts, Governor Newsom launched Engaged California, a new platform that gives Californians a unique opportunity to share their thoughts and connect with other people on topics that are important to them. It creates new opportunities for Californians to connect with their government to inform and shape policy through honest, respectful discussions.

The program was launched in February with the first use case focusing on the impacts of the Los Angeles wildfires.

Today's announcement was made possible through partnerships with philanthropic and community organizations who are aiding wildfire recovery in Los Angeles.

LA Rises is a unified recovery initiative that brings together private sector leaders to support rebuilding efforts led by the city of Los Angeles, Los Angeles County and the State of California. In January, the Governor enlisted Dodgers Chairman Mark Walter, business leader and basketball legend Earvin "Magic" Johnson, and Casey Wasserman, LA28 Chairperson and President to lead and recruit others to this private sector and philanthropic effort.

ten years, and ten years ago, people were laughing at us and said that 100% rap is impossible. Well, they're not laughing at us anymore, and I know that doesn't sound like a lot, but for us, it means a lot. People are coming to the booth now, and they know who we are. Our brand and our recognition, has gone through the roof. People are coming from all over the world to see us at these events.

Noel: When people hear about it for the first time, I don't think the question they first think of is whether they would use it or not. It's usually: "Is this for real?" When you face that, how do you talk to that person?

McMurray: They usually approach us very skeptically. They don't believe it, at first. You know, the national average for RAP is twenty-one percent. We're all talking about net-zero, zero emissions, lowering emissions, and green infrastructure, so how are we still at 20% RAP? We're still tying one hand behind our backs.

Noel: How do you engage a conversation with producers?

McMurray: That's one of the first things we ask: How much RAP are you running? And some guys are higher. Some guys are trying fifty percent in some of their commercial mixes, and we like to hear that, because they're less skeptical. But a lot of guys are doing zero RAP. If they're doing airport work or Port Authority work, doing State work, they're stuck around whatever their state cap is.

Noel: I think that the other difficultly is the contractors, the pavers, right? You know, if you can win over the producers, that's one half of the battle. But they're not the customer, though. The producers are beholden to the people that are gonna buy the asphalt from them.

McMurray: Our technology is a tough sell because the agencies aren't ready for it. Let's say you owned a plant, and you want to do this. Who

are you going to sell it to? Are you going to try to convince every one of your customers to use a product that no one's ever used before?

Overcoming The Barriers One State At A Time

That last questions McMurray asked is ironic, since that is exactly the task that Green Asphalt had before them when they set out into the industry.

Noel: The biggest thing that I run up against when I talk about your 100% RAP to contractors, is they immediately just say, "It's gonna be a shit-mix." They just write it off immediately, and before they can even hear the arguments in favor of it. How do you overcome that kind of stonewalling?

McMurray: (Laughing) Well, everyone knows, you can make a "shit-mix" and you can have shitty lay down whether you use 100% RAP or virgin mix. The proof is in the pudding. We're working with New York State right now, and they've given us a goal post, it's very similar to balance mix design. It's called a PEM spec, performance engineered mix. They said, if you want to be taken seriously, you have to meet this spec and we'll talk. We've been working on that diligently for the last eighteen months. We did a couple test runs. We're doing another two tests in April, and New York State will send down inspectors, and they sample it and they test it side-by-side with our guys. They want to see us succeed.

Noel: It's good to know that the people who are championing net-zeros and championing efficiencies are actually working with you, and not just throwing down arbitrary roadblocks. But what in other states? What if someone was interested who isn't in New York?

McMurray: Let's say we meet someone in Massachusetts who's interested in 100% RAP. We will reach out to Massachusetts DOT to set up a meeting. We're not trying to get anything approved, yet. We just want to talk about what

we're doing. What are your concerns? Have you ever heard of 100% RAP? What are your limits? What are your biggest worries? For some of them it's performance, because no one's ever done it before. How do you know where your millings are coming from? Do you test them? Do you separate them? They are all great questions! And it helps us know what information to provide, and then we'll also join that state asphalt association, just to get to know other members and not be an outsider. That's kind of been working for us. Obviously, it's a process, and we're not a huge staff, so we can't do all 50 states at once.

The NAPA Midyear 2024

One huge opportunity that Green Asphalt had last year was the mid-year conference which was held nearby in Brooklyn, NY, last June. As part of the conference, NAPA offered a guided tour of their plant and operations so that members could see for themselves just what they're up to.

Noel: I wondered if you had an anecdote from your presentation and the tour you did at the mid-year. In your mind, was that a successful event? Do you feel like you got to win there?

McMurray: I think we went above and beyond, and we actually made mix. We had a spreader and a truck there, and had a paving crew put down 100 feet of asphalt and gave people shovels. You know, I'm so mad. It was, it was really good because, because you can talk about all you want, but we had people who were shoveling asphalt and looking at it and saying, "There's no way this is 100% RAP," and that was a win, that felt like a real win. Did we sell a conversion that day? No, but are we are we one step closer we 100% are."
