Priorities for California's Economy

California's economy is poised to undergo a profound transformation, driven by dynamics that are rewriting the future of work. The response to these shifts will determine the strength of the state's economy-and whether new economic opportunities will reach all Californians.

The state needs an economy that can withstand mounting climate risks. Recent experience with flooding and wildfires shows how climate-driven events endanger people's lives and livelihoods, hindering job growth and interrupting economic activity. Over the long term, sectors that are advancing the state's climate goals through electrification, wind, and solar energy are projected to grow, requiring workers in construction, engineering, and other infrastructure-related occupations. Meanwhile, the oil and gas sector-vital to Kern County-and agriculture-vital to the broader Central Valley and other rural areasmay shrink. Helping these sectors, workers, and communities transition to promising new opportunities is essential.

New forms of automation and artificial intelligence (AI) may alter the job market and business

environment. Historically, automation has most affected blue-collar jobs, and advancements in IT and robotics will continue to reshape manual and service occupations. However, new technology like generative AI is most likely to replace or assist with office tasks. While these shifts may eliminate some white-collar jobs, they could also increase demand for managing these new technologies and boost worker productivity. Exactly how this will affect economic activity is uncertain, but regions like the Bay Area—which could be home to these innovations but also has many professional workers whose jobs could change—may see disproportionate impact.

The shift toward a slowly growing or shrinking population will have long-lasting consequences. California's economy has long benefited from people moving here in search of greater opportunity, and lower levels of international and interstate migration could dampen growth. At the same time, our population is aging and the birth rate is slowing, with significant impacts on the demand for goods and services, such as transportation and housing. In addition, the need for health care services—already one of the state's biggest, most widespread industries-will rise even more. Aging will also have an enormous impact on our workforce, which we discuss further below.

California has endured upheavals and transformations before, but past transitions raise a cautionary note. Over the last 40 years, income



inequality has widened drastically as technological changes and global trade propelled a longterm shift toward jobs that require and reward college-educated workers—with benefits largely accruing to the top income brackets. Since 1980, incomes have grown 63 percent at the top, but

only 7 percent at the bottom (reaching \$291,000 at the 90th percentile vs. \$26,000 at the 10th percentile in 2021). Low incomes coincide with persistent poverty; in 2023, 5 million Californians were unable to meet their basic needs.

Mayor London Breed Issues Executive Directive to Screen Potential Vulnerable Concrete Buildings and Publish Seismic Retrofit Standards

Mayor London Breed issued an Executive Directive instructing City Departments to develop legislation to identify concrete buildings that may be vulnerable in major earthquakes. The Directive serves to enhance San Francisco's seismic safety by protecting life and public safety, preserving housing and critical buildings, preparing the City for expedited

post-earthquake recovery, and safeguarding the local economy.

The resulting legislation will pave the way for the City to develop a retrofit program and related services to address a subset of concrete buildings that are known to be unsafe during large quakes.

"San Francisco is always working to prepare for its next earthquake because for us it's not a matter of if, but when," said Mayor London Breed. "Our efforts to increase San Francisco's seismic resilience must work hand in hand with our work to strengthen San Francisco's economic resilience. I want to thank the City Departments and stakeholders who have been developing standards and who are committed to doing the work ahead to keep our city safe and strong as we prepare for the next earthquake.'

Executive Directive 24-01 calls on the Office of Resilience and Capital Planning (ORCP) and the Department of Building Inspection (DBI) to draft legislation that mandates screening concrete buildings for vulnerabilities that could lead to structural failure. Certain types of concrete buildings are known to be vulnerable during large earthquakes, like the one that hit Taiwan earlier this month. However, concrete buildings cannot be identified easily from the street. A screening phase will help identify which buildings are actually concrete.

The Directive also directs the Department of the San Francisco Existing Building Code.

"I want to thank Mayor Breed for her leadership in convening stakeholders focused on concrete buildings and for her immediate actions to move us forward with this Executive Directive," said City Administrator Carmen Chu. "Assessing our real risk grounded in building-by-building data will help us better understand the magnitude of work needed and options for mitigating displacement and cost. Building owners who are ready to retrofit benefit from clear guidelines moving forward. I look forward to continuing our work in partnership with our stakeholders and policymakers."

This week, the Office of Resilience and Capital Planning released recommendations developed by a working group of technical experts and community stakeholders to provide a framework to develop a Concrete Building Safety Program. The recommendations, developed during a 12-month-long series of convenings hosted by ORCP, are available to read here.

Diversity In Construction: Why it Matters & Tips for Leaders

How to Get Started With Your Construction DEI Journey

It's no surprise that the construction industry isn't very diverse. But there is a cultural shift underway regarding diversity, equity and inclusion or DEI

Diversity, equity and inclusion at its most basic concept means truly accepting, supporting and including the full range of human differences, including but not limited to race, ethnicity, gender and gender identity, sexual orientation, age, social class, physical abilities, religious or ethical values systems, national origins and political beliefs.

Trimble and others understand that the construction industry must take action to recruit, retain and advance diverse talent.

Research indicates that companies that prioritize diversity outperform others; they have greater earnings, better governance, greater innovation and more opportunities.

Research indicates that companies that prioritize diversity outperform others; they have greater earnings, better governance, greater innovation and more opportunities, according to CREW Network's annual study, which in 2020 began asking questions about diversity. Although its study centers on commercial real estate firms, it's become a common belief that any company that does not prioritize DEI will be left behind. They will miss the talent and the opportunity to be more profitable.

In this blog, Tonia Dunbar, Director of Professional Services at Trimble and a board member for the Trimble Foundation Fund, discusses the impacts of diversity, equity and inclusion (DEI) on the construction industry and offers suggestions on how others can get started with their DEI journey.

1. What does diversity, equity and inclusion in construction mean to you—and how does Trimble support this initiative in the work-place?

Diversity equity inclusion is extremely important to me as a black female leader in the space of software and more specifically in the construction industry. "If we didn't have things such as DEI, I wouldn't have the opportunities that I have today," says Tonia Dunbar, Director of Professional Services at Trimble and a board member for the Trimble Foundation Fund. "Historically, and even currently, people of minority

ethnicities are underrepresented in many industries, but vastly underrepresented in construction."

DEI helps drive the impact of having diverse thought, diverse representation and helping in-advertently drive businesses. "As the chair of the black professional network, which is one of our employee resource networks within Trimble, we have many that represent various groups, or underrepresented groups, not only from an ethnic background, but from other representation backgrounds."

The Trimble Foundation established a DEI subcommittee to give back to communities, not just within the United States, but globally, she says. The company is focused not only on impacting communities, but also local businesses to make sure people have equal opportunity and equal access.

2. How has the conversation regarding DEI changed - specifically to technology - or been prioritized since you began your career?

The recent highlights of civil unrest, especially in the United States, have driven people to open their eyes a little bit and get comfortable being uncomfortable, Dunbar says.

"DEI really is about that. It's about having the hard conversations. It's about addressing the topics of race and addressing the topics of equity for the underrepresented and that makes people uncomfortable."

"If I look back 15 years ago to now, I think we've got into a transition of leadership across the globe, across many industries that have said this can't keep happening or have said our businesses are not being as successful as they need to be because we don't have enough diverse perspective," she says. "Quite frankly, the world is moving in a direction in terms of how it operates very differently than 15 years ago."

Dunbar points to the online virtual world called the Metaverse, NFTs and the Pandemic as new items businesses now have to grapple with today and in the future. "This is a global pandemic which nobody has experienced and then has turned all industries upside down and how we operate. DEI became extremely important because you have to do things differently to continue to be successful. That challenges the status quo of where people's comfort levels have been historically in pushing them outside of that box."

Is Your Construction Business Feeling the Effects of the Final DBA Rule?

Is your company benefitting from the \$1.2 trillion in government infrastructure spending yet—or is the final Davis-Bacon and Related Acts regulation making it harder to win that type of work?

The Biden administration's final rule "Updating the Davis-Bacon and Related Acts Regulations" took effect on Oct. 23, 2023. In "the first comprehensive regulatory review in nearly 40 years," the Department of Labor has returned to the definition of "prevailing wage" it used from 1935 to 1983—before Microsoft released the first Windows operating system.

Construction industry leaders must be aware that this is the most comprehensive review and overhaul of the act in 40 years; with it, the DOL has attempted to modernize its approach to wage creation and fringe benefit allocation. There are more than 50 procedural changes to the act, which means it is very important for contractors to be aware of wage classifications when bidding, performing work on Davis-Bacon Act projects and using applicable fringe dollars for bona fide benefits.

UNDERSTANDING THE CHANGES

Some of the critical adjustments included in the final rule that contractors should be aware of include:

Wage determination changes during a project: Historically, contractors could rely on the wage determinations used to win a project for the life of the project. However, the final rule now requires the contractor to use current wage determinations when a contract is changed or extended. The DOL "proposed this change be-

cause—like a new contract—the exercise of an option requires the incorporation of the most current wage determination."

New recordkeeping requirements: All contracts, payrolls and other "basic records," including the craft worker's last known phone number, email address—new data points that are to be obtained if not already available—job classifications of work done and the hours worked in each classification must be kept for at least three years after

High levels of income inequality and poverty dampen the likelihood of advancement for all Californians. It often takes time and money to invest in the skills and experiences needed to move up the economic ladder, but for many these resources are lacking. Data over the past four decades shows that most children born in low-income families in California earn low incomes as adults

Even in times of great change, policy can support upward mobility-and bolster the economywith the right tools. Most recently, policymakers took steps to protect public health during the COVID-19 crisis while also addressing the economic fallout. Thanks in part to wide-ranging investments in businesses, workers, and families, labor markets recovered quickly, the unemployment rate reached historic lows, and low-wage workers saw record high wage growth.

Historic investments in infrastructure and climate-including the federal Inflation Reduction Act, the Infrastructure Investment and Jobs Act, Build Back Better grants, and California Jobs First (formerly the Community Economic Resilience Fund)—could likewise strengthen California's economy amid the challenges outlined above. But whether these investments better position workers, employers, and communities for the future depends on the ability of the state and local leaders to prepare for these transitions, accurately monitor regional needs, and assess the impact of investments.

Help workers and businesses navigate upcoming transitions. Prior economic transitions have benefited some—but not all—residents. To ensure that more Californians can take advantage of promising new opportunities in clean energy, technology, health care, and more, bridging the gap between employers and educational institutions will be critical to adapt to evolving skill requirements, to achieve greater equity in training and employment, and to ultimately meet workforce and worker needs.

Track shifting labor market and business needs. Monitoring the impact of long-term challenges on employment and wages across sectors and regions is critical for adjusting policies to support a high-functioning labor market. Right now, it is not entirely clear what skills will be most valuable to workers and businesses as climate adaptation and AI technology unfold; tracking these emerging workforce needs is a first step to helping more Californians benefit.

Increasing Support for the Increasing Number of Women in Construction

The construction industry has long been maledominated, but the tide is turning as more women are making their mark in this traditionally challenging field. It's invigorating to witness the increasing presence of women in various roles within the industry, and the importance of this trend cannot be overstated, as it brings a diverse range of skills, perspectives and experiences to the table, ultimately benefiting the sector as a whole

Federal legislation could help to normalize the presence of women not only in construction careers but on construction sites. The Infrastructure Investment and Jobs Act, offering more opportunity for infrastructure spending and building, also offers more opportunity for hiring women to fill positions on new projects—a great way to introduce women to the field from apprenticeship and/or undergraduate programs and get more female project managers on more jobsites more often, following the years of remote and/or hybrid work of back-office employees.

The COVID-19 pandemic not only impacted office dynamics, but it also impacted—or rather benefitted—gender dynamics within the construction industry. While many industries experienced layoffs, construction proved to be an exception by providing opportunities to women who were rethinking their career paths amid the pandemic. In about a year, women recovered all their pandemic-era losses in construction, further demonstrating their resilience and contribution to the sector.

VICTORIES AND OPPORTUNITIES

While challenges abound, women in construction have made significant strides. The share of women in construction has hit a record high, with over 1.1 million working in the industry nationwide.

And even more women are joining the industry, not only in traditional office roles but also in trade and executive positions. Plus, about 13% of all construction companies are now owned by

women. There is a growing recognition of the value that women bring to the construction sector, leading to increased support for their professional development and advancement.

INCREASING REPRESENTATION OF WOMEN IN CONSTRUCTION

The construction industry is becoming more open and accepting of female workers, offering a wide range of career opportunities, from project management and engineering to trades like carpentry and plumbing. their customers, employees, and planet. Some measures include using fewer toxic products, saving water and energy, reducing waste, and improving indoor air quality.

"Every Green Business awardee is an inspiring trailblazer, weaving sustainability into their operations and culture," said Tyrone Jue, San Francisco Environment Department Director. "This record-setting group of honorees is igniting a vital movement, showcasing that going green not only benefits the planet, but bolsters a thriving business."

The San Francisco Green Business Program is a part of the California Green Business Network, which collectively supports and recognizes businesses, non-profit organizations, and institutions in San Francisco that meet high environmental standards. Certified Green Businesses in San Francisco include the Exploratorium, Cal Academy, Oracle Park,

Chase Center, Bi-Rite, Cole Hardware, and The Fillmore.

Specific to this year's certification pool, most notably, includes the San Francisco Marriott Marquis in the South of Market, making it the largest certified Green Business in the City and third largest in the State. The Axiom Hotel, Inn at the Presidio, and Lodge at the Presidio also achieved Green Business certifications this year, as well as a renewed certification of the Intercontinental Mark Hopkins. Other still-recognized Green Businesses in the hospitality industry from prior years include the Proper Hotel, Omni San Francisco, W San Francisco, St. Regis San Francisco, Argonaut Hotel, Hotel Zoe Fisherman's Wharf, and the Laurel Inn by Hyatt.

"These record-breaking certifications from San Francisco's hospitality community show-

case our commitment to sustainability and our environmental leadership nationally," said Alex Bastian, President & CEO of the San Francisco Hotel Council. "San Francisco's hospitality community is the only one in the country making good faith efforts around using 100% renewable energy, providing significant access to electric vehicle charging options, and striving to achieve zero waste. We work collaboratively with our city partners balancing the need for sustainability, with the need for businesses to be successful. For the environmentally conscious traveler, there's no better place to visit in the country than San Francisco."

During the Mayor's Earth Month Kick-off on April 3, Mayor Breed recognized Frances Yee of Dee Dee's Boutique for becoming the firstever certified Green Business in Chinatown's history, serving as yet another key milestone for the Program.

Additionally, San Francisco has uniquely helped three local nail salons achieve Green Business certification this year making them the first and only certified nail salons across the State of California. The businesses are The Upper Hand Nail Spa in Noe Valley, Gentle Nails Salon in the Inner Sunset, and Valencia Nail Spa in the

Mission. The success of these new certifications in the nail salon industry is due to the decade of experience the Environment Department has had in helping salons adopt safer products and practices through its Healthy Nail Salon Program. The Green Business certification helps these salons take their sustainability efforts to the next level, incorporating water, energy, and waste-saving measures while continuing to protect their workers.

"The San Francisco Green Business Program is as much of an environmental program as it is a small business assistance program," said Katy Tang, Director of the Office of Small Business. "Since SF Environment launched the rebate and pre-bate program in 2019, they have distributed \$50,000 in resources to 50 businesses to help them implement their sus-

tainability improvements. Small businesses are the backbone of our neighborhoods, and this kind of essential assistance helps these businesses thrive—sustainably."

Since 2021 when Little Joe's Pizza, the iconic pizzeria in San Francisco's Excelsior District, was recognized as a Green Business, they have continued to use sustainable practices like low-flow water fixtures and green cleaning products and have improved their composting and recycling program. When the restaurant made the decision to switch out its interior lighting, the Green Business Program paid for the upfront cost of replacing 50 halogen bulbs, helping Little Joe's save an estimated \$1,500 per year in energy costs. These measures provide a compelling and measurable example for how new busi-

nesses can reduce environmental impacts, while also saving critical dollars.

In its earliest days, the San Francisco Green Business program was focused primarily on helping businesses become energy efficient to save money and assist the city in meeting its bold zero emissions and zero waste goals. While that is still the case today, the program is constantly evolving to provide businesses, especially small businesses, with the support they need to operate sustainability. This includes rebate and pre-bate programs to minimize or eliminate the burden of going green and working with community-based organizations to reach small businesses in the Bayview, Hunters Point, Excelsior, and lower Fillmore neighborhoods.

The California Green Business Network has developed more than 30 unique sector check-lists providing guidelines for a variety of businesses to conserve resources, build healthy communities, and save money. Businesses can be recognized at three levels: Entry-level, Certified, and Innovator. These three options help businesses take the next step on their sustainability journey no matter where it begins.

the prime contract is complete.

Apprenticeship locality: The final rule explains that contractors and subcontractors must comply with the apprentice wage and ratio standards of the locality where the work is performed irrespective of the wages and standards of the facility training the individual.

Contracting agency omission of Davis-Bacon and Related Acts requirements: Suppose a project owner fails to include DBA requirements (e.g., prevailing wage determinations) in its bid request. In that case, the agency can now retroactively to the date of the award or start of construction, whichever comes first, use an "operation-of-law provision" to require contractors to follow all DBA rules and pay prevailing wages. While the contracting agency is supposed to pay additional contractor costs for this oversight, it can be challenging for merit shop contractors to determine and receive compensation for those

additional costs and ensure subcontractors and affected employees are made whole.

How fringe benefits are annualized: Annualization is the DOL-developed process to determine a per-hour cost of a contractor's contributions toward a bona fide fringe benefits plan, which may be credited against the workers' fringe benefit requirements.

Annualization is particularly important for merit shop contractors whose craft workers are subject to prevailing wage mandates on federally funded projects but also do "private" work where there are no fringe rates.

Contributions to "Defined Contribution Pension Plans," such as a 401(k), are exempted from the annualization requirement if the plan meets specific mandates, such as immediate vesting and irrevocable contributions.

Also to note, on Nov. 7, 2023, ABC filed a lawsuit in the U.S. District Court for the Eastern District of Texas challenging the DOL's inflationary and controversial final rule, citing the rule returns to "failed policies of the 1970s and unlawfully expands coverage of prevailing wage requirements."

OPPORTUNITY FOR GOVERNMENT CONTRACTORS

While these changes present additional complexities—ABC states these adjustments will only "make compliance challenges worse" and drive "small contractors out of public works projects or even business"-contractors are simultaneously presented with a dramatic increase in government-funded construction projects. The Infrastructure Investment and Jobs Act will spend \$1.2 trillion over eight years, focusing on physical infrastructure (notably roads, bridges, railways, water, sewage, broadband and electric vehicles), and these funds are just becoming "shovel ready." Additionally, the Inflation Reduction Act's expansion of energy-efficiency tax incentives—such as the §179D energy-efficient commercial buildings deduction-will invest

another roughly \$369 billion subject to prevailing wage requirements.

The IRA and several state laws, such as California's SB 54 and SB 740, contain policy enacting "skilled and trained workforce requirements" that are likely to push developers into hiring unionized contractors and union labor on a more frequent basis. For the first time, prevailing wage compensation and government-registered apprentice participation requirements are mandated on private (non-governmental) project

The government's spending presents a wealth of opportunity for merit shop contractors but will require more work than ever to ensure compliance. Mayor London Breed Issues Executive Directive to Screen Potential Vulnerable Concrete Buildings and Publish Seismic Retrofit Standards

San Francisco has 72 percent chance of experiencing an earthquake with a magnitude of 6.7 or greater by 2043, according to the U.S. Geological Survey (USGS). For comparison, the 1989 Loma Prieta Earthquake, in which 63 people died and over 12,000 people were displaced, was a 6.9 magnitude quake.

"To ensure our City's buildings are prepared to withstand the next big earthquake, we need to identify which ones need to be improved," said San Francisco Department of Building Inspection Director Patrick O'Riordan. "The Mayor's directive will enable us to understand the current condition of the City's concrete buildings, identify which ones need to be retrofitted, and establish the safety standards those structures will need to meet in the coming years."

"Each proactive step we can take as a city to mitigate damage after a major earthquake helps set all of us up for a more resilient recovery," said Mary Ellen Carroll, Executive Director of the San Francisco Department of Emergency Management. "As our city takes these decisive steps to enhance seismic resilience, this directive reminds residents and businesses that we all play a vital role in minimizing the inevitable impacts of a major earthquake. We are grateful for this opportunity to identify and therefore mitigate risk to concrete buildings."

"We need to strengthen our downtown and our economy, ensuring that our community and our businesses are resilient to earthquakes now and into the future," said Rodney Fong, President and CEO of the San Francisco Chamber of Commerce. "Now is the time for the City to create a clear pathway so that owners of concrete buildings who decide to retrofit can jump on the opportunity to do so."

"At this critical time for our City and our economy, the Mayor is taking the right step by initiating a screening program to better understand our seismic risk," said Janan New, Director of the San Francisco Apartment Association. At the same time, owners of concrete buildings who choose to retrofit need clarity. We need to give people options to minimize cost and disruption to tenants and to maximize safety."

Following Landmark Housing Agreement, Governor Hochul Announces Suffolk County Site Will be First State Property Targeted for Housing

Just weeks after a landmark housing agreement in the FY 2025 Enacted Budget, Governor Kathy Hochul today announced the first stateowned property targeted for potential housing. The Governor issued a Request for Proposal to purchase and redevelop an approximately 13acre site on Conklin Street in East Farmingdale. The site, currently owned by the New York State Department of Transportation as part of Republic Airport, has been vacant since the 1990s and serves no direct function for the airport. The property offers a prime opportunity to transform what is currently a blighted and underutilized lot into a thriving mixed-use residential development that enhances housing options for a wide range of New Yorkers. Applicants can view the Request for Proposals document here and a photo of the site here. Proposals should be submitted to Empire State Development by August 7, 2024 by 5:00 p.m. EST.

"We just secured a landmark housing deal that will make New York more affordable and livable, and now we're getting to work to turn it into reality," Governor Hochul said. "Leveraging state-owned land is a significant opportunity to increase housing supply and help New Yorkers find a place to call home."

Empire State Development President CEO and Commissioner Hope Knight said, "The Conklin Street RFP represents a significant opportunity to create a vibrant, mixed-use development that will enhance the local community and contribute to the region's economic growth. ESD looks forward to bringing this project to fruition and unlocking the full potential of this site."

The project site is located in the Hamlet of East Farmingdale within the Town of Babylon, Suffolk County, bordered by Conklin Street to the south, MTA's Long Island Rail Road tracks to the north, and Broadhollow Road/Route 110 to the west. Currently controlled by the New York State Department of Transportation, the site totals approximately 13 acres. Previously utilized for airplane manufacturing, the structures on the site are now vacant and set for demolition. This location is conveniently positioned a mile equidistant from both the Farmingdale and Pinelawn LIRR stations and offers proximity to Route 110, one of Long Island's largest commercial centers, enhancing its potential for a transformative mixed-use development.

Empire State Development, in close collaboration with the Town of Babylon, aims to establish a mixed-use hub that provides critically needed residential housing and stimulates economic growth and new job opportunities within East Farmingdale and across the region. Additionally, the development will be solicited to provide public open space, enhance pedestrian connectivity to surrounding commercial centers and deliver other community amenities. Empire State Development anticipates that 20 percent of the housing on the development will be affordable housing units restricted to households earning 80 percent of the Area Median Income.

Additionally, the development plan must include sufficient parking, designs that emphasize sustainability, resilience, and energy efficiency to align with the goals of New York's Climate Act, and meet all FAA and NYSDOT requirements to allow for the release of the property before development can begin. Some remediation may be needed on site for potential subsurface environmental contamination, which will be supported by an up to \$4 million Department of Housing and Urban Development grant to the Town of Babylon, secured by U.S. Senate Majority Leader Charles Schumer and U.S. Representative Andrew Garbarino.



Learning the ins and outs of the family baking business, Zach proceeded to go to college, later opening his own neighborhood bakery in Mendocino County. Working 6.5 days a week baking, cooking, and doing administrative work, he quickly learned his future success would depend on his inherited 'Do or Die Attitude' and a solid group of reliable employees.

Following, the most impactful decision made was bringing on Lisa Hensley as the Operations Manager. Lisa was a natural fit to handle the Human Resource needs of 50 part-time employees, overseeing operations in three locations, and helping in the Bakery when needed. There were still missing pieces in running
