How Construction Can Beat A Growing Labor Shortage

Is your construction firm planning to increase headcount in 2022? That could prove to be a difficult task. According to a recent survey by the Associated General Contractors of America, 88% of construction firms indicated they are experiencing project delays and worker shortages are the second leading cause (61%) cited behind longer lead times or shortages of materials (75%).

Despite uncertainty over the timeline for a full recovery from the pandemic, almost three-quarters of firms are planning to add new employees over the next 12 months. Unfortunately, 90% of firms who employ hourly craft workers had at least one unfilled position and 62% had unfilled positions for salaried employees.

For firms trying to fill craft worker jobs, 89% are having difficulty doing so and 86% that are hiring salaried professions are facing difficulties filling those positions. Some of the hardest positions to fill include pipelayers, bricklayers, concrete workers, project managers, supervisors, and estimators.

Just to put the struggles in perspective, during the Great Recession over 2.3 million jobs in construction were lost from January 2007 to January 2011. By February 2020, there were still 77,000 fewer jobs in construction than in January 2007. And then the COVID-19 pandemic struck. Between February 2020 and April 2020, the construction industry shed 1.1 million jobs.

As of February 2022, employment levels have gotten back to pre-pandemic levels. Despite that, the number of job openings in construction remains high. There were 389,000 job openings in construction in January 2022. Preliminary numbers for February have brought that amount down to 364,000 openings.

The median age of people working in construction in 2021 is 42.3, while the median age in 1985 was just 36. About 43% of all people employed in construction are age 45 or older. Compare that to the little more than 9% who are 24 or younger. Individual companies, and the industry as a whole, need to step up their efforts in order to attract more youth to jobs in construction.

The story behind Asian Pacific American Heritage, and why it's celebrated in May

May marks Asian Pacific American Heritage Month, which celebrates the histories of Americans hailing from across the Asian continent and from the Pacific islands of Melanesia, Micronesia and Polynesia.

This year's theme, selected by the Federal Asian Pacific American Council, is "Advancing Leaders Through Collaboration," which builds on a leadership advancement theme series that began last year.

Cynthia Choi, co-executive director of Chinese for Affirmative Action and co-founder of Stop AAPI Hate says the month is a time to speak out, share stories and debunk myths about Asian communities, she said. But it's not the only time to celebrate Asian culture or diversity.

"Our history is also filled with incredible stories of resilience, of persistence, of determination, to fight for our basic rights," Choi told NPR. "This is a celebration of our history, of our culture ...

Before it was a month, it was a week

The month was the brainchild of Jeanie Jew, a former Capitol Hill staffer, who shared the idea with Rep. Frank Horton, who introduced the leg-islation that formed it.

Jew's great grandfather, M.Y. Lee, left China for the United States in the 1800s before he helped build the transcontinental railroad, according to Time. Lee became a prominent businessman in California and later traveled to Oregon. He was killed during a period of unrest and anti-Asian sentiment.

"Mrs. Jew turned a personal tragedy in her family history into a positive force," Horton later told Congress in 1992.

In 1977, Horton introduced a resolution that would establish Pacific/Asian American Heritage Week. Sen. Daniel Inouye introduced similar legislation to the Senate. In the following year, Horton, with cosponsor Rep. Norman Mineta, introduced another related resolution that passed. President Jimmy Carter signed it in October of 1978.

The resolution "authorized and requested" the president to proclaim the 7-day period beginning May 4, 1979 as Asian Pacific American Heritage Week. It also called on Americans, and especially educators, to observe the week with "appropriate ceremonies and activities."

Congress later passed legislation to extend the observance to a month in 1990. Two years later, Congress passed another public law to annually designate May as Asian Pacific American Heritage Month.

Why May was chosen to commemorate AAPI heritage

The legislation to annually designate May as Asian Pacific American Heritage Month referenced two key dates: May 7 and May 10.

May 7, 1843, marks the arrival of the first Japanese immigrants to the United States. And May 10, 1869, or Golden Spike Day, recognizes the

Guaranteed Income Advisory Group Releases Report to Guide the Future of Guaranteed Income Work in San Francisco

Report offers strategies to develop and implement policies that can transform how San Francisco pursues economic justice and wellbeing for its residents

The San Francisco Guaranteed Income Advisory Group today released its final report, "From Pilots to Policy Change: Recommendations from San Francisco's Guaranteed Income Advisory Group." This report suggests steps the City and County can take to strengthen support for existing and future pilots, while also advocating strategies to move beyond pilots, developing and implementing guaranteed income policies that can transform how San Francisco pursues economic justice and wellbeing for its residents.

"San Francisco is uniquely positioned to advance guaranteed income as a transformative solution to poverty and economic insecurity," said Jim Pugh, founder of the Universal Income Project and Advisory Group member. "As the city with the most guaranteed income programs in the country, other cities and states are looking to us as a model for implementing this policy and for establishing a new narrative around poverty -- one that recognizes people's inherent dignity and that the way out is to simply provide people with the resources they need."

The Advisory Group was established by an ordinance introduced by Supervisor Matt Haney to advise the Board of Supervisors, the Mayor, and appropriate City departments on various aspects of guaranteed income - direct, unrestricted and unconditional cash transfers to individuals or households. Members brought diverse knowledge and experiences to the work, including researchers, advocates, people who have personally experienced poverty, people with professional experience serving low-income communities, and staff from relevant City departments. The Advisory Group was staffed by the Office of the Treasurer & Tax Collector. The report provides a synthesis of the findings and recommendations surfaced during a yearlong process of research, stakeholder interviews and testimony, and public meetings.

Elena Chávez Quezada, an Advisory Group member and the Chief Impact Officer at EPIC, stated: "I am proud of the shared vision that this Advisory Group developed over the past year, and excited about the potential for San Francisco to lead in advancing a bold antipoverty agenda. Guaranteed income has the potential to help heal feelings of shame and stigma, increase agency, and ultimately change the poverty narrative – especially by centering the insights, ideas, and experiences of people living in poverty."

Guaranteed income is a policy response to systemic poverty and rising inequality, particularly during a pandemic that has brutally exacerbated these problems. Recipients are empowered and trusted to make their own choices about how best to use their money. Guaranteed income is similar to universal basic income (UBI) but targeted rather than provided to everyone in a community.

"As we confront decades of disinvestment in Black and Brown communities here in San Francisco, direct cash assistance – with no strings attached – gives us a powerful tool to heal wounded spirits, improve outcomes, and begin to fix the systems that caused the damage," said Sheryl Davis, Executive Director of the San Francisco Human Rights Commission and Advisory Group member. "Guaranteed income programs and policies that target racial disparities can improve outcomes from health and wellness to housing insecurity to financial stability and economic mobility." In the report you will find several recommendations, including aligning guaranteed income strategies through centralized staffing and coordination, focusing on racial equity and periods of critical transition, pursuing structural, sustainable and scalable cash transfer policies, and centering community voices in the planning, implementation and evaluation of guaranteed income work. The report also reflects the Advisory Group's emphasis on the importance of changing narratives around poverty and public assistance from scarcity and "deservedness" to abundance and dignity.

"I am proud to have served on the guaranteed income advisory group and grateful to my fellow members and staff for putting this report together," said Jacob Denney, Economic Justice Policy Director at SPUR and an Advisory Group member. "This report gets right that good policy begins with centering the voices of the people, and I am excited to use these lessons to begin transforming guaranteed income from pilots to policy in San Francisco."

The report comes amidst surging interest in guaranteed income, with more than a hundred pilot programs in operation or develop-

Building a Diverse and Equity Driven Clean Energy Economy

It's clear we need to accelerate the clean energy transition as the climate crisis continues to worsen. To achieve the speed and scale of innovation necessary to meet this challenge, the clean energy industry cannot afford to repeat past patterns of economic exclusion that have left behind low income communities of color. If advocates, government agencies, and industry want to achieve our goals of fighting climate change and increasing prosperity, we have to intentionally center equity, invest substantially more resources, and reward innovation.

The public and private sectors can support forward-thinking entrepreneurs who, because of systemic racism and disinvestment, have been denied access to capital. Low-income people of color have developed creative solutions to the problems of systemic oppression and environmental degradation for decades. Investing in their ideas and innovation can ensure that new technologies truly represent and uplift low-income communities of color and lead to equitable climate action. The clean energy industry has the opportunity to benefit everyone. So far it's falling short.

There is no doubt that the clean energy industry is booming. According to E2, the clean energy industry employed nearly six times as many workers compared to the number of employees who work in fossil fuel extraction and generation in 2021. Further, median hourly wages for clean energy jobs are almost 30% higher than the statewide median wage.

However, as Climate Justice Alliance states, "Transition is inevitable. Justice is not." While Black and Brown communities bear the worst burdens of air pollution and are affected most by climate related disasters, they are least likely to currently be included in the rapidly expanding clean energy technology (or cleantech) industry. According to analysis by Third Derivative, only 8% of the clean energy workforce are Black, 16.5% are Latinx, and 27% are women.



Small Business Concerns Around Inflation Grow As Prices Soar and Economic Instability Continues

Nearly one in three (30.5%) business owners report feeling extremely worried about inflation and rank it as a top business concern and another 62.5% say they are generally concerned about inflation and are keeping an eye on rising prices, according to new survey data from SCORE, mentors to America's small businesses and a resource partner of the U.S. Small Business Administration.

SCORE's Spring 2022 Megaphone of Main Street: Inflation & the Economy report surveyed more than 1,000 small business owners on how they felt about the current economy and inflation. Only 7% of small businesses are not troubled about inflation impacting their company; meaning there is a general consensus of concern regarding the cost of rising goods and services.

While finding customers remains a serious problem for small business owners (51.8%), cash flow (35.9%), inflation (33.9%) and sup-

ply chain disruptions (30%) are all rapidly growing issues as the economy remains tumultuous.

Small business owners are feeling the impact of these top concerns:

SCORE East Central Iowa client Aaron Mulherin, owner of AM Glass Repair, says that he is slammed with 12-15% price increases on materials every four to six weeks. "Due to these price increases, AM Glass Repair is forced to purchase materials more than six months ahead of time to lock in lower prices, which causes cash flow issues," Mulherin explains.

Dennis Ittenbach, owner of H.O.P.E. Life, Lymphedema and Rehab Center, says prices for services and supplies have gone up at a surprising rate, even though the reimbursement from third party payers in the medical field have gone down. "Because I am a health care provider and 80% of my patients are Medicare or Medicare alternative plan patients, I'm not able to adjust my prices," says Ittenbach."In fact, over the last year we've had a reduction in our reimbursement which significantly affected our profit and is proving unsustainable."

Due to continued instability, three out of four small business owners (76.4%) report having mixed feelings about the economy overall and are uncertain how to feel.

"Small business owners have been inundated with curve balls throughout the past two years with no signs of slowing down," according to SCORE Vice President of External Relations Betsy Dougert. within your industry and your local area. Offering competitive wages and benefits like health insurance and gym membership reimbursement to your employees is just the beginning. Remember, you're competing for employees just like you compete for work.

Set your firm above your competition by creating a strong company culture that values its employees and empowers them to have their voices heard and is backed by a strong leadership team. Engage your employees by offering opportunities that are both challenging and rewarding. Be the first place a candidate applies to when seeking a new job rather than being their last resort.

Invest in Your Employees

Construction firms need to increase their investment in training and development of the workforce. Make sure you are making opportunities such as training and continuing education courses available to both your new and existing employees. Offer to reimburse employees for classes once they've successfully completed them. Potential employees want to know that there are advancement opportunities and multiple career paths to move up within an organization.

Retaining good employees should be as important to your company as recruiting them. You want to keep the good workers once you've hired them. This means investing in them and their continued growth and success with your company.

People want to feel like they are contributing team members as opposed to just employees who show up to do a job. Show your employees they are appreciated and valued. Keep employees motivated by recognizing and rewarding them for their hard work and dedication to your company.

Seldom will a job candidate walk through your door with all the prerequisite skills, education,

training, and work experience listed in your job posting. Remember, skills can be trained, a strong work ethic typically cannot. If you're willing to put the extra time into training a new hire make sure they have the right attitude, integrity, are reliable and are willing to put in the same amount of effort you are investing in them.

Check References

Conduct background checks, drug screenings, and pre-employment assessment tests on potential new hires before you make that job offer. Make sure the candidate is a good fit for your company by asking for references. Contact them to get an idea of what kind of employee your candidate will be. One of the best questions to ask a reference is whether they would hire/rehire the candidate.

Even after you've done your due diligence and made a job offer, not everyone you hire will be a good fit for your firm. This will be evident after the first couple of months they are on the job. Sometimes businesses are hesitant to let someone go considering the time and money that went into recruiting and training an employee. Don't continue to spend your time and money on an employee who isn't working out.

Internships & Apprenticeships

Construction firms need to look to the future by offering internships and co-ops to local high schools, trade schools, and college students. Reach out to your local universities and community colleges that offer courses of study in the construction industry. More and more companies are setting up training programs with community colleges and vocational schools to offer training programs to meet their needs.

Consider getting involved in youth programs aimed at getting kids interested in construction careers. The ACE Mentor Program and MAGIC Camps, which stands for Mentoring a Girl in Construction, are both great programs to get involved with.

Find local apprenticeship programs, or consider starting your own registered apprenticeship program so you can offer industry-specific training programs that can benefit your company. This creates an additional pipeline to tap into when it comes time to hire a new employee.

Hire Veterans

Don't forget to look to veterans and active-duty military who will soon be transitioning to civilian life and looking to start new careers. There are a number of programs like Helmets to Hardhats and Veterans in Piping geared to attracting and training veterans for careers in construction.

We're already seeing reports of construction delays due to worker shortages across the country. These issues are only going to get worse and spread to other areas of the country, especially for construction companies that aren't being proactive and creative in their recruitment efforts.

The August 2021 Job Openings and Labor Turnover Survey from the Bureau of Labor Statistics had the seasonally adjusted rate of job openings in construction at 365,000 which was down from July 2021's all-time high of 377,000.

The entire construction industry needs to pull together to develop a fundamental change in its approach to attracting more people to careers in construction.

Abraham Lopez, YucaTech Technology Solutions

Abraham arrived in San Rafael, California in 1997 from Mexico. His first job was washing dishes. Through his willingness to learn and hard work, he moved from busboy to waiter to supervisor at Rickey's Restaurant in Novato.

But Abraham had a dream of owning a business – perhaps a fine dining Mexican restaurant or a computer repair shop as he liked technology. He tried his hand at business ownership and opened a small catering company in 2007. The recession hit and he had to close.

He loved to fix his own gadgets and has a passion for technology, so he promised his 10-year old son, Johny: "Someday, we're going to open an electronics business." For an immigrant from Yucatan, Mexico, with little English at the time, no formal technical skills or money, it was a tall order.

In his spare time, he studied English, earned his GED, and took courses to get an Associate's Degree in Computer Information Systems at the College of Marin. With all this new knowledge, he started repairing electronics for his neighboring friends and family around 2011.

Abraham was in transition; he lost his house and got a divorce. With nothing to lose, he decided to start fresh. And start with something better. It was time to pursue the dream.

He started by working on his finances. He enrolled in a workshop with EARN that taught ways to save and come out of debt. The EARN program offered a matched Independent Savings Account to start a business. In order to be able to qualify for the match, Abraham needed a business plan and a business counselor. The counselor referred him to the Renaissance Entrepreneurship Center in Marin in 2011.

Abraham took Renaissance's "Como Empezar Tu Propio Negocio/Start and Grow Smart" class to work on his business plan and received oneon-one advising through the Renaissance-hosted SBDC to finalize his plan. His instructor, Fermin Alvarez, gave him an understanding of what it takes to open a business. And his business counselor Luis taught him Quickbooks, budget management, and inventory management.

While starting his business, he continued to work 16 hour days: five nights a week at the restaurant and daytime doing maintenance for a hotel. That left him three-to-four afternoons to work on his electronics business.

In May of 2013, he decided it was time to fulfill his promise to Johny. His studio apartment was becoming overcrowded with computers and parts with no room to work on them. And he was eligible to withdraw the money he saved through the EARN program to put a deposit on a physical location. He opened YucaTech Technology Solutions — a dedicated, customer-focused electronics service business on Fourth Street in San Rafael.

In 2014, Renaissance recognized Abraham with the Emerging Entrepreneur of the Year Award. Abraham continued to stay involved with the Center by receiving ongoing consulting and participating in Renaissance's events. And though the Center later relocated to Richmond, Abraham still keeps in touch with the people who helped him.

The story behind Asian Pacific American Heritage, and why it's celebrated in May



completion of the first transcontinental railroad in the U.S., which had significant contributions from Chinese workers.

The railroad stretched from the West Coast to the East Coast, and 15,000 to 20,000 Chinese immigrants were a major part of its construction, according to History.com. Initially, construction superintendent James Strobridge deemed the immigrants unfit for the job. But the railroad needed workers, and many white people weren't interested.

Conditions were brutal in the Sierra Nevada, and Chinese workers weren't receiving the same pay as their white counterparts, according to the Chinese Railroad Workers in North America Project. Unlike white workers, Chinese workers had to pay for their own food and had to work longer hours, according to the project.

The railroad was fundamental to the development of the American West, according to His-



tory.com. It cut travel time across the U.S. from months to less than a week.

This year's theme: Advancing Leaders Through Collaboration

The Federal Asian Pacific American Council a nonprofit that supports the interests of Asian Americans, Native Hawaiians and Pacific Islanders in the federal and D.C. governments — selected the theme: Advancing Leaders Through Collaboration.

The theme builds on the Advancing Leaders series, which began in 2021 and will run through 2024. Last year's theme was Advancing Leaders through Purpose-Driven Service. "When you have diversity at the leadership table, the magnitude of what you can accomplish is enormous," Fahmida Chhipa, FAPAC's vice president, told NPR. "You really expand yourself in the horizons to have something creative and innovative."

And collaboration can lead to innovation, Chhipa adds. The council says this year's theme "further highlights FAPAC's efforts in advancing leaders in the Federal and DC governments," according to a press release.

Choi also emphasized the importance of collaboration.

"We do need to center the experiences of those who've been disproportionately impacted," she told NPR. "And when government not only listens, but implements the recommendations of communities who are closest to those who are being impacted right now, you get better results."
