

How to Recruit and Retain the Next Generation of Construction Workers

Labor shortages are one of the major issues the construction industry is struggling to overcome. For many construction firms, keeping their workforce fully staffed is their biggest challenge. The Bureau of Labor Statistics reports that in March 2022, there were 396,000 job openings in the construction industry, up from just 149,000 in December 2017.

A recent survey by the Associated General Contractors of America shows that construction companies are struggling to fill both craft worker and salaried positions within their firms. While 74% of firms surveyed expect to add headcount over the next 12 months, a large majority are finding it difficult to fill open positions. Nearly 90% of firms looking to hire craft workers are really struggling to fill those positions. Pipelayers and bricklayers topped the list of being the most difficult positions to fill.

The biggest issue firms are having is finding qualified workers. There's just not enough skilled workers to fill all of the open positions. And since skilled workers aren't going to just

start falling from the sky, construction firms are going to have to change their approach to attract and train the next generation of workers.

The labor shortage needs to be addressed head-on, it's not something that will self-correct itself over time. If anything, the situation will only get worse as more workers age out and retire with fewer younger workers coming in to take their place. For construction companies to recruit and retain workers, they may need to alter their methods in order to competitively attract the next generation of construction workers.

Reach Out Locally

People entering the workforce these days aren't exactly flocking to the construction industry. If you want to generate interest, you need to start reaching out to kids at the junior high and high school levels to introduce them to the construction industry. Offering summer jobs or internships to high school students can spark an early interest in a career in construction.

National programs like ACE Mentor Programs of America and YouthBuild USA are great ways to get your company involved and intro-

Governor Newsom's Revised Budget Blueprint Presents an Opportunity to Center Small Businesses in California's Economy

"We are happy to see solid investment in small businesses included in Governor Gavin Newsom's revised budget proposal. Our recent national poll revealed that 32% of small business owners were unsure how long their business would survive without additional funding or other market changes. California's smallest business owners are among those job creators continuing to face financial challenges.

We support the governor's efforts to prioritize a budget that will create equity and help entrepreneurs thrive. The 'May Revision' includes investments in several policy areas that will help to promote greater access to capital, affordable healthcare, and a strong ecosystem aimed at helping to accelerate California's small businesses and economic recovery, including:

- \$500 million for the California small business Hard-Hit Industries grant program administered by CalOSBA to stimulate growth for the top 10 industries hardest hit by the pandemic.

- \$304 million to bolster California's premium assistance program for middle-income Californians.
- \$73 million for the Department of Healthcare Services to resume regular Medi-Cal eligibility operations, including annual redeterminations of beneficiary eligibility and the expansion of Medi-cal coverage regardless of immigration status.
- \$500 million in one-time grant funding in 2024-25 to support the completion of the Broadband Middle-Mile Initiative.

We are also glad to see that the revised budget package includes support for working families to access child care. More than \$883 million has been proposed to build infrastructure in child care deserts and low-income communities, reimburse provider rates for one year, and help small childcare business owners access capital. Additionally, the governor has proposed \$157 million toward waiving child care family fees through June 30, 2023, to benefit 40,000 low-income California families, generating savings of up to \$595 per month. With this revised budget, the governor is taking steps

to create opportunities for the child care industry to thrive by investing in target programs for self-employed business owners, microbusinesses, and small business employees.

Despite these positive proposals, we are disappointed that the revised budget still does not include investments in the Paid Family Leave (PFL) Program, a key component of supporting small businesses and working families. The PFL and State Disability Insurance programs are paid entirely through employee contributions, but many in the small business ecosystem cannot participate because the current wage replacement rate (maximum 70%) is inadequate. The revised budget also does not include increased funding for technical assistance through Women's Business Centers to make up for the loss of federal funding from the CARES Act. Compared to their male counterparts, women entrepreneurs lack access to social capital that helps an entrepreneur build a professional network and tap into specialized knowledge and resources.

EPA Announces \$6.3 Million California Investment, Supported by the Bipartisan Infrastructure Law, to Revitalize Communities

California Communities Will Receive Brownfields Assessment and Cleanup Grants to Help Build A Better America While Advancing Environmental Justice

The U.S. Environmental Protection Agency (EPA) is announcing a \$6,321,123 million investment in California to revitalize communities across the state by cleaning up contaminated and blighted properties and redeveloping them for productive reuse. Nine California communities have been selected to receive over \$4.3 million in EPA Brownfields Assessment and Cleanup grants, and two high-performing Cleanup Revolving Loan Fund programs will receive \$2 million to expand their work. The grants are supported by President Biden's Bipartisan Infrastructure Law, which provides a total of \$1.5 billion to advance environmental justice, spur economic revitalization, and create jobs by cleaning up so called "brownfield" properties -- contaminated, polluted, or hazardous sites slated for revitalization through a specialized EPA program.

"Today's announcement breathes new life into California communities by turning contaminated properties into economically productive community resources," said EPA Pacific Southwest Regional Administrator Martha Guzman. "Thanks to the historic Bipartisan Infrastructure Law, EPA is significantly increasing our investments in California communities, providing assistance to areas long overburdened and underserved."

"I am pleased to see nine projects across California receive Brownfields grants from the Environmental Protection Agency," said United States Senator Alex Padilla. "These grants will build capacity in local communities to advance sustainable projects that clean up and redevelop some of their most contaminated properties. This funding will help revitalize long vacant or contaminated sites, making our neighborhoods cleaner, healthier, and more prosperous."

EPA's Brownfields Program also delivers on the Biden Administration's Justice40 Initiative, which directs at least 40 percent of the overall benefits from federal investments in climate and clean energy to disadvantaged communities. EPA is committed to meeting and exceeding this goal. Approximately 86 percent of the communities



selected to receive funding as part of today's national announcement will support historically underserved areas.

EPA's funding supports California communities' efforts to address the economic, social, and environmental challenges caused by brownfields by stimulating economic opportunity and environmental revitalization. Projects range from cleaning up former lumber mill sites to assessing downtown properties for affordable housing and commercial reuse.

Two communities are selected to receive nearly \$900,000 to clean up former lumber mill sites, both projects building on former EPA investments. The City of Arcata is selected to receive \$369,783 for cleanup at the Little Lake Industries Mill facility, providing both economic reinvestment in this light industrial area and ecological benefits to waterways that drain to Humboldt Bay. The Sierra Institute for Community and Environment is selected to receive a \$500,000 Brownfields Cleanup grant to continue cleanup of properties at the Crescent Mills Former Louisiana Pacific Mill facility. This project supports redevelopment of the property into an operation which will generate value-added wood products out of low-value woody material, with benefits accruing to forest restoration and fire risk reduction efforts.

Seven communities are selected to receive over \$3.4 million for the identification, assessment, and cleanup and redevelopment planning of brownfield properties, as well as community engagement. They are:

The San Diego State University Research Foundation is selected to receive \$500,000 to work with National City to focus on a 158-acre district at the city's core identified as the Downtown Specific Plan Area. Priority properties include a former education center, a vacant lot in a former industrial neighborhood, and a former welding shop. The project will support new housing and commercial development close to transit.

The City of South Gate is selected to receive \$500,000 to focus on the Gateway District, Tweedy Boulevard Corridor, and Hollydale Village neighborhoods. Priority properties include a 3-acre former shipping and distribution center, the former Mondo Chrome facility, and an 88-acre former General Motors assembly plant. This project will support new mixed-use transit-oriented development and new affordable housing.

The City of Bakersfield is selected to receive \$500,000 to focus on the city's downtown area. Priority properties include a 17-acre former corporate headquarters and several vacant and infill development sites. This project will support new

affordable housing and transitional housing for residents experiencing homelessness.

The Fresno Metropolitan Ministry is selected to receive \$500,000 to focus on the Blackstone Avenue Corridor, the city's primary commercial corridor. Priority properties are located in the southernmost portion of the corridor, an area that has experienced substantial disinvestment resulting in many vacant, abandoned, and underused properties. This project will support a mix of housing, retail, office, and active public spaces in a pedestrian/"complete street" oriented environment.

The Spanish-Speaking Unity Council of Alameda County, Inc., a neighborhood-based social equity development corporation, is selected to receive \$451,340 to focus on several neighborhoods in East Oakland. Priority properties include an 8,000-square-foot mixed-use building, a 13,000-square-foot vacant lot, and three large residential buildings. This project will support development and preservation of affordable housing.

The City of Grass Valley is selected to receive \$500,000 to focus on the city's South Auburn Street and Bennett Street Corridors and the Southern Grass Valley Sphere of Influence/Annexation Areas. Priority sites are several mine-scarred properties adjacent to residential communities. This project will support the long-term development of housing, parks and recreation, community space, sustainable "fork-to-table" programs and economic development.

The City of Tulelake is selected to receive \$500,000 to focus on Tulelake's Downtown area, with priority properties including the historic Marcha Theater and the Old Tulelake Hardware and Sporting Goods Store. This project will support the redevelopment and revitalization of community-serving institutions, such as a cultural/entertainment center and professional/medical building.

Two high-performing Brownfields Cleanup Revolving Loan Funds are also selected to receive funding to expand their existing programs.

The City of Fresno is selected to receive \$1 million to focus on cleanup of downtown properties contaminated with hazardous building materials. Humboldt County is selected to receive \$1 million to fund cleanup of brownfield properties throughout the county, particularly those impacted by former timber and rail operations.

Since its inception in 1995, EPA's investments in brownfield sites have leveraged more than \$35 billion in cleanup and redevelopment. This has led to significant benefits for communities across the country. For example:

- To date, this funding has led to more than 183,000 jobs in cleanup, construction, and redevelopment.

- Based on grant recipient reporting, recipients leveraged an average \$20.43 for each EPA Brownfields dollar and 10.3 jobs per \$100,000 of EPA Brownfield Grant funds expended on assessment, cleanup, and revolving loan fund cooperative agreements.
- In addition, an academic peer-reviewed study has found that residential properties near brownfield sites increased in value by 5% to 15% because of cleanup activities.
- Finally, analyzing data near 48 brownfields, EPA found an estimated \$29 million to \$97 million in additional tax revenue for local governments in a single year after cleanup—2 to 7 times more than the \$12.4 million EPA contributed to the cleanup of those brownfield sites.

High-Speed Rail Board Completes Environmental Clearance to Connect Silicon Valley and Central Valley

The California High-Speed Rail Authority (Authority) Board of Directors today certified the Final Environmental Impact Report/ Environmental Impact Statement (EIR/EIS) and unanimously approved the approximately 90-mile San Jose to Merced project section in Northern California. This action completes the environmental clearance for nearly 400 miles of the high-speed rail project's 500-mile Phase 1 alignment from San Francisco to Los Angeles/Anaheim – including a contiguous stretch between Merced and Palmdale plus January's clearance of the Burbank to Los Angeles section.

The Board's actions mark their first certification of a project section environmental document in the Northern California region and the first in the San Francisco Bay Area.

"Today's approval represents another major milestone and brings us one step closer to delivering high-speed rail between the Silicon Valley and the Central Valley," Authority CEO Brian Kelly said. "The Authority is poised to make the vision of high-speed rail in the Bay Area a reality. We look forward to continued collaboration with our federal, state and local partners to advance the project in Northern California."

This project section will connect the existing construction in the Central Valley to San Jose's Diridon Station, slashing travel times and improving mobility in both regions. The high-speed rail system will make the trip from



Fresno to San Jose in just one hour, compared to three hours by car today.

"I am grateful, as are all of us in the City of San Jose, for the extraordinary work that's now culminated in this environmental document reflecting thousands of hours of stakeholder outreach and an enormous amount of environmental analysis," said San Jose Mayor Sam Liccardo. "Completion of this critically important high-speed rail project helps the state expand economic opportunity and affordable housing, two critical goals for all of us."

The Board's certification of the San Jose to Merced Final EIR/EIS and approval of the project section is a critical milestone that moves the project section closer to being "shovel ready" for when pre-construction and construction funding becomes available.

The Authority Board of Directors selected Alternative 4 as the approved project alignment among the four alignment alternatives studied. This alternative modernizes and electrifies the existing rail corridor between San Jose and Gilroy, allowing for both high-speed rail and Caltrain service.

"Next to San Jose, Gilroy will be the next most significant transit hub on this stretch," said Gilroy Mayor Marie Blankley. "Gilroy Transit Center is very much ready for this to happen."

East of Gilroy, the alignment includes more than 15 miles of tunnels through the Pacheco Pass in the Diablo Range. The Board will consider certification for the final environmental document for the San Francisco to San Jose project section this summer.

The Final EIR/EIS and the Board's certification and approval resolutions are on the Authority's website: www.hsr.ca.gov.

This approval was just one of several actions taken by the Board during the two-day board meeting, during the meeting they also:

- Unanimously approved moving forward with the design of the four stations (Mer-

ced, Fresno, Kings-Tulare and Bakersfield) in the Central Valley.

- Unanimously approved a multi-million dollar funding and planning agreement with the Los Angeles Metropolitan Transit Authority (LA Metro) to modernize the historic LA Union Station through the Link Union Station (Link US) project. Union Station will be a major connective hub for California's future high-speed rail service in the LA basin.

- Adopted the 2022 Business Plan.

California high-speed rail is currently under construction along 119 miles in the Central Valley at 35 active job sites. To date, more than 7,500 construction jobs have been created since the start of construction. For more on construction, visit: www.buildhsr.com External Link.

Rosa Guerrero, California Vegan Food Company

Rosa Guerrero Contreras had a dream of launching her own plant-based food business for the last five years. What started as a hobby soon became a passion, but Rosa wasn't quite sure of how to convert that passion into a business. Last spring, Rosa joined Centro's Basic Entrepreneurship Program to launch California Vegan Food Company (CVFC). CVFC's mission is to satisfy the needs of their customers while contributing to a more sustainable planet. They do this by keeping the familiarity of the foods Latin@s grow up with.

In 2018, Rosa found herself unclear of exactly how to build the foundational pieces of her business. "Before Centro, my business was just a concept," Rosa said. "I needed to put my ideas into action and Centro empowered me to do so." As she participated in Centro's program, Rosa evaluated every part of her business, from its mission and vision to its marketing strategy and finances. She also created her business plan, using Centro's Business Planning App. The program provided Rosa with access to local entre-

preneurs that also serve as mentors.

Since completing the program, her company has begun manufacturing two products, launched its first line of vegan protein creations, and received a \$10,000 interest-free loan from Kiva. She used the loan to expand to pop-up and community events, and will soon have a presence at her local farmer's market in San Jose. Rosa credits Centro with empowering her to get to the next level as an entrepreneur. "Our advancement as a business since finishing Centro's entrepreneurship program gave me and my co-founder affirmation that we have been doing something right, something good," Rosa said. "I look forward to further growing California Vegan Food Company this upcoming year."

Over the next year, CVFC hopes to acquire a van to facilitate their logistics and storage. CVFC will also continue to expand the variety of products they offer.



When he first arrived in Sacramento, Javad found a job at a phone accessories shop. The entire time, he was considering opening his own business to better support his family.

When a sunglasses cart in the mall went up for sale, Javad jumped at the opportunity. He purchased the business in November of 2014, but needed more capital for inventory. Javad heard about Opening Doors from his brother, and came to us for technical assistance and a loan.

Opening Doors helped Javad create a strong business plan and cash flow projections. By December, Opening Doors approved him for an \$8,000 loan, which he used to purchase a variety of inventory right before the holiday rush.

US Department of Labor announces \$3.4M funding opportunity to attract, retain women in Registered Apprenticeships, nontraditional occupations

The U.S. Department of Labor announced a funding opportunity of \$3.4 million for up to nine grants to attract and keep women in Registered Apprenticeship Programs and industries where they are underrepresented such as manufacturing, infrastructure, cybersecurity and healthcare.

Administered by the department's Employment and Training Administration and Women's Bureau, the Women in Apprenticeship and Nontraditional Occupations grant program supports community-based organizations in their efforts to recruit, train and retain more women in Registered Apprenticeships and nontraditional occupations.

While women make up nearly half the U.S. labor force, they comprise only 13 percent of Registered Apprentices.

These grants are intended to help address the significant underrepresentation of women in Registered Apprenticeship programs and in high-growth, high-wage STEM occupations.

Registered Apprenticeships are a pathway for workers to the middle class. They also help employers to recruit, develop, and retain a highly skilled and diverse workforce. While this earn-while-you-learn model has a long history in skilled trades, such as construction, emerging

and high-growth industries like manufacturing, infrastructure, cybersecurity and healthcare are increasingly using Registered Apprenticeships to strengthen their workforce.
