

# "Once-in-a-Generation" Opportunity for Women in Construction: Infrastructure Investment & Jobs Act

The Infrastructure Investment and Jobs Act (IIJA) is a "once-in-a-generation" investment in America's national infrastructure. With this plan, the goal is to rebuild many of the bridges, rails, and roads throughout the country to improve the overall infrastructure across America. Additional parts of this bill – now law – include making sure that every American has access to high-speed internet, advancing environmental justice, investing in communities that have been overlooked, and addressing the climate crisis.

In this article, we're looking at the IIJA and its impact on opportunities for women in the industry. The IIJA is intended to grow the U.S. economy while making it more sustainable, resilient, and just. The White House states that it will drive the creation of union jobs and help grow the economy in a sustainable way that makes sure all people, including under-represented communities get ahead for decades to come.

Aside from enhancing the country's global competitiveness, the IIJA will create meaningful jobs for America's workforce, especially in construction. In fact, it's estimated that this federal investment will add at least 1.5 million jobs to the economy over the next 10 years. Of those jobs, 175,000 are expected to be in the construction industry, which will largely be responsible for the restructuring of railways, bridges, roadways, and other transformational infrastructure changes around the country.

The recruitment and hiring of women have the potential to meaningfully change the workforce landscape of the construction industry. For example, by 2013, 38 projects in Massachusetts had adapted to focus on increasing the number of women in the industry and had 7.33% of the work hours completed by women. That year, it was around twice the national average. For women in construction, this IIJA is an excellent opportunity to make construction jobs more inclusive around the nation.

So, how does the IIJA advance opportunities for women? Well, it has its own participation goals for women, which may offer a "once-in-a-generation" opportunity to reduce or eliminate barriers to women in the construction industry.

#### Current representation of women in construction

Women are underrepresented in the construction industry, and they have been for a long time. According to Commonwealth Magazine, "in 1989,

# California's Massive \$97.5 Billion Budget Surplus Offers a Path Forward to a Just Economy

The Greenlining Institute Urges Legislators to Invest Historic Budget Surplus in California's Most Vulnerable Communities to Close the Racial Wealth Gap

Governor Newsom's California budget revision released detailed how the governor plans to spend the state's massive \$97.5 billion budget surplus. The May Revise includes substantial investments to combat climate change, increase access to healthcare including reproductive healthcare, and provide economic relief to California residents. These investments double down on Gov. Newsom's forward-thinking January budget proposal, and offer a path forward for advancing racial equity and improving the lives of all Californians.

However, given the inequitable recovery from COVID-19, the devastating impacts of climate disasters, and the widening racial wealth gap, these investments are an important stop-gap but nowhere near the comprehensive redistribution of resources we need to ensure an equitable economic future for all. While this budget proposal is a massive investment, no matter how substantial the budget surplus is this year, it won't fully redress the long legacy of injustice created by generations of underfunding communities of color.

"California's historic budget surplus comes at a time when the racial wealth gap is exploding and the climate crisis is worsening. Communities of color need bold, long-term investments in a future where all communities can thrive," said The Greenlining Institute President and CEO Debra Gore-Mann. "At this moment, lawmakers have a responsibility to ensure that communities of color can share in the benefits of the state's strong financial standing. The Governor and Legislature must seize this \$100 billion opportunity to commit to a long-term vision for racial equity that goes beyond the pre-pandemic status quo."

"Now more than ever, California has an opportunity to finally make innovative investments that anticipate the harsh realities that low-income communities and communities of color face in a California that is only getting hotter and more expensive. For too long, advocates like us have been told the funding isn't there," said Alvaro Sanchez, Vice President of Policy at The Greenlining Institute. "Well, now it's time to put our money where our mouth is and fully fund the programs that we know work by putting lowincome communities of color first. Because the money won't always be there, we also need an Office of Racial Equity to ensure the commitments lawmakers make to communities of color today are enacted tomorrow."

#### Highlights of the governor's May Revise include: Economic Relief for Californians:

Utility Debt Relief: \$1.4 billion to address utility energy debt, \$1.2 billion for residential energy debt, and \$200 million for water utility debt. This crucial relief can prevent hundreds of thousands of California households from losing vital services or having to make the choice between basic human needs like power, food, or rent.

- **Rebates:** \$11.5 billion for tax refunds to help address inflation including \$400 checks for California drivers, and \$750 million for three months of free public transportation. The Greenlining Institute applauds this effort to support struggling Californians. However, we look forward to working with the Legislature to ensure the majority of these resources are as targeted and impactful as possible and delivered in a way that maximizes benefits to our most vulnerable communities.
- **Community Resilience to Climate Change:** \$170 million over two years for Community Resilience Centers to offer immediateterm respite and relief at trusted facilities during climate disasters alongside crisis preparedness and recovery in disadvantaged and vulnerable communities. We are pleased to see additional investments for these centers, but urge the Legislature and Governor's Office to allocate \$1 billion to meet the full need for much-needed resilience centers across the state, especially in light of the large surplus.
- Zero- Emission Vehicles: \$1.75 billion in accelerated funds for the Clean Cars 4 All, Clean Vehicle Assistance Program, Clean Mobility Equity Programs and Charging Infrastruc-

ture. No new funding for the Clean Vehicle Rebate Project, which has been demonstrated to mainly benefit higher-income households. It's time for the decade-long investment in CVRP to start ramping down.

**Zero Funding for an Office of Racial Equity:** Without the infrastructure to create, staff, and implement long term equity strategies, lawmakers will not be able to maximize the impact of the equity investments made with this historic budget surplus. The Greenlining Institute urges the Legislature and Governor's office to allocate at least \$40 million to fund the establishment of a statewide Office of Racial Equity, consistent with SB 17 (Pan).

"There is no reason not to fully invest in our communities. We have the resources, we just need the political will," Gore-Mann said. "The Greenlining Institute supports the equity priorities in the May Revise and we call on the Legislature to move swiftly to approve a budget that meets the dynamic needs of California's diverse communities," she continued. "Building a more equitable society for California will require an authentic commitment to build a broader economic foundation that secures a multi-generational and inclusive future."

# "Once-in-a-Generation" Opportunity for Women in Construction: Infrastructure Investment & Jobs Act

women made up somewhere between 2% and 3% of the national construction workforce. Fifteen years ago, we were at about 3%; 2020: 4%."

Today, women represent approximately 11% of the U.S. construction industry. In the field, that's even less. Women make up only 4.5% of all construction laborers and 3% of all construction equipment operators, according to the U.S. Bureau of Labor Statistics.

Chicago Women in Trades has been helping women move into jobs in the construction industry since 1981. "Our work through the National Center for Women's Equity in Apprenticeship and Employment allows us to provide technical assistance, toolkits, training to support industry leaders who are ready to deliver on commitments to create welcoming environments to women in construction," according to Lauren Sugerman, the Director of the National Center for Women's Equity in Apprenticeship and Employment at Chicago Women in Trades (CWIT).

Adding more women to the construction workforce will provide benefits. "When women join the construction workforce, they are closing the generational race, ethnicity, and gender gaps," she explained.

"Another benefit," expressed Drew Olsen, the U.S. Department of Transportation Sales Lead, Autodesk Construction Solutions, "is that diverse perspectives and life experiences contribute to a more well-rounded team. Furthermore, it has been my experience that men and women each have their own diverse strengths. By having a diverse team, we are in a better position to fill in one person's weakness with another's strength. Think of critical skills around communication, planning, and organizing (where projects can live or die); we need as many diverse perspectives as we can to deliver on the gigantic needs of our infrastructure and the scale that the IIJA will bring. I hope we are nearing the point where this is a foregone conclusion."

The Infrastructure Deal has the potential to help close these gaps and to encourage more women in the construction industry both in and outside of the field.

#### Improving representation in the workforce

Action needs to be taken to increase the total number of women working in construction. Women need to have access to resources, like childcare, vocational training, and apprenticeships, which help them address educational and training needs as well as specific industry needs.

Fortunately, organizations and the government itself are working toward helping more women enter the workforce in construction. Occupational Health & Safety Magazine points out some helpful tips for recruiting women, such as creating inclusive job listings, reaching out to women who may fit a role, and including women in the hiring process. Providing good networking and support is also essential for companies looking to build communities that are inclusive and diverse.

In addition to bringing more women into the construction workforce, there has to be an importance placed on retention. For Olsen, he believes that the focus has to be placed on putting women in leadership positions to foster a welcoming environment and to help foster support for women-led organizations.

"Fostering support through women-led organizations like Women in Transportation and Engineering (WTE) is one option. We also need to branch out of design and engineering and into the core construction industries."

Sugerman adds, "The industry won't see good retention rates for women if we don't address the harassment and exclusionary practices many tradeswomen still report facing in the construction workplace. Good federal and state oversight to ensure non-discrimination and respectful workplaces can be a hallmark of these investments, especially if contractors are responsible for conducting anti-harassment training, bystander intervention training, establishing and following policy that protects victims of harassment, and requiring equitable practices in apprenticeship classrooms and on-the-job training.

The retention of women is also rooted in ensuring industry leaders, contractors, unions, and apprenticeship programs equip them with the knowledge, skill, and confidence to affirm their role in the construction industry. CWIT can conduct anti-harassment training and assist companies, unions, and apprenticeship programs in setting up peer support and mentorship programs."

#### The impact of the IIJA on women

Now that the Infrastructure Bill has passed, it is causing changes. For Sugerman, this is an extension of what she has already focused on. For instance, CWIT offers their own preparatory training programs like Women Build Illinois and contributes to training programs supported by several organizations like ComEd's Construction Infrastructure Academy. The IIJA creates more jobs, which means that there is, and will be, a greater need for women to enter the field of construction. It presents a very unique opportunity to create thousands of jobs for populations that historically would not have been able to access them, such as women and people of color, according to Jane Villinga, Executive Director of CWIT.

While women have not historically represented a majority of the workforce in this field, that may be based on a preconceived notion that women are not as strong or capable as men. However, women have been doing heavy labor and can do heavy labor alongside men. There are over 308,400 women who already work frontline jobs in the construction industry in the United States today. With the passing of the Infrastructure Bill, many more have the opportunity to join those numbers. The question is, how will employers pursue opportunities to grow a more diverse workforce–especially in the field?

### The IIJA is a unique opportunity to create lasting change

Now that the Infrastructure Investment and Jobs Act has passed, there are many new opportunities for women to join the construction workforce. It's not just up to them, though. While participation goals have to be met while this bill is in place, it is up to all people working in the industry to foster a welcoming environment, to address a lack of women leaders in construction, and to bridge the gap between current numbers and the total number of women who are needed in this industry in the future.

Tap into the veteran talent pool

If you're not recruiting in the veteran space, you are missing out on a significant pool of talent. Statista indicates that states with the largest veteran population of 600,000 or more are California, Texas, Florida, Pennsylvania, Ohio, Virginia, North Carolina, Georgia and New York. Pew Research Center reports that over 60% of families in the U.S. have had an immediate family member serve in the armed forces.

Pew Research Center also reports that 8 in 10 active duty officers have a bachelor's degree and are four times more likely to have completed a postgraduate degree. It's a known and observed fact that veterans are often cross-trained in multiple skills and proficiencies with experience in varied tasks and responsibilities. They know what it means to put in a hard day's work and meet the demands of a focused organizational objective, and they appreciate the challenges and satisfaction of a job well done.

Veterans are problem solvers, not by innate skill, but by experience. They are organized and disciplined, which gives them the individual

#### Other companies are paving the way

There are a vast number of resources that you can use to find talent in the veteran community, and you can start by looking to companies that are already utilizing veteran talent.

Rockwell Automation started addressing the shortage in manufacturing as an industry back in 2017 by developing the Academy of Advanced

Manufacturing, which supports veteran upskilling programs in multiple industries that support the nation's threatened supply chain. After completing an in-depth initial screening process, veterans complete a 12-week training program that includes instructor-led training and handson laboratory experience.

You might also consider creating a paid veteran internship program. Schneider, a long-distance transportation and logistics company, in partnership with the Department of Veterans Affairs, provides veterans a 12-month apprenticeship program where veterans are eligible to earn a monthly educational benefit check from the VA in addition to the wages they earn with the company.

Veterans are actively looking for their next mission or "why." Having a purpose provides focus and structure for veterans, especially for those who experience the hardships and realities of military careers. But don't hire veterans just because they're veterans — give them a purpose while putting their many skills to full use.

## Al and Tamanna Rahman, Garden of Roses

Al and Tamanna Rahman met in 2012 when Tamanna was working as a floral arranger for Roger's Flower Shop. They were married a year later, and Tamanna decided to open Garden of Roses, her own florist shop. Al believed they could make it a success, and quit his job as marketing manager at Verizon to devote his time to launching the business. In late 2013, they decided to use Valentine's Day as an opportunity to aggressively promote their new business, but they needed to purchase a cooler and inventory for the holiday rush.

They applied for a loan from Wells Fargo, but were declined. Al had left his job, so they didn't have his salary to fall back on, and they had been in business for only a few months. Wells Fargo, like most banks, requires two years of financials to provide a small business loan. With few other lending options in Moreno Valley, the Rahmans were stuck. They considered using a personal credit card to purchase the equipment, but didn't have a high enough credit limit.

Luckily, the Wells Fargo loan officer had a relationship with CDC Small Business Finance. CDC offers SBA microloans specifically tailored to newer businesses, and doesn't require the established history that bank loans do. Instead, CDC loan officer Carla Ulloa looked at the Rahman's banking history and savings to make sure they had the reserves to make the loan payments and still cover all their bills. Inland Empire Small Business Development Center walked them through the application process and made sure all their documentation was in order.

Thanks to an online loan application and the MMS underwriting system, CDC was able to approve them for a loan in five weeks. Al and Tamanna had asked for \$20,000, but MMS underwriting offered them \$10,000 due to the newness of their business and the size of their cash reserves. The cooler they needed cost \$12,500, though, so Carla negotiated a deal with her underwriter to use the cooler as collateral against the loan.

Garden of Roses bought the cooler and haven't looked back. Customers rave about their service, and especially love the text messages they receive with a picture of the flowers their loved ones will receive. Today, the business that started as a husband and wife team employs five employees and delivers floral arrangements throughout the Moreno Valley and beyond.
