

# States With the Most Veteran-Owned Businesses

According to the U.S. Department of Veterans Affairs, there are about 19 million veterans living in America. Many of these people who served their country are starting businesses, joining an increasing number of Americans who sought to become entrepreneurs after the onset of COVID-19, according to the U.S. Census Bureau.

Demographic data sheds light on who these veterans are. According to the U.S. Bureau of Labor Statistics, around nine out of 10 veterans are men. The largest cohort is over 60 years old, comprising about a 35% share of the U.S. veteran population. In October 2021, an estimated 8.4 million veterans participated in the civilian workforce, and in 2021, the unemployment rate for veterans (4.4%) was lower than the rate for nonveterans (5.3%).

The rise in overall entrepreneurship seems logical in the face of an undeniable fact: a decreasing number of Americans are realizing the American Dream. According to Pew Research, the U.S. middle class has contracted steadily over the last five decades. In 1971, the share of American adults who lived in middle-class households was 61%. By 2021, that number was 50%. Pandemic-related financial issues impacted lower- and middle-income households the hardest; from 2019 to 2020, median incomes fell 3.0% for

lower-income households and 2.1% for middle-income households. There was almost no change in the median incomes of upper-income households during the same period.

For most business owners (roughly 64% according to the Census Bureau's Annual Business Survey), achieving greater income is one of the primary drivers behind owning their businesses. And that number is fairly consistent across veterans and nonveterans. Interestingly though, when comparing veteran business owners to nonveteran owners across other metrics. there are a few notable differences. Compared to nonveterans, veteran business owners value being their own boss, working for themselves, and wanting to start their own business more heavily. On the other hand, nonveterans are more likely to report having flexible hours and a better worklife balance as primary motivators for business ownership.

While nearly 6% of employer firms overall are owned by veterans, the concentration of veteranowned businesses varies by industry. Comparing what types of businesses veterans started to overall filings for new businesses shows some divergence. The top industries for entrepreneurs who are veterans include oil & gas, finance, professional services, manufacturing, construction, and transportation. According to the Business Formation Statistics from the U.S. Census

# California High-Speed Rail Authority Pursues First Major Award Of New Federal Infrastructure Funds

### Seeks Nearly \$1.3 Billion in Federal Funds for MEGA-projects

The California High-Speed Rail Authority has submitted two applications totaling nearly \$1.3 billion in federal grant funding for the nation's first high-speed rail project. The applications are the first major push for a continued federal partnership under the newly enacted Bipartisan Infrastructure Law, signed by President Biden in November, 2021.

"With the state's continued commitment and the Biden Administration's leadership and support,

we are confident we will deliver a project the country will be proud of," said Governor Newsom in his support letter for the grants. "California is the home of innovation, and we are committed to advancing this very innovative project to improve our economy, advance clean mobility and expand economic opportunity for all."

More than 40 letters of support from up and down the state of California accompanied the Authority's grant applications, including letters

from United States Senators Dianne Feinstein and Alex Padilla, members of the Legislature, mayors and other elected officials, business, transportation and labor leaders statewide and nationally.

The Authority's two applications include funding for:

- Constructing the second track for the initial operating segment between Merced and Bakersfield, beginning with the two tracks on the first 119 miles currently being built in the Central Valley.
- Advancing design work for the extensions to Merced and Bakersfield.
- Station development in Fresno and Kings/ Tulare.
- Purchasing six fully electric train sets capable of speeds in excess of 200 mph.
- Advancing the next phase of design for two segments into the Bay Area (Merced

to San Jose and San Jose to San Francisco) and into Southern California (Bakersfield to Palmdale and Burbank to Los Angeles).

If awarded by the U.S. Department of Transportation, these grants will help California accelerate progress toward the opening of the nation's first 220 mph, electrified high-speed train system. They will also advance design on crucial segments in both Northern and Southern California that cleared the environmental process in the past year.

California's high-speed rail project is currently under construction in the Central Valley, employing an average of 1,000 men and women on more than 30 active job sites daily. For continued progress information visit www.buildhsr.com

Bureau, the top types of overall new businesses from 2020 to 2021 were in retail trade (including e-commerce), professional services, construction, and transportation and warehousing. Veterans are least likely to own businesses in the arts, entertainment, education, accommodation, and food services sectors

States where the highest number of veterans call home are California, Texas, and Florida, and these three states also have the country's highest total numbers of veteran-owned businesses. Looking at the proportion of businesses that are veteran-owned by state shows a cohort of Eastern and Southern states, ranging from New Hampshire, Virginia, and Georgia to Tennessee, Oklahoma, and Alabama. At the metro level, the concentration of veteran-owned firms mirrors the state-level trends with higher percentages in metropolitan areas located in Eastern and Southern states. These include cities in Maryland, North Carolina, Virginia, Florida, and Georgia.

The data used in this analysis is from the U.S. Census Bureau's 2020 Annual Business Survey and the U.S. Census Bureau's 2020 American Community Survey. To determine the locations with the most veteran-owned businesses, researchers at HireAHelper calculated the share of employer firms (those businesses with paid employees) that are veteran-owned. Researchers also included statistics on the total number of veteran-owned firms, employees and revenue at these firms, and the veteran population share in each location.


The analysis found that in California, 4.2% of all businesses are owned by veterans—a total of 31,432 businesses employing 359,630 workers.



# **Mayor London Breed Announces Investments to Support Small Business Recovery in San Francisco's Economic Core**

Mayor London N. Breed announced \$47.9 million in new funding to support the economic recovery of the City's Economic Core that will be part of her proposed budget. This will include new direct support for small businesses, as well as new events, activations, and public space improvements to support areas that rely on workers, tourists, and other visitors. The funding proposal will also continue the City's existing Ambassador programs located in areas like Mid-Market, Union Square, Downtown, South of Market, and along the

These resources are aimed primarily at funding initiatives that directly support and drive foot traffic to the small businesses in San Francisco's Economic Core, which includes Downtown, South of Market, Union Square, Civic Center, Yerba Buena, and Mission Bay. These areas continue to experience ongoing and significant disruptions to the employee and tourist-based foot traffic that they relied on prior to the pandemic.

"While San Francisco is bouncing back from this pandemic, we continue to see major shifts in our city, and we see that in our Economic Core more than anywhere else," said Mayor Breed. "I've been visiting businesses large and small, and while it's clear we are all committed to adapting and thriving as part of our long-term recovery, our small businesses in these downtown areas cannot wait any longer. They need all of us dedicating our energy and resources to help them in the short-term, as we continue to do the work to get our city back on track."

#### The Mayor's Budget proposal includes:

- \$10 million for direct grants and loans aimed at helping small businesses launch, stabilize, scale up and adapt business models. New funding will expand programs to serve businesses throughout the City, including businesses within the Economic Core
- \$10.5 million over the two years for the City Core Recovery Fund to support events, public space and ground floor activations, as well as a city-wide marketing campaign. This funding is envisioned to support community driven ef-

forts to beautify, improve, and activate public spaces and ground floor vacancies throughout the Economic Core.

- \$25.4 million over the next two years to continue the Mid-Market/Tenderloin Community-Based Safety Program, which provides community ambassadors who are focused on creating more welcoming, clean, and vibrant environments for residents, workers, and visitors in the areas around the Tenderloin, Civic Center and Market Street
- \$2 million for SF Welcome Ambassadors and Retired Police Community Ambassadors stationed in key transit and tourist nodes such as Downtown BART stations, Union Square, Moscone Convention Center, and along the Embarcadero. These funds will maintain the City's current investment and will allow for a consistent and visible safety presence as well as proactive positive engagement and friendly assistance in wayfinding, making referrals and recommendations, and coordinating with other City departments and community-based efforts to support posi-

tive street conditions and experiences by business owners, employees, residents, and visitors alike.

The specific programming and initiatives created through this funding will be informed by convening key representatives of the industries, businesses, community groups, and other stakeholders in the Economic Core to understand and respond to the immediate needs and challenges those on the ground are experiencing, and to adopt and scale the solutions they are developing.

"San Francisco small businesses are the cornerstone of our economic recovery. Through the leadership of Mayor Breed, these proposed investments are practical solutions that will help bring customers and visitors back into our Economic Core which comprises over 40% of our small businesses," said Kate Sofis, Executive Director of the Office of Economic and Workforce Development. "As the dynamic continues to change and shift on the ground, we want to ensure we stabilize our small businesses, including our local artists, musicians, and performers with new funding and programs that activate and



create opportunities and a safe and welcoming space for everyone. When our small businesses thrive, our city thrives."

Mayor Breed partnered with Advance SF to create the "Renewing San Francisco's Economic Core Forum," a facilitated conversation with a cross-section of stakeholders from the Economic Core including large and small businesses, arts groups, brokers and real estate representatives, hospitality and entertainment establishments, and community benefits districts, among others. This group began a process to develop a shared vision for supporting the ongoing vibrance of the Economic Core in the post-pandemic economic context and identify immediate needs as well as mid- and long-term initiatives to explore.

Through ongoing dialogue and discussion and in coordination with a broad set of stakeholders, San Francisco will continue to advance strategies that leverage key assets of its Economic Core to support its continued vibrancy and preserve its role in supporting the region's economic well-being.

"Over the last several months, Advance SF has worked with the Mayor's Office to bring private and public sector partners together to develop strategies to restore our Economic Core," said Larry Baer, Co-Chair of Advance SF. "Mayor Breed is laser-focused on San Francisco's post-pandemic recovery and the budget released today sets a clear vision to immediately address our city's most pressing economic challenges," continued Lloyd Dean, Co-Chair of Advance SF.

Prior to the pandemic, 469,745 people commuted to San Francisco for work. According to the most recent report from the City Economist, offices are seeing just 35% of their workforce returning to the office. Between commuters and tourists, the City averaged one million daily visitors prior to the pandemic, and SF Travel does not estimate a full tourism recovery until 2024.

The Mayor's proposed budget prioritizes the urgent needs of the small consumer-facing businesses in the Economic Core. Over 42% of the City's small businesses are in the Economic Core and pre-pandemic, this area generated more than 45% of the City's sales tax. While sales tax indicates that almost all of San Francisco's neigh-

borhoods have recovered the vast majority of the economic activity they generated prior to the pandemic, San Francisco's office and tourist districts, including the Financial District, East Cut, Yerba Buena, Union Square, Mid-Market and SOMA maintain deficits of 20% or more.

"The challenges facing small businesses in San Francisco's Economic Core are immense," said Andrew Chun, Owner of Schroeder's Bar and Restaurant at Front and California Street. "As the rest of the City continues its recovery from the pandemic, it's easy for Downtown small businesses to feel abandoned. The Mayor's new budget highlights the need to proactively invest in a revitalized economic core. We are excited to work with the Mayor and appreciate the efforts of the City and community partners to invest in Downtown's future."

"Bringing foot traffic and business to our restaurants and small businesses in our downtown Economic Core area is critical to the survival and vibrancy of San Francisco," said Laurie Thomas, Executive Director of Golden Gate Restaurant Association. "We continue to work hard with our partner organizations, larger employers and the City to help drive customers to

these businesses so they can keep their staff employed and help their businesses open. We thank the Mayor and her team for prioritizing these restaurants and businesses in her budget and look forward to a continued partnership. We can do this if we work together."

"As an employer with a large employee presence, we see the strain that the pandemic has created for our small businesses. We have worked in partnership with the small business community to ensure that as our employees return to the office, we are maximizing their support of surrounding small businesses that depend on them. With investments such as the City Core Recovery efforts that Mayor Breed has proposed the City can scale efforts like what we piloted with Golden Gate Restaurant Association to the benefit of all," said Rebecca Prozan, Director of West Coast Government Relations and Public Policy at Google.

# 6 Tips for Dealing With Subcontractor Default

Dealing with a defaulting subcontractor can be a real nightmare for general contractors. A nonperforming subcontractor or one that isn't meeting its contractual obligations can wreak havoc on a project.

This can lead to delays in the schedule that impact other subcontractors and can result in costly rework. Having to replace a terminated subcontractor or supplement their work can kill a project. If a subcontractor is experiencing difficulties it is imperative that you work with them to resolve any issues before they escalate and get out of hand.

The first thing to keep in mind is that no subcontractor enters into an agreement with the intention of not performing the work. Subcontractors have to front a substantial portion of the costs on a project before they start getting paid.

This can quickly lead to cash flow problems despite having the capital to handle a project once it began. Subcontractor default often occurs when they overextend themselves by taking on too much work or when a contractor on another project is delaying payment to them.

#### **Prequalify Your Subs**

Before you take pricing or solicit bids from subcontractors you need to make sure they are capable of completing the work, both physically and financially. Review your prequalified subcontractors to weed out those that aren't experienced with the size and scope of the project. You might have a dozen prequalified electrical contractors that you regularly work with but for this particular project only six might be capable of doing the work. Invite those six to bid on the project.

If a subcontractor ever asks why they weren't invited to bid, be as open as possible and explain the situation. You want to maintain a good relationship with all your subcontractors. Just because they aren't right for one particular project doesn't mean you won't need them for future projects.

Be sure to check out post, "Why Not Prequalifying Subcontractors is Still Risky Business," for some pointers on what information you requiring to properly prequalify your subcontractors.

#### Know the Signs

Subcontractors might not always be forthcoming when they begin experiencing difficulties. Even if they are performing their work and staying on schedule, trouble could be brewing just beneath the surface. It's important to keep a watchful eye on all of your subcontractors to monitor for any signs that they are experiencing difficulties or at risk of defaulting.

Common signs a subcontractor is running into problems include a sudden decrease in their workforce for a project, change in demeanor, de-

layed materials deliveries and failing to pay their subcontractors or suppliers on time. Be proactive in monitoring your subcontractors if you suspect things might be getting off track.

Don't be fooled. If you start noticing some of these red flags, you should address them immediately with your subcontractor regardless of whether they are performing their work as required. Waiting too long to react to a subcontractor who might be struggling can kick off a chain reaction that can derail the whole project.

#### Craft a Plan

Whether you discover it on your own or if the subcontractor comes to you about it on their own, you need to sit down and work with them to correct the issue. Once you've determined what the issue is, you need to determine the root cause

Find out if they are having difficulties with one of their subcontractors underperforming or a supplier not delivering materials on time. If they are having cash flow problems make sure the issue isn't with you not paying them enough or on time for the work completed.

Sit down with your subcontractor and discuss what options are available and what assistance you can provide to help them get back on track. This is typically the easiest and most cost-effective solution.

It could be as simple as supplementing some of their workforce with your own or self-performing some of the work. You may need to alter the subcontract to a labor-only contract to alleviate some of their financial burdens so they can focus on paying their workers and completing the project on schedule.

#### Put It in a Contract

Make sure your contract includes provisions outlining your rights to supplement work, suspend the subcontractor's performance or terminate the contract. Failing to perform work as required should obviously be covered, but you may want to include other circumstances such as delaying payments to their subcontractors and suppliers. The contract should also include the right to reimbursement for any reasonable costs you incur should you have to step in and take action.

If your subcontractor defaults make sure you follow any notice requirements before you exercise your right to supplement their work or take other action. Typical contract documents require you provide the subcontractor with written notice of default and a deadline for curing the default.

If the subcontractor hasn't cured the default within the specified time, the general contractor can then go in and supplement the work.

# Max Aram & Chris Blevins, PickMySolar.com

As passionate advocates of solar technology, Max Aram and Chris Blevins want to help residential consumers make smart choices about installing solar energy systems. Their company, PickMySolar.com, is an online marketplace where solar providers bid against each other on residential installations, lowering the cost to homeowners by 25 to 30 percent.

The chaotic state of the solar market hampers widespread adoption of the technology. Residential customers do not know what factors to consider when deciding to go solar. Aram compares the marketing strategy of solar power installers to that of a "used-car-salesman," which he believes ultimately dissuades homeowners from solar power installation. "I had the idea to create

an online platform to help consumers search for the best deal on solar installation," Aram says. "But it was just an idea I didn't know how to execute." He needed help in early 2013, Aram took a course held by the Small Business Development Center at Pacific Coast Regional.

PCR SBDC Business Advisors Martha G. Castro and Harold C. Hart-Nibbrig helped Aram figure out how to monetize his idea, conduct market research, develop a business plan with financial projections, incorporate the business and develop a partnership agreement once Blevins came on board

Castro showed Aram how to do extensive market research to make sure there was a demand for his idea. "After doing more research in-depth and looking into competitors in the space, we [modified] the business a little bit," says Aram.



Doing research inspired Aram to add more features to the service, such as the ability for homeowners to upload bids they already have from solar installers outside the PickMySolar system. PickMySolar then provides up to two hours of free consultation to assess whether the bids are fair. "At this point, our service is unique-no one else is doing what we're doing," states Aram proudly.

After investing \$40,000 of their own money in their startup, Aram and Blevins were able to raise \$100,000 in convertible debt financing from friends and family. They plan to seek additional capital in the next few months to finance marketing, advertising and hiring key personnel. References from the PCR SBDC also helped PickMySolar earn a coveted space in the Los Angeles CleanTech Incubator. Without marketing, PickMySolar has grown solely on word-of-

mouth. Since the beta website launched in January 2014, the company has actively expanded its network of solar installers. Currently, Pick-MySolar has installers in Los Angeles, Ventura and Orange counties, with plans to expand to all seven Southern California counties by the end of June 2014. Future plans include establishing direct partnerships with financiers to facilitate sales, bringing on taxequity investors to provide their own internal financing options to customers, and expanding to serve the entire state of California by 2015.

#### Creating a Safer, Pedestrian-Friendly Western Addition

San Francisco Public Works completed pedestrian safety improvements this month in the Western Addition neighborhood. These improvements include sidewalk widening, bulbouts with ADA curb ramps, and more at Buchanan Street and Golden Gate Avenue, and Buchanan Street and Turk Street. Additionally, 14 new pedestrian lights and 13 upgraded pedestrian lights were installed along McAllister Street, between Fillmore and Webster Streets. These improvements were identified by the community in the Western Addition Community Based Transportation Plan and requested by District 5 Transportation Authority Board Member Dean Preston.

These improvements will better connect the community to recreational spaces including Buchanan Mall and major destinations like the African-American Arts and Culture Center, Ella Hill Hutch Community Center, and Fillmore Street. The Transportation Authority provided funding from the half-cent for transportation sales tax, Prop AA vehicle registration fee, and more to support improvements.

The San Francisco Recreation and Parks Department also has plans to renovate the Buchanan Mall and is working with local residents to plan, design, and build new park enhancements aimed at making the park a safe, green, and well-used center for the neighborhood. On May 13, Mayor London Breed announced the allocation of \$3.9 million in federal funding to fully fund the renovation project. Construction will begin on the first three blocks, from Eddy Street to Golden Gate Avenue, and McAllister Street to Fulton Street, in Spring of 2023. Construction of the remaining two blocks, from Golden Gate Avenue to McAllister Street and Fulton Street to Grove Street, will begin in Summer 2024. #### **EPA Announces over** \$1.7 million to Pacific Islands, Hawaii and California to **Support Water Quality Monitoring for Safe Beach** Recreation

The U.S. Environmental Protection Agency (EPA) is preparing to award up to \$10 million in grants to 38 states, territories, and Tribes to develop and implement beach monitoring and notification programs nationwide. The Pacific Island territories, Hawaii and California will receive \$1,757,000 to support beach monitoring activities, including efforts with an environmental justice focus.

Since 2002 EPA's partners have used nearly \$206 million in BEACH Act grants to protect beachgoers by monitoring beaches for bacteria, maintaining and operating public notification systems, identifying local pollution sources, and reporting results to EPA.

"This investment advances EPA's commitment to environmental justice by supporting our disadvantaged communities along the coastlines of the Pacific Southwest, from Guam to California. Continued monitoring of our beaches helps us to provide safe and equitable beach access to our Pacific Island, Hawaii and California coastal communities," said EPA Pacific Southwest Regional Administrator Martha Guzman. "This funding supports local public health agencies' ability to give communities peace of mind when taking their families to the beach.'

Over 51% of EPA Region 9's 2022 BEACH Act grant funding will be awarded to the U.S. Pacific Island Territories, filling a critical need to provide safe beach recreation in disadvantaged coastal communities:

- American Samoa \$302,000
- Guam \$303.000
- Northern Mariana Islands \$303,000

In addition Hawaii will receive \$324,000 in funding while \$525,000 will go to California.

This funding supports the President's Justice40 initiative, with the goal of delivering 40 percent of overall benefits of relevant federal investments to communities with environmental justice concerns. The beach water data collected directly helps EPA identify where water quality problems may be and recommend priorities for enforcement, wastewater infrastructure projects, and closures of illegal large capacity cesspools.

Under the Beaches Environmental Assessment and Coastal Health (BEACH) Act. EPA awards grants to eligible state, territorial and Tribal applicants to help them and their local government partners monitor water quality at coastal beaches. When bacteria levels are too high for safe swimming, these agencies notify the public by posting beach warnings or closing the beach.

EPA's most recent Beach Report found that beaches on U.S. coasts and along the Great Lakes were open and safe for swimming 92 percent of the time in 2020. Check with your local public health authority on water conditions when making plans to go the beach.
