Lenny Mendonca, owner of the Half Moon Bay Brewing Company, has accepted the Chairmanship of the 2022 EEMTF. Serving alongside Mendonca as Task Force Vice Chairs are Gurinder S. Ahluwalia, Member of the Board of Hightower Advisors and InspereX and Maria S. Salinas, President & CEO of the Los Angeles Area Chamber of Commerce. Mendonca is the former Chief Economic and Business Advisor to Governor Gavin Newsom. He is also a Senior Partner Emeritus of McKinsey & Company, a lecturer on inequality at the Stanford Business School, and Founding Chair of the Coastside News Group. Over the course of his career, he has helped dozens of governments, corporate, and nonprofit clients meet their most difficult management challenges.

Mr. Mendonca stated, "I'm excited about the goals of this Task Force! And I know that with the assistance and experience of our Vice Chairs Ahluwalia and Salinas, we will work together to improve the success rates of California's entrepreneurs and improve economic mobility in California."

## Mayor Eric Garcetti today signed the 2022-2023 fiscal year budget

Mayor Eric Garcetti signed the 2022-2023 fiscal year budget, which makes record-breaking investments in homelessness while achieving the largest cumulative reserves in City history at 9.3%.

"This spending plan is about more than doubling down on the improvements and solutions that Angelenos can see and feel in their daily lives – it's about placing our City on a fixed course to stability, prosperity, and equity for generations to come," said Mayor Eric Garcetti. "This budget is both prudent and progressive – bold, but balanced. As Mayor, I've always tried to make decisions that keep an eye toward the future, and this budget is proof that we can make historic investments today while creating our most fiscally responsible budget yet."

The \$1.16 billion budget tackles homelessness with the largest proposed investment by nearly \$200 million; \$415 million for Prop HHH enabling the continuation of construction and development for 98 projects with 6,194 new units in the pipeline. Other investments in homelessness include more than \$255 million for a new

Mayor Garcetti has made fiscal responsibility a top priority throughout his tenure, and worked closely with key players over the past year to ensure his final budget would deliver a stable and secure set of reserves to hand over to the next administration. The 9.3% in cumulative reserves is the highest mark of all time, making the City more prepared to withstand any future economic challenges than at any time in its history.

Other key components of the City's 2022-2023 fiscal year budget include:

- \$15 million for waste diversion and water resiliency improvements;
- \$12.4 million for electric vehicle purchases and leases, electric vehicle infrastructure, and charging infrastructure across the City;
- \$10.5 million for the establishment of the two-part Climate Equity Fund to provide mitigation actions for low-income communities that disproportionately suffer from climate impacts;

- \$9.7 million for street safety improvements;
  - \$4 million in cool pavement, doubling the City's current investment;
- \$5.7 million for Summer Play LA, which will provide low-cost summer camp programs at recreation centers;
- \$5 million for solar and decarbonization efforts on municipal buildings;
- Over 800 sanitation workers, including more than 200 youth positions for the CleanLA program;
- \$2 million for tree planting in low-canopy neighborhoods.

"We are excited about this year's budget and the future that it points to. It's extremely important that we continue to make investments in innovative ideas and community based approaches to the work," said Dr. Lena Miller, CEO of Urban Alchemy. "As a result of the new budget, Urban Alchemy will be able to deploy additional Practitioner Teams with lived experience

## **CONSTRUCTION SITES SAFETY TIPS**

# **Beat the Heat: Keeping Cool at the Construction Site**

The dog days of summer will soon be upon us and the higher temperatures bring with it the danger of suffering heat-related illnesses at the construction site. Construction workers are at high risk for heat-related illnesses due to the strenuous nature of their jobs and prolonged exposure to the heat and humidity brought on during the summer months.

The risk is increased for workers where the temperature can reach higher than the outside air temperature such as those performing roof work, road construction or doing interior work on a building with no air conditioning and poor ventilation. We've compiled a list of tips and tricks to beat the heat at the construction site this summer.

### Hydrate, Hydrate, Hydrate

You should be drinking water or other fluids every 15 - 20 minutes. Cool water should be your main source of hydration. Sports drinks (i.e. Gatorade, Powerade, etc.) and coconut water are good for restoring electrolytes. Fresh fruits and juices are also a good option.

Beverages to avoid include coffee, sodas, and alcohol which contain diuretics and will cause you to become dehydrated. Some of the symptoms of dehydration include increased thirst, dry mouth, swollen tongue, inability to sweat, weakness, dizziness, and decreased urine output. If you experience any of these symptoms you should immediately take a break and rehydrate.

### Get Acclimated

This applies mainly to new workers and to workers who have been out of work due to illness or vacation for a number of days. To acclimatize, you should start doing about 50% of your normal workload and gradually work up to 100% over the next 5 to 7 days so your body can adjust to the heat and strenuous activity.

### **Dress for Success**

In this case, we aren't talking about a suit and tie. Light-colored, loose-fitting and lightweight clothing is the way to go. Natural fiber clothing such as cotton is always a good choice because it's breathable and absorbs moisture well. Moisture-wicking clothing is also a smart option because it draws the sweat off your body. This allows your body to cool quicker which is helpful in more humid climates where sweat evaporation becomes more difficult.

### Get an Early Start

The air temperature usually peaks between 3:00 pm and 6:00 pm. The earlier you start your day, the better off you'll be. This is especially true if you can finish up or spend a limited time working before the onset of the hottest hours of the day.

### Made in the Shade

Taking frequent breaks in the shade is an important step to avoid heat-related illnesses. Whenever you are feeling overheated or presenting symptoms of heat stress you should take at least a 5-minute break in a shaded area. This is also a great time to rehydrate if you haven't already done so.

### Lather on the Sunscreen

Whenever you are working outdoors you should be using sunscreen. Even on cloudy and overcast days, ultraviolet (UV) rays can reach you and cause sunburn. When working outside you should reapply often with a broad-spectrum sunscreen that contains zinc oxide, titanium dioxide, and/or avobenzone. Try to find a sunscreen that is either sweat-proof or waterproof to help ensure that you don't sweat it all off in the first few minutes of work. It's also a good idea to wear a wide-brimmed hat to block the sun's deadly rays.

### Keep Cool

Helping your body maintain a stable internal temperature is vital in avoiding heat-related illness. Once the air temperature gets near or above normal body temperature the blood circulated to your skin can't shed the heat. This causes you to sweat, but that's not enough to cool your body if the humidity won't allow the sweat to evaporate.

To cool your body temperature down, try getting inside an air-conditioned space like a vehicle or jobsite trailer. You can also apply a cool, wet cloth to pulse points on your body such as the neck, wrists, and elbows. The tops of your feet and inside of your ankles are also pulse points so try soaking them in a bucket of cool water for a few minutes. (We suggest taking your shoes and socks off first.)

If you are working indoors with no air conditioning consider setting up some portable fans to increase air circulation and cool you off. There are also a number of personal cooling devices on the market like cooling vests or neck coolers that can help you beat the heat.

### Mind the Heat Index

Employers and workers should always be aware of the heat index. The heat index combines air temperature and relative humidity to determine the apparent temperature. Apparent temperature is what it actually feels like outside. As we mentioned earlier, if the humidity is too high it inhibits sweat from evaporating which reduces the body's ability to cool itself. Very low humidity increases sweat evaporation which can lead to dehydration.

OSHA has a Heat Safety Tool mobile app called that will help calculate the heat index and displays the risk level to workers. It can also provide reminders with protective measures to take based on the risk level. Being aware of the heat index and taking the recommended precautions can reduce the risk of heat-related illnesses.

### Know the Signs

Heat stress, heat rash, heat cramps, heat exhaustion, and heatstroke are all heat-related illnesses

The Biden Administration recently announced over \$368 million in grants to improve rail infrastructure and to enhance and strengthen supply chains. Included in those grants is the Consolidated Rail Infrastructure and Safety Improvements (CRISI) program. A \$25 million CRISI program grant was awarded to the Alameda County Transportation Commission (Alameda CTC) by the Federal Railroad Administration (FRA) for Alameda CTC's Rail Safety Enhancement Program (RSEP) to enhance safety, efficiency, and reliability of intercity passenger and

### freight rail.

"Safety is a top priority of the Alameda County Transportation Commission. With rail infrastructure traversing the county, particularly in low-income communities of color, and an emphasis on increasing transit rail use to reach climate goals. improving safety for pedestrians, bicyclists, rail and roadway users is critically important," says Alameda CTC Chair. # **Making Progress on High-Speed Rail**

As we approach the halfway mark of 2022, the California High-Speed Rail Authority (Authority) continues to push the nation's first high-speed rail program forward at high-speed. Construction is happening within 119 miles in the Central Valley, with approximately 1,000 hard-working men and woman on site every day.

Just last week, we submitted two applications totaling nearly \$1.3 billion in federal grant funding for California's high-speed rail project. The applications are the first major push for a continued federal partnership under the newly enacted Bipartisan Infrastructure Law.

The Authority also completed and submitted to the Legislature the 2022 Business Plan, which puts forward a path for us to:

- Deliver an electrified, two-track initial operating segment connecting Merced, Fresno and Bakersfield as soon as possible.
- Invest statewide to advance engineering and design work as every project section is environmentally cleared.
- Leverage new federal and state funds for targeted statewide investments that benefit local service providers and advance highspeed rail in California

The Authority's Board of Directors also recently took action on several important items that will position us to explore avenues to advance construction that will ultimately connect the Central Valley with Northern and Southern California when funding becomes available.

### **Environmental Clearance to Connect Silicon** Valley and Central Valley

In April, the Authority's Board of Directors certified the Final Environmental Impact Report/ Environmental Impact Statement (EIR/EIS) and unanimously approved the approximately 90-mile San Jose to Merced project section in Northern California. This action completed the environmental clearance for nearly 400 miles of the high-speed rail project's 500-mile Phase 1 alignment and marked the first certification of a project section environmental document in the Northern California region and the first in the San Francisco Bay Area

### Authority and LA Metro Agree on Funding to **Improve Los Angeles Union Station**

In April, the California High-Speed Rail Authority Board of Directors approved a multimillion-dollar project management and funding agreement, allowing LA Metro to modernize the historic LA Union Station through the Link

Union Station (Link US) project. Stephanie Wiggins, CEO of LA Metro, which approved the same funding agreement in May, applauded the Authority's \$423.335 million commitment and affirmed Metro's commitment to working closely with the Authority to prepare LA Union Station for high-speed rail service. LA Metro and the Authority will now work to execute the funding agreement soon, with LA Metro returning to its Board in June to seek approval for the contract award. Environmental work is expected to be completed by Summer 2023 with early construction work starting that fall.

### **Design of Central Valley Stations Moves** Forward

There is exciting news for high-speed rail program progression in the Central Valley. In early May, the Authority issued a Request for Qualifications for station design for the high-speed rail stations that will be in Merced, Fresno, King/Tulare, and Bakersfield. Advancing design is key to advancing electrified high-speed rail service by the end of the decade.

### Working with the Community to Develop a **High-Speed Rail Station in Fresno**

The effort to deliver a station site at Fresno has officially launched, with the Authority conduct-

ing virtual meetings with multiple Fresno stakeholders late last year. To date, the Authority has hosted several virtual workshops and collected feedback from City of Fresno staff, non-profit organizations, business associations and community advocates. The intent of this outreach is create a station that honors the local preferences of the Fresno community

### What We've Heard So Far

Community members have highlighted the importance of appreciating Fresno's treasured and unique culture as part of the station design effort. The three key themes were:

- Encourage comfortable and quick pedestrian and bicycle connection between Downtown and Fresno's Chinatown;
- Highlight Chinatown's diversity and food culture; and
- Encourage many modes (transit, bikes, scooters, and walking) in the station area and ensure that parking is not a barrier to connectivity and access.

In addition to providing responses to ideas about the station and access, stakeholders also provided suggestions for activities that could ben-

that can occur at the construction site. It is important to have properly trained safety personnel on hand to monitor workers and if necessary provide first aid to any worker presenting symptoms of any of these illnesses. Symptoms can arise quickly so it's also important to train your workers so they also monitor themselves and their coworkers and empower them to notify a supervisor and take the appropriate steps if they feel they or a coworker is becoming ill.

Thousands of workers every year are affected by heat-related illnesses every year. Heatstroke can cause major damage to your organs including your heart, liver, and kidney. It can also cause damage to muscles, blood disorders, and death. Heat exhaustion can cause workers to be less alert which can result in other constructionrelated injuries. By taking the above precautions most heat-related illnesses can be prevented or caught in enough time to treat and avoid serious injury or death. Be sure to check back later in the week when we discuss tips for employers to protect their workers from suffering heat illness.

efit the community before high-speed rail train service initiates. Sites where "early activation" (or activities that deliver community benefits today) could occur were an important component of conversations to date. These early activities, many of which will be temporary, depend on local partnerships and community participation for successful implementation. Building activity in the short term helps us keep positive interest in and attention to our station site, stimulates economic activity, and helps build ridership.

On May 27, Authority staff attended the 559 Night Market in Fresno, asking the community what they would like to see by way of early activation as part of the eventual Fresno Station complex.

To that end, EEF will work to accelerate the growth of emerging, high-potential, diverse-owned businesses by making direct equity investments and increasing access to non-predatory sources of capital, including revenue-based financing and low-cost working capital.

"Every person, regardless of race or background, deserves an equal opportunity to realize their dreams. Unfortunately, in America the color of your skin and where you grew up are the most reliable predictors of economic success. We believe that investing in underrepresented entrepreneurs and diverse-owned businesses will be an efficient and effective means for forging a more inclusive economy, reducing the wealth and employment gaps, and strengthening our democracy," said Tyra A. According to a September 2020 Citi report, providing fair and equitable lending to Black entrepreneurs alone over the past 20 years would likely have resulted in the creation of an additional \$13 trillion in business revenue and potentially created 6.1 million jobs per year.
