# SBA's Economic Injury Disaster Loans and Advance Program Reopened to All Eligible Small Businesses and Non-Profits Impacted by COVID-19 Pandemic

To further meet the needs of U.S. small businesses and non-profits, the U.S. Small Business Administration reopened the Economic Injury Disaster Loan (EIDL) and EIDL Advance program portal to all eligible applicants experiencing economic impacts due to COVID-19 today.

"The SBA is strongly committed to working around the clock, providing dedicated emergency assistance to the small businesses and nonprofits that are facing economic disruption due to the COVID-19 impact. With the reopening of the EIDL assistance and EIDL Advance application portal to all new applicants, additional small businesses and non-profits will be able to receive these long-term, low interest loans and emergency grants - reducing the economic impacts for their businesses, employees and communities they support," said SBA Administrator Jovita Carranza. "Since EIDL assistance due to the pandemic first became available to small businesses located in every state and territory, SBA has worked to provide the greatest amount of emergency economic relief possible. To meet the unprecedented need, the SBA has made numerous improvements to the application and loan closing process, including deploying new technology and automated tools.

SBA's EIDL program offers long-term, low interest assistance for a small business or non-profit. These loans can provide vital economic support to help alleviate temporary loss of revenue. EIDL assistance can be used to cover payroll and inventory, pay debt or fund other expenses. Additionally, the EIDL Advance will provide up to \$10,000 (\$1,000 per employee) of emergency economic relief to businesses that are currently experiencing temporary difficulties, and these emergency grants do not have to be repaid.

# High-Speed Rail Continues Building California and Celebrates Creating 4,000 Construction Jobs

The California High-Speed Rail Authority (Authority) announced more than 4,000 construction jobs have been created across 119 miles of the high-speed rail project. More than 73% of the workers dispatched to various construction sites reported living within the Central Valley. The Authority and its contractors have worked diligently to continue construction during the coronavirus pandemic and ensure California's workforce remains employed and contributing to the local economy.

The Authority is proud to partner with the local trade unions, the State Building and Construction Trades Council and the Fresno Regional Workforce Development Board as well as continued work alongside our carpenters, electricians, laborers, ironworkers, operating engineers, and many others who are building California and the nation's first high-speed rail system.

"I've been in this trade for about 10 years and have had to travel 5-6 hours to get to work," said carpenter foreman, Matt Jimenez. "I feel blessed having a stable job near my home in Visalia, especially with everything going on in our country and seeing friends and family out of work right now. I just feel blessed."

"We have expanded the work in the Central Valley and tripled the number of workers dispatched to the job sites over the course of the last year," said Brian Kelly, CEO of the California High-Speed Rail Authority. "This is the strength of our program — stable work, stable paycheck, stable families and a more stable future for California."

"The 4,000th worker on site building California's high-speed rail project really is a great milestone for not only the Authority but for the local economies and local workforce. The vast majority of these workers are from counties in the Central Valley. That is thousands of workers and hundreds of apprentices on the 119-mile long construction site that are building a critically needed third mode of mass transit that is clean, fast and will relieve congestion our state's

highways, freeways and airports," said Robbie Hunter, President of the State Building and Construction Trades Council of California. "This is not only an infrastructure project that is driving our economy, but it is absolutely necessary to meet the needs of the growing population of California while protecting the environment."

Since the beginning of the high-speed rail project, the Authority and the project's design-builders have worked to ensure jobs created on the project benefit disadvantaged areas through the execution of a Community Benefits Agreement. The agreement includes a Targeted Worker Program that requires 30% of all project work hours be performed by individuals who come from disadvantaged communities where household income ranges from \$32,000 to \$40,000 annually.

Out of the 4,000 workers dispatched to the project, 62 reported living in Merced County, 223 reported living in Madera County, 1,969 living in Fresno County, 121 living in Kings County, 395

living in Tulare County, and 572 living in Kern County as of May 31, 2020.

The Authority currently has 119 miles under construction within three construction packages. Design-builder contractors Tutor-Perini/Zachry/Parsons, Dragados-Flatiron/Joint Venture, and California Rail Builders have more than 32 active construction sites with more expected to open in the coming months. This work totals more than \$4.8 billion in construction commitments

# SBA's Economic Injury Disaster Loans and Advance Program

- SBA's COVID-19 Economic Injury Disaster Loan (EIDL) and EIDL Advance
- The SBA is offering low interest federal disaster loans for working capital to small businesses and non-profit organizations that are suffering substantial economic injury as a result of COVID-19 in all U.S. states, Washington D.C., and territories.
- These loans may be used to pay debts, payroll, accounts payable and other bills that can't be paid because of the disaster's impact, and that are not already covered by a Paycheck Protection Program loan. The interest rate is 3.75% for small businesses. The interest rate for non-profits is 2.75%.
- To keep payments affordable for small businesses, SBA offers loans with long repayment terms, up to a maximum of 30 years. Plus, the first payment is deferred for one year
- In addition, small businesses and nonprofits may request, as part of their loan application, an EIDL Advance of up to \$10,000. The EIDL Advance is designed to provide emergency economic relief to businesses that are currently experiencing a temporary loss of revenue. This advance will not have to be repaid, and small businesses may receive an advance even if they are not approved for a loan.
- SBA's EIDL and EIDL Advance are just one piece of the expanded focus of the federal government's coordinated response.
- The SBA is also assisting small businesses and non-profits with access to the federal forgivable loan program, the Paycheck Protection Program, which is currently accepting applications until June 30, 2020.

Nationally, HHS awarded over \$107 million across 45 states and U.S. territories to improve the quality, distribution and diversity of health professionals serving in communities across the country.

"Supporting a strong health workforce is essential to improving health in rural and underserved communities," said HHS Secretary Alex Azar. "We've seen stark disparities in health and healthcare access contribute to the burden of the COVID-19 pandemic. As part of the Trump Administration's work to address health disparities, these grants provide support for the training of healthcare workers in rural and underserved communities.'

These programs provide financial and professional support to physicians, faculty, dentists, nurses and students as they pursue careers in health care settings. Awardees will be able to develop and retain clinicians in high-need areas to meet the vital health needs of the most disadvantaged communities.

"Access to a robust and high-quality health care workforce is essential for the prevention and treatment of chronic diseases in underserved areas," said HRSA Administrator Tom Engels. "These awards help meet the demand for health care from individuals who urgently need it.'

#### Nationally these awards support the following programs:


- Nurse Faculty Loan Program (NFLP) -(\$26.7 million, 81 awards) The NFLP expands nursing faculty nationwide. Loans are provided to nursing students who receive up to 85% loan cancellation in exchange for full-time post-graduate employment as nurse faculty.

# **Best Small Business Loans for Minority Entrepreneurs**

While minorities own 29% of all businesses, minority business owners are three times more likely to be declined for a loan than non-minority owners, according to the U.S. Minority Business Development Agency. If those minority business owners are approved, they typically pay higher interest rates on lower loan amounts than do non-minorities. To help minority entrepreneurs get access to capital, we've researched and evaluated a variety of loan and financing options below

#### **Best Business Loans for Bad Credit**

When it comes to getting a business loan, your personal credit matters. However, even if your personal credit history isn't great, there are still funding options available.

#### Nonprofit Lenders and Microlenders

There are two Small Business Administration (SBA) loan programs that we think can be a good fit for minority business owners with below average credit: the microloan program and the Community Advantage program. Loans from those programs do not come from the SBA directly; rather, the Administration guarantees a portion of each loan made by nonprofit and community partners across the country. The goal of these programs is to provide underserved business owners-such as women, minorities and those in low-income communities-access to capital. In fact, many of these organizations, like the Oregon Association of Minority Entrepreneurs, focus their outreach and lending efforts specifically on minority small business owners.

Under the microloan program, business owners can borrow up to \$50,000 for as long as six years. Interest rates on these loans generally fall between 8% and 13%. While each microlender can set their own eligibility criteria, we have found that many are willing to work with borrowers who have personal credit scores that are under 630. For example, Accion, one of the largest SBA microlenders, requires only a 575 credit score to apply for many of its loan products.

The other program, Community Advantage (CA), offers loan amounts of up to \$250,000, and has the same mission-based lending directive as the microloan program. The maximum interest rate you will pay on a CA loan is 6% above the Prime Rate, which is 4.25%, as of this writing. The SBA also promises a turnaround time of five to 10 days on their credit decision,

so the application process can be quicker than that of a standard SBA loan.

#### **Best Business Loans for Good Credit**

More options exist for borrowers with excellent personal and business credit history. Nevertheless, we recommend borrowers consider their bank or credit union first, as it generally offers the lowest rates, before turning to an alternative lender.

#### **Bank and SBA Loans**

Business owners with strong credentials should make their bank their first stop when they need financing. While bank loans are more difficult to obtain and take longer to process, they offer the lowest interest rates, longest terms and largest loan amounts. It pays to develop a relationship with your banker, as that should increase the likelihood you'll be approved with better terms or nonstandard exceptions to your loans. If you don't already have a bank, we recommend considering a local bank or credit union over a national bank, as regional institutions generally have a greater interest in lending to and working with entrepreneurs in their communities.

Your bank may also make SBA loans, which are another excellent source of funding for small business owners, especially if you are unable

to meet your bank's standard lending requirements. Because the SBA guarantees a portion of the loan, these loans are a little easier to qualify for than a conventional loan. However, they are harder to qualify for than an online loan. Most business owners opt to get a standard SBA 7(a) loan, which can be used for almost any purpose, but the 504 loan program is another option for borrowers who plan to purchase real estate or long-term machinery and equipment.

#### **Best Startup Loans**

The two SBA programs we mentioned above (microloans and Community Advantage) are also open to new businesses and startups. We recommend business owners try these options before considering the alternatives listed below.

Bank loans: While it is possible to get a bank loan for a startup, it's often exceedingly difficult. For many banks to even consider your application, you'll need to have strong industry experience, stellar credit history, a solid business plan, enough assets to put up as collateral, and sufficient cash to use as a down payment.
