Federal Government Achieves Small Business Contracting Goal for Sixth Consecutive Year

Record-Breaking \$120 Billion to Small Businesses

The U.S. Small Business Administration announced that the federal government exceeded its small business federal contracting goal for the sixth consecutive year, awarding 25.05 percent in federal contract dollars to small businesses totaling \$120.8 billion, an increase from the previous fiscal year of nearly \$15 billion. The Fiscal Year 2018 Small Business Federal Procurement Scorecard marks the first time more than \$120 billion in prime contracts has been awarded to small businesses. Overall, the federal government earned an "A" on this year's governmentwide scorecard.

"I'm happy to report that for the first time in history the federal government has awarded more than \$120 billion in federal contracts and marked the sixth year in a row exceeding our target milestones for small businesses," said Acting Administrator Chris Pilkerton. "Through these businesses, we strengthen the economy, and support the American workforce in the process. For example, the federal prime and subcontract awarded to small businesses in FY18 equate to more than one million jobs created. Every contract that gets in the hands of a small business is a win-win for our nation, the entrepreneurs, their employees and the communities they support all across the country."

FY2018 Small Business Federal Procurement Scorecard:

The individual agency scorecards released today by the SBA, as well as a detailed explanation of the methodology, is available online.

- In FY18, the federal government exceeded the service-disabled veteran-owned small business and small disadvantaged business goals and the prime contract dollar awards in all small business categories increased from previous years.
- The federal government also exceeded its subcontract goals for awards to small businesses and women-owned small businesses, and awarded more than \$79 billion in subcontracts to all small businesses.

The little experience I have had in addressing public meetings, in country schoolhouses, avails me nothing on the present occasion.


The papers and placards say, that I am to deliver a 4th [of] July oration. This certainly sounds large, and out of the common way, for it is true that I have often had the privilege to speak in

A Public Policy

Avoiding Burnout While Fighting for Racial Equity

Although I didn't grow up in a particularly political household, I entered college a wide-eyed student ready to understand how U.S. systems of power shape life and culture here and abroad. Taking coursework on inequality in the U.S. my first year of college allowed me to articulate my struggles with class, race, and sexuality, offering me the clarity and language to truly express my hopes and doubts about my future. It also opened my eyes to the power of policy to improve the lives of folks at the margins. Since then I have dedicated my time towards ensuring any corrective policy work, especially dealing with racial equity, doesn't leave queer and trans people of color behind - and, like lots of people doing racial equity work, found myself having to learn to avoid burnout.

My work supporting queer and trans folks of color led me to Berkeley's Public Policy and International Affairs Junior Summer Institute, where I cultivated public policy skills and also

got to learn about several policy organizations across the U.S.

Although I entered the program planning to go directly to law school after I graduated, I was swept away in particular by a presentation on the Greenlining Institute. As Danielle Beavers, Greenlining's Director of Diversity and Inclusion, shared her experiences with the organization. I envisioned a clearer path for myself. The organization's mission, to bring economic equity to low-income communities of color, combined with the Leadership Academy's trainings and mentorship, had made her better advocate and a better leader. After learning about her team's work, to create sustainable jobs for low-income communities of color, I was sold. When the Academy offered me a Fellowship, I put my plans for law school on hold, choosing to come to Greenlining as the Diversity and Inclusion Fellow.

Alongside the D&I team's external work, we look inward as well. This year I have helped lead the organization's workplace equity and inclusion initiative. We seek to ensure every staff member feels empowered in their role and that our organization's culture, whether it be hiring practices or the trainings offered to staff, reflects our values and moves our racial equity mission forward. As my time in the Fellowship nears its end, I'm left reflecting on the tools that supported me through this work, taking me back to my first lessons in the Academy and how those early lessons helped me learn to avoid the burnout that's so common in social justice work.

In the first weeks of the Fellowship, Fellows have many conversations on life as a professional of color, the passions that bring us to racial equity work, and how to sustain ourselves along the way. This marked the first time I had an explicit conversation touching on burnout in the nonprofit world that centered the POC experience. With the Academy's support and a system for accountability, I crafted a personalized sustainability plan for the year. As the year went on I incorporated mindfulness exercises into my daily life, like 10 minute walks around downtown Oakland, and began attending therapy for stress management. I acknowledged that, like many racial justice advocates, the work I do is deeply personal and that, truthfully, I allowed my work to shape my self-worth. When I thought about how I wanted to develop this year, shifting this behavior became a priority.

At first this felt like an uphill battle. More than anything, challenging the ways I'd been conditioned to work was unsurprisingly tough, but I owed it to myself to try. By putting into practice my early lessons from the Academy, I've become deeply patient with myself and a more confident and empowered racial justice advocate. In my final weeks of the Fellowship, this empowerment leaves me more determined to continue the fight for communities of color. More than anything, I now know if we are to see equity though for our communities, we must learn to sustain ourselves and not get trapped by burnout, especially in the workplace.

Paperwork: Dig Out From Under

Is your desk turning into your personal nightmare closet? Does the overflow from your inbasket see he across your desk, flood onto the credenza and cascade from there to the floor? Do you dream of being buried in an avalanche of inquiries, invoices, reports and journals?

One challenge we all face is coping with the mass of paper that pours across our desks. It becomes increasingly difficult to find things, keep track of projects or work comfortably, when the stacks and piles turn into clutter. If you do not

move that paper on, you may never see your desktop again.

The solution is to take control: Get organized up front, maintain that organization and create a filing system that works. Ensuring a smooth paper flow means removing the stacks, rearranging and color-coding files and learning to handle the in- and out-baskets quickly and effectively.

The In Basket

Ideally, the in-basket is the one place other people put material they want you to see. It is an essential tool, but you have to learn to use it for what it is good for. Do not try to transform it into a filing system, a bulletin board or a nagging reminder.

Your in-basket isn't working if:

- You don't have one.
- You have one, but even though you sort through it many times a day, the stack never gets any smaller.
- You only touch your in-basket once a week.

- The entire top of your desk is the in-basket.
- Your coworkers know the only way to make sure you see something is to put it on your chair.

Touch it Once

You should sort through and handle the papers in your in-basket twice a day. Establish a To-do list and a Reading file. With these two items it should take no more than 15 minutes to empty your in-basket. Make a decision on every piece of paper and put it in its proper location. Not at the bottom of the basket.

Papers relating to a project you are currently working on should be scanned and put in the project file. The latest in-house periodical, a newsletter, long memo, etc., all go in the Reading file. A cartoon from a friend goes in your Personal file. Something requiring your signature should be signed immediately and put in the out-basket. An item you want to discuss with a coworker goes in a file with that person's name on it. Throw away the draft of the third revision that supersedes the second revision which is to be followed by the semifinal copy.

To-do List. Handling the in-basket means sorting, filing, delegating and tracking its contents. It does not mean you have necessarily completed every item. Projects that require further attention from you need a temporary home until you have the time to work on them. Each time you file a piece of paper that requires additional action on your part, make a note on your To-do list. This eliminates the fear that once it is filed away and out of sight, it will be permanently forgotten.

Reading File. Those items that need more than a couple of minutes to read should go into a Reading folder. If you take the time to read everything when it first arrives, you will never get through your in-basket. Scan and save only the material that you are likely to need. Scheduling 30 minutes twice a week should be enough to keep you current and the reading stack down. Take reading along to look over while you wait for appointments or while commuting or traveling. When your reading file is full sort the oldest portion with this question in mind, "How likely am I to read this or refer to the information in the near

SBA Introduces Online Tutorials for Small Businesses Seeking Federal R&D Funding

The U.S. Small Business Administration released its highly anticipated Small Business Innovation Research (SBIR) online tutorials to help small businesses navigate the SBIR program. The site provides users with a mobile-compatible site to learn about the program through a combination of videos and text. This platform will provide accessible program information and training resources to underrepresented areas. There is no registration or fee required and the courses are open to all.

"We are excited to introduce these tutorials. We know there are many small businesses in rural communities as well as young entrepreneurs that are unaware of this amazing program," said Mark Walsh, SBA's Associate Administrator for Investment and Innovation. "SBA has pulled together resources from across the federal government, providing them in a format easily accessible on mobile devices, while allowing users to select just the information they need."

The SBIR and Small Business Technology Transfer (STTR) programs, also called "America's Seed Fund," inject \$2.5 billion every year into small, innovative and nimble firms across the nation. The mission of each program is to support R&D in technical areas that align with American priorities, and build a strong national economy to meet the pressing needs of the federal government. Currently, there are 11 federal agencies with SBIR/STTR programs. "This new source should be invaluable to entrepreneurs looking to take advantage of our SBIR and STTR programs, which are the largest source of non-dilutive early stage R&D dollars available to small businesses," Walsh added. "Further, these courses will help the SBA provide timely and accurate information about the programs to our entrepreneurs regardless of their geographic location or ability to attend one of our conferences or SBIR Road Tour events."

With 52 modules housed within 10 courses, the platform addresses topics relevant to small businesses that are new to the SBIR/STTR programs and companies that have previously received SBIR funding. Topics include:

- Agency differences
 - Registration requirements
 - SBIR Data Rights
- Accounting and
 - How to find partners.
- More topics are being developed for future tutorials. Tools, resources, links and quizzes accompany each tutorial to help users navigate the process of applying for and winning federal awards.

SBA continues to collaborate with federal agencies to expand small business opportunities for small business contractors to compete and win federal contracts. The FY2018 scorecard analyzed the prime contracting and subcontracting performance, and other contributing factors which resulted in an overall "A" grade for the federal government. Eight agencies received A+, 12 received a grade of "A", three received a "B" grade and one received a "C" grade.

Small Business Federal Procurement Scorecard Overview:

The annual Procurement Scorecard is an assessment tool to: (1) measure how well federal agencies reach their small business and socioeconomic prime contracting and subcontracting goals; (2) provide accurate and transparent contracting data and (3) report agency-specific progress. The prime and subcontracting component goals include goals for small businesses, small businesses owned by women, small disadvantaged businesses, service-disabled veteranowned small businesses, and small businesses

located in Historically Underutilized Business Zones (HUBZones).

Every year, the SBA works with each agency to set their prime and subcontracting goals and their performance is based on the agreed upon goals. Each federal agency has a different small business contracting goal, determined annually in consultation with the SBA. The SBA ensures that the sum total of all of the goals exceed the 23 percent target for the federal government as well as the socio-economic goals established by law.

While each federal agency is responsible for ensuring the quality of its own contracting data, SBA conducts additional analyses to help agencies identify potential data anomalies. As part of its ongoing data quality efforts, the SBA works with federal agency procurement staff to provide analysis and tools to facilitate review of data, implement improvements to procurement systems and conduct training to improve accuracy.

"What to the Slave Is the Fourth of July?"

this beautiful Hall, and to address many who now honor me with their presence. But neither their familiar faces, nor the perfect gage I think I have of Corinthian Hall, seems to free me from embarrassment.

The fact is, ladies and gentlemen, the distance between this platform and the slave plantation, from which I escaped, is considerable—and the difficulties to be overcome in getting from the latter to the former, are by no means slight. That I am here to-day is, to me, a matter of astonishment as well as of gratitude. You will not, therefore, be surprised, if in what I have to say. I evince no elaborate preparation, nor grace my speech with any high sounding exordium. With little experience and with less learning, I have been able to throw my thoughts hastily and imperfectly together; and trusting to your patient and generous indulgence, I will proceed to lay them before you.

This, for the purpose of this celebration, is the 4th of July. It is the birthday of your National Independence, and of your political freedom. This, to you, is what the Passover was to the emancipated people of God. It carries your minds back to the day, and to the act of your great deliverance; and to the signs, and to the wonders, associated with that act, and that day. This celebration also marks the beginning of another year of your national life; and reminds you that the Republic of America is now 76 years old. I am glad, fellow-citizens, that your nation is so young.

Seventy-six years, though a good old age for a man, is but a mere speck in the life of a nation. Three score years and ten is the allotted time for individual men; but nations number their years by thousands. According to this fact, you are, even now, only in the beginning of your national career, still lingering in the period of childhood. I repeat, I am glad this is so. There is hope in the thought, and hope is much needed, under the dark clouds which lower above the horizon. The eye of the reformer is met with angry flashes, portending disastrous times; but his heart may well beat lighter at the thought that America is young, and that she is still in the impressible stage of her existence. May he not hope that high lessons of wisdom, of justice and of truth, will yet give direction to her destiny? Were the nation older, the patriot's heart might be sadder, and the reformer's brow heavier. Its future might be shrouded in gloom, and the hope of its prophets go out in sorrow. There is consolation in the thought that America is young. Great streams are not easily turned from channels, worn deep in the course of ages. They may sometimes rise in quiet and stately majesty, and inundate the land, refreshing and fertilizing the earth with their mysterious properties. They may also rise in wrath and fury, and bear away, on their angry waves, the accumulated wealth of years of toil and hardship. They, however, gradually flow back to the same old channel and flow on as serenely as ever. But, while the river may not be turned aside, it may dry up, and leave nothing behind but the withered branch, and the unsightly rock, to howl in the abyss-sweeping wind, the sad tale of departed glory. As with rivers so with nations

Fellow-citizens, I shall not presume to dwell at length on the associations that cluster about this day. The simple story of it is that, 76 years ago, the people of this country were British subjects. The style and title of your "sovereign people" (in which you now glory) was not then born. You were under the British Crown . Your fathers esteemed the English Government as the home government; and England as the fatherland. This home government, you know, although a considerable distance from your home, did, in the exercise of its parental prerogatives, impose upon its colonial children, such restraints, burdens and limitations, as, in its mature judgment, it deemed wise, right and proper.

But, your fathers, who had not adopted the fashionable idea of this day, of the infallibility of government, and the absolute character of its acts, presumed to differ from the home government in respect to the wisdom and the justice of some of those burdens and restraints. They went so far in their excitement as to pronounce the measures of government unjust, unreasonable, and oppressive, and altogether such as ought not to be quietly submitted to. I scarcely need say, fellow-citizens, that my opinion of those measures fully accords with that of your fathers. Such a declaration of agreement on my part would not be worth much to anybody. It would, certainly, prove nothing, as to what part I might have taken, had I lived during the great controversy of 1776. To say now that America was right, and England wrong, is exceedingly easy. To side with the right, against the wrong, with the weak against the strong, and with the oppressed against the oppressor! here lies the merit, and the one which, of all others, seems unfashionable in our day. The cause of liberty may be stabbed by the men who glory in the deeds of your fathers. But, to proceed.

Feeling themselves harshly and unjustly treated by the home government, your fathers, like men of honesty, and men of spirit, earnestly sought redress. They petitioned and remonstrated; they did so in a decorous, respectful, and loyal manner. Their conduct was wholly unexceptionable. This, however, did not answer the purpose. They saw themselves treated with sovereign indifference, coldness and scorn. Yet they persevered. They were not the men to look back.
