## Why prequalification tech is a must for choosing subcontractors today

Choosing subcontractors for your projects is a lot like choosing a mate. You're going to go through a lot together. lenges in reaching global targets for gender equity, homelessness, housing, climate action, education, economic growth, and more.

Global development begins with local leadership, and Los Angeles is proud to take the reins in translating the Sustainable Development Goals into real progress in our communities," said Mayor Garcetti. "With this report, we are holding ourselves accountable for our promises to build a stronger city—and showing the world what we do every day to

At a time when the value of international agreements is being questioned, today's report summarizes the City's steps toward achieving the SDGs and outlines how Los Angeles has mapped policy initiatives to achieve those goals. Hilton Foundation and the Mayor's Fund for Los Angeles, Mayor Garcetti announced that Los Angeles would work to localize the goals and make significant progress ahead of the 2028 Olympic and Paralympic Games. Since then, the City has partnered with students and faculty from Occidental College, UCLA, USC, and Arizona State University to capture data and align current plans with the SDGs.

"Issues such as localization and building inclusive communities are important to us as a Foundation, and we are excited to see how the Mayor has built a coalition of university partners, civil society organizations, and other cities to advance the Global Goals," said Shaheen Kassim-Lakha, Director of Strategic Partnerships at the Hilton Foundation.

## Surviving Employee Evaluations

There are very few managers or supervisors who enjoy conducting employee evaluations. The entire process is fraught with anxiety, and they are often delayed until the last minute. In fact, missing the scheduled review date entirely is not uncommon. Annual reviews need not be a heavy weight around your neck. The secret is to manage your interactions with the employee throughout the year. This will provide the foundation for your formal discussion.

#### Before

Throughout the year, discuss performance issues as they occur. This helps the employee understand your concerns, and offers an opportunity to make changes. During these regular mini-reviews, take notes; you will then have a running track record of performance from which you can draw the necessary information for the formal review. The content of an evaluation should never come as a surprise to an employee. The conversation should be more of a summary discussion and never be perceived as a trap.

Reviews take a lot of focus, attention and emotional energy. Try to avoid scheduling more than two on the same day. You don't want to get burned out on the process. If the review is going to be uncomfortable or highly emotional—i.e. you are placing the employee on a probationary status, schedule the discussion for a Friday. That gives the person the weekend to really think about the situation.

#### **During**

Give yourself enough time to conduct the review without being rushed. Hold all your calls and do not allow interruptions. The review needs to be thorough. Avoid superficial or tangential issues because that will cause two problems. One, you will not get to the underlying concerns and, two, you risk the employee's misunderstanding the significance of the review process. Hone in on the important and avoid being sidetracked by transient or less critical issues.

Unless you are discussing a pattern of behavior with the view to making recommendations for change, do not dwell on past mistakes. Try to determine the reasons behind a series of misjudgments so that the underlying problem can be identified and addressed. A conversation outlining every date that the person was late to work is less useful than a review of the policy about tardiness, a discussion about the cause, and an agreement reached about what will happen in the future to prevent the tardiness.

People like to feel good about themselves and hear about what they do well. Although evaluations are opportunities to discuss difficulties, problems, or poor performance, they should be balanced with the positives so that the employee has a well-rounded view of his or her performance.

Be cautious about comparing one person to your star performer. That can backfire. Comparisons can set up internal rivalries. Asking a high performer to train another on a specific task is different from a "why can't you be more like her" comparison.

Reviews are not debates or arguments. If you have made a judgment and it is well-reasoned, stick by it and do not let the conversation degenerate. Resist the tendency to be defensive about your judgments. Back up your statements with research and documentation. If the two of you cannot come to agreement, then there are other steps you can take, including referring that employee to human resources.

## 3 Ways to Get Working Capital for Your Business

Alternative lenders use various types of data during a review such as revenue data from business checking and other popular services.

Business credit cards are a perfect example of a revolving line of credit. With a business credit card, you can decide to either pay off your balance in full each month or make the minimum monthly payment. Before you apply for a business credit card be sure to review our guidelines for success.

There's no single best funding option for working capital. However, let these options listed here provide you insight and guidance as to what is available. If you need access to working capital fast and you don't meet bank qualifications, consider one of these options as a possible solution.

## Why prequalification tech is a must

discuss scope and schedule, you have a higher chance of success and can ask better questions. This approach ultimately saves everyone time and wasted effort.

#### Understanding what causes relationships to fail

Most importantly, knowing and tracking all this information allows you to make decisions that lessen the chance that a sub will fail and affect your project's success. What causes subs to fail? Why would your beautiful relationship fall apart? Subcontractor default data shows financial issues, labor issues, and quality issues top the list. And, unfortunately, as with dating, we often cause the problems ourselves.

Financially, subs don't usually starve to death; they bite off more than they can chew. This can be a result of your level of comfort with their past work. If a sub always does projects for you in the \$1 mil-

lion range, and you give them a \$2 million job because they did so well, you just might be "loving them to death." I have seen it over and over again. Subs' project sizes should be carefully grown at a measured rate. Your financial analysis can prevent overloading them if you compare your project stats against the subs' past projects and use that information to make calculated decisions.

Technology makes it easier to sort through and assess all these details. From an overall perspective, the process is not that different from the traditional, paper-based subcontractor selection process. Safety still looks at safety, finance still looks at financials, etc. The difference is in the ability to search and crunch a lot of data make decisions based on all factors, and increase the ease of the workflow. Instead of passing a file around to the different parties, everyone who needs to sign off can do their diligence at once and easily document their conclusions

#### Overcome selection bias by getting a fuller picture

Another important function of prequalification is that it can help you overcome the biases we all have towards the familiar. Interestingly, default claims data supports that subs in business over 20 years make up the largest proportion of sub defaults, but those are the very subs your teams trust the most

There are a lot of factors that add up to this phenomenon - succession, growth, technology - but the takeaway is that just because a sub was at the top of their game even just last year does not mean they are up to the job you are bidding now. Past experience is important to consider, but it has to be viewed through the lens of current data and fit for the work you are considering awarding to them. This is the kind of analysis that modern prequalification methods empower: the ability to look at a sub holistically, including past performance, present financial standing, workforce, and typical project size. It's very challenging to keep all this coordinated absent a technology solution.

#### Wrap-up

At the end of the day, you are the one bearing the consequences of these decisions. Sometimes a potential partner just isn't quite right — for you — right now. Just because they're not right for a particular project does not mean they aren't a very fine sub with many sterling qualities and maybe even a perfect fit for your next project, or the project down the street. You need to let them go pursue those other opportunities. The old saw says "If you love them, let them go." Today, I'd say that sometimes the kindest thing you can do for a subcontractor is let them go.

## Where Do College Graduates Go For Jobs?

By Andrew Foote

Thinking about college? You may want to consider where you will likely locate to land your first job after you graduate and in what industry.

A good way to do this? Check out the U.S. Census Bureau's Post-Secondary Employment Outcomes (PSEO), which shows where college graduates get jobs and in what industries.

On top of that, it does it by institution and type of degree.

The data address a major gap in education statistics by providing a much clearer picture of how graduates transition from school to employment.

The PSEO project tabulates employment flows and earnings outcomes by institution, degree level, and degree field, and provides counts of employment by employer industry sector and Census Division.

PSEO does this by linking university transcript data to the Census Bureau's Longitudinal Employer-Household Dynamics (LEHD) records. Those records list job histories covered by unemployment insurance by employer, which is

then linked to industry and location information on the employers.

"Up until now, individual states could only measure earnings and employment outcomes for persons who worked in the same state where they were educated," said John Abowd, the Census Bureau's chief scientist and associate director for Research and Methodology.

"Thanks to this pilot," he said, "states, universities, and prospective students have the opportunity to see employment outcomes by program of study, by region and industry."

#### What PSEO Offers

Currently, the PSEO statistics include data from the University of Texas System, Colorado Department of Higher Education, University of Michigan-Ann Arbor, and University of Wisconsin-Madison.

The figures below show where graduates with bachelor's degrees from four flagship institutions work by Census Division.

#### Do Graduates Find Jobs Nearby?

There are significant differences in the geo-

graphic dispersion of employment for graduates.

UT-Austin, for example, sees most of its students stay in the state, while University of Michigan graduates disperse across a wide geographic area

University of Colorado Boulder and UW-Madison are somewhere in the middle of these two

First Post-Graduation Jobs Don't Always Match Field of Study

In addition to geographic dispersion, PSEO allows users to see the industry sector of employment for graduates.

The graphs below look at industry employment for all bachelor's recipients in Colorado in three specific fields of study.

It's clear that graduates in communications are more likely to land jobs in professional services, information and retail industries while social science graduates are more likely to end up in education and health.

Business majors are heavily concentrated in finance/insurance and professional services. Important to the analysis of career paths, PSEO also measures how specific majors transition into highly-related fields.

The figure below measures the share of graduates from health programs who enter the health industry sector one year after graduation.


Surprisingly, individuals with master's degrees in health are much less likely to end up working in the health industry than those with shorterterm certificate and associates degrees.


Instead, master's graduates in health also end up in Education (22.2%) and Public Administration (7.2%).

All these tabulations are available on the PSEO website for download, as well as additional documentation. The Census Bureau is currently developing a data visualization tool for the employment flows data, which is scheduled for release in the coming months.

Your goal in a review is to solve problems, coach development, and provide support and encouragement to enable the person to excel. During the problem-solving phase, it is not your job to come up with all of the possible solutions. Involve the employee in identifying options so that he or she takes ownership for the strategies. This not only saves you time and energy, but it reduces the likelihood of that person coming back saying, "Well, I never thought that idea would work anyway." In the same vain, avoid like the plague any discussions that start with, "If I were you..."

#### After

Transfer pertinent information from your notes. Note any commitment dates on your calendar. Write up a summary of the discussion for later reference. It never hurts to review the interaction to determine what, if anything, you would do differently the next time. If you view performance evaluations as more of a summary of a series of interactions that have taken place throughout the year, they need not be onerous. Remember, the end result should not be simply checking a task off your to-do list but rather, improved performance from someone you work closely with and depend upon.
