

# Empowering the Next Generation of Leaders: Centering Tech Equity in Workforce Development

The explosion of technology jobs over the past decade has radically altered the career landscape—for better and for worse. For this generation of job-seekers, the tech industry offers a new, relatively accessible path for building the kind of wealth that was previously only available to a privileged few. But as the tech industry leverages the massive talent pool of computer programmers and engineers to expand into lucrative businesses like data mining, targeted ads, and military IT infrastructure, tech companies can perpetuate harm and violence on the same communities that make up their workforces.

For example, a child of refugees from the Vietnam War, looking for economic stability, studies computer vision and ends up working in military drone development that could be used to target other communities during war. Someone lands a job at Amazon, monitoring worker efficiency while their high school classmate working in the warehouse develops chronic pain from overwork. A market optimization developer unwittingly helps prototype clickbait messaging that contributes to disinformation that prevents their own extended family from getting the

COVID-19 vaccine or a fair home loan.

- Who do we hold accountable for the harmful impacts that tech companies inflict on our own communities, when for many, a job in tech is an economic lifeline?
- How can we name the ongoing destabilization and surveillance of our communities, while recognizing that these jobs are opportunities for economic prosperity that were previously out of reach?

Silicon Valley players and community partners alike have sought to rectify community harms by investing in programs that better prepare folks for tech industry jobs. These programs promise lucrative job prospects as a software engineer, yet ignore the myriad barriers the tech industry has created including discrimination and displacement. Additional funding for these programs continues to proliferate, including through the Infrastructure Investment and Jobs Act (IIJA), which allocates nearly \$2.75 billion dollars to digital inclusion efforts, including digital device distribution and digital literacy training.

As these programs grow, bringing more and more people into the tech industry, we must imagine more than the promise of employment at the expense of our communities.

## Black Business Month – August 2022

Black Business Month is celebrated in August — it’s a time to acknowledge and appreciate black-owned businesses across the nation and all that they represent in the country’s continual striving for diversity and equality. Denise Moore, CEO of the Black Business Alliance in Peoria, Illinois, has this to say about the importance of Black Business month: “Black Business Month is exciting because it gives us an opportunity to focus on a community that is far too often under-

represented when it comes to access to capital and opportunities to build wealth.”

When we celebrate the contribution of black business owners and entrepreneurs, it pays homage to them and their legacies, especially since celebrating this month recognizes the importance of black-owned businesses when it comes to contributing to the nation’s economy as well. Approximately 10% of all American businesses are black-owned, and if we look at what statistics say about minority-owned businesses, about 30% of these would belong to black business

owners. The primary sectors in which black-owned businesses operate include health care, social work, repair and maintenance, beauty salons, restaurants, and more. Black businesses across the country are booming and on the rise, with Washington D.C. having the highest ratio of black-owned businesses, a whopping 28%. These business also have an important role to play towards supporting student and education by giving funds towards scholarship of African American Students, here is a list of numerous scholarship provided to African-American’s.

### History of Black Business Month

he history of Black Business Month can be traced back to the year 2004, when engineering entrepreneur Frederick E. Jordan partnered with the president and executive editor of the scholarly publishing company eAccess Corp,’ John William Templeton, to start this annual event. The intention of the pair was to “drive the policy agenda affecting the 2.6 million African-American businesses,” in order to highlight and empower Black business owners all over, especially given the unique challenges faced by minority business owners. This stemmed from Jordan’s

own personal experience of the struggle to gain financial backing and funding when he began his own firm in San Francisco in 1969.

Today, he is the successful owner of F. E. Jordan Associates Inc., a company that has international reach, but it also led him to realize that the odds are still not in favor of Black entrepreneurship. To push for equity in the business spaces and to celebrate those who are thriving despite the challenges, Black Business Month is a month-long celebration of entrepreneurs who beat the odds.

Since the late 1700s, both free and enslaved Black people began to open their own small businesses, from barbershops to tobacco shops and shoemaking. As emancipation grew, so did the establishment of Black-owned businesses, and this led to the period between 1900 — 1930 being labeled as the ‘golden age’ of Black-owned businesses. Segregation saw entire districts becoming Black-owned, such as Black Wall Street in Tulsa, Oklahoma.

In 1915, with the establishment of The National Negro Business League, there was widespread

# PUBLIC WORKS: A PRIMER

Nearly every construction contractor reading this column should have more than a passing familiarity with the terms ‘public works’ and ‘prevailing wages.’ The two go hand in hand and it has been that way since the federal government instituted its Davis Bacon Act and, later, the Davis Bacon & Related Acts, in the late 1930s. In fact, the more seasoned contractors call California’s prevailing wage laws Baby Davis Bacon or Little Davis Bacon.

As seems typical of efforts mangled with the imprimatur of “the government,” public works contracting can be as simple an endeavor as “pushing a car uphill with a rope” (to paraphrase late comedienne Moms Mabley opining on another subject).

Indeed, Lloyd Aubry, Jr., then director of the state’s Department of Industrial Relations (DIR), wrote in 1992, “California’s prevailing wage laws represent a complicated system for ensuring that the ability to obtain a public works contract is not based on paying lower wage rates than a competitor. Under the law, all bidders are expected to use the same wage rates. However, implementation and enforcement of these laws is complex...”

From the perspective of a contractor, and I have been one, the very thought of executing an aleatory contract is painful beyond imagining. Many contractors, particularly the small and micro contractors, “just seek a day’s wages for a day’s work,” as my dad, Raymond Cooks Sr., often put it.

Dad, who left his beloved Marine Corps in Oceanside, Calif. to settle to the north in Oakland, worked as a journeyman roofer for the venerable, Berkeley-based Malott & Peterson Roofing Company. A collective bargaining agreement, with wage rates mirrored by the state’s prevailing wage determination for his craft, set dad’s wage rate and lifted us into the middle class. All four of his sons followed him into the trades and, with just a few hiccoughs, into the middle class, as well.

Fixed wage rates settled one of the uncertainties attendant to construction bidding. With the wages essentially predetermined for all bidders,

the successful bidders became those with sharper pencils, more modest profit requirements, creative deployment strategies, or superior process efficiencies in place – or some combination thereof.

Of course, some bidders became successful by skirting prevailing wage requirements, effectively breaking the law. These errant contractors enjoyed an unfair business advantage over the compliant contractors. The evidence argues that compliant contractors number in the majority, most certainly. That brings us to one of the purposes of this column.

Over the coming months, we expect to demystify, as much as that is possible, the prevailing wage statutes influencing most publicly funded construction contracts. We shall commence by vetting the functional definition of a public work in its most practical terms; that is, how it applies to contractors.

We expect to profile some of the “go to” labor standards enforcement folks within the enforcement agencies, awarding bodies, trades, and trusts.

With the growth of electronic certified payroll report collection and validation, new problems and conventions developed. That will inform our discussions, too.

Many school districts and special districts, e.g., transit and water districts, maintain formal labor compliance programs as a funding requirement (tied to bonds, usually). There are many surprises for contractors within and we will spend time with them.

Our endeavor is to cover as much public works ground as we can, as systematically as we can. If questions emerge along the way, drop us a line at [KatoCooks@yahoo.com](mailto:KatoCooks@yahoo.com). However, legal advice in these matters comes from attorneys, either yours or those employed by an enforcement agency. This column proffers no such conceit.

What we will do is research and cite the code, refer questions to those at DIR or DOL (the federal Dept. of Labor) whose duty it is to respond, and wax profoundly on industry practices versus lexical promises. And we will keep you abreast of developments that may affect the construction of your bids. After all, the bottom line is the thing.

My dad believed that knowledge is the basis of power. One of my historical influences, Dr. Huey P. Newton, defined power as “the ability to define phenomena and make it act in a desired manner.”

By understanding the mechanics of public works better, opportunities to manipulate it legally to a contractor’s advantage increase.

Equity In / Equity Out: A Model for Building More Inclusive Industries

The energy world is plagued by equity challenges when it comes to workforce representation and the impacts of energy developments. Although environmental harms disproportionately affect communities of color, the energy industry doesn’t operate within a social justice framework. The consequences are similar: energy developments tend to create negative to neutral impacts on low-income communities and communities of color. An example of a program that has demonstrated its potential to break this mold

is the CalSEED program. Run by the California Energy Commission and funded by SB 350, the CalSEED program provides funding and professional development assistance to early-stage clean energy entrepreneurs, with an emphasis on equitable access and benefits. The Greenlining Institute uses an “Equity In / Equity Out” framework to ensure that the CalSEED program does not further perpetuate this divide.

- Equity In: Recruiting individuals from low income communities, communities of color, and other communities disproportionately impacted by climate change and those who do not have as much access to entrepreneurship.

- Equity Out: Encouraging entrepreneurs to develop equitable solutions that positively impact the populations most vulnerable to pollution, climate change and economic opportunities.

### Applying Equity In / Equity Out to Tech Workforce Development

So how does “equity in” translate to workforce development groups in tech? Through the Town Link, a year-long project to close the digital divide in Oakland, the Greenlining Institute worked with workforce development organizations that provide insight into how programs can build technical skills equitably. Here’s what we found:

To start, tech-focused workforce development groups should prioritize applicants who have limited access to technical education, yet are disproportionately impacted by the harms that new technology has created. These groups must also consider how to make learning opportunities more accessible — for instance, workforce development organizations in Oakland provide laptops, stipends or scholarships for participating in classes, and a flexible curriculum that allows participants to progress at their own pace.

The framework of “equity out” is trickier to imagine, but remains the same in the workforce

## Centering Tech Equity in Workforce Development

### Continued from page 2

development universe — skills developed during development programs should help students develop solutions oriented towards tech challenges that disproportionately affect communities of color, such as surveillance, data privacy, and algorithmic bias.

### Putting it Into Practice: Hack the Hood

Hack the Hood, one of the workforce development partners in the Town Link, frames its coding curriculum as "culturally competent data skills". Their programs provide an introduction into the tech industry, and training in software engineering and data science using a unique "justice-centered approach".

Black, Latinx, AAPI, and Indigenous learners participating in Hack the Hood's programs identify problems they have faced or seen in

their communities, and Hack the Hood instructors contextualize classes within the learner's experience. This empowers participants to think critically about solutions that are for and by their communities.

Hack the Hood's program model includes mentorship by other Black, Latinx, Indigenous and AAPI people and teachings on topics like ethics in tech design, data activism, and the new Jim Code (coined by Ruha Benjamin in her book, *Race After Technology*). Their programs have enabled youth and community leaders to begin their paths toward a career in tech, while empowering them to address challenges they know already exist in their communities with just technical solutions.

When it comes to technical education, providing impacted communities the necessary tools

and autonomy to make their own decisions is paramount. Dr. Lauren Quigley, Hack the Hood's Senior Advisor for Curriculum, Impact & Innovation emphasizes the importance of offering participants a holistic understanding of the tech industry—including its complications, ethical dilemmas, and alternate pathways. For Hack the Hood, a metric of success is learners' ability to make their own choices regarding their career and use of technology, not just a pipeline to a standard software development role.

Through the Town Link, the Greenlining Institute has had the opportunity to collaborate with and learn from workforce development organizations that center Black, Indigenous, and people of color to address equity issues in the tech industry. The takeaways are clear: workforce development should not just focus

on employment alone, but should empower participants with the skills and agency to understand the sector, recognize its pitfalls, and if they so choose, rectify these harms with technical skills.

As more state and federal level funding is made available for more training in this ever-growing industry, we need to think about which programs to invest in. True economic resilience and equity in the face of an ever-growing industry cannot exist without the ability to name these harms in a digital world and have a path forward to correcting them.

## These North Texas Counties Aren't the Cheapest for New Construction Value, Report Finds

Collin and Denton counties are tops in Texas,  
and maybe in not such a good way.

The ever-developing counties are the most expensive in Texas when it comes to average new construction value, according to a report by Construction Coverage.

Researchers crunched numbers from the U.S. Census Bureau's Building Permits Survey (2021), the most recent data available. The average permit value per unit authorized was determined and ranked by county from large, mid-size, small, all counties, and nationally.

Among the nation's 87 large counties (750,000 or more residents), Collin County's average new construction value was \$251,424 per home or apartment, ranking the county the most expensive in Texas. Denton County was right behind and 26th nationally with a \$249,413 value.

Of the top 26, Collin and Denton had the most total units authorized with 17,140 and 11,575.

Single-family homes made up 78.7 percent of the new residential construction permitted in Collin and 78.4 percent of the new housing authorized in Denton County.

Among all U.S. counties, Collin and Denton were ranked 88th and 90th.

Tarrant County ranked 65th with a \$190,620 average new construction value.

Dallas County has the 15th-lowest average new construction value at \$171,161, compared to \$218,791 per unit nationally. Single-family units made up 41.1 percent of the total in Dallas County compared to 64.2 percent of the units nationwide.

# Angela Bicos Mavridis, Tribalí Foods

Angela Bicos Mavridis, a San Marino, California resident, comes from an entrepreneurial family. Her father owned a drive-thru that served up burgers, fries, and shakes. This, she later realized, was a far cry from the way her grandmother cooked and ate in their homeland of Greece. Angela spent childhood summers there, enjoying scratch-made Paleo cuisine comprised of organic, local foods.

Later, she became an entrepreneur in her own right. A graduate of USC and Pepperdine University, Angela would go on to own and operate her own shoe and clothing stores. "I love the flexibility, freedom, and responsibility of owning your own business," she said.

As she got older, Angela became the definition of fit. She became an avid runner, cyclist, and CrossFitter. But something felt amiss. She suspected her diet choices — protein shakes and bars — were triggering bloating and fatigue and taking a toll on her body. That was the point she decided to take control of her health and become a holistic nutritionist.

It dawned on her that eating "clean" proteins paired with ancestral ingredients — akin to her grandmother's Greek fare — made her feel better physically and emotionally. Within days, her gut and digestive issues subsided and her body began to heal itself, she said.

As she saw her lifestyle improving, the single mother of three wanted to explore whether she could bring her nutrient-dense, high-quality food to the masses. In October 2016, she created Tribalí

Foods, a distributor specializing in quality, meat-based food products that are actually good for you.

In less than a year, the company launched its products at Los Angeles area natural grocers and certain Whole Foods locations. She's also reached agreements with Target and Bristol Farms.

The retail and consumer demand were clearly there. But Angela needed funding to keep the momentum going, from funding more production to buying raw materials.

That funding came in the form of an affordable SBA small business loan through CDC Small Business Finance. "The SBA and CDC were very easy to deal with," she said. "I had lots of confidence in the CDC soon after I met some of



the representatives and didn't feel the need to look elsewhere."

She recalls the day she got the call informing her she had been approved for financing. "It was a very exciting day," she said. "The call came in right at the perfect time because I literally didn't know how we were going to fulfill the orders we received."

In the short period of time Tribalí Foods has been around, Angela has managed to catapult the brand toward mainstream success with appearances on The Today Show and already amassed a number of honors. They include:

- Becoming a certified-owned business through the Women's Business Enterprise National Council, or WBENC.

- Winning the Nexty Award at EXPO West for Best New Frozen Food Product.
- Taking home the Project Nosh Pitch Slam victory in November 2017, and
- Receiving the "Delicious Living Best Bite" award for their Umami Patty.

If you're thinking about starting your own business, Angela has some timeless, expert advice for you. "You have to have passion, you have to be persistent, and you have to persevere," she said. "There will undoubtedly be hurdles and obstacles, but the 3 Ps will get you through to the other side."

# 3 Keys to Building Strong General Contractor-Client Relationships

As a general contractor, building strong relationships with your clients is important to your company's success. Good client relationships can lead to repeat business, referrals, and word-of-mouth marketing. A good working relationship built on trust and understanding can go a long way when issues arise on a project.

The general contractor-client relationship should be mutually beneficial to both parties regardless of whether it's for one project or for multiple projects. It's a simple formula, the client receives a project completed on time and within budget built to their satisfaction, and the GC gets paid on time and makes a profit.

But how does a general contractor go about building that relationship? What's necessary to take it from simply rendering services once to something more, something better?

### Communication

Establishing good communication with your client is probably the most important step to building a strong relationship. The first thing you want to do is establish a single point of contact who will be responsible for all communications with the client. It will simplify the flow of information and eliminate any confusion as to who the client should contact.

You also need to determine what method of communication and how often you will communicate information to the client as a project progresses. This may mean daily or weekly updates or less frequently on larger projects like when major milestones are completed. It's all about keeping



the client informed without bombarding them with constant updates and becoming a nuisance.

Each client is different, so it's important to discuss how and when they will be communicated with. Email and text are popular methods for communication because it creates a digital paper trail that can be referenced in the event of any issues or disputes. Phone calls and in-person meetings are also good when discussing more complex issues, just be sure to follow up with a quick email recapping what was discussed.

In addition to regular project updates, you also want to keep the client in the loop when any issue or potential problem arises that may lead to a delay in completion. Even if a delay doesn't happen, you're showing the client that you are on top of the situation and have a plan of action to keep the project moving.

### Contract

Regardless of whether it's a first-time client or one you've worked with for years, having a clear and concise contract in place is essential to building and maintaining a strong relationship. It might seem strange to think about a legal document as a key to building a strong relationship. But let's think about that for a moment, a good contract clearly establishes roles and responsibilities for all parties involved and what each party is responsible for.

A good contract should be easy to understand and written in plain English. The contract should clearly outline roles and responsibilities for both the client and the GC. Clauses for the scope of work, payments, change orders, claims, etc. should be clearly outlined in the contract.

Both parties should sit down and carefully review the contract together. Any gray areas or ambiguous

language should be addressed and corrected before signing the contract. Laying out the expectations of both parties in the contract leads to fewer disagreements and finger-pointing should issues arise.

### Collaboration

If you're really looking to build a strong relationship with your client, you want to work with them, not for them. Certain contracting methods and project delivery methods like design-build and integrated project delivery tend to rely on a more collaborative approach. As a general contractor, the earlier in the design phase that you can get in on a project, the better.

Focus on determining what aspects of the project are the most important to the client. It could be the budget, project timetable, quality of work, sustainability, etc. Be sure to ask open-ended questions so you truly understand what the client wants and needs in their building.

Don't be shy in offering advice and alternatives to your client. Part of your duty to your client is to provide your expertise and knowledge. This can be anything from construction methods and constructability of architectural drawings to subcontractor selection to the building materials and finishes selected for the project.

Keeping your client engaged in the entire construction process also makes it easier to work through change orders and other bumps in the road. Guiding them through the process and being open and honest about how changes will impact the cost and construction timetable is a great way to gain your client's trust.

# 4 Ways to Improve Construction Jobsite Safety

Construction work is inherently dangerous. Construction consistently leads all industries in total worker deaths each year and has one of the highest fatality rates for worker deaths. The top priority of every construction company should be to protect their workers from injuries and ensure everyone makes it home safe at the end of each shift.

There are several reasons why construction work is so dangerous. Each jobsite is unique and presents its own sets of challenges and potential safety hazards. Unlike in a controlled environment, like a manufacturing plant or an office, jobsite conditions are constantly changing every day.

New hazards and safety concerns pop up as construction progresses. New crews of subcontractors come and go to complete various trades. Due to la-

bor shortages still being felt from the last recession, there is a larger number of less experienced workers on jobsites that don't have the years of safety training as the veterans they've replaced.

Providing a safe working environment for your workers doesn't have to be overcomplicated. With the proper planning and preparation, creating a safer jobsite is something that can be easily incorporated into your preconstruction planning process and duplicated on all your future projects. Taking these steps can bolster your company's safety culture and promote your commitment to providing a safe jobsite on every project.

### Craft a Plan

Because each jobsite is different, it's important to build a site-specific safety plan for each project. As you work through building out your construction schedule, you should also be plotting out your safety plan. Be sure to rely on historical data from

previous projects that are similar to your current one to craft your safety plan.

Identify the potential safety hazards and risks that each phase of the project will present. Determine the best way to mitigate the risks and eliminate the hazards with engineering controls, training, and personal protective equipment (PPE). These will change as work progresses, so be sure to focus on each stage or phase of the project and the individual tasks that workers will be required to complete.

For example, early in the project, your safety focus will probably be on potential hazards during site work like trenching accidents, cave-ins, equipment rollover, and workers potentially being struck by heavy equipment. As the project moves along you might have more workers working at height, so your focus will shift to fall protection and ladder and scaffold safety.

If you are the general contractor on the project, be sure to include your subcontractors in your planning process. Lean on their expertise for knowing what safety concerns are most prevalent in the work they do and how best to protect their workers. Trade contractors working as subs should work with the GC to provide input to ensure that their workers are properly protected from injuries.

### Stage for Safety

You already stage your construction site for things like material delivery and equipment storage. Why not take it a step further and stage your jobsite for safety? Designate areas for specific trades or tasks near where the work is taking place.
