States Expand Apprenticeship Programs as Worker **Shortages Grow**

Every state in the continental U.S. has fully reopened and 70 percent of the jobs lost in the spring of 2020 have been recovered. But a mismatch between the needs of employers and the priorities, and supply, of workers is the bigger

Forty-six percent of small business owners surveyed in June by the National Federation of Independent Business had job openings they could not fill, more than double the average over the past 48 years. As many as 80 percent of employers contacted by the Conference Board say it's difficult to find qualified workers.

A Pew survey found that two out of three workers who became unemployed during the pandemic are reconsidering their choice of work. Job losses were more than twice as great for those in low-income jobs as for middle-income positions, and low-wage workers were shaken by the speed at which their jobs became disposable.

It's not hard to understand that a low-wage job would offer small prospect of relief after the stresses of the past year. For a family of four with one working adult, a minimum wage salary is less than half the living wage in every state in the U.S. If both parents work in minimum wage jobs, their earnings are still less than half what's needed to meet basic needs in 19 states and well below the cost of living in every other state.

An unprecedented combination of massive retirement rates, near zero growth in the working age population, declining workforce participation and lack of interest in "blue-collar" jobs has created a situation that "could easily develop into one of the worst labor shortages of the last 50 years," according to the Conference Board. No worker can be taken for granted at this juncture.

A system established to empower workers as the country emerged from the Great Depression is helping today's employers get the workers they need and clearing paths to middle- and high-income jobs.

Investing in Latinas is investing in the future

Hundreds of thousands of Latinas dropped out of the workforce over the past year. They were not just temporarily unemployed — they were forced to completely leave the labor market due to a safety net that often proved inaccessible and inequitable during the pandemic. Drastically affected by unemployment and heightened domestic responsibilities that reduced their ability to work, Latinas faced economic challenges that likely will take decades to overcome.

Fortunately, President Biden's American Families Plan and California's new Unseen Latinas Initiative may be part of the solution to getting Latinas, a workforce essential to prosperity, back to work.

Now more than ever, we need comprehensive social policies designed to help the women and children most affected by inequity but least represented in government relief and recovery efforts.

With low-income families already spending over a third of their income on child care, many mothers were forced to stay home when schools and day cares closed during

the pandemic. Among the hardest-hit Americans were Latinas. Almost 3% (337,000) of Latinas working in August 2020 had dropped out of the labor force by September. They experienced the highest decrease in labor force size of any demographic group in the U.S. In that single month, Latinas left jobs at three times the rate of their white counterparts. Since then, the number of Latinas in the labor force has fluctuated, but is still lower than it was in August 2020 and far below what it was pre-pandemic — 455,000 fewer Latinas were in the workforce in April 2021 than in March 2020

It may be tempting to write this off as a consequence of a pandemic that had bad outcomes for everyone, but strong labor force participation of Latinos, one of the youngest and fastest-growing demographics, is necessary for positive economic growth. And in California, the largest state economy in the nation, where nearly 20% of the population is Latina, it is imperative to strengthen the Latina labor force with key investments, because their economic contributions are tied to the prosperity of all Californians.

At the state level, the Unseen Latinas Initiative, spearheaded by Assemblymember Lorena Gonzalez, puts a much-needed spotlight on the unique challenges Latinas face and the solutions required to meet their needs. At the same time, the American Families Plan, a \$495 billion investment to support children and families, could provide Latinas with the critical resources needed to prosper, including improved access to quality health care, food, housing, clothing and school supplies. It also would provide support to endure health crises, stay employed, return to work or continue searching for living-wage jobs that create avenues to social mobility and wealth creation.

The plan includes access to free universal preschool, a reform that would improve the educational attainment and upward mobility of families while also reducing gender and racial wealth gaps.

Research has shown that child care investments can increase women's presence in the workforce, which in turn can stimulate the economy, boosting the gross domestic prod-

Standards for Apprenticeship

In the late 1930s, the U.S. experienced a shortage of skilled workers. Training programs provided by unions and large corporations had been disrupted by the Great Depression. The Fitzgerald Act, known as the National Apprenticeship Act of 1937, established standards and responsibilities for apprenticeships, with the aim of ensuring that apprentices received adequate training and had real opportunities for advancement.

The national Registered Apprenticeship Program that developed out of the Fitzgerald Act is overseen by the U.S. Department of Labor (DOL) and is active in every state and territory. It is administered either by the DOL or by a state apprenticeship

agency; the directory for the National Association of State and Territorial Apprenticeship Directors includes members from 27 states, three territories and the District of Columbia.

Workers who graduate from apprenticeships registered with the DOL or a state agency earn an industry-recognized credential. This is a significant distinction from company-run training programs, says Patricia Morrison, director of the division of registered apprenticeship for the Virginia Department of Labor and Industry.

"A company program may be perfectly fine and good, but if it's not registered, apprentices don't get the same nationally portable credential," she says. "They're not really a journey worker."

Morrison is seeing a renaissance of interest in

the registered apprenticeship model, and a dawning recognition that it now encompasses many fields. "Some people think it's union construction programs only, but it's not," she says. "We are in IT, computer science, early childhood education, management — there are 1200-plus occupations that use this model."

Apprentices are paid from the day they begin, and if their jobs require academic training, the employer usually pays for it. This model benefits adult workers who yearn for a career change, but don't have the resources to quit working or pay to learn new skills. It offers high school graduates an alternative to accumulating college debt or joining the military to access VA education benefits, without closing the door on middle- and high-income employment.

Reconsidering the Holy Grail

Morrison acknowledges that not every job is an apprenticeable occupation. The model is most applicable to skilled, technical jobs that require a year or more to learn; some jobs in fields such as medicine are only accessible to those with advanced degrees. But apprenticeship agencies and employers are finding that, with creativity, the model can be adapted to more and more jobs, to the benefit of employers and workers alike.

Small Business Loans California: Top Options in 2021

Small business loans in California are transparent and user-friendly-because they have to be. California recently signed into law SB 1235, which puts into place transparency requirements for small business lending that mirror the regulations that federal law places on consumer lending.

If you're borrowing for your small business in California, then you can rest easy knowing you're seeing the full picture—even when small business owners in other states, working with the same lenders, might not necessarily have access to as much information as you.

Searching for small business loans only locally available in California could make for even more transparent, community-based funding. Indeed, small business loans specifically for California small businesses are some of the most affordable and growth-focused options in the nation.

Top 11 California Small Business Loan Options

Because of Senate Bill 1235, signed into California state law in October 2018, California is one of the very best states to be a small business borrower in. The state law requires all small business lenders to meet transparency requirements so that small businesses know exactly what they're getting themselves into when they sign a business loan agreement.

So, small business loans in California are, by law, more transparent and better for the borrower. On top of that, though, there are multiple state and local government-led small business loan programs that offer affordable funding to California small businesses in need of capital.

These two upsides combine to make California small business loans some of the very best in the nation, and we've compiled details on eleven of the best options here:

1. California Small Business Loan Guarantee **Program**

Small business loan guarantees are available for California small businesses through the California Small Business Loan Guarantee Program. This small business loan guarantee program is run by the Small Business Finance Center of the California state government in partnership with seven Financial Development Corporations. Through the California Small Business Loan Guarantee Program, the Small Business Finance Center provides 80% to 95% guarantees of the small business loans that FDCs lend directly.

To be eligible for the guarantee program, you'll need to run a small business in California with one to 750 employees. Some nonprofits will also be eligible. That said, the FDCs that lend directly through the program will have their own requirements, so be sure you meet those before applying to a given lender through this program.

Small business loans through the California Small Business Loan Guarantee Program can be as large as \$20 million, though can only come with guarantees of up to \$2.5 million. Repayment terms for these California small business loans will be at least seven years long but could stretch longer. Interest rates attached to these small business loans will vary based on which direct lender you fund with.

uct by almost \$210 billion. For every 10% increase in the labor force participation of women, we can expect wages for all workers to increase by 5%. With the growing proportion of Latinos in the state representing a larger share of the workforce, the success of Latina workers stands to be a significant boon to our economy, now and in the future.

Past policy interventions, expressed commitments to racial justice and attempts to bolster aid too often have failed to reach the most vulnerable communities, and the pandemic has underscored how vulnerable Latinas are to economic shocks.

Our state and federal government share a commitment to pulling our most vulnerable people from the shadows, distributing resources that have the potential to result in long-term economic growth, and closing gender and racial wealth gaps. Our legislators must be urged to support these investments. Doing so means investing in kids, families and the country's economic future.

Reduce builders' fees to make housing more affordable

As anyone who has tried to buy a home in the past year knows all too well, California's housing costs are soaring. The primary reason is basic economics – there is a strong demand for housing and a limited supply because not enough homes have been built over the past two decades to meet that demand.

But a recent study has made it clear that increasingly high fees charged to builders by cities, counties and special districts, and ultimately paid for by homebuyers, is a major cost factor as well, and one that can be addressed

As elected officials working to add to our communities' housing supply and to improve affordability, we urge city councils, school boards and boards of supervisors around the state to ensure that their fees are appropriately scaled so that it's easier, not harder, for families to buy – and homebuilders to provide — the new homes our state so badly needs.

Builders have reported for years that high fees have been a problem in many coastal areas. But a recent report prepared for the North State Building Industry Association shows that the total fee burden in our area now averages an astonishing \$95,000 for each new homebuyer.

Some of these fees pay for essential items — basic infrastructure like roads, water treatment, schools or parks. However, the study revealed that similar communities in the Central Valley and the Inland Empire region of Southern California — areas similar in nature and lifestyle to Sacramento — see much lower fees than Sacramento for these same amenities.

The fees in those two regions average a full \$40,000 per home lower than what Sacramento homebuyers generally pay. These findings clearly show that fees hurt the region's affordability and put homeownership out of reach for thousands of area families.

In our region, every \$1,000 increase in price prevents 936 families from affording an average home. That translates to some 37,000 local families who are being priced out from buying a new home right now.

The fees affect affordability for middle-income homebuyers as well as low-income families looking for government-sponsored housing options. Affordable-housing builders must pay fees as well. And when middle-

income families cannot afford a new home, it prevents them from moving out of their condos or smaller homes, creating gridlock and blocking opportunities for poorer families wishing to climb the homeownership ladder.

Eliminating the additional \$40,000 in government fees would save the average homeowner \$175 per month, \$2,000 per year and an incredible \$60,000 more over the course of a 30-year mortgage.

The study was conducted by Economic and Planning Systems, a firm that provides expertise on real estate and land use for public- and private-sector clients across the country. It recommends that local jurisdictions cut fees to spur more homebuilding to boost supply; reduce or remove unnecessary amenities to bring fees down; and use local funds for larger amenities that benefit entire communities.

Local governments throughout the state can examine how Lodi, Clovis, Riverside and Ontario have been able to keep fees so much lower than Sacramento before they approve new fees.

The Legislature is considering Assembly Bill 602 to standardize local fee calculations and to create greater accountability and transparency in fee calculations and

payment methods. This legislation should be passed, but with additional provisions so that local governments may reduce and eliminate unnecessary fees.

Also, because some fees are the result of state mandates for goals such as better water quality or helping fund affordable housing, other methods to fund these essential needs should continue to be explored to reduce the burden on the next generation of homeowners

As discussions around a bipartisan federal infrastructure package and state budget talks continue, members of Congress and state legislators should be open to working further with local governments. Allocating funds to support broad societal benefits like parks, water and sewer infrastructure improvements and affordable housing would help ensure equity of these needs throughout the state.

Bringing housing demand and production into better balance would help improve affordability, but so would reducing costs to produce housing. And we know that is possible.

Popular Deep-Cleaning Operation Set to Expand with Intensive Focus on San Francisco's Neighborhood Corridors

San Francisco Public Works
CleanCorridorsSF street cleaning crews
will begin deploying on Thursday to a
different commercial district weekly,
tackling grime and graffiti to create a
more welcoming environment

Mayor London N. Breed welcomed the kickoff this week of an expanded CleanCorridorsSF operation that deploys a large, coordinated team of Public Works street cleaners to different neighborhood commercial corridors to power wash and sweep the sidewalks, flush down the roads, dig out weeds and wipe out graffiti.

The program was tested over the last year as a pilot with crews providing intensive cleaning in a different neighborhood commercial corridor every week, focusing on five blocks over four hours. Starting Thursday, the operation will expand to eight hours a week and allow crews to deep clean at least 10 blocks – double the coverage as before.

This week's operation will put 15 Public Works street cleaners on Fillmore Street on Thursday, between McAllister and Pine streets. CleanCorridorsSF crews will be on the ground once a week, rotating through neighborhoods across the City, including the Castro, the South of Market, West Portal, the Ingleside, North Beach and the Haight.

The City's new budget included \$2.1 million for the expanded CleanCorridorsSF program. A companion workforce development operation, the Power Wash Mobile Team, received \$140,000 for a 6-month pilot that employs immigrants with barriers to employment to provide monthly steam cleaning services in Chinatown the Bayview, Visitacion Valley, the Richmond, the Sunset, the Excelsior, the Mission and the Fillmore. The stepped-up street cleaning efforts fall under Shine On

SF, a new public-private recovery initiative that aims to rekindle civic pride and improve the condition of San Francisco's streets and public spaces.

"These investments will go a long way in making sure that San Francisco shines," said Mayor Breed. "Keeping our neighborhoods clean creates a more inviting environment for our residents, visitors and businesses, and is especially important now as we're reopening and welcoming more people back.

But we know that the City and our nonprofit partners cannot do the job alone. It requires all of us to do our part. If you are able, volunteer at a neighborhood cleanup, contact 311 to report illegal dumping so we can clean it up quickly and, perhaps most importantly, help us get to a place where people won't feel it's OK to mess up our beautiful city in the first place."

San Francisco Public Works has street cleaning crews on the job around the clock. CleanCorridorsSF provides the department another tool to perform more intensive, proactive cleanups. In addition to the cleaning crews, Public Works will deploy outreach staff to let property owners, residents and merchants know how they can help keep their neighborhood clean.

"We saw firsthand through the pilot that CleanCorridorsSF gets welcome results," said Acting Public Works Director Alaric Degrafinried. "Now that we have additional resources to expand the operation, thanks to support from Mayor Breed, the Board of Supervisors and our community partners, we expect greater success in addressing the challenges of keeping San Francisco looking good."

At long last, infrastructure legislation based on President Biden's American Jobs Plan is moving forward in Congress. This represents a historic opportunity.

Too many Americans are suffering from the devastating effects of structural racism, decades of systemic disinvestment, and climate change. If we have learned anything from COVID, it is that one's economic security is inextricably linked to the environment, health, and access to economic opportunity.

President Biden's American Jobs Plan is a solid start, and rightly identifies the existential threats of climate crisis and pervasive racial injustice. But, the final legislation must incorporate racial equity into the design and implementation of the program to be successful. Lawmakers can look to the innovative approaches pioneered across California to see how they can address long-standing racial inequities and fight against global climate change.

As The Greenlining Institute noted in our letter to legislators, the American Jobs Plan can build stronger, healthier, more prosperous communities by emphasizing anti-racist and community-driven solutions. Here's how:

Climate Mitigation, Adaptation, and Resilience. To build community resilience in response to climate change, we must actively include impacted communities in the design and implementation of solutions. Stockton has invested significant resources to develop climate action plans that bring green investments and address pressing, local environmental concerns, while allowing communities to determine the path forward. Programs like the Transformative Climate

Communities and Regional Climate Collaboratives show that by marrying community leadership with technical capacity, we can form enduring partnerships that combat racial equity, address climate resilience needs, and provide access to economic opportunity.

- Just and Equitable Transition from Fossil Fuels. Data from CalEnviroScreen show the uneven burden communities of color experience of higher rates of pollution inside and outside of their homes from fossil fuel appliances and closer proximity to power plants because of housing discrimination, and its economic impact. The American Jobs Plan can invest in fossil fuel-free technologies like building electrification to reduce health impacts and cost burden, extend access to affordable fossil fuel-free energy, and provide good jobs.
- Clean Mobility and Vehicle Electrification. Undoing the legacy of policies like highway construction that segregated communities of color and expanded our reliance on personal vehicles require solutions that explicitly address race. California's Sustainable Transportation Equity Project funds communities to make comprehensive investments in transit, mobility, vehicle electrification, and infrastructure. By incentivizing walking, biking, public transit, and shared transportation, we reduce emissions, improve mobility, reduce traffic, and create economic opportunity for communities of color.
- Quality and Affordable Broadband. Greenlining's research identifies that formerly-redlined neighborhoods are the same neighborhoods that now suffer from limited access to affordable technology and internet services. California's \$6 billion in investment towards open-access middle-mile fiber networks, municipal broadband and last

mile infrastructure provides a blueprint for the American Jobs Plan to address the digital divide and establish a sustainable path for long term wealth building that internet access affords. The significant broadband investment included in the current bipartisan infrastructure legislation represents a solid start.

Congress and the White House must take this once-in-a-generation opportunity to foster eco-

nomic prosperity, fight climate change, and advance racial equity. Only by facing the historic legacy of injustice with boldness and equity-centered solutions can we ensure that race is never a barrier to opportunity.
