## California Department of Transportation (Caltrans) Disparity Study

The California Department of Transportation (Caltrans) is responsible for managing more than 50,000 miles of California's federal and state highways. As a United States Department of Transportation (USDOT) fund recipient, Caltrans implements the Federal Disadvantaged Business Enterprise (DBE) Program, which is designed to address potential discrimination against DBEs in the award and administration of USDOT-funded contracts. Caltrans retained BBC Research & Consulting (BBC) to conduct a disparity study to help evaluate the effectiveness of its implementation of the Federal DBE Program in encouraging the participation of minority- and woman-owned businesses in Federal Highway Administration- (FHWA-) funded contracts.

A disparity study examines whether there are any disparities between:

- The percentage of prime contract and subcontract dollars an agency awarded to minority- and woman-owned businesses during a particular time period (i.e., utilization); and

- The percentage of prime contract and subcontract dollars minority- and woman-owned businesses might be expected to receive based on their availability to perform specific types and sizes of contracts the agency awards (i.e., availability).

Disparity studies also include other quantitative and qualitative information related to:

- The legal framework surrounding minority- and woman-owned businesses programs;
- Marketplace conditions for minority- and woman-owned businesses; and
- Contracting practices and business programs agencies use to award contracts.

Caltrans could use information from the disparity study to help refine its implementation of the Federal DBE Program, including setting an overall goal for the participation of DBEs in its FHWA-funded contracts and procurements and determining which program measures to use to encourage the participation of relevant groups of minority- and woman-owned businesses.

## SBA Awards \$2.7M in Grants to 14 Women's Business Centers

The U.S. Small Business Administration issued 14 grant awards of up to \$200,000 each to organizations in 13 states as part of the Women's Business Centers (WBC) Resiliency and Recovery Demonstration Grant under the SBA's Office of Women's Business Ownership (OWBO). The purpose of the grants is to establish or continue innovative projects that aim to improve service delivery, training, and support provided to women-owned businesses impacted by COVID-19.

"The growth and recovery of women-owned small businesses is essential to our nation's economy. During the pandemic, our Women's

Business Centers have played an integral role in meeting the needs of women entrepreneurs during an especially challenging time. As resource providers, they too have been impacted by the changing business landscape and have had to pivot to meet community needs," said Natalie Madeira Cofield, Assistant Administrator for SBA's Office of Women's Business Ownership. "With this funding, we will support WBCs that have established innovative programming to increase outreach to aspiring and active women entrepreneurs nationwide. We are proud to support organizations who have deep connections to small, diverse, and rural communities across the country and who understand their unique needs."

This grant program was open to existing SBA-funded WBCs. Approximately \$2.7 million in total funding was available for this program. Successful respondents demonstrated innovative approaches to service delivery to address the needs of women business owners adversely affected by COVID-19. Proposals included detailed plans to continue or establish projects to improve service delivery, training, and support to women-owned businesses impacted by the pandemic. Applicants were required to also provide counseling, technical and financial skill development, comprehensive business assessments, and mentoring services to women interested in starting or growing a small business.

The project awards will be made for a one year of performance.

## To restore California's ecosystems, we must adopt smarter permitting

California's ecosystems underpin the state's economy: They nurture and protect the state's water supply, shorelines, agriculture, fisheries and wildlife. But many of these ecosystems are in dire health, and climate change is now accelerating the loss of biodiversity already underway. Ecosystem degradation is having ripple effects across the state. Severe problems with water supply dwindling populations of native wildlife, and the critical need to better manage and store carbon require urgent and large-scale action.

There is a solution: The state enjoys a vibrant, growing restoration movement that has seen some tremendous successes. For instance, when a coalition of state, federal and private agencies acquired more than 15,000 acres of commercial salt ponds in the southern end of San Francisco Bay in 2003, the land was largely barren. Some 18 years later, the salt marshes of the South Bay Salt Pond Restoration Project are home to a constellation of wildlife, including at least two endangered species — the salt marsh harvest mouse and Ridgway's Rail. These emblematic

creatures, found only in San Francisco Bay, returned to the marshes quickly after restoration, and the restored areas are now sequestering carbon, protecting the shoreline and providing access to nature and recreation in the heart of the Bay Area.

Other actions are showing promise, too. Gov. Gavin Newsom's "30 by 30" executive order aims to conserve 30% of California's land and waters by 2030, and the measure enjoys broad bipartisan support. Similarly, the Cutting the Green Tape initiative aims to improve coordination and partnerships to facilitate ecological restoration. However, too many restoration efforts still face costly, arduous permitting processes that delay projects — or scuttle them altogether. They're subject to, ironically, the very regulations that were intended to slow or prevent environmental degradation — but are now hindering work to expand restoration.

Obtaining permits for a restoration project typically involves many agencies — local, regional, state and federal — each with their own language, requirements, timeline and procedures.

So how can we ramp up ecosystem restoration to stop and even reverse the loss of crucial ecosystem functions? The state must first address the

costly, time-consuming permitting process and embrace smarter permitting for restoration.

### What is smarter permitting?

In our new report, we researched restoration case studies and innovative permitting approaches across California. We found that successful smarter permitting efforts typically achieve better outcomes in a few key ways: By shortening the permitting timelines, lowering costs, increasing the extent of restoration and promoting better ecological outcomes.

We also observed some important patterns. Successful programs used at least one, and sometimes all, of the following approaches. First, they coordinated across similar projects with programmatic permitting. Second, they coordinated within and among regulatory agencies to promote a culture of teamwork and improve the working relationships with permittees. Third, they advanced permitting to restore key ecosystem functions — which meant planning over a larger geographic area than most individual restoration projects.

### Who can enact smarter permitting?

Smarter permitting does demand a major culture change at many agencies. It will take strong

leadership to build a culture of trust that allows agency staff to take chances and try new things. But our study shows that a few changes can yield major benefits. This includes unblocking challenging planning processes by coordinating restoration at an ecosystem scale, so that objectives can be traded off in different locations. And bringing all parties together early in the process, with a common foundation of scientific knowledge, helps foster collaborative problem-solving and builds trust from the start.

Restoration proponents have a huge role to play: Nearly every successful smarter permitting innovation we studied started out as a grassroots endeavor. Nonprofit organizations, government agencies and water users all wield more power than they know.

It truly is a time to get all hands on deck. The sooner these permitting changes are enacted, the sooner we can help California's struggling ecosystems — and the people and wildlife they support — grapple with a climate that's changing faster than we'd like.

## Loans and Financing for Business Consulting Companies

Business owners looking for a small business loan for their consulting business are in luck, there are a lot of options, including an SBA loan, business cash advance, a line of credit, or other term loan. Interest rates and terms will vary depending on the creditworthiness of the borrower, so to get the best loan rates and terms you'll need a good to excellent personal credit score, several years in business, and annual revenues of \$250,000 or more.

Consulting company loans come in a lot of different shapes and sizes, which means there are options even if you have a younger business or don't meet some of those other criteria, but you should expect to pay a higher interest rate, be offered a smaller loan amount, and could have shorter terms.

### Overview of Financing for Consulting Businesses

Before you start looking for business financing, you'll need to evaluate your business and financial position to make sure you're looking in the right place and that you get the financing that is best suited for you and your consulting business. The application process will vary from lender to lender, but there are a few things you will likely need to complete your loan application:

- Your annual revenues
- Your monthly cash flow
- 3-6 six months of bank statements to apply (depending on the lender)
- Time in business
- Business and personal credit history

In addition to the above, most traditional lenders (like banks and credit unions) as well as the SBA will likely want to see a detailed business plan, collateral (like real estate), and several years in business before they'll approve a loan.

Although they probably won't ask it this way, lenders want to know the answers to these three questions,

1. Can you repay a loan? Which is why your revenue and cash flow numbers are so important. They are looking for evidence that your consulting business has the financial ability to make periodic payments.
2. Will you repay a loan? This is a little different question, but is why they look at your personal and business credit history. Fortunately, different lenders have different thresholds for

what they will accept, so even if you have a less-than-perfect credit history there are still options for you.

3. Will you make all your periodic payments throughout the term of the loan? Although there are many lenders that don't require several years in business to approve your loan application, they are all trying to evaluate what you will do with the payments associated with this financing, based upon what you've done in the past.

If a lender requests electronic access to your business bank account, it's a good idea. It makes it possible for the lender to confirm you have the revenue and cash flow to support periodic payments and it streamlines the process for you and your business.

## Understanding Soil Settlement for the Builder and How to Educate the Homeowner

With increases in housing starts and the high price of land, lots that once seemed unbuildable are now seeing homes and other structures. Some of these lots have been filled for better curb appeal and an easier sale.

Understanding soil structure and settlement has always been a critical component of excavation. Without it, problems such as settling and cracking of the foundation, slabs, stoops, and sidewalks can manifest months or years later.

Typically, in the design stages of commercial construction, a soil engineer prepares a sub-surface exploration and foundation evaluation that would include a serious of soil borings. A soil bore can give you a glance at the sub-surface, type of material, density, and moisture content, as well as possible water table at any given depth. This information also gives the excavator an idea of what kind of material they will be excavating and if it can be used as structural fill under slabs and walkways or if it would need to be removed from the site. Information from soil bores can help excavating contractors bid projects, but most residential

construction projects don't involve a soil engineer or soil borings.

Experienced contractors and inspectors make sure the bottom of the footing, once excavated, has no organic material (black dirt or topsoil) and virgin ground has been reached before pouring footings. The sides of the excavated walls can shed light about whether the site has been filled in the past. I believe there is an advantage in choosing a local excavator who has experience working near the build site. Clay, hardpan, silt, peat, and sand should be obvious to an experienced builder, but a local excavator may have knowledge about other materials

and their structural integrity from working in that area over the years.

If questionable soil conditions exist, I recommend seeking out a geotech engineer for testing. If the soil is inadequate for building, there are a few possibilities an engineer may consider.

By the way, there are many lenders that won't even consider your loan application if you don't have a business bank account.

## Types of Financing Options for Consulting Businesses

There are a number of different consulting company loans available to firms looking for working capital or to augment short-term cash flow needs. Depending on the financial situation of your business, there are a number of options to consider.

- **SBA Loans:** Although the SBA (Small Business Administration) isn't a lender, they do guarantee loans with member banks and credit unions offering some of the lowest interest rates and best loan terms available. To qualify, you'll need "acceptable" credit—in other words, reasonably good credit in the mid-600s. You'll also likely need some collateral if you're looking for a loan over \$25,000, but they will sometimes loan to younger businesses.
- **Traditional Financing:** If you have good to excellent personal credit and your business credit profile is good, you can apply for a loan or line of credit for your consultancy at a bank or credit union. Interest rates will likely be lower than other types of financing and will usually offer longer terms (meaning lower periodic payments). They usually want to see several years in business with strong revenues. They may also require some form of collateral in addition to your personal guarantee.
- **Online Loans:** Online lenders will often work with borrowers that traditional lenders won't, but lower interest rates and longer terms are typically only offered to borrowers with the strongest credit history, a few years in business, and revenue that demonstrates the ability to make periodic payments. Some online small business loans offer very competitive interest rates to highly-qualified borrowers that rival traditional financing.
- **Business Lines of Credit:** This type of business financing offers a tremendous amount of flexibility to a business consultant allowing the business to use the credit available to

them (within the credit limit), repay the credit line, and use it again. Your consultancy will only pay interest on the amount of credit you use and will have extra capital available when you need it. Interest rates on a line of credit are typically a little higher than a conventional loan, but will vary depending on the creditworthiness of your consulting business.

- **Equipment Financing:** This can be a good option for younger consultancies because the equipment being purchased can be used for collateral, provided you have a good, or better, personal credit history. If you're thinking, "I don't have heavy equipment, why would equipment financing work for my business," your computers, office equipment, and office furniture also qualify as equipment. This can be a good option because it will enable you to free up cash flow for those things that require cash.
- **AR Financing:** Not to be confused with Invoice Factoring (which is another type of AR Financing available to you), AR Financing leverages your Accounts Receivable as collateral for small business financing and can be a good way to obtain extra capital if you have a lot of customers who pay via invoice.
- **Business Cash Advance:** Business cash advance is financing based upon your business' cash flow. The credit requirements are less strict than some of the longer-term financing options mentioned above and interest rates will be higher (possibly much higher depending on your credit history). With that said, this type of financing can be a good way to capture additional ROI on a particular project because you can often get an answer on your loan application within hours opposed to days or even weeks. The periodic payments will likely be either weekly or daily as opposed to monthly, but if you need fast access to additional capital and don't have a business line of credit, this is an option you should consider.
- **Business Credit Cards:** Business credit cards offer much of the flexibility of a business line of credit, but don't typically offer the same credit limits. Nevertheless, a business credit card can be a fast and convenient way for

many small business consultants to access borrowed capital for a variety of purposes. What's more, because approvals are often based on the business owner's personal credit score, if you have a good or better score, a business credit card will be much easier to qualify for than other types of financing.

## How to choose the best type of financing for your consulting business

The best type of consulting company loan for your business will depend on several factors.

- Your personal credit score
- Your business credit profile
- Your time in business
- Your annual revenue
- Your monthly cash flow
- Whether or not you have collateralizable assets

Having a great credit history doesn't necessarily mean you'll be able to choose the type of financing you want, but it will provide you with several options that could be a good choice for your specific use case. Choosing the best loan options for your business will require you to ask yourself some additional questions:

- **What is my loan purpose?** Why am I borrowing? This will help you determine how much capital you need and how quickly you will need it. It will also help you determine how much you can afford in terms of interest rate and total dollar cost of the financing.
- **How much do I need to borrow?** Regardless of where you borrow, there are costs associated with financing, so borrowing more than you really need is not only expensive, it can hurt your business. What's more, some lenders are better at different size loans than others. In other words, some lenders (like online lenders) work with smaller loan amounts every day while others (like banks) prefer larger loans—so borrowing \$25,000 would be a very different experience than borrowing \$500,000 depending on the lender you choose.
- **What does my credit profile look like?** Honestly evaluate your credit situation before

you start applying for financing. Wasting time applying with lenders where the possibility of approval is slim can be incredibly frustrating. Focus your search on those places where you are likely to have the best measure of success and look for the best option there.

Don't be discouraged if you get turned down by the local bank, there are other options available to you. Options that might even help you improve your credit situation so you can be a better borrower and demonstrate your ability to successfully service debt.

## How to qualify for financing for your consulting business

Qualifying for financing will vary depending on where you apply. Start by evaluating your credit profile, the health of your business consultancy, along with your cash flow and revenue. Pull this information together so you have it at your fingertips when you apply. The more prepared you are before you talk to a lender the smoother the process will go and the faster you'll be able to get an answer.

## How to apply for a loan for your consulting business

If you're applying at a bank or credit union, expect a multi-page application and several days (if not weeks) for your application to be reviewed. On the other hand, online applications are typically very short and will leverage technology to make the process easier and much faster.

Be upfront with your situation when you apply. Don't try to paint a rosier picture of your business' financial situation than actually exists. Lenders will find the truth during the underwriting process and a disingenuous application will result in immediate rejection.

If you're asking for the right loan amount and chosen the lender most likely to approve your loan based upon your consulting company's qualifications, you'll be more likely to get the financing you're looking for.

The Local Business Utilization Policy 7115 requires that there is a mandatory fifty percent (50%) LBU participation with a 25% or less Local Business (LBE) participation and a 25% or more Small Local or Small Local Resident Business (SLBE/SLRBE) participation for all capital program/construction-related contracts and professional services agreements.

District Modification: Based on the availability analysis conducted for this specific RFQ/P, the District is

waiving the entire 25% SLBE/SLRBE requirement. The minimum local business utilization requirement of 50% is still applicable for this RFQ/P and can be met with a 50% LBE participation.

On April 28, 2021, the Board of Education amended the Local Business Policy which had named the City of Oakland as the singular agency to certify local businesses to include five additional local business certifications. ## California Department of Transportation (Caltrans) Disparity Study

BBC summarizes key information from the 2021 Caltrans Disparity Study in five parts:

- Analyses in the disparity study;
- Availability analysis results;
- Utilization analysis results;
- Disparity analysis results; and
- Program considerations

#### A. Analyses in the Disparity Study

BBC examined extensive information related to outcomes for minority- and woman-owned businesses in Caltrans' transportation-related contracting as well as the agency's implementation of the Federal DBE Program:

- The study team conducted an analysis of regulations, case law, and other information to guide methodology for the disparity study, which included a review of legal requirements related to minority- and woman-owned business programs, and specifically, the Federal DBE Program (see Chapter 2 and Appendix B).
- BBC conducted quantitative analyses of outcomes for minorities, women, and minority- and woman-owned businesses throughout California. In addition, the study team collected anecdotal evidence about potential barriers individuals and businesses face in the local marketplace through in-depth interviews, surveys, public meetings, and focus groups (see Chapter 3, Appendix C, and Appendix D).
- BBC estimated the percentage of Caltrans transportation-related contract and procurement dollars minority- and woman-owned businesses are available to perform. That analysis was based on Caltrans data and information gathered from surveys the study team conducted with businesses that work

- in industries related to the specific types of transportation-related construction and professional services contracts and procurements Caltrans and subrecipient local agencies award (see Chapter 5 and Appendix E).
- BBC analyzed the dollars Caltrans and subrecipient local agencies awarded to minority- and woman-owned businesses on transportation-related construction and professional services contracts and procurements during the study period (see Chapters 4 and 6).
- BBC examined whether there were any disparities between the participation and availability of minority- and woman-owned businesses on transportation-related construction and professional services contracts Caltrans and subrecipient local agencies awarded during the study period (see Chapter 7 and Appendix F).
- BBC reviewed the measures Caltrans uses to encourage the participation of minority- and woman-owned businesses in its transportation-related contracts and procurements as well its implementation of the Federal DBE Program (see Chapter 8).

- BBC provided guidance related to Caltrans' next overall goal for the participation of DBEs in its FHWA-funded contracts and procurements as well as additional program options and potential refinements to current contracting practices (see Chapters 9 and 10).

#### B. Availability Analysis Results

BBC used a custom census approach to analyze the availability of minority- and woman-owned businesses for Caltrans' transportation-related prime contracts and subcontracts, which relied on information from surveys the study team conducted with thousands of potentially available businesses located in California and information about the contracts and procurements Caltrans and subrecipient local agencies awarded during the study period. That approach allowed BBC to develop a representative, unbiased, and statistically-valid database of relevant California businesses to estimate the percentage of relevant Caltrans contract and procurement dollars for which minority- and woman-owned businesses are available. BBC presents availability analysis results overall and for different subsets of contracts and procurements.

1. All contracts and procurements. Figure ES-1 presents dollar-weighted availability estimates by relevant business group for Caltrans contracts and procurements. Overall, the availability of minority- and woman-owned businesses for relevant Caltrans work is 26.8 percent, indicating that minority- and woman-owned businesses might be expected to receive 26.8 percent of the transportation-related contract and procurement dollars Caltrans and subrecipient local agencies award in construction and professional services.

2. **Funding source.** As part of the Federal DBE program, Caltrans and subrecipient local agencies use DBE contract goals to award many individual FHWA-funded contracts and procurements. In contrast, because of Proposition 209, Caltrans does not use contract goals or any other race- or gender-conscious measures to award state-funded contracts or procurements. As shown in Figure ES-2, the availability of minority- and woman-owned businesses considered together is higher for Caltrans' FHWA-funded work (27.6%) than for state-funded work (23.4%).

Among other factors, that result could be due to the fact that a larger share of FHWA-funded contracts and procurements include subcontracts when compared with state-funded contracts and procurements. Subcontracts tend to be much smaller in size than prime contracts and are thus often more accessible to minority- and woman-owned businesses.

3. **Contract role.** Many minority- and woman-owned businesses are small businesses and thus often work as subcontractors. Because of that tendency, it is useful to examine availability estimates separately for Caltrans prime contracts and subcontracts.
