New Initiative Looks to Support Smallest of California Small Businesses

The Governor's Office of Business and Economic Development (GO-Biz) announced the California Rebuilding Fund, a new public-private partnership that will leverage government backed capital to support California's small businesses – especially the smallest under-served firms and entrepreneurs from communities that have been historically disenfranchised.

The initiative was approved yesterday during the California Infrastructure and Economic Development Bank's (IBank) August board meeting. Prior to the approval, the State of California allocated \$25 million and new statutory authority to IBank to enable a collaboration with the state's private sector. This public-private partnership will in turn drive capital to Community Development Financial Institutions (CDFIs) and other mission-based lenders that provide much-needed loans to California's underbanked small businesses. With the support of this new IBank funding, California's CDFIs increase their capacity to help small businesses recover and reposition themselves to survive the realities of the COVID-19 marketplace.

"Businesses across California have been devastated by COVID-19 and our smallest businesses have been the hardest hit," said Governor Newsom. "Ensuring that these businesses have access to capital will help jumpstart economic growth in communities across the state and provide needed support for entrepreneurs working hard to keep their doors open."

The California Rebuilding Fund is the latest program supported by the State of California aimed at helping the state's smallest small businesses in response to the COVID-19 crisis. Additional small business support by the State includes:

- On April 2, Governor Newsom announced that the state would allocate \$50 million to IBank for a COVID Disaster Relief Loan Guarantee Program (DRLGP) that mitigates barriers to capital for those small businesses that do not qualify for federal disaster funds, including low wealth and immigrant communities. The program has since been expanded to include under-served businesses that may have received

CSUSB launches School of Entrepreneurship first in California

With the start of the 2020 fall semester, California State University, San Bernardino (CSUSB) will launch the School of Entrepreneurship, the first of its kind in California. The unique program, one of less than 15 existing worldwide, will boost the university's already highly successful entrepreneurship program.

The School of Entrepreneurship, housed in the Jack H. Brown College of Business and Public Administration, further places CSUSB as a leading entity in the growing field of entrepreneurship education, said Mike Stull, a professor of entrepreneurship and director of the university's Inland Empire Center for Entrepreneurship, who will serve as the school's director.

"Establishing the School of Entrepreneurship is an important step for CSUSB and the Jack H. Brown College as it evolves and innovates to meet the needs of students and the local community," said Stull. "We envision a substantial positive impact, as it will further cement the JHBC reputation as a leader in the field of entrepreneurship education and increase the college's ability to engage with the local business community in terms of relationships, collaboration, and resources."

As a school of entrepreneurship, it will oversee and coordinate eight major academic programs in entrepreneurship with over 20 full- and part-time faculty, Stull said.

Cal State San Bernardino President Tomás D. Morales said he was pleased to give the final approval to establish the School of Entrepreneurship, which had been championed at the department, college, Faculty Senate, and by the provost.

"The School of Entrepreneurship represents a truly wonderful and pioneering example of our mission here at Cal State San Bernardino in offering our students a challenging, yet rewarding, educational experience," Morales said. "The school's offerings and dynamic faculty will inspire our students to succeed and help prepare



them for life after graduation where they will become our future business leaders and leading entrepreneurs."

"Our entrepreneurship program has evolved to the point where it makes sense for it to control its own destiny as a distinct academic discipline," said Lawrence Rose, dean of the Jack H. Brown College. "As a school, the program will gain greater visibility and collaboration campus wide. It will be able to innovate and engage different stakeholders across campus structures. Faculty recruitment will become easier, and employers will better understand what hiring a graduate from the School of Entrepreneurship can contribute to their organizations. I also strongly believe this will allow us to deepen our partnership with the community, bringing significant resources and collaborations that will benefit all parties."

The creation of the School of Entrepreneurship will significantly raise the university's profile in recruiting potential students and reinforcing its

efforts to become a "destination" program that draws students from beyond the Inland Empire region, Stull said.

"Students are looking for programs that are leaders and innovators in the educational field and have the ecosystem that will support their goal to create new ventures or become innovative change makers in their career field," Stull said. "CSUSB checks all the boxes in that regard – an innovative, well-established program that is going to the next level by creating a school of entrepreneurship."

For the existing CSUSB entrepreneurship faculty, the designation will provide an advantage in applying for external research and grant funding. It will also create a significant competitive advantage as the school recruits for top faculty talent. The designation also allows for more interdisciplinary collaboration on campus and the potential for joint faculty appointments with fields such as art, natural sciences, social sciences and education.

The school will add to the university's entrepreneurship program's already high profile within the inland region with potential employers, donors and other organizations, which in turn enhances support for startup ventures as well as job and internship opportunities for students in the school, said Stull, who added that the hope is that this will attract more local professionals and entrepreneurs to support the school as mentors, guest lecturers and adjunct faculty.

The CSUSB entrepreneurship program is accredited by the Association to Advance Collegiate Schools of Business (AACSB), the leading accreditation for business academic programs worldwide and has evolved and grown substantially since it was launched in the early 2000s.

Enrollment has grown from fewer than 20 students in fall 2002 to its current total of 265 students. Program officials believe strongly that the entrepreneurship academic program could nearly double in five years.

This growth will be fueled by increasing interest in entrepreneurship among students from all different fields. In fall 2020, CSUSB is welcoming its largest ever freshman class in entrepreneurship, and the school is launching several new initiatives including a dedicated graduate degree in Entrepreneurship and Innovation, collaborative entrepreneurship academic programs with Art, Liberal Studies and Education and unique new courses such as The Improvisational Mind, a collaboration between entrepreneurship and theater arts faculty.

"We believe strongly that the entrepreneurship academic program can reach 500 students by 2025," Stull said. "Supporting this potential growth is the fact that entrepreneurship expanded to our Palm Desert Campus in fall 2019 and is currently implementing a wide range of new courses and programs that appeal to students from every discipline on campus."

As entrepreneurship has grown at CSUSB, the greater academic field of entrepreneurship has also grown and evolved to become recognized through research and programs as a distinct discipline in the field of business. These trends, coupled with the anticipation of future growth

Steady Your Cash Flow

According to The New York Times, more than 70% of a seasonal company's income accrues during its busy cycle. During the strong months, you can prepare for a seasonal lull by creating a solid cash flow management plan that will ensure you can meet payroll and your bills year-round.

insufficient federal relief. In addition, the California Rebuilding Fund will also raise capital to enable CDFIs to fully utilize the COVID DRLGP.

- In his signing of the State Budget, Governor Newsom provided an additional \$50 million across all IBank Small Business Finance Center programs for loan loss mitigation and reducing the cost of capital for small businesses.
- The California Office of the Small Business Advocate (CalOSBA) with California's Office of Emergency Services (CalOES) have coordinated with six regional hubs to dis-

tribute free personal protective equipment (PPE) to under-served and impacted small businesses throughout the state. Orders for delivery as of 8/24 include: 7,188,010 face masks, 580,372 16.9oz bottles and 1,004 gallons of sanitizer, and 645,672 face shields for distribution.

- The California Entrepreneurship Task Force launched a series of virtual trainings to create a supportive community to help small businesses innovate and pivot during COVID-19.
- On July 8, California declared the month of July to be "California for All Small Business Month" and launched a new campaign, Calling ALL Californians: #ShopSafeShopLocal,

75 percent of Black business owners have seen an increase in business since June

In the days and weeks after George Floyd was killed while in police custody in late May, articles and posts online shared lists of Black businesses to support as the nation again confronted its racism.

Since the beginning of June, 75 percent of Black business owners have seen an increase in business, according to a poll of more than 400 Black business owners by Groupon and the National Black Chamber of Commerce. Searches for Black-owned businesses on Groupon have also increased by more than 300 percent in that time.

“George Floyd’s murder has brought America’s attention once again to the systemic racism that informs policing, prisons, banking, housing,

healthcare, and education,” the nonprofit NABC said in a release on June 8.

The flood of support was much needed, the survey found, with as many as 41 percent of Black small businesses forced to close permanently due to COVID-19 compared to just 17 percent of white-owned businesses, according to the National Bureau of Economic Research. And even though 76 percent of Black-owned businesses reported being negatively affected by COVID-19, only 5 percent of those that applied for a Paycheck Protection Program loan received one, the recent survey found.

While 74 percent of Black business owners reported being hopeful about the future of race relations in the United States, 74 percent said they’ve had fewer opportunities due to a lack of capital investment and resources targeted towards Black communities, according to the

survey, published to coincide with the beginning of National Black Business Month. Nearly half said it took between three and six years for their businesses to get off the ground and become successful, and 80 percent said they faced more challenges in doing so due to their race. Black business owners account for about 10 percent of U.S. businesses and about 30 percent of all minority-owned businesses, according to the U.S. Census Bureau.

“We’re thrilled to celebrate Black Business Month as this community has been disproportionately impacted by COVID-19 and traditionally suffers from a lack of access to adequate capital and resources,” said Aaron Cooper, Interim CEO, Groupon, in a release. “One of the many ways that we’re translating our support for Black Lives Matter into meaningful action is by highlighting and championing the success of Black-owned businesses and looking for more

ways to connect them to our diverse customer base. We hope that everyone will join us in supporting the more than 2 million Black-owned businesses in this country at a time when they need us the most.”

Groupon has also announced a number of initiatives, mostly based out of Illinois, where the company is headquartered, including a curated collection of Black-owned businesses, a “#PassTheMic” social media campaign and a series of panel discussions. The company is also partnering with Kiva.org, a nonprofit that allows people to lend money via the Internet to low-income entrepreneurs and students, to raise funds for a Black-owned business fund.

California High-Speed Rail Authority Releases Environmental Scoping Document for Los Angeles to Anaheim Project Section



Progress continues for Southern California high-speed rail. Today, the California High-Speed Rail Authority (Authority) issued a Revised Notice of Preparation (NOP) under the California Environmental Quality Act (CEQA), and a Revised Notice of Intent (NOI) under the National Environmental Policy Act (NEPA), for the 30-mile Los Angeles to Anaheim Project Section. The releases kick off a one-month formal scoping period to solicit input on additional facilities in the Cities of Colton and Barstow needed for project construction and operation.

As planned, the Los Angeles to Anaheim project section will travel along the BNSF Railway Company (BNSF) owned rail corridor between Los Angeles and Fullerton, which serves BNSF Railway's Hobart and Commerce Intermodal Facilities. The corridor runs through an urban environment, with other existing rail operators – Amtrak, Metrolink and BNSF – in the area.

In order to accommodate future high-speed rail service, and to do so in a manner that protects the ability of the current operators to make full use of the corridor during high-speed rail construction and operations, a portion of BNSF's freight rail service will need to be relocated away from the Los Angeles to the Fullerton corridor. This will be accomplished with the environmental clearance and provision of new freight facilities in San Bernardino County, consisting of a new intermodal facility in Colton and staging tracks in Lenwood, an unincorporated area of San Bernardino County near Barstow.

In conjunction with the public review period for the document, the Authority invites the public to participate by attending virtual public scoping meetings. The meetings will provide an opportunity for the public to hear about the Revised NOP/NOI and provide comment. Comments received will be reviewed and responded to as required by law.

Written comments on the scope of the Los Angeles to Anaheim Project Section Environmental Impact Report/Environmental Impact Statement should be provided to the Authority by Thursday, Sept. 24.

this. You can automatically track and send out invoice reminders, set terms and implement late fees to help encourage your clients to pay on time.

Maximize the Off-Season

Leverage your slow season – The off-season can be a great time to train employees, especially if you've purchased new equipment. A staggering number of workplace injuries occur within the first five years of employment, according to SFM, so having trained, experienced workers can be a big benefit to your business and protect your working capital.

Stay current with industry trends – Growing your business means you can use the off-season to attend trade shows. Understanding the latest construction methods and technology helps you compete in the field and stay relevant to your customers.

Network with other construction business owners – The off-season is also a good time to network. Sometimes you can team up with another company to bid on large projects where you each have a particular strength. Or you can refer work to each other if you're too busy to take it on.

and development of the program, resulted in the unanimous decision by the CSUSB entrepreneurship faculty to propose the establishment of a new academic unit representing Entrepreneurship.
