## Materials Shortages in Construction: Catapulting a Sustainability Revolution?

Across the globe, the impact of Covid-19 on the construction sector continues to weigh heavy on the industry bringing forward new and evolving challenges in its wake. Social distancing measures, local lockdowns and rows over contracts began as early as March 2020 when the pandemic first hit. Now as our economies move to ease restrictions the industry is faced with managing the impact of material shortages across the supply chain.

For countries like the UK, the fallout from Brexit coupled with Covid-19 is impacting the sector, driving up prices for critical materials the country's construction sector urgently needs to respond to the post lockdown demand. With a surge in construction activity and output in recent months across the UK, is the shortage a local issue or something that is hitting countries across the globe?

**Post-pandemic bounce-backs: are they supercharging the issue?**

Several countries are experiencing a post-pandemic bounce back in construction. The sector is addressing a backlog of orders, and revenue expectations along with a surge in construction confidence has meant pressure on material needs are increasing. According to the US Chamber of Commerce Commercial Construction Index, construction material prices are increasing significantly causing additional pressures on existing project revenues. Lumber and steel, two primary building materials across the US, have seen prices increase anywhere between 20-25%.

Most industry professionals cite the impact of the Covid-19 pandemic as the main factor in these price hikes. When local and national lockdowns began to come into effect in early 2020, many factories reduced their production output as demand lowered. Essential health and safety measures meant they were unable to operate at full capacity in order to protect

## High-Speed Rail Celebrates 6,000 Construction Jobs While Helping Train for the Future

The California High-Speed Rail Authority (Authority) today announced it has crossed another milestone with 6,000 construction jobs created to date across 119 miles of active construction in the Central Valley.

“We wouldn’t be where we are today without all the dedicated women and men who are out in the field each and every day,” said Garth Fernandez, Central Valley Regional Director. “We’re proud to work with a skilled labor force that is bringing high-speed rail to life while working with statewide and local partners to help train the next

generation of high-speed rail professionals.”

Last month, the Authority welcomed students as part of ValleyBuild Partnership, a workforce training program that provides pre-apprenticeship training in the building and construction trades to put students on a path to the union construction apprenticeship of their choice.

“These students come from up and down the Central Valley, particularly from disadvantaged communities. We prep them for the job opportunities that come about on high-speed rail and other transportation projects,” said Chuck Riojas, executive director of the Fresno, Madera, Tulare, Kings Building Trades Council. “Bring-

ing them onto construction sites gives them real-world experience and purpose to stick it out and become the next generation of workers responsible for building for the future.”

Each of the project’s design-builders is implementing the Targeted Worker Program, where 30 percent of all project work hours are performed by workers from disadvantaged communities

where annual household incomes range from \$32,000 to \$40,000. Out of the more than 6,000 jobs created, 2,230 went to residents from Fresno County, 1,039 from Kern County, 217 from Kings County, 291 from Madera County, and 588 from Tulare County as of July 2021.

## 4 Tips For Obtaining Construction Surety Bonds

The ability to obtain surety bonding is a necessity in the commercial construction industry. Public entities typically require bid bonds along with performance and payment bonds for their projects.

General contractors often require surety bonds from their subcontractors. More and more private entities are requiring bonds to protect themselves against contractor default. Establishing and maintaining a surety line can be challenging for a construction company.

We've put together the following tips to aid you in securing construction surety bonds or increasing your bonding capacity:

### Select a Reputable Bond Broker & Surety Company

When selecting a surety bond broker or producer you want to make sure they specialize in contract

surety bonding and are familiar with construction contracts in the states you will need bonding. A good place to start is with the National Association of Surety Bond Producers (NASBP). Your broker will be able to match your company with a surety provider that best meets bonding needs.

Make sure your broker only works with reputable surety companies. Your surety company should be certified with the U.S. Department of Treasury to write surety bonds for federal construction projects and have an A-rating or higher from A.M. Best or an equivalent rating from a respected rating organization such as Dun & Bradstreet or Fitch Ratings.

The surety company your broker selects needs to be able to meet your bonding needs including the ability to bond you in the states your work and has the capacity for your workloads.

### Get Prequalified

Before you do anything that's going to require a surety bond, whether it's a contractor license

bond, bid bond, or performance and payment bond, you will have to go through a prequalification process to ensure you are bondable and to determine your bonding capacity.

The surety company will want to review the financial statements of your company along with the personal financial statements of all owners. Other information the surety company will want to review includes an organizational chart, business plan, management, and continuity plans, resumes of key personnel, history of work completed, references, and line of credit.

### Build a Relationship With Your Broker

Your broker should be your ally and advocate. Open communication is the key to building a good relationship with your broker and surety company. You need to notify them at the first sign of problems with a construction project.

Keep your broker updated on any changes to your company, such as ownership changes or

plans on expansion into new markets or larger projects. Your surety company is more likely to increase your bonding capacity if you've established a pattern of trust and reliability.

### Maintain a Healthy Business

In order to maintain and grow your bonding capacity, you need to maintain a healthy business, and a healthy business is a profitable one. This means being able to successfully manage cash flow and completing projects on time and within budget.

You should also work within your capacity and don't overextend beyond your capabilities. This may mean not taking on new projects if you don't have the working capital, equipment, and personnel to successfully complete the project.

## ADUs Must Be Built for BIPOC Communities, by BIPOC Builders

Since I was in middle school, my dad has owned a small construction business. On my way to school, I would help him check the numbers on his bids. On my way home, I would sometimes hear the outcomes. There was always an excuse. My dad either "didn't have enough experience" or the general contractor went with who they knew and were "comfortable with." I knew these were covers because my dad had worked for over a decade managing similar projects as a civil engineer. What he didn't have was membership in the good ol' boys club. Until he did, his "impressive" bids would not be enough

to win the larger contracts. The systematic exclusion of small BIPOC (Black, Indigenous and People of Color) builders like my father from the construction industry robs BIPOC communities of another avenue to generate wealth. California's growing boom in accessory dwelling units, or ADUs, can help right this wrong.

### THE LINGERING EFFECTS OF REDLINING HURT SMALL BIPOC BUILDERS

One in four of California's 70,000 construction firms are BIPOC-owned. In a state where residents of color represent the majority, small BIPOC builders struggle to enter the \$118 billion construction industry. They have to jump through hoops to get their businesses off the

ground, and then must jump through more hoops to keep their businesses afloat.

These obstacles are not merely the cost of doing business, but an inequity stemming from redlining that continues to deprive BIPOC communities of vital wealth-building, small business opportunities.

Small BIPOC builders are undercapitalized. While many small White builders can source start-up capital from their assets or family and friends, the racial wealth gap ensures that small BIPOC builders usually do not have this option. This often leaves banks as the only available funding source. However, BIPOC businesses in general are denied loans more often and pay higher interest rates than White-owned businesses, accord-

ing to the U.S. Department of Commerce. They are also systematically excluded from relief programs. A Center for Responsible Lending study found that during the COVID-19 pandemic, structural inequities in the Paycheck Protection Program meant that small BIPOC businesses were less likely to qualify for critical loans.

Then, there's the chicken-and-egg dilemma of capacity and experience. To win projects, small BIPOC builders need the capacity to complete them. But, to build capacity, they need projects. Too often, they are shut out of the market with a slew of excuses, left without the skills and exposure they need to grow their businesses.

### SBA Awards \$5.2 Million in PRIME Grants to Help Emerging Micro-entrepreneurs Gain Access to Capital

#### Grants Will Help 27 Organizations Provide Technical Assistance and Training Services to Economically Disadvantaged Businesses in HUB and Opportunity Zones

The U.S. Small Business Administration has awarded 27 organizations across the United States a total of \$5.2 million under the Program for Investment in Micro-Entrepreneurs (PRIME) grant awards. PRIME supports these nonprofit organizations as they help low-income entrepreneurs get financing to establish and expand their small businesses by providing direct technical assistance, or provide capacity-building training

for other organizations that provide capital to underserved small businesses.

“The Biden-Harris Administration and Congress have worked together tirelessly to ensure our nation’s small businesses have the resources they need to survive this pandemic and build back better,” said SBA Administrator Isabella Casillas Guzman. “This year, SBA focused our PRIME grant selection process on our nonprofit partners who can best bring federal resources to life, especially in the regions and communities where they are needed most. I look forward to partnering with these organizations as they help us connect America’s entrepreneurs with the capital they need to start and grow their enterprises.”

Congress established PRIME as part of the Program for Investment in Microentrepreneurs Act of 1999. Grant funds will be made available on September 30, 2021, and the project period for each grant is one year.

The SBA placed special emphasis in this year’s competition on projects that will offer training and technical assistance to strengthen economically disadvantaged businesses, particularly those that service entrepreneurs in Opportunity Zones, rural areas, and HUBZones.

Among this year’s 27 recipients, 15 provide services in Opportunity Zones and 12 provide services in HUBZones. Nearly 9,000 communities in all 50 states, the District of Columbia, and five

U.S. territories have been designated as Opportunity Zones.

The PRIME grants range from \$75,000 to \$250,000, and typically require at least 50 percent in matching funds or in-kind contributions. In total, over 101 organizations applied for PRIME grants for 2021.

## Mayor London Breed Expands CityBuild to Support San Francisco's Local Workforce and Economic Recovery

Mayor London N. Breed and the Office of Economic and Workforce Development (OEWD) today announced the expansion of CityBuild, a nationally recognized construction training program that provides career pathways for historically underserved San Francisco residents into the building and construction trades, to now serve 600 local residents over the next two years. The expansion, which doubles the number of participants, will provide more opportunities for workers to learn in-demand skills, receive wraparound services and job placement assistance in the City's growing construction industry.

"As we look to our economic recovery and focus on getting people back to work, it is critical that we invest in providing our local workforce with the skills necessary to succeed. That is why we are doubling the number of CityBuild participants and creating more well-paying jobs for local San Franciscans," said Mayor Breed. "Training our city's workforce and placing them in meaningful careers will support those that were most impacted by the

pandemic and help drive equitable employment opportunities for our city's residents."

The expansion will double CityBuild's capacity to train 600 participants through CityBuild Academy, Special Trainings, and CityBuild-Building Trade Partnerships, including funding through Mayor Breed's Women & Families First Initiative. The construction industry anticipates significant growth due to the local hiring requirement that is part of President Biden's infrastructure package. In August, the U.S. Senate approved President Biden's \$1.2 trillion proposal to invest in the nation's roads, bridges, public transit, broadband, and essential infrastructure, creating hundreds of thousands of jobs nationwide, including goals for local community hiring.

"Local Hire has led to more job opportunities for historically underserved communities. The expansion of CityBuild capitalizes on those opportunities to ensure that local residents have access to livable wages and long-lasting careers in a growing industry," said Kate Sofis, Director of the Office of Economic and Workforce Development. "CityBuild is vital to San Francisco's equitable economic recovery—serving as an example of how we can meet

the moment, strengthen our local workforce, and get San Franciscans back to work"

San Francisco's Local Hire Ordinance requires 30% of all project hours on City-funded construction to be performed by local residents. CityBuild assists in providing a pipeline of qualified workers to meet the requirements of the Ordinance and the demands of the industry. In years since the Local Hire Ordinance's adoption, local residents have performed 33% of a total of 8.2 million work hours on covered projects, with 48% of apprentice hours worked by local apprentices. President Biden's Infrastructure deal builds on the success of local hiring policies to create economic opportunity for disadvantaged residents by implementing a resident hiring requirement in Federal infrastructure construction projects for the first time, creating a significant demand for San Francisco residents in the construction industry. Congress will resume consideration of the proposal upon returning from recess on September 20.

"CityBuild was the Office of Economic and Workforce Development's first training program, pro-

Finally, like so many other industries, the construction industry is all about who you know. Typically, small builders attend networking events and conferences to raise their business profile. But many small BIPOC builders cannot afford the cost or time away to attend these events and benefit from these networks. And many more are not even invited.

### A DIVERSE ADU WORKFORCE WILL BUILD WEALTH IN BIPOC COMMUNITIES

California must do more to equip small BIPOC builders to thrive in the construction industry. When BIPOC businesses thrive, their communities thrive. If California's construction industry resembled the state's racial diversity, BIPOC communities could expect about \$32.4 billion of payroll investments alone. This money flows directly to these communities, as BIPOC builders employ BIPOC workers at higher rates. They are also more prone to spur culturally-informed redevelopment in majority-BIPOC neighborhoods. Addressing systemic barriers to entry in the construction industry will thus expand intergenerational wealth in formerly redlined communities across California.

The statewide Accessory Dwelling Unit boom presents an opportunity to diversify the construction industry and generate wealth in BIPOC communities. Also called a casita or in-law unit, an accessory dwelling unit is a smaller housing unit located on the same lot as a single-family home. About 9,000 ADUs are built in California each year. Small BIPOC builders can use these small-scale projects to build their portfolio and client base and eventually tackle larger projects in the future. By committing to include small BIPOC builders in ADU development, cities and the state will expand and target resources and business development opportunities for BIPOC businesses.

Mobile applications that make it easy to evaluate participation and effectiveness of safety activities also allow construction businesses to make that data readily accessible across business divisions, thereby eliminating existing information silos.

#### Improve training through digital content

Recent research has shown that 90% of work-site accidents are caused by unsafe behaviors and envi-

ronments. This often happens as a result of a lack of understanding of the safety protocols by on-ground personnel, inadequate safety training, and a general lack of awareness of established safety protocols. The existence of safety protocols and the availability of safety training are often not enough to ensure all workers are properly briefed regarding the relevant safety processes.

Creating digital content can help business leaders ensure that each worker on the ground has easy access to this information at all times. Digital content, when distributed through an integrated data service, also allows managers to make sure participation and engagement levels remain high during the training. Refresher courses and regular digital assessments can also improve workers' familiarity with new processes and regulations they should be aware of.

#### Augment physical labor with wearable technology

A recent United States Chamber of Commerce report detailed the rise of wearable technology in the construction industry, predicting that almost a quarter of contractors will use this technology by 2023. Wearable technology in construction can come in many forms, from augmented reality and virtual reality headsets to exoskeletons that provide muscular and skeletal support for employees dealing with heavy physical workloads.

The physical nature of work in the construction industry can often take its toll on the human body and overexertion is a common cause of injury and fatigue at many jobsites. The use of wearable technology can physically strengthen workers with exoskeletons, while monitoring fatigue levels and identifying vulnerable workers before a disruptive event is recorded.

#### Preempt safety gaps with predictive data analytics

The introduction of any modern technology into construction sites can generate massive amounts of data that can be analyzed to extract valuable insight. Recent research has shown that the proper use of predictive analytics can predict workplace accidents with almost perfect accuracy. As construction hardware increasingly connects to the Internet of Things, software analysis of the data collected from them must keep pace.

Predictive analysis allows site managers to identify mechanical points of failure before it happens. This greatly reduces the likelihood of workers being hurt due to malfunctioning or under-serviced equipment.

#### React to catastrophic events quickly with localization technology

As a result, the integration of all these technologies becomes extremely important. their workers. The knock-on effect of this has badly impacted material supply chains and hampered hauliers who have struggled to move goods across the globe as transport and shipment delays came into play. Egypt's Suez Canal blockage in March of this year lasted for six days and data from Lloyd's List showed the stranded ship was holding up an estimated \$9.6bn of trade along the waterway each day of the blockage.

### Build, build, build

But what does this mean for our governments who are pledging to build their way out of the economic impacts of the Covid-19 crisis? Demand for construction materials continue to increase as a result of new government-backed and much needed infrastructure, commercial and residential projects in many countries, yet crucial supplies have slowed, and prices are on the rise.

Although Brexit is impacting the UK more sharply, the global knock-on effect of changes to customs and tariffs rules are beginning to emerge. New paperwork needed for covering trade between the E.U. and U.K. has meant that both markets are experiencing delays

when it comes to building materials being imported and exported as border officials deal with a new and complex landscape. And widespread global shortages for materials like steel and timber means that many construction companies will need to explore alternatives to the traditional materials they use.

When it comes to construction, are we at a tipping point towards necessitating sustainable solutions for good? With a commercial need for alternative materials and new methods of construction, how can the construction industry capitalise on this opportunity? Also, what are the alternatives, and how can they be used as ammunition in the material shortages battle?

### Modern methods of construction

Shortage of suitable available housing is a growing global issue that all governments are tackling. It is top of the agenda in the UK and Ireland, with the authorities setting ambitious targets when it comes to providing more affordable homes.

Over the past 15 years, CityBuild's Training Academy has graduated 1,350 participants, including 146 through partnerships with projects such as the Chase Center, Gleneagles, and Alice Griffith. Graduates of the program represent the diversity of San Francisco's disadvantaged job seekers with 30% Black, 19% Latino, and 36% Asian-Pacific Islander. In an industry that is nationally comprised of less than 1% women, CityBuild graduates are comprised of 12% women.

"At the core of CityBuild's success are our partnerships," said CityBuild Director Ken Nim. "Thanks to the support from labor organizations, construction contractor community, inter-agency and government collaboration, and community-based organizations providing services on the ground, we developed a strong foundation to deliver a program for all San Franciscans to prosper.
