# How Building Design Has Evolved in the Wake of Increased Natural Disasters

Every time you turn on the news, it seems like another natural disaster has struck in some part of the world. From major floods and hurricanes to earthquakes and tornadoes, natural disasters of all types are becoming increasingly common around the globe—including right here in the United States.

Natural disasters are nothing new, but they are happening more frequently and causing more damages. In 2017 alone, there were 15 natural disasters in the United States, each of which caused more than \$1 billion in damages. In response to the increasing prevalence and cost of natural disasters, architects and builders are embracing new technologies and materials that can withstand such events.

There are several ways in which building design has evolved in the wake of the storms and other natural disasters that have plagued the nation in recent years. Here are just a few of them.

#### Disaster Resilience

In places like the United States, disaster resilience has become a hot topic in the construction industry. Builders need to create housing and commercial buildings that can withstand the forces of things like hurricanes, earthquakes, and tornadoes and recover quickly following such a disaster.

Buildings with resilient designs and materials are becoming increasingly common, especially in areas that are prone to things like hurricanes, floods, fires, and tornadoes. Because they are designed to experience minimal damage during such events, their owners typically have to spend less during the recovery process. In fact, for every \$1 spent on resilient construction, the average building owner saves \$6 in recovery costs.

#### **Building to Withstand High Winds**

High winds are the leading cause of damage in tornadoes and hurricanes. When wind speeds exceed 100 miles per hour, the consequences can

# **Construction Employment Increases In 265 Metros From November 2017 To November 2018**

Houston-The Woodlands-Sugar Land and Weirton-Steubenville, W.Va.-Ohio Have Largest Annual Gains;St. Louis, Mo.-Ill. and Laredo, Texas Have Worst Total and Percentage Job Losses for the Year

Construction employment grew in 265, or 74 percent, out of 358 metro areas between November 2017 and November 2018, declined in 45 and was unchanged in 48, according to a new analysis of federal employment data released today by the Associated General Contractors of America. Association officials cautioned that employment gains may be tapering off because contractors cannot find enough qualified workers.

"Construction employment growth remains widespread, but as unemployment hits historic lows in many metros, contractors are having ever-increasing difficulty filling positions," said Ken Simonson, the association's chief economist. "As a result, construction employment may level off in more areas, even while the demand for projects—and workers—continues to be strong."

The Houston-The Woodlands-Sugar Land, Texas metro area added the most construction jobs during the past year (24,000 jobs, 11 percent). Other metro areas adding a large amount of construction jobs during the past 12 months include Phoenix-Mesa-Scottsdale, Ariz. (17,500 jobs, 15 percent); Dallas-

Plano-Irving, Texas (14,800 jobs, 10 percent); and Orlando-Kissimmee-Sanford, Fla. (11,100 jobs, 15 percent). The largest percentage gain occurred in Weirton-Steubenville, W.Va.-Ohio (26 percent, 500 jobs), followed by New Bedford, Mass. (22 percent, 600 jobs) and Lewiston, Idaho-Wash. (21 percent, 300 jobs).

The largest job losses between November 2017 and November 2018 occurred in St. Louis, Mo.-Ill. (-4,500 jobs, -7 percent), followed by Baltimore-Columbia-Towson, Md. (-3,000 jobs, -4 percent) and Middlesex-Monmouth-Ocean, N.J. (-2,400 jobs, -6 percent). The largest percentage decrease occurred in Laredo, Texas (-10 percent, -400 jobs), followed by Portland-South Portland, Maine (-9 percent, -900 jobs) and Spokane-Spokane Valley, Wash. (-8 percent, -1,100 jobs).

In November, Simonson noted, the number of unemployed jobseekers with recent construction experience—375,000—was the lowest yet for that month. Meanwhile, job openings in construction totaled 292,000 at the end of October, a jump of 59,000 or 25 percent from a year earlier and the highest October level in the 18 years that the Labor Department has published the series. Together, these figures suggest contractors in many metro ar-

eas cannot find experienced workers to fill vacancies. Simonson said.

Association officials said the steep increase in job openings, along with the record low availability of workers with construction experience, underscores the need for policy measures to increase the supply of workers. They urged government officials to modernize career and technical education, double the funding over the next five years and enact immigration reforms that would enable construction employers to bring in international workers when there are not enough locally available construction workers.

"The construction industry makes a major contribution to the economies of metro areas nationwide, but those gains are at risk," said Stephen E. Sandherr, the association's chief executive officer. "Public officials should do their part to help local economies continue growing by overhauling career and technical education to prepare more students for rewarding and high-paying careers in construction. At the same time, immigration reform can provide needed shortterm relief while communities rebuild the pipeline for recruiting and preparing local workers."

### L.A. secures \$23 million for community revitalization in Pacoima-Sun Valley

State Cap-and-Trade grant will support environmental projects, zero-emission transportation, and workforce development programs

Mayor Eric Garcetti announced that L.A. has been awarded \$23 million in State Cap-and-Trade funding for environmental projects, zero-emission transportation, and workforce development programs in Pacoima-Sun Valley.

"The people of Pacoima-Sun Valley have been tireless in their pursuit of a healthier, more prosperous future for their children and grandchildren — and today that hard work is paying off," said Mayor Garcetti. "These funds will help to improve public health, create goodpaying jobs, and enhance the quality of life for Angelenos in an extraordinary community.'

The Department of City Planning and several community organizations were also awarded a \$200,000 planning grant to position South L.A. for more significant state Cap-and-Trade funding in the future.

Both grants are administered by California's Transformative Climate Communities (TCC) program, which is overseen by the California Strategic Growth Council (SGC), a committee formed by the state Legislature to advance local community revitalization efforts.

The Pacoima-Sun Valley TCC implementation grant will fund environmental initiatives and low-carbon transportation options that will reduce greenhouse gases — including 14 new battery-electric DASH buses to service Pacoima-Sun Valley, the installation of solar panels on 175 single-family homes, and the planting of 2,000 street trees to create shade for commercial and residential properties

The funding will also finance safety improvements along 2.4 miles of City streets and over 900 feet of new sidewalks, as well as renovations at David M. Gonzalez Park - including the installation of a stormwater bioswale, walking paths, and nearly 100 trees. These improvements will create new jobs that Pacoima-Sun Valley residents can access through workforce development programs.

"This is a tremendous win for the Northeast San Fernando Valley," said Councilmember Monica Rodriguez. "I look forward to working with our partners to reverse decades of injustice and accelerate greener, healthier neighborhoods for our kids and future generations."

The programs are linked with an anti-displacement plan for businesses and residents, including efforts to bring existing accessory dwelling units (ADUs) up to code, which will enable homeowners to legally rent the units, delivering a new source of income for low-income families and bolstering the community's affordable housing supply.

"Fed up with decades of incompatible land uses and the burden of negative health impacts, the residents of the Northeast San Fernando Valley came together and crafted a real plan with real deliverables," said Councilmember Nury Martinez. "Through the Strategic Growth Council's proposed award of \$23 million, it is clear that environmental justice neighborhoods not only have a voice, but they are the front line in the fight against climate

The programs being funded through the TCC grant were developed by the "Green Together" collaborative, led by Pacoima Beautiful and including Community Partners, the Trust for Public Land, GRID Alternatives, Los Angeles Conservation Corps, Los Angeles Business Council, the Los Angeles Cleantech Incubator, the UCLA Center for Neighborhood Knowledge, the Department of Transportation, and the Bureau of Sanitation.

"This project will truly transform Pacoima and Sun Valley," said Pacoima Beautiful Executive Director Veronica Padilla. "This investment in our community is a reminder that genuine

### Smart Ways TO WORK

#### **Negotiate Overwork Situations Without Getting Fired**

Nationally, unemployment is at its lowest level in approximately 30 years. Even with the rash of downsizing and mergers, many jobs are open but unfilled due to lack of candidates. Within some industries, there are candidates literally lined up just waiting for a chance. With this looming in the background, what should do when you find yourself overworked but nervous about negotiating a more reasonable and realistic workload with your boss. Is it safer to grin and bear it than complain? Martyrhood is unnecessary. You can negotiate a doable workload without getting fired.

With jobs changing so quickly, renegotiating your position or responsibilities is becoming more common. Overwork situations are not all created equal. Are you overworked consistently; week after week there are not enough hours to accomplish your routine responsibilities? Is your overwork occasional, coinciding with special projects? It may be more comfortable to negotiate about a specific project or a looming deadline than it is to discuss your entire job and its overall responsibilities. However, if you are fully prepared, able to document your situation, usually in writing, and offer solutions, change is possible. The better you understand your boss, the easier this will be.

#### **Unaware Boss**

With jobs changing so quickly, renegotiating your position or responsibilities is becoming more common. Your boss may be unaware of your situation and needs to be fully apprised. For example, you have four major areas of responsibility, and the special 6-month assignment to the task force is now moving into its second year. If that project takes 40 percent of your time, there is no way to complete your other responsibilities even if you work 10 hours a day. Suggestion: Do your homework prior to scheduling a meeting. Think about what the job entailed originally and contrast that to what the job circumstances are now. Your boss may not take the initiative to renegotiate with you because he or she may not recognize the importance of those changes.

#### **Swamped Boss**

Your boss may know exactly what is going on because he or she is equally overworked. At the risk of sounding like a time management specialist, negotiation always starts with reviewing priorities. Suggestion: In a situation where all the work cannot be accomplished, having an agreement about the order in which tasks are done can go a long way to reducing those explosions caused by not doing a task that ended up being important.

#### This-Is-For-Your-Own-Good Boss

If you have a supervisor who intentionally assigns more work than can be done, that may reflect a belief that having too much to do keeps people on their toes. Suggestion: You need to be more assertive in your communication and set boundaries at the time you receive the assignment. Accept it, but be sure to outline the conditions of your performance. "I am willing to try but given the time frame and the trip to headquarters intervening, it's quite possible that I will not be able to finish." In the case where you have a long project that will take many months, be sure to give your boss progress reports on a regular basis. This is particularly important if you have some question about whether you can complete it in time. This avoids the last-minute recriminations or hysteria as it becomes clear to everyone that the deadline will be missed.

#### Additional Strategies

Ask for very short 5 or 6-minute conversations every morning where you talk with your boss about what you plan to do and your priorities. If your boss does not institute these conversations. you should. That way you have daily agreements on work needs and can also identify upcoming problems.

Being up front about your situation is always important. Whenever the workload is heavy, you need to let people know where you stand. If you are falling behind, be up front about it so that your colleagues have some warning if you're going to call upon them for help. Although that means they must delay their own projects. This sort of juggling is not unusual, and often it is the two supervisors

who rearrange the work schedule. It is too late to learn Thursday morning that a promised document due to a client will not be finished in time. Your boss and colleagues need to know this earlier in the week, giving them enough time to find an alternative and avoid a crisis

If the overwork situation is affecting your entire department, you might approach your boss as part of a team. Present the situation and a plan to reorganize responsibilities, increase the head count, streamline procedures or other solutions from which he or she can choose. A well thought out strategy can often get your boss's support and in turn allow you that extra position.

Solving overwork problems is tied to your ability to be self-confident, to come to consensus in setting important goals and your relationship to your boss.

A \$200,000 planning grant was also awarded to the Los Angeles Department of City Planning and South L.A. community organizations, including the Los Angeles Equity Alliance. Brotherhood Crusade, and South Los

Angeles Transit Empowerment Zone (SLATE-Z). The grant will fund the development of a "South L.A. Climate Commons Plan," a climate resilience strategy to revitalize community spaces, create jobs, and prevent residents and businesses from being displaced.

"This award signifies a shift in the way we think about community planning and investment, acknowledging systemic injustice and marginalization facing low-income communities of color," said Gloria Walton, President and CEO of Strategic Concepts in Organizing and Policy Education (SCOPE), an organization in the Los Angeles Equity Alliance. "The plan provides an opportunity for us as a city to grapple with critical issues like climate change, structural poverty, and displacement and to reimagine a more equitable and just future."

Since 2015, Mayor Garcetti has worked to secure nearly \$160 million in Cap-and-Trade funding to support affordable housing, urban environmental programs, and zero-emission transportation options, including a \$35 million TCC grant for Watts last year.

# New Small Business Public Works Certification Effective Jan. 1, 2019

Senate Bill 605 was signed into law on Oct. 11, 2017, amending Government Code (GC) sections 14837 and 14838, which are certification provisions of the Small Business Procurement Act. This bill will create more opportunities for small businesses because it increases the Small Business (SB) Gross Annual Receipts (GARS) cap to \$15 million for SBs and \$5 million for microbusinesses. Senate Bill 605 also creates a

new SB certification category for Public Works (PW) contracts and PW projects as defined in California Public Contract Code § 1101 and GC § 4525. The eligibility requirements for SB-PW suppliers are a maximum of \$36 million GARS averaged over the last three years and a maximum employee count of 200 averaged over the most recent four quarters. This new certification expands opportunities to participate in public

works projects to firms that are relatively small in the PW arena. Also, it allows SBs close to exceeding the \$15 million GARS cap to maintain an SB certification for PW contracts and projects. #### How Building Design Has Evolved in the Wake of Increased Natural Disasters

be devastating. Many traditionally built homes and buildings simply are not equipped to withstand the force and end up facing extreme damage. Ripped-off roofs, homes being lifted off their foundations, and flying debris penetrating structures are all common causes of damage during these types of storms.

Because natural disasters involving high winds are becoming more and more common, builders are working to construct buildings that can weather the storm. Many of the same practices that are used in hurricane-prone areas are now being used in areas where tornadoes are common since the winds experienced during the two events are similar.

Practices like creating load path continuity from the roof-to-wall connections all the way through to the wall-to-foundation connections help keep roofs from detaching during high winds, and materials like laminated windows minimize damage from airborne debris.

While current building codes in most areas only require nails for making roof-to-wall connections, experts recommend using metal connectors to further help keep everything in place. When any type of adhesive is used in the construction of a home, it is vital to ensure that it is appropriate for the application to prevent it from failing during a severe weather event. In many situations, metal bracing and/or connectors should be used to strengthen bonds when construction adhesive is used for structural applications.

#### **Building for Earthquakes**

Earthquakes present their own unique challenges. Like strong winds and tornadoes, these events can destroy buildings in a matter of seconds. Withstanding seismic activity, however, requires different techniques and materials than withstanding high winds.

In response to the increasing number of earthquakes, builders are creating ductile structures that are capable of sustaining significant damage without losing their strength or stability. This helps prevent building collapse and keeps occupants safer during earthquakes. Steel is a highly ductile material, so it is often used in structures in areas where hurricanes are likely to occur. Builders must also be mindful of how steel building frames move when subjected to seismic activity.

Research into how to make buildings more resistant to earthquakes is ongoing, but builders have already started implementing a wide variety of materials and techniques. Shock absorbers, for example, are often placed on each level of a building to minimize horizontal movement. In skyscrapers, massive pendulums are installed to absorb vibrations caused by both earthquakes and high winds.

#### Flood Resistance

The oceans are rising, and flooding is happening more often than ever before. In the United States alone, more than 36 million people reside in places where there is a high risk of flooding, so builders have developed ways for homes and commercial buildings to better withstand this type of damage.

In coastal areas, homes are commonly built on stilts or pier foundations. This type of construction allows even major floods to flow underneath the home without causing any damage to the house itself. Buildings in flood-prone areas also tend to only use ground-level floors for parking or storage. Builders install special breakaway walls that are quickly knocked out by flood waters, enabling the water to flow through freely. This helps keep the structures from being washed away.

#### Conclusion

Tornadoes, wildfires, earthquakes, hurricanes, floods, and other natural disasters are all becoming increasingly common. There is no denying that our world is changing, and builders and architects are responsible for creating homes and commercial buildings that are capable of withstanding the forces of mother nature. 
