Building Relationships: One Construction Project at a Time

Strong relationships between general contractors and subcontractors are an important component of a successful project. These relationships don't mature overnight, and it takes time effort from both parties to build a level of trust that evolves into a strong working partnership. Putting in the work to build these relationships can be mutually beneficial to both parties and pay off for years to come.

So, how do relationships between and subcontractor and a general contractor start? Sometimes a general contractor needs additional bid coverage for a project or is expanding into new areas. A subcontractor might be looking to break into doing larger projects or branch out into other sectors of the industry.

Regardless the how or why, they usually begin with a single project, a single bid. Here are some tips for both general contractors and subcontractors to follow to build strong relationships through every step of a project from the initial bid phase all the way through project completion.

During the Bid Process

Subcontractors

If you're bidding to a general contractor for the first time this is your opportunity to make a strong first impression. In addition to a competitive bid, you need to prove that your company is the best choice to perform the work. This means putting together a proposal highlighting your company's level of experience, expertise, knowledge base, and capacity to perform the work.

A strong portfolio of past projects, sound financial footing, and stellar safety record are great ways to make your company stand out amongst the competition. Be sure to ask any questions if you are unclear on the scope or scale of the project and always attend any pre-bid meeting the general contractor holds.

General Contractors

When bidding out projects, make sure your invitations to bid (ITBs) are easy to understand and provide as much information and documents necessary for subs to submit a bid. Make sure the scope of work for each trade is clearly defined to avoid subs bidding on work that they assume might be part of their bid.

Mayor Garcetti unveils new zero-emission equipment at Port of Los Angeles

Mayor Eric Garcetti celebrated California Clean Air Day at the Port of Los Angeles by unveiling state-of-the-art, zero-emission port equipment and showcasing the world's first all-electric tophandlers — one of 16 Port projects deploying or testing zero-emission technologies.

"Every Angeleno deserves to know that future generations will inherit a sustainable city and a livable planet — and that our air, water, and natural resources will be protected and preserved," said Mayor Eric Garcetti. "Clean Air Day gives L.A. an opportunity to show what it means to put our principles into practice with cleaner transportation, goods movement, and energy sources — to leave a healthier world for our children and grandchildren."

Mayor Garcetti was joined by Congressmember Nanette Barragán and L.A. County Supervisor Janice Hahn to unveil the zero-emission equipment as part of California Clean Air Day — a

"Today shows we are making good on our pledge to do the hard work of advancing commercially feasible solutions to meet our goal of transitioning all cargo handling equipment to zero-emissions by 2030," said Port of Los Angeles Executive Director Gene Seroka. "We're excited to power up these battery-electric top handlers and test them under the real-world conditions of a working container terminal."

Known as "top-picks" or "top-handlers," these large vehicles are used within a terminal to load and stack containers weighing up to 70,000 pounds. The battery-electric vehicles are supported in part by a \$15 million MOU signed last year between LADWP and the Port for portwide charging infrastructure, as well as a \$4.5 million sustainability grant from the California Energy Commission. The new electric cargo handling equipment is one of 16 projects in which the Port is deploying or testing zero-emission technologies, including alternative fueling and charging stations; hybrid and fully battery-electric fuel cell heavy-duty trucks; battery-electric forklifts; yard tractors; and emissions control equipment on large ships and harbor crafts.

The shift to zero-emission technologies at the Port is a result of Los Angeles' bold commitments in the Clean Air Action Plan, including a pledge to obtain 100% zero-emission cargo handling equipment by 2030 and see 100% zeroemission trucks coming into and out of the port by 2035. The Port is currently North America's leading seaport by container volume and cargo value, and facilitated \$297 billion in trade during 2018.

Beyond the progress at the harbor, LADOT also marked Clean Air Day by providing free rides on its DASH, Commuter Express, Cityride,

Governor Signs Bill to Promote Supplier Diversity Across California's Hospital Industry

Over this past weekend, Gov. Gavin Newsom signed AB 962, introduced by Assemblymember Autumn Burke (D-Inglewood) and coauthored by Assemblymember Rob Bonta (D-Oakland). This bill establishes California's first-ever reporting requirement for hospitals' contracting with businesses owned by people of color, women, veterans, and LGBT individuals to the Office of Statewide Health Planning and Development. This bill will shed light on the degree to which California's \$230 billion hospital sector contracts with and outreaches to diverse businesses for various products and services.

"AB 962 is the embodiment of some of the values that are at the core of our state: transparency, economic opportunity, and diversity," said Assemblymember Burke. "The signing of this measure furthers California's storied history of promoting opportunity for the communities that comprise the backbone of our economy, and shows that we value diversity across all levels of this state, whether it is in the hospital industry, utility industry, or in the makeup of the legislature. Continuing this history of promoting diversity is crucial because when our diverse communities thrive, all Californians thrive."

"AB 962 introduces a proven formula to increase diversity," said Greenlining Institute Health Equity Director Anthony Galace. "Requiring hospitals to report their supplier diversity will lead to significant contracting opportunities for diverse businesses, which will directly benefit the populations and communities those businesses serve. We applaud Assemblymember Burke's leadership on this important issue and look forward to working with hospitals across the state, and with OSHPD to ensure proper implementation of this bill." This bill, sponsored by The Greenlining Institute, is modeled on several successful supplier diversity programs overseen by the California Public Utilities Commission and the California Department of Insurance. After both programs were enacted, the number of contracts going to diverse businesses skyrocketed, and advocates credit the reporting and transparency requirements created by these programs. They anticipate similar results from AB 962.

CleanPowerSF Wins Prestigious C40 Cities Award

CleanPowerSF, the City's local renewable energy program, has won a C40 Cities Bloomberg Philanthropies Award, a prestigious honor that provides international recognition for cities that are demonstrating climate action leadership. San Francisco was one of only seven winners from across the globe who were announced yesterday at the C40 World Mayors Summit in Copenhagen.

"When I first helped to launch CleanPowerSF as a Supervisor, I knew it had the potential to make a transformative change for this City," said Mayor London N. Breed. "We are seeing significant reductions in emission levels and are well on our way to meeting our climate action goals. We will continue to push forward, working with our allies in the C40 Cities coalition to find new and innovative solutions to the challenge of climate change."

CleanPowerSF has played a major role in San Francisco's ability to reduce greenhouse gas emissions 36 percent below 1990 levels. The program will also help the City realize its ambitious climate action goals, including reaching 100 percent renewable electricity by 2030 and reducing net emissions to zero by 2050. Last month, Mayor Breed's legislation to transition private commercial buildings of 50,000 square feet and larger to 100 percent renewable electricity was enacted into law. Earlier this week, the Board of Supervisors passed legislation requiring electric vehicle charging stations in large commercial parking facilities.

Operated by the San Francisco Public Utilities Commission (SFPUC), CleanPowerSF launched in 2016 with a mission to provide San Francisco residents and businesses with the choice of having their electricity supplied from clean, renewable sources at competitive rates. Following the largest and most recent enrollment period in April of this year, CleanPowerSF now serves more than 376,000 customers in San Francisco, a 360 percent increase from the prior year. With a 96 percent participation rate, the program is popular among businesses and residents.

"San Francisco is a global leader in sustainability, and we're honored to be recognized with such a respected award," said San Francisco Public Utilities Commission General Manager Harlan L. Kelley, Jr. "Building on our 100-year legacy of providing clean energy to San Francisco, we launched CleanPowerSF to provide more power options to our residents and businesses, who share our commitment toward a more sustainable future."

CleanPowerSF was selected as the winner by C40 Cities in "The Future We Want Requires Transformative Change" category. C40 Cities received 195 climate action project submissions this year, which were evaluated on the following criteria: climate action, benefits, innovation, governance, and sharing and scaling.

C40 Cities connects ninety-four of the world's leading cities to take bold climate action towards a healthier and more sustainable future. Representing 700 million residents and one quarter of the global economy, mayors of the C40 cities are committed to delivering on the most ambitious goals of the Paris Agreement at the local level.

"Cities worldwide are at the forefront of providing innovative solutions to the climate crisis humanity is facing—demonstrated brilliantly by the inspiring examples showcased in Cities100," said Mark Watts, Executive Director of C40 Cities. Along with CleanPowerSF, the SFPUC operates the Hetch Hetchy Regional Power System, which provides 100 percent greenhouse gas free energy to public facilities, such as City Hall, San Francisco International Airport, Muni buses, schools and libraries. Collectively, the two programs meet approximately 80 percent of the electricity demand in San Francisco.

Access to Capital Ready to Grow Your Business?

SBA Small Business Lending Reflects Strong Economic Trends

The U.S. Small Business Administration announced FY19 lending numbers showing that it guaranteed over \$28 billion to entrepreneurs that otherwise would not have access to capital to start, grow, or expand their small businesses.

"A strong economy is powering America's 30 mil-lion small businesses, and the SBA's FY19 num-bers bear that out," SBA Acting Administrator Chris Pilkerton said. "When the economy is doing well, 7(a) lenders are more willing to provide capital without the need for a federal loan guarantee. Our 504 and Microloan programs continued to grow from last year, as all of these loans are designed to create jobs and grow all small businesses in communities across the country. We continue to be proud that the SBA is here to help America start, grow, and expand opportunities for entrepreneurs.'

In FY19, SBA's flagship 7(a) loan program made approximately 52,000 7(a) loans totaling \$23.17 billion. The 504 loan program had another year of increased performance, with more than 6,000 loans made for a total dollar amount of more than \$4.9 billion.

"With a strong economy and historically solid small business optimism, we know that 7(a) lenders are making loans conventionally without the SBA guarantee. We also saw a 4.3% growth in the 504 loan program due to the longer term and low fixed interest rate that the product provides to small businesses," said Associate Administrator for SBA's Office of Capital Access William Manger. "We are also proud that our Microloan program had another record year with a nearly 7.5% increase in small business lending.

In FY19, there was significant growth of dollars lent in the SBA's Microloan program, with more than 5,500 loans approved for nearly \$81.5 million

In addition to the strong lending numbers, the SBA continues to innovate and improve processes by leveraging enhanced technologies. Lender Match is an SBA technology platform that gives entrepreneurs the ability to complete a quick online form, without registration or cost to the user to connect with an SBA-approved lender within 48 hours. To date, Lender Match has generated 4.4 million leads on behalf of small businesses to our lenders, and lenders have contacted more than 230,000 unique borrowers with financing options.

About the 7(a), 504 and Microloan programs

The 7(a) loan program is the SBA's primary program for providing financial assistance to small businesses and offers guarantees on loans to small businesses of up to \$5 million on reasonable terms and conditions. 7(a) loans are commonly used for acquiring land, purchasing equipment, or working capital. The CDC/504 loan program provides capital to small businesses for the acquisition of fixed assets to promote economic development in the form of long-term fixed-rate financing on reasonable terms. Under this program, the SBA authorizes Certified Development Companies (CDCs) to provide financing to small businesses with the help of third-party lenders (typically banks). The maximum loan amount is generally \$5 million; however, certain eligible energy-efficient or manufacturing projects may qualify for up to \$5.5 million. The Microloan program provides loans to not-for-profit lending intermediaries that, in turn, make loans of up to \$50,000 to small businesses on reasonable terms.

Building Relationships: One Construction Project at a Time

Communicate any due dates or prequalification requests as far in advance as possible to give trade contractors ample time to ask questions and compile all the necessary information and documentation. Hold a pre-bid meeting or site visit to and answer any questions that subs might have. Be responsive and timely when a sub reaches out for more information on a bid and make sure any plan revisions or addenda gets distributed to all your bidders.

After Bids are Awarded

Subcontractors

If you're awarded a contract, you need to meet with the general contractor to discuss the project schedule, key milestones, logistics, safety plan, and payment schedules. Review the contract and ask to make any changes to any unnecessarily unfavorable conditions or clauses in the contract.

If you weren't awarded a contract, ask the general contractor for a meeting to go over why you didn't win. Regardless of whether it was an uncompetitive bid, lack of experience, or failure to provide required documents or prequalification forms, you should try and find out what you could do better to improve your chances on your next bid.

General Contractors

Meet with all your awarded subs to for an indepth review of the upcoming project. Leverage their knowledge and expertise as you develop the construction schedule and project timeline. Lay out expectations for safety meetings, daily reporting, and how and when information is to be communicated. Make it clear that any issues or complications should be brought to you immediately so both parties can work to resolve them as quickly as possible and keep the project on track.

Make yourself available to any subcontractor who you didn't award a contract to so you can explain why they didn't win. Providing transparent and honest feedback to a subcontractor, especially one bidding to you for the first time, will help them submit a better proposal next time. It's also a good time to build rapport with subs you haven't worked with to ensure they will bid on future opportunities you send their way.

During Construction

Subcontractors

Show up to the jobsite every day with the tools, equipment, materials, and workers you need to get that day's work done. Make sure your workers act and perform their duties safely and professionally. Practice good housekeeping and clean up after every workday, picking up tools and equipment and disposing of any construction waste as you go.

Keep in contact with the site supervisor and project manager with updates on your progress and advise them immediately of any issues or potential delays that might impact other subcontractors on the job or the overall project timeline.

General Contractors

Communication is key to every successful construction project. Check in on all your subcontractors throughout the project and be available to discuss how the work is progressing and to monitor their performance. If you're keeping your subs in the loop on any potential changes to the schedule or scope of work, it's easier to work together to develop a solution rather than expecting them to be able to just go with the flow.

When issues arise, and they will, be professional and respectful of the other person's opinions and suggestions. When something goes wrong on a project it's easier to resolve the problem if everyone can work things out with a rational and respectful discussion rather than simply pointing fingers and laying blame. It's easy for tempers to flare when things aren't going right so it's always best to let cooler heads prevail.

Project Completion

After the completion of each project, general contractors and subs should get together to do a post mortem. Items to discuss should include what worked, what didn't, what issues arose and how they were handled, and how they might handle them in the future. This should be an open and frank conversation to work through any disagreements and difficulties so that these items can be addressed and corrected before the next project.

Once a project has been completed successfully and both parties are satisfied with the outcome it's just a matter of rinse, wash, and repeat. As time goes on, and more successful projects are completed between a general contractor and a sub, that level of trust and mutual respect will strengthen and grow into a strong relationship and partnership that both parties will benefit from for many years.
