Key Takeaways from Construction Cost Management Report by Dodge

Cost management is key to ensuring construction projects stay on budget and on schedule. Yet many projects, as many as 33% come in over budget, as reported in the Construction Cost Management Report by Dodge Data & Analytics (Dodge). Surveyed contractors note that even among their best-performing projects, one out of five does not meet the budget requirements.

Efficiently tracking construction costs and monitoring risks make a big difference in maintaining budgets. Tracking costs and monitoring risks, however, requires a strong cost management discipline. Insights into current cost management practices can help fine-tune practices to build discipline. In this article, we'll review highlights from the report and key takeaways to drive your cost management discipline.

Key takeaways

 Owners and general contractors alike prefer a single primary tool for cost management, complimented by a limited number of thirdparty tools.

- Forecasting costs with real-time field data is the top future need for cost management.
- Alignment between owners and general contractors is critical to building an integrated cost management discipline, and revealed as an opportunity for both project teams and solution providers.
- Project-focused staff shows higher capability of being involved in cost management on a more holistic level. One reason is due to the ease in which technology allows this to happen.

Owners and contractors prefer a single cost management tool, yet most use more than one

Overall, owners, general contractors, and specialty contractors use more than one tool for cost management. Forty-four percent leverage more than one tool but lean on one as their primary. Thirty-three percent use two to five tools with none as their primary. Only 21% use one tool alone, while 5% use more than five tools with none as their primary.

For respondents in project-related roles, there is a strong preference for using a primary technology tool for cost-management-related challenges such as establishing a system of cost accounts,

California gets small share of infrastructure bill

California will receive about \$45.5 billion from the infrastructure improvement legislation that Congress approved last week, which sounds like a lot of money.

In fact, it's the largest share of the \$1.2 trillion program of any state and President Joe Biden wants Californians to be appreciative.

"The historic Infrastructure Investment and Jobs Act will make life better for millions of California residents, create a generation of good-paying union jobs and economic growth, and position the United States to win the 21st century," the White House said in a statement detailing the state's share

Gov. Gavin Newsom echoed the White House, saying, "This historic infrastructure package stands to accelerate investments in our clean transportation infrastructure, help mitigate some of the worst impacts of climate change and accelerate new projects that will create thousands of jobs."

From a relative standpoint, however, California's allocation is small. At just over \$1,200 per Californian, it's one of the lowest of any state. States with relatively small populations, such as Alaska and Vermont, benefit the most on a perresident basis.

Two-thirds of California's share, about \$30 billion over five years, is reserved for repairing roads, highways and bridges and we can certainly use it because, as the White House breakdown observes, "For decades, infrastructure in California has suffered from a systemic lack of investment."

Our highways rate at or near the bottom vis-à-vis those of other states simply because ever since the 1960s, governors and legislators have been unwilling to impose the taxes on motorists to keep what was once the nation's best roadway network in good repair.

Four years ago, then-Gov. Jerry Brown and legislators passed a \$5.4 billion per year package of taxes and fees to slow the system's deterioration but while it narrowed the gap, it did not close it. The new injection of federal money will be welcome, but will fall short of doing what's needed to restore our roadways to their previous levels.

Another \$9.45 billion (over five years) is ticketed "to improve public transportation options across the state."

There will be no shortage of applicants for those funds. Local and regional transit systems will be vying for slices of the pie and it could be a factor in whether Newsom and legislative leaders resolve their impasse over the state's muchtroubled bullet train project.

Newsom wants the Legislature to provide the remaining \$4.2 billion from a 2007 bond issue to finance continued construction of a bullet train section in the San Joaquin Valley while legislative leaders want to divert the money into local and regional commuter transit.



TCC: COMMUNITY OUTREACH

Fighting Redlining and Climate Change with Transformative Climate Communities

The COVID-19 pandemic has heightened awareness of structural inequities in the U.S., and it has become undeniable that the climate crisis does particularly severe harm in underresourced communities, including communities of color and low-income communities.

In order to build a future where all communities can build wealth, live in healthy places filled with economic opportunity, and are ready to meet the challenges posed by climate change, the U.S.'s efforts to combat the climate crisis must confront this reality.

California has pioneered a unique approach to fostering community-led solutions that meet the needs of those hit first and worst by climate change through a program called Transformative Climate Communities. TCC, managed by the Strategic Growth Council, is unique in two ways:

- TCC puts community leadership first, requiring all projects to develop a collaborative governance structure between stakeholders such as local government, community-based organizations and residents. The process works to ensure that projects are derived from resident-identified needs, giving community members ownership over changes taking place in their own neighborhoods.
- TCC then funds communities to develop and implement holistic, connected visions for how to transform their neighborhoods to reduce CO2 emissions and provide meaningful community benefits such as cleaner air, improved health and job opportunities.
 For example, this might include building affordable housing near transit, planting an urban street canopy and installing solar on homes, all at once.

TCC was created by AB 2722 (Burke, 2016), cosponsored by The Greenlining Institute and the California Environmental Justice Alliance. Since then, it has provided Planning Grants to 18 communities to develop their projects, and eight Implementation Grants enabling on-the-ground work to begin.

Five years after the program's establishment, The Greenlining Institute is examining TCC's progress thus far, and is beginning to gauge both successes and areas for improvement. Greenlining conducted an intensive qualitative evaluation of how TCC's components work together to deliver equity outcomes. This evaluation includes four detailed Case Studies from Ontario, East Oakland, the Northeast San Fernando Valley and Stockton, which examines specific local planning and implementation efforts in greater detail.

Overall, climate equity experts found substantial success in creating new models for community-centered governance leading to climate action plans that can deliver meaningful benefits to underserved communities while reducing carbon emissions. Below is an overview of Greenlining's policy recommendations:

Key Findings

1. The TCC model is working.

With 18 planning grants and eight implementation grants issued so far, the TCC model is working -- helping communities design and implement real change based on needs they themselves identify, fighting climate change and improving their neighborhoods. "Residents know their voice is not only being heard but we're doing something about it," said Jasmine Silva of Community Partners, administrator of the Northeast San Fernando Valley project.

2. TCC Communities are drastically reducing CO2 emissions.

Even though implementation has only recently started in many places, TCC is already producing concrete results, from a new bikeshare program that's expanding clean transportation and creating jobs in East Oakland to a formerly neglected alley now reclaimed as a community green space in Pacoima, part of the East San Fernando Valley TCC effort. Projects in the works include affordable housing near transit, EV charging, solar panels for low-income households and more. Overall, these communities are on track to reducing nearly 200,000 metric tons of CO2 emissions over the next five years, equivalent to removing nearly 43,000 cars from the road.

3. TCC should be replicated nationally.

TCC represents a new model for climate action that should be expanded within California and replicated nationally. Contrary to the false narrative that climate action means a loss of jobs, TCC shows how communities can use efforts to cut CO2 emissions to create jobs and build healthier, stronger neighborhoods.

4. Despite these great successes, challenges remain.

Inconsistent and inadequate funding has greatly limited the number of projects that could be funded and made it difficult for communities to plan. Also, California should reduce administrative and financial burdens that make it difficult for under-resourced cities and counties to participate. Advocates were heartened by a funding increase approved in the recently-concluded California state budget process, but future funding is not guaranteed. The state must adequately and consistently fund the pathway from planning to implementation, and support the local ecosystems needed to support community transformation.

Report Recommendations

1. Funding must be adequate and consistent.

TCC can only fund catalytic, transformative, community led-change if it is adequately funded. Governor Gavin Newsom's 2021-2022 budget recently proposed \$420 million over three years for TCC, and this represents a good start. To sustain community transformation, the governor and legislature should explore ways to establish a consistent funding source for the program.

2. Remove needless funding barriers.

The State of California should allow advance payment so that community organizations don't face insurmountable cash flow challenges. Restrictions that hamper community outreach, such as inability to use State funds to pay for child care or food for participants, should be removed immediately.

3. Help communities build capacity.

To meet capacity challenges and support TCC communities from planning to implementa-

tion, the Strategic Growth Council should provide increased guidance, resources, technical assistance and peer learning, fully stepping into the role of a State partner facilitating, supporting and incubating community-led transformation. SGC should clarify and streamline overall guidance, provide publicly accessible models and best practices, offer tailored technical assistance and solutions thinking, and facilitate peer-to-peer learning.

4. Expand TCC nationally.

As the federal government and state governments expand their climate change efforts, they should use TCC as a model for programs to be implemented all over the U.S. To simultaneously fight climate change and build community health and prosperity, funders and policymakers must invest in community capacity and community-led transformations at all levels. The U.S. must fund a pathway from planning to implementation, as well as support the local ecosystems needed to support community transformation.

Conclusion

Transformative Climate Communities is a community capacity-building model for fighting climate change, building economic prosperity and redressing the historic systemic disinvestment of low-income neighborhoods. The TCC model empowers the communities most impacted by poverty and pollution to choose their own goals, strategies and projects to reduce greenhouse gas emissions and deliver multiple tangible benefits.

status reporting during a project, and identifying areas of the project that require more attention

For best results from a primary cost management tool, prioritize ease of access and use

We can see a consistent preference for having a primary cost management tool, yet just over a fourth of owners and contractors actually use one tool alone. The leading approach to construction cost management relies on a primary tool with supporting tools. For that reason, it's important to choose a primary tool that allows you to connect your project data to cost activities and schedules. Integrations factor in here too to connect the field and office teams while avoiding

For best results from a primary cost management tool, prioritize ease of access and use. These solutions should connect to schedule and cost activities over the lifecycle of the project.

The Dodge report also indicates a preference for third-party tools among respondents. About 47% use third-party tools, with around 60% leaning on desktop applications and 40% using cloudaccessible ones. Thirty-two percent of owners and contractors use internally developed tools, and 16% use spreadsheets.

We'll likely see the number of people using internally developed tools and spreadsheets decrease in the future due to the customization capabilities of third-party tools and the maintenance costs of homegrown solutions. Organizations can generate better cost-related outcomes for all involved partners by focusing on using fewer, more comprehensive tools that engage all stakeholders in a shared approach to cost man-

Success criteria for cost management solutions: what owners and general contractors expect

When measuring cost management success, respondents indicated that they use the following three metrics most frequently:

- Turnaround time on processing change or-
- Achieving expected profit margin
- Final cost compared to budgeted cost

Owners and contractors are split evenly on the subject of spending levels on cost management. Thirty-nine percent believe they are spending more than they should have to, 32% think they are spending the right amount, and 29% say they're spending less than they should. In the subgroups, variation exists with owners more likely to believe they're spending too much, especially those in public entities (55%). Contractors, on the other hand, especially those in trades, are the least likely to believe they are overspending (31%).

There is also a significant amount of variation between how owners and general contractors measure the success of cost management solutions. Owners cite the following metrics most frequently:

- Final cost compared to budgeted cost (30%)
- Generating useful data to benchmark for future projects (26%)

In comparison, contractors pinpoint minimal unplanned changes as their top success criteria. These preferences align with the responsibilities of each role but also indicate a lack of synergy on what successful cost management means.

Forecasting costs with real-time field data in top future need for cost management

Respondents selected the most critical future need from 14 cost management practices. Thirty percent selected forecasting critical costs with real-time field data as the most important to improve over the next three to five years. This practice ranked number one across all four regions studied, with the United Kingdom selecting it most frequently (32%) and Canada choosing it least frequently (26%).



Salmon, orca, and the soul of Seattle

If Seattle had its own Seven Natural Wonders, surely the salmon run at Carkeek Park would top the list

For the past two weeks, I've been glued to the sight of enormous coho swimming, wriggling and leaping their way up Pipers Creek to spawn, completing their journey home from the Salish

Seattle wouldn't be Seattle without salmon. Or at least it wouldn't feel like Seattle anymore. If you come here on vacation, the iconic salmon toss at Pike Place Fish Market is probably one of the first sights on your checklist. But if you live here, you know that salmon are more than just a mascot — they're an age-old food source for our region and a vital part of our ecosystem.

Without plentiful salmon, we can't have orca. And without the orca, then we'd lose even more of our regional identity.

As the population around Puget Sound grows, generating more pollution in our runoff, we are racing headlong toward a crossroads: Will we save the wildlife that gives our area that distinct Pacific Northwest personality? Or will we end up like Northern California, where orca sightings are rare and the salmon population is literally drying up?

That was my haunting takeaway after creating the podcast Beasts of Seattle for Town Hall Seattle, a six-episode limited series in which I interviewed artists, ecologists and other local gurus about the Northwest's iconic species . The more

I learned about the animals that make our area unique, the more concerned I became about their tenuous future. They won't disappear overnight, but without enough political willpower to stop it from happening, these precious creatures could slowly disappear.


Case in point: The population of southern resident orcas quietly declined from 74 to 73 during the few months I spent producing and editing Beasts of Seattle. As Lynda V. Mapes, author of Orca: Shared Waters, Shared Home and an environmental reporter at The Seattle Times, recently observed, that's roughly equivalent to the size of the population when the horrific capture era ended in 1976. "We're not getting anywhere in terms of recovery," Mapes told KUOW last

But it was something else Mapes said during a conversation with me for the podcast that has been ringing in my ears ever since. If we were to lose the salmon, if we were to lose the orca, Mapes said, "Suddenly, we'd be just like everywhere else.

This isn't just an ecological concern, then, although that's certainly paramount — it's a matter of local pride too. Picture a Seattle where we have a salmon slide at Carkeek Park but no actual salmon swimming up the creek. A Seattle where we have orca mascots at our schools but no southern resident orca in our waters. Imagine a place where the ghosts of these creatures linger in our historical memory instead of continuing to be an active presence in our lives.

Mayor London Breed and City Attorney David Chiu Announce \$2.5 Million to Support Entertainment Venues and Launch New Outdoor Live Performance Series

Mayor London N. Breed and City Attorney David Chiu announced a \$2.5 million investment to promote and support the live music and entertainment sector in San Francisco. The funding will support the SF Live Initiative, which will produce a new series of live performances presented by local entertainment venues at outdoor parks and plazas in 2022.

The goals of the initiative are to showcase and support the San Francisco music and entertainment sector, boost neighborhood vitality and enhance the City's economic recovery through arts and culture. Funding through SF Live will cover the costs of producing this outdoor event series as well as stipends to participating entertainment venues, who will curate talent lineups and market the performances. The \$2.5 million investment is funded through an allocation from the California State Legislature led by City Attorney David Chiu, when he was an Assemblymember.

"Our local venues are an indispensable part of San Francisco's culture and economy. They're places where longtime residents have been seeing shows for years and where visitors can catch their favorite band when they're in town. They're where people get to know their neighbors, start relationships, and make memories that will last a lifetime. Our local venues were the first to shut down and the last to reopen due to COVID-19. We want to ensure that we're doing everything we can to not only recover from the pandemic, but help lead our economic and night-life recovery," said Mayor Breed.

"San Francisco is famous for our live performances that bring our communities together and make our neighborhoods vibrant," said City Attorney David Chiu. "I was more than happy to secure state funding as an Assemblymember to start this initiative and support our live performance venues. The SF Live Initiative should serve as a model for ongoing investment in outdoor live performances."

To complement the outdoor performance series, SF Live will also fund the development of coordinated marketing and branding for San Francisco's music and entertainment industry as well as a promotional campaign to encourage residents and visitors to attend local live entertainment venues. SF Live will be developed and refined in partnership with venues and stakeholders. The initiative aims to launch next year in 2022.

"Live performances are a critical economic driver in San Francisco. We know that our entertainment venues faced significant pre-pandemic challenges. As the City emerges out of the pandemic, live entertainment will play a major role in our economic recovery," Kate Sofis, Executive Director of the Office of Economic and Workforce Development. "This initiative will showcase our many amazing music venues, offer new performance opportunities for local musicians, and emphasize San Francisco's role as a vibrant place to live, work, and visit."

Charina Vergara, Titas of Manila

Charina Vergara began her culinary career as a food vendor at local night markets where she offered original Filipino cuisine. In 2019, she was offered a business opportunity to take over an existing Filipino restaurant. Ms. Vergara & her business partner jumped on the chance and became the new owners of Titas of Manila in West Covina. CA.

Like many other small business owners needing capital, Ms. Vergara initially used her personal savings to launch and operate the restaurant. However, the funds were soon exhausted. Fortunately, she was connected to PACE Business where she worked with Loan Officer Redy Babasa-Thompson to obtain a \$100,000 SBA Community Advantage Loan.

When the COVID-19 pandemic struck in March of 2020, Titas of Manila was forced to temporarily close down and later drastically alter its operations in order to comply with the Governor's statewide closures of dine-in restaurants. As a relatively new venture with only 14 months of operation under its belt, the restaurant almost immediately felt the adverse effects of the pandemic: staffing was cut by 50%, menus were streamlined, and expenses were cut in order to further mitigate financial loss.

Ms. Vergara once again connected with PACE and Mr. Babasa-Thompson helped her secure an SBA Economic Injury Disaster Loan (EIDL), 1st draw PPP loan, and, most recently, a 2nd draw PPP loan for \$149.950.

Thanks to PACE's guidance and Ms. Vergara's perseverance, while other businesses and restaurants were closing down during the height of the pandemic, Titas of Manila stayed afloat and continued serving delicious and authentic Filipino meals.

"We were terrified by the uncertainty of the situation. But financial help came in. Thanks to PACE, we had a lifeline that allowed us to continue running the restaurant, despite the uncertainty. We know we can always count on PACE to help us when the going gets tough," said Ms. Vergara.

With business now stabilized, Ms. Vergara is working with PACE once again to obtain a Small Business Grant in order to expand her business.



Fact Sheet: The Bipartisan Infrastructure Deal

Congress passed the Bipartisan Infrastructure Deal (Infrastructure Investment and Jobs Act), a once-in-a-generation investment in our nation's infrastructure and competitiveness. For far too long, Washington policymakers have celebrated "infrastructure week" without ever agreeing to build infrastructure. The President promised to work across the aisle to deliver results and rebuild our crumbling infrastructure. After the President put forward his plan to do exactly that and then negotiated a deal with Members of Congress from both parties, this historic legislation is moving to his desk for signature.

This Bipartisan Infrastructure Deal will rebuild America's roads, bridges and rails, expand access to clean drinking water, ensure every American has access to high-speed internet, tackle the climate crisis, advance environmental justice, and invest in communities that have too often been left behind. The legislation will help ease inflationary pressures and strengthen supply chains by making long overdue improvements for our nation's ports, airports, rail, and roads. It will drive the creation of good-paying union jobs and grow the economy sustainably and equitably so that ev-

eryone gets ahead for decades to come. Combined with the President's Build Back Framework, it will add on average 1.5 million jobs per year for the next 10 years.

This historic legislation will:

Deliver clean water to all American families and eliminate the nation's lead service lines. Currently, up to 10 million American households and 400,000 schools and child care centers lack safe drinking water. The Bipartisan Infrastructure Deal will invest \$55 billion to expand access to clean drinking water for households, businesses, schools, and child care centers all across the country. From rural towns to struggling cities, the legislation will invest in water infrastructure and eliminate lead service pipes, including in Tribal Nations and disadvantaged communities that need it most.

Ensure every American has access to reliable high-speed internet. Broadband internet is necessary for Americans to do their jobs, to participate equally in school learning, health care, and to stay connected. Yet, by one definition, more than 30 million Americans live in areas where there is no broadband infrastructure that provides minimally acceptable speeds – a particular problem in rural

communities throughout the country. And, according to the latest OECD data, among 35 countries studied, the United States has the second highest broadband costs. The Bipartisan Infrastructure Deal will deliver \$65 billion to help ensure that every American has access to reliable high-speed internet through a historic investment in broadband infrastructure deployment. The legislation will also help lower prices for internet service and help close the digital divide, so that more Americans can afford internet access.

Repair and rebuild our roads and bridges with a focus on climate change mitigation, resilience, equity, and safety for all users. In the United States, 1 in 5 miles of highways and major roads, and 45,000 bridges, are in poor condition. The legislation will reauthorize surface transportation programs for five years and invest \$110 billion in additional funding to repair our roads and bridges and support major, transformational projects. The Bipartisan Infrastructure Deal makes the single largest investment in repairing and reconstructing our nation's bridges since the construction of the interstate highway system. It will rebuild the most economically significant bridges in the country as well as thousands of smaller bridges. The legislation also includes the

first ever Safe Streets and Roads for All program to support projects to reduce traffic fatalities, which claimed more than 20,000 lives in the first half of 2021.

Improve transportation options for millions of Americans and reduce greenhouse emissions through the largest investment in public transit in U.S. history. America's public transit infrastructure is inadequate — with a multibillion-dollar repair backlog, representing more than 24,000 buses, 5,000 rail cars, 200 stations, and thousands of miles of track, signals, and power systems in need of replacement. Communities of color are twice as likely to take public transportation and many of these communities lack sufficient public transit options. The transportation sector in the United States is now the largest single source of greenhouse gas emissions.

The legislation includes \$39 billion of new investment to modernize transit, in addition to continuing the existing transit programs for five years as part of surface transportation reauthorization.
