Embracing Technology and Remembering Our Roots

Like many industries, construction has changed quite a bit in the past 10 to 15 years. I remember the industry 40 years ago, when I started in it, and it looks nothing like the construction of today. When I talk to contractors who have been in the construction industry as long as I have, we end up reminiscing about how the industry was when we first began. There seems to be a connection as we share with each other how we used to do things-things that this generation today will never experience.

We can all agree that technology has and will continue to affect the construction industry in a huge way. This advancement has improved areas such as computers and software, building designs, materials and methods, management, estimating, communications, education, project efficiency, tools and equipment, security and safety, and more.

When I started in the construction industry as a carpenter, woodworking was not the only skill a carpenter had to know. During that time, carpentry included hanging doors from scratch, building stairs and cutting roofs, running equipment, shooting elevations, form and pour concrete, welding, roofing, and tile work. Basic drafting

skills were needed for drawing details when items needed to be fabricated. Daily job-site logs and time cards were filled out at the end of each day using paper. We knew we were hightech when a pager was strapped to our tool belt. It was in 1985 when I got my first mobile phone, and it felt like I was in the space age era. That Motorola DynaTAC measured 13 x 1.75 x 3.5 inches and weighed 28 ounces. The inventors of the phone nicknamed it "The Brick." Contractors relied on word of mouth and printed ads to increase sales.

Today, each one of those skill sets has been segmented for a person or contractor to specialize in. They can hone their skills and connect with associations and businesses to keep up on the latest technology and become an expert in that specific portion of the industry. The education and training aspect has shifted. Once someone knows the basics, we put a strong focus on the use of modern tools, equipment, materials, and procedures. The increase in pre-fabrication of building components has saved up to 20% in time on the job site with less material waste and increased efficiency and safety.

Computer skills and certifications of safety training are qualifications many employers are requiring from employees. More technology skills and

EPA Awards \$300K to California Small Businesses to Develop Innovative Technologies

The U.S. Environmental Protection Agency (EPA) announced \$300,000 in funding to three small businesses in California to develop new technologies that protect the environment while growing the American economy. About \$1.7 million was awarded to 16 small businesses nationwide.

"EPA is providing small businesses with financial support to develop innovative technologies that will address urgent environmental and pub-

lic health needs across the nation," said EPA Acting Administrator Andrew Wheeler. "This year, we are encouraging the development of a variety of new technologies, including innovations to help address PFAS and improve water quality nationwide."

The contracts announced today are funded through EPA's Small Business Innovation Research (SBIR) program, which encourages the development and commercialization of novel

technologies that support EPA's mission to protect human health and the environment. The small businesses that are being funded are working on a wide range of topics including water quality, air quality, land revitalization, homeland security, manufacturing, and construction mate-

EPA is awarding phase 1 contracts to the following three small businesses in California for up to \$100,000 for six months:

- Seacoast Science Inc., Carlsbad, Calif., to develop innovative broad-spectrum analysis methods for Per- and Polyfluoroalkyl Substances (PFAS) that will simplify PFAS analysis, reduce cost-per-sample, and allow portability to remediation sites.
- Altex Technologies Corporation, Sunnyvale, Calif., to create a process to produce renewable, toxic-free, low-energy, low cost bioplastics.

Intelligent Optical Systems Inc., Torrance, Calif., to create greener, degradable plastics with a high heat tolerance, produced from bio-based feedstock.

Nationwide, EPA awarded 17 phase I contracts to 16 small businesses for up to \$100,000 for six months. Phase I recipients are eligible to apply for a phase II contract, which will help commercialize the technology that was conceptualized in phase I. A phase II contract can fund these companies with up to \$300,000 to develop their environmental technology for the marketplace.

Fireproofing Yourself

In these turbulent times, where security is fleeting to say the least, the more you can do to provide value to your boss, work group and organization the more secure you will feel. If you have a great job and you want to keep it there are some skills you can master that will help you stand out as "Keeper".

Be accountable for outcomes. Take responsibility for results. Particularly now with organizations running so lean, every-

one counts and every action truly does have a reaction. Remove "it is not my job" from you vocabulary. If the results are not good do what you can to correct the situation if you did not cause it initially. If you are seen as a person who is willing to take responsibility and be accountable that is a highly sought trait.

Have an active desire to learn new things. Constantly upgrade your skills, learn new procedures, or volunteer to be crossed trained. Some of this learning can be gained at work in standard ways: a class, on the job training, or asking a colleague for a quick lesson. Don't be limited to this. Credit Inquiries: What You Should Know About Hard and Soft Pulls

Did you know every time someone, including you, reviews your credit report a credit inquiry is added to your report instantly?

A credit inquiry is a request that's made by a "legitimate business" to check credit report information on an individual from a credit reporting agency. There are two types of credit inquiries vou should know about.

The first one is a hard inquiry also known as a hard pull. The second one is a soft inquiry also known as a soft pull. As you know credit inquiries are a major part of the underwriting process for all types of credit.

The good news is your personal credit report lists all of the inquiries, including some that are not seen by anyone else. All credit inquiries remain on your credit report for two years

Let's break down each of these inquiries and how they impact your credit scores.

What are Hard Inquiries?

Hard inquiries get triggered when you apply for credit or other actions that may require a credit check such as applying for cell phone service or renting an apartment. Your credit may also get checked when you apply for employment since many employers take it into consideration when

If you're a small business owner and establishing business credit for the first time, a card issuer will require a credit check but many suppliers and vendors may not.

This type of inquiry does affect your credit score and may even reduce your score up to five points. However, when you decide to go "rate shopping" for an auto loan or mortgage there is a built-in allowance for interest rate shopping. Most credit scoring models treat multiple inquiries for an auto loan or mortgage within a 30-day window as a single hard inquiry.

Each hard inquiry usually decreases your credit score for a short period of time. It's important to avoid a high number of hard inquiries in a short period of time because lenders interpret this as an attempt to expand available credit fast which creates a higher risk for a lender.

What are Soft Inquiries?

A soft inquiry happens when someone other than you, such as a lender or credit card issuer, checks your credit for promotional purposes. These are credit checks that you don't ask for so they don't have an impact to your credit scores.

Anytime you receive a pre-approved credit offer in the mail, it's from a bank that pulled your credit information for promotional purposes. Soft inquiries can also occur from banks lenders and/or card issuers that you currently have a loan or line of credit with. This is typical during account reviews for credit limit increases and/or additional product offerings.

Bottom line, soft inquiries mostly occur without you even knowing about them. How you find out about them is when you check your personal credit report and review the inquiries section on your report. Remember, only hard inquiries can be seen by others who check your credit reports. They do not see the soft inquires, only you do.

What about a Personal Credit Inquiry?

A personal credit inquiry occurs when you check your own personal credit report. This action has no impact to your scores. You can check your credit anytime and it's a smart financial move that you should adopt prior to applying for credit.

You can request a personal credit report from all three major consumer credit reporting agencies for free once every 12 months at Annual Credit Report.com

Checking your credit reports gives you time to review the information being reported to ensure it's accurate and up to date. If you uncover and mistakes or inaccurate information be sure to correct your credit report by visiting the credit reporting agency's website and initiate an investigation.

Remember, not all credit inquiries are the same; only a hard inquiry will impact your credit score. If you want to track changes to your credit reports and be alerted to new information, you may want to consider a credit monitoring service.

On a final note, credit literacy requires us to be diligent and forward thinking. It begins by educating our children and ourselves on sound credit and financial management principles.

5 Ways CEOs Can Change Their Behaviors To Lead More Efficiently

In business, the adage "it starts at the top" can prompt an uncomfortable question: "Can the boss finish what he or she started?"

Many CEOs and entrepreneurs wrestle with this challenge, with both short- and long-term implications. Meanwhile, a disconnect develops between the CEO's initial big-picture vision for the company and its seemingly sporadic execution toward those goals.

The Global Leadership Forecast 2018 highlights issues of greatest concern to CEOs; among them is a lack of alignment among senior leaders. The last problem any CEO wants is an inability to get everyone on the same page, aligned and executing their strategy.

"I've witnessed CEOs struggle with this question: "Why is it so difficult to execute what I already know I should be doing?" says Mark E. Green, a speaker, coach to CEOs and author of Activators: A CEO's Guide to Clearer Thinking and Getting Things Done (www.Activators.biz). "They and their teams generally know what to do and how to get it done. But they avoid the decisions and actions they know could advance their success.

"All roads lead back to obstacles within your mind. New behaviors leading to execution require new ways of thinking."

Green lists five ways for CEOs to change behaviors that obstruct them from leading their company efficiently and effectively:

- If/when, then. Green points to a study on influencing behavior by German researchers, who found that formulating an "if/when, then" plan stating a specific time to accomplish a task provided a cue to provoke the desired response. "I've worked with many CEOs who were not classically trained in accounting and finance and are overwhelmed by numbers," Green says. "Such fears drove them to avoid financial information and reports. Making an if/when, then statement compels them to change the behavior."
- Relate and repeat. To change, one needs to believe that change is possible. "Cultivate relationships with those who can help you see that the change you desire is attainable," Green says. "Then repeat by testing out the new behavior or thought pattern and seeking feedback."
- Know when to say no. As the company leader, being a giver is important but not to the point where sacrifice damages your own performance. "Credible research shows that high-performing givers knew when to say no," Green says. "Track your yes-to-no ratio. It's the only way to protect your time, energy, and focus as a leader.

- Forget perfectionism Green says perfectionism is a waste of time and energy for a CEO. He references the 80/20 Rule - also known as the Pareto principle, first articulated by Italian economist Vilfredo Pareto - which holds that roughly 80 percent of the effects come from 20 percent of the causes. "The 80/20 Rule also applies to perfectionism – the majority of the value in any endeavor comes from a small amount of the overall effort," Green says. "Perfectionism frequently limits our progress and fuels our fears. If you can keep the 80/20 Rule in mind, you can reduce your fears and accomplish more."
- Hold yourself accountable. One way CEOs and entrepreneurs can judge their performance is by asking themselves selfassessment questions daily. "You need accountability strategies that require you to evaluate your progress and focus on the importance of your goals," Green says.

"Often, the best way to modify a behavior is just to jump in," Green says. "Seek out examples of the behaviors you want to employ, embrace some discomfort, and emulate them until they begin to feel natural."
