The Anatomy of a Successful Construction Partnership

Compass was only a few years old when it committed to changing the way it approached engagement with architectural and design support. We had just lost a significant opportunity to build a data center for a big-name customer. Though Compass offered the most cost-competitive proposal, the prospect chose another provider in the 11th hour because they weren't comfortable with the Compass design.

This loss put the company's commitment to its long-standing ethos 'Humility In, Pride Out' to the test. Leaders had to ask the tough question — do we eat a big slice of humble pie and go back to the drawing board? Or stick with the design we've invested so much time and effort in?

The answer was obvious. This design created a competitive issue with the potential to arise in the future. The team had to admit that they may not represent all the best and brightest thinking and that bringing in partners to challenge assumptions and make bold moves might be uncomfortable and costly but was the right thing to do. This was when Compass resolved to approach engagement with architectural and engineering support differently.


Compass engaged HED five years ago to build a better partnership. Strategically, Compass' leadership set out to reframe the client-service provider relationship, onboarding HED as part of the team in a way that it had never done with previous firms

Rather than work at arm's length, Compass and HED have developed a relational and collaborative approach to the challenges of building large-scale data centers. Together, they've worked to identify solutions to issues associated with data center construction. By challenging assumptions and the status quo, the collaboration has reworked designs and come up with better ways of doing things, positioning Compass to rise to the challenges of mounting demand for data center development in a cost efficient and environmentally responsible manner.

The fruits of this partnership have been many. The team has made some bold prototype design changes and implemented process improvements to constantly evolve and improve how Compass builds.

Uniformity in design pays dividends

Having to make adjustments in the field is a time consuming and expensive process, with potential to impact the integrity of the structure.

The research by black social commentators That Sister studied 500 technology companies that have been founded and led by African Americans in the past five years, including their headquarters' locations and their total funding to discover the most influential state for African American technology companies

California scores 13.4 out of 20 to grab the second position. The home of Silicon Valley has supported the creation of 79 African American-founded Tech companies, the highest in the US since 2017, which have raked in a combined \$1.4 billion in funding. The state's size means that its company-to-population ratio is not as high as Delaware, coming to approximately 490,000 people per business; however, it does have the highest funding score, with the funds raised by the companies equivalent to \$36 per person. Headquartered in El Segundo, Savage X Fenty is the most

funded African American tech company in the US, with \$310,000,000 in total.

Delaware comes first with the highest influence score of 16.1 out of 20. It has seen total funding of \$22.1 million raised by six companies in the past five years, which means the state is home to one African American tech company for every 168,000 people – the best ratio of people to companies out of all 50 states. The funding raised by the Delaware companies equates to \$22 for each person in the state. The highest-funded company identified in Delaware is Stack Diagnostics, Newark, a provider of genetic diagnostic tests and services, and has received \$18.8 million in total funding.

Commenting on the study, a spokesperson from That Sister said: "We are excited to see the progress of African Americans in the tech space – founding and building companies which are attracting hundreds of millions of dollars in funding and investment. It's fas-

CalOSBA Announces Small Business Technical Assistance Grant Awardees

The California Office of the Small Business Advocate (CalOSBA) has announced grant awards to recipients of the California Small Business Technical Assistance Program (SB TAP, formerly named SB Technical Assistance Expansion Program). The state of California allocated approximately \$23 million in grant funding to over 100 Technical Assistance Centers for support of their business consulting and training services for historically underserved business groups, including women, minority, and veteran-owned businesses and businesses in low-wealth, rural, and disaster-impacted communities.

"Support from the CalOSBA Technical Assistance Program has been critical for the growth of the San Diego and Imperial Small Business Development Center Network," said Danny Fitzgerald, Regional Director of the San Diego and Imperial Small Business Development

Center Network. "With the funding we have received since 2018, over 12,000 businesses have received one-on-one expert advising, 55% of which are business owners of color, resulting in them receiving over \$900,000,000 in capital, creating 5,500 jobs, and obtaining over \$400,000,000 in government contracts."

Since launching in 2018, the Technical Assistance Centers funded by TAP and its partner program, the Capital Infusion Program (CIP), have served over 560,000 small businesses with free and low-cost training in over 30 languages. These efforts have resulted in over \$4.5 billion in capital infusion to support California small businesses. Training and consulting provided by these programs have helped start over 5,000 new small businesses and aided in the creation of over 35,000 new jobs.

"While everyone is focused on the pandemic and how to make a positive impact on small businesses and entrepreneurs, ongoing support from programs such as CalOSBA's TAP provides our Center the opportunity and capacity to continue our efforts to engage, educate and empower small businesses through our technical assistance accelerators and programs," said Dr. Cassandra Little, President & CEO of the Fresno Metro Black Chamber of Commerce & Chamber Foundation. "The TAP program is crucial for ensuring that our businesses continue to start, grow and sustain despite any crisis we may encounter."

TAP allocates funding to eligible Centers through a competitive process. This year's funding supports Centers across the state, including: all five California Statewide Small Business Development Center networks (SBDC), 16 Women's Business Centers, Five (5) Procurement Technical Assistance Centers, Rural Development Centers, Chambers of Commerce, the Manufacturing Extension Partnership Center Network, and small business-serving local nonprofits. The

grantees will focus on bridging the opportunity gap and increasing economic mobility for underserved small businesses and entrepreneurs, by offering consulting and training services business owners need to launch a business, increase their revenues, and create jobs.

Small Business Technical Assistance Centers are designated by federal and private funding partners to operate small business technical assistance programs throughout the state. These Centers provide one-on-one, confidential consulting, and training to help small businesses and entrepreneurs start, expand, facilitate investment, and create jobs in California. The TAP provides state grant funding to support ongoing and new consulting and training services provided by designated Centers.

How to Support the Hispanic/Latino Construction Workforce

"Hispanic origin can be viewed as the heritage, nationality, lineage or country of birth of the person or the person's parents or ancestors before arriving in the United States. People who identify as Hispanic, Latino or Spanish may be any race," according to census.gov.

One out of every five people in the United States is of Hispanic/Latino origin. A total 18.9% of the United States population is of Hispanic/Latino origin. More than half of the Hispanic/Latino population lives in California, Texas and Florida, according to the U.S. Census Bureau in 2021.

According to the U.S. Census Bureau's American Community Survey of 2021, as of July 1, 2021, the Hispanic population of the United States is considered the nation's largest racial or ethnic minority.

Hispanics consisted of 30% of the construction workforce in the United States, according to 2020 U.S. Bureau of Labor Statistics. Additionally, 46.7% of construction laborers in the United States are Hispanic.

These statistics show that it is of ever-increasing importance to learn what is important and motivating to Hispanics/Latinos as they become a critical part of the construction industry and workplace.

This workforce group places a high value on family and culture, and they have a strong desire for self-improvement.

The emphasis on family is very important to note. One should consider "small talk" an important element as the employee of Hispanic/Latino background could feel more connected to those at work.

Personal contact is also very common in the Hispanic/Latino community and is considered normal. Greeting one another with a hug and kiss on the cheek is part of interactions on a daily basis.

Because of the strong desire for self-improvement, Hispanic/Latino workers are very self-motivated and appreciate a workplace in which they can be promoted and advanced.

The Hispanic culture embraces specific family and social values that are strong and permeate all family members' lives. Many research studies emphasize the impact and role that family has on career choices. In "Experiences of Hispanic-American Women in Choosing Their Desired Careers: Family and Cultural Perspectives," a 2007 study of Hispanic American Women, the findings show that the relationship between career and the participants' ethnic culture appeared as a significant thread throughout their experiences. The Hispanic culture embraces the value

of the family first.

Although the Hispanic and much of the mainstream culture hold to traditional gender role patterns, all of the participants either were not constrained to these roles growing up or rejected the gender role patterns at a later period. These actions contributed significantly to their abilities to pursue their desired careers. This type of study is important as more women have been entering the construction workforce than ever before. An interesting variable of this study is that it was conducted in Miami-Dade County, Fla. More than 50% of the population in Miami is Hispanic/Latino, which could have an impact on the findings compared to other studies conducted in different parts of the country in which the Hispanic/Latino population is closer to the national percentage

Early in the development of facility prototypes, the HED-Compass collaboration ran into an issue installing our power centers. Since Compass has multiple prototypical designs that utilize a kit of parts that are interchangeable from one prototype to another, neutralizing the interface for all long-lead equipment (like the power center) to avoid a disconnect between the pre-cast wall and the power center was critical. Otherwise, the precast provider would have to make new cuts which opens up room for errors. There were cascade effects on the electrical side as well.

To avoid future field adjustments, which throws timelines and budgets off, the team reexamined the design specifications for all prototypes to implement a uniform method of power center installation This change made it possible to plugand-play equipment from different locations, which is paying dividends now with supply chain challenges. This lesson on uniformity was then applied to the offsite fabrication and onsite installation of plenums which has sped up and prevented bumps in the road during future plenum installs no matter the building type.

Design grouping for efficient change management

With multiple prototype designs, when a change needed to be made, the team was chasing it through multiple different designs and projects. While a lot of the detailing is the same, if there is a detail in need of modification based on a lesson learned in the field, the team was having to go through every step for each of the different prototypes.

The solution was to "lean-up" the process. HED carved out from the design documents a "common detail package" where all typical details that are shared across all prototypes live. This made it possible to provide one set of site- and building-specific documents and one common detail package. Now, there's an orderly and efficient process for making adjustments on a quarterly basis and rolling those out to active projects and the prototypes. The team isn't going project by project to adjust multiple different buildingspecific packages. This structure has created huge time savings when site-adapting any of the prototypes to allow for mass customization without "breaking our design" for all of our clients.

Taking time to save time

Reviewing hundreds of contractor submittals had become onerous, to say the least. By standardizing specifications and prioritizing what and how submittals are reviewed, Compass is saving the internal, HED-Compass team, as well as contractors, significant time on the front-end and bringing projects to fruition faster. Working together, the HED-Compass team overhauled the submittals and review process.

Using a standardized design means many aspects of the prototype share the same parts, construction processes and products. While each facility is tailored to the customer and site, the core elements of each remain the same and are executed in a repeatable manner. Repetition creates opportunity to streamline and prioritize contractor submittals and reviews

As part of the effort to bring uniformity to specifications, Compass and HED grouped required system components by sub-contractor architectural, structural, mechanical, electrical. For each group, they assessed every submittal type and determined whether it required full, limited or no review (for boilerplate specifications that will be the same from project to project).

While time consuming on the front end, this process revealed that almost half of the more than 800 submittals required for one facility fall into the pre-approved or boilerplate category. In addition to significantly narrowing down the volume of required submittals, this overhaul eliminated conflicts, duplications and ambiguity on the specification.

Production scheduling drives down labor hours and improves safety

Super sizing data centers after the post-pandemic building boom required a rethink on traditional, dated construction methods. Compass and HED took a deep dive on process and procedure to identify opportunities to drive down labor hours and build a better facility without compromising

WA's state budget forecast grew \$762M despite recession worries

When the state budget forecasters look at the economy, they see the uncertainty of the present moment: rising inflation and interest rates, global fallout from Russia's invasion of Ukraine, tech company layoffs, potential railway and dockyard strikes and a slowing housing market.

Meanwhile, Washington's projected tax collections have continued to roll in higher than expected.

The numbers released Friday by the Washington State Economic and Revenue Forecast Council provide key information as state lawmakers and Gov. Jay Inslee prepare to write a new twoyear state budget. That spending blueprint funds schools, parks, prisons, public lands, the state's mental health system and other social services.

Overall, projections for the current two-year budget cycle came in almost \$762 million higher than expected, according to the council. The state is also projected to bring in about \$681 million more than anticipated for the coming 2023-2025 budget cycle - the budget lawmakers and Inslee are tasked with drafting during the legislative session that begins in January.

That sets up the Democratic-controlled Legislature and Inslee with roughly \$66.2 billion for the coming two-year budget cycle, which begins next July. Lawmakers are likely to consider more education spending, mental health services and ways to address Washington's housing affordability crisis, among other issues.

In Friday's council meeting, lawmakers and others expressed cautious optimism – but they're not convinced revenue growth will last. Steve Lerch, director of the forecast council, pointed to rising interest rates, concerns about a recession, and layoffs by technology companies like Amazon and others, which could potentially hurt growth.

"We still do believe that things will slow down," Lerch added later.

State revenue projections are improving partly due to strong collections in the state's sales and Business & Occupation taxes. But just as in the City of Seattle, the state homesellers' tax is coming in a bit below expectations as the housing market starts to cool.

Three Sisters Reinvent the Family Farm into a World Class Cheese Producer

After nearly 100 years of dairy farming along the Northern California coastline, the Giacomini family dairy farm had reached an impasse. The farm had grown to its limits at the same time that profitability for dairy farms nationally had fallen, and its owner, Robert "Bob" Giacomini, was in his 60s. Also, his daughters, who had grown up on the farm, had all moved away to start their own careers in different industries around the world.

Faced with this situation, Bob called in the family in 2000 and asked the daughters if they would like to help re-envision the farm. The daughters, Diana Hagan, Lynn Stray, and Jill Basch, weren't passionate about the dairy operation they had always known, but they were united in a common love for fine food and sustainability. That was enough for the sisters to leave their careers and come home, where one of the early decisions they made was to pivot

the family business from milk production to environmentally sustainable, artisanal cheesemaking

They started off slowly, using the cash flow from the dairy operation to build the cheese business around just a handful of well-produced cheeses. By 2015, the sisters' business had both successfully gained the love and admiration of cheese lovers nationally and throughout the bay area, but the farm also plateaued in its ability to grow larger.

"We had to decide at that time if we wanted to grow more or not," said Lynn Stray, "And that was not an easy decision to make because it would mean moving cheese production off of the farm and into a facility." After a significant amount of soul searching and getting the buy-in and support from their employees for the decision to grow, the three sisters drafted a plan to take the Point Reyes Farmstead Cheese Company to the next level.

Central to that new plan was the construction of a new \$7.8 million creamery and distribu-

tion facility in Petaluma, CA, which was made possible through the SBA 504 loan program and approved by Capital Access Group, a local 504 lender. At over 20,000 square feet, the facility offers enough room for the family-owned business to quadruple its space for aging pasteurized cheeses and manufacturing large batches of their new flagship Toma-style cheese.

"I am so pleased that Point Reyes Farmstead Cheese was able to take advantage of the SBA 504 program's low down payment and low, fixed interest rate to purchase a new facility to grow their business," said Julie Clowes, U.S. Small Business Administration District Director, San Francisco District Office. "We know it's not easy to run a business, so we are happy to offer resources, like the 504 program, to help support business growth and expansion."

Point Reyes Farmstead Cheese Company currently employs 85 individuals across their new creamery, farm, and culinary and event center located on the farm. They've already begun to



export their cheeses to Hong Kong, where demand for fine cheese has been rising.

"With our immediate and future growth plans in place, we have a real opportunity for leadership... in specialty cheese, in North Bay agriculture and maybe most-importantly, as a successful, women-owned business," said Jill Basch. "We're excited for the many ways we can make a difference through cheese."
