## 4 Ways to Avoid Profitability Traps That May Be Costing You

Maintaining profitability on any given project is a challenge that many AEC firms face. It's no secret that the construction industry has some of the lowest margins out there; data from Camino Financial states that the construction industry has an average net profit margin of just 5%.

For this reason, teams are under immense pressure to meet project budgets. However, doing that can be a major challenge because construction projects face several profitability traps. These traps are present at all stages of a project and come in many forms—including inaccurate forecasting, data silos, lack of accountability, and so much more.

To avoid these pitfalls, teams must centralize their workflows, standardize their practices, and connect project data to critical processes. In doing so, you can improve productivity and reduce delay, which ultimately results in higher profits.

One firm that's gotten good at avoiding these profitability traps is BL Harbert, a construction firm based in Birmingham, Alabama. BL Harbert

brings in about \$1 billion in annual revenue and employs 8,000 staff members across the globe.

Dane Pemberton, the firm's US Group Construction Technology Manager, delivered an very helpful industry at AU 2021 where he discussed how BL Habert improved profitability by maximizing data and workflows


Dane spoke with Esteban Corrales, Manager of Technical Solutions for Construction at Autodesk, and outlined the steps that the company took to streamline its process and maximize profits.

## 1. Create efficient processes to eliminate bottlenecks

There are plenty of bottlenecks that can slow the progress of construction projects. It could be a case of stakeholders unable to quickly find the info they need. Other times, there's a lack of alignment between teams.

Whatever the situation, bottlenecks cause delays, which lead to higher costs and lower profits. As Dane puts it, "Bottlenecks affect productivity. And if your productivity is affected, your profit margins are affected as well."

## How should California spend its big budget surplus?

California's broader economy is a bit sluggish, but certain sectors have been booming, thanks to record low interest rates and many billions of stimulus dollars from Uncle Sam.

Retail sales, housing and the stock market, three sectors that are very sensitive to federal fiscal and monetary policies, are soaring, even as the state grapples with the nation's highest unemployment and poverty rates.

The state treasury has seen a bumper crop of tax revenues from the high-flying sectors, giving Gov. Gavin Newsom and state legislators tens of billions of extra dollars to spend.

The state budget enacted in June spent the bounty on a wide variety of new and expanded programs, including cash payments to low-income Californians, but revenues are continuing to outpace the budget's estimates by billions of dollars

It means, the Legislature's budget analyst, Gabe Petek, said last week, that the 2022-23 budget could have a \$31 billion surplus — so much that it will collide with the state's rarely invoked

Gann spending limit.

Newsom also says the state will have an "historic budget surplus," although he won't put his number on it until January, when he releases his first draft of the next budget.

It could be a much different number because Newsom's Department of Finance is often at odds with Petek's staff, but whatever it is, Newsom and lawmakers will have a lot of extra dollars, and those who want some of them are beginning to line up.

The Gann Limit, originally enacted by voters in 1979 and modified a decade later, will, Petek warns, be a complicating factor, although there will be disagreement over what it is. Once revenues exceed the limit, the surplus must be used for a few designated purposes, including, potentially, tax rebates.

In 1987, then-Gov. George Deukmejian and legislators rebated \$1.1 billion to taxpayers — a significant sum in those days — after revenues exceeded the Gann Limit. The rebate led to a loosening of the limit to make rebates less likely in the future.

The 2021-22 budget's cash payments to help those financially impacted by the pandemic were framed as tax rebates to satisfy the Gann Limit's restrictions. Assembly Speaker Anthony Rendon says he wants more "one-time investments allowed under the Gann Limit," seemingly a hint about extending the payments.

Newsom has said he wants to commit some extra money to paying down pension debts and/or infrastructure. The overwhelmingly Democratic and left-leaning Legislature would prefer to expand even more social, educational and medical benefits.

Since it's the season for proposing ways to spend the state's embarrassment of riches, let's add one more — doing something about the state's \$20-plus billion debt to the federal government for unemployment insurance payments during the recession.

California's unemployment insurance system, financed by taxes on employers, provided basic support for more than two million suddenly unemployed workers and quickly exhausted what were already scant reserves. The state then began borrowing from the federal government to keep checks rolling out.

## \$100 Billion in Community Benefits in 2021

The Greenlining Coalition and partners secure more than \$100 billion in community benefits from financial institutions

You heard that right. Billions with a b. In 2021, The Greenlining Coalition and our partners at the California Reinvestment Coalition and the National Community Reinvestment Coalition negotiated over \$100 billion in community benefits with financial institutions directing critical resources to formerly redlined communities.

Earlier this fall, the Greenlining Institute and the California Reinvestment Coalition announced a \$1.4 billion, five-year community benefits agreement with Banc of California that will increase financial resources available to low- and moderate-income people and communities throughout California

CRC and The Greenlining Coalition held Banc of California accountable for loaning millions and extending credit to problematic landlords in L.A. -- exacerbating an already dire housing crisis. Coalition members urged federal regulators to deny Banc of California approval to proceed with a proposed merger unless the bank put pressure on their borrowers to be more equitable and responsible landlords and provide better services to low- and moderate-income communities.

As a result of the pressure to do better, Banc of California agreed to a five-year, more than \$1.4 billion community benefits package that includes investments in economic develop-

ment, a \$200 million affordable housing commitment, and a significant increase in the bank's contributions to LMI-serving organizations, including groups providing homeownership and small business counseling.

The Greenlining Institute has a decades-long history of successfully negotiating community benefits agreements with financial institutions who must comply with the Community Reinvestment Act — a 1970s-era federal antiredlining law that regulators must consider before approving a bank expansion.

Before the pandemic and racial equity crises, there was a strong case for banks to make consolidation moves, and this case has grown stronger during this early rebound from CO-VID-19. U.S. bank merger and acquisition activity jumped in late September as four huge deals were announced, setting a new record in 2021

In January, Silicon Valley Bank announced a major \$11 billion community benefits plan negotiated by The Greenlining Institute and CRC to invest in low-income communities

and CRC, we suc-

cessfully secured one of the largest community investment plans in recent history with PNC Bank. PNC Bank is committing to a four-year, \$88 billion Community Benefits Plan that aims to expand economic opportunities for communities of color and low- and moderate-income individuals and communities.

That brings the total in secured community benefits to over \$100 billion in 2021 alone.

The Greenlining Institute is building on a 30 year track record of success to create a better, more just future for everyone. We envision a future where communities of color can build wealth, live in healthy places filled with economic opportunity, and are ready to meet the challenges posed by climate change.

In order to realize this vision, the financial industry must be held accountable and responsible to all of America's communities. Some of Greenlining's most important work is based on the Community Reinvestment Act, passed in 1977 and barely updated since then. The CRA requires traditional financial institutions to demonstrate to regulators that their lending, investments, and services adequately serve the communities in which they have market presence. Notably, the growing number of nonbank lenders like financial technology (fintechs) and credit unions are exempt from the CRA's requirements.

This law has made it possible for Greenlining and our partners to negotiate community benefits agreements with leading financial institutions, bringing \$700 billion in investments to low-income, historically redlined communities.

Our work over the last three decades has shown us that equity will not just "happen." It will be created with intentional, decisive, immediate action. That's why we are so invested in confronting systemic racism at its root and building enduring, transformative new solutions

## 4 Ways to Avoid Profitability Traps That May Be Costing You

One of the best ways to overcome project bottlenecks is to get all stakeholders on the same page using a common data environment (CDE). Avoid using point solutions or disconnected systems, as this will create silos and reduce efficiency. Instead, centralize your data and workflows and ensure that teams can access everything they need from a single platform.

"Centralizing our model and pulling everyone into a common environment was really important to us," explains Dane. "And so Autodesk Construction Cloud, and the unified platform it provides, has been key in helping us in our centralization effort."

You can also eliminate bottlenecks through standardization. By making sure that teams follow the same procedures—and those processes are carried out on the same platform—you can keep things moving along more smoothly.

As an example, Dane shares their previous process for handling RFIs, which involved a lot of back-and-forth between various stakeholders.

"We would encounter an issue on the job, and then a superintendent would pick up the phone to tell the project manager. That person would then write the RFI and relay it to the vendor or subcontractor, who'll use their own system and coordinate with other stakeholders. Then they'll turn around, and send it back to us." The process was quite disconnected and left plenty of room for miscommunication. So, the company adopted digital tools which streamlined the RFI process.

"Now, with Autodesk Build and [Autodesk] Construction Cloud, we have a more concise workflow. We have at least a central source for all the data to live. We have the connected workflows inside of Build that help us take a pen off a sheet, immediately click on that, create an RFI, send that out."

Dane continues, "And the tracking process is seamless. We send it to users that are already in the system. They get notified via email or notification on their phone. And they can immediately answer or share it with other team members. It has helped create efficiency through connecting all those workflows together, plus centralizing and standardizing what the RFI form looks like, and what the process looks like."

#### 2. Establish clear accountability across teams

Promoting accountability ensures that project tasks and milestones are met. When everyone knows what they're responsible for—and they are empowered to fulfill those responsibilities—projects run smoothly and you fall into fewer profitability traps.

## FACT SHEET: The U.S. Small Business Administration is Delivering Support to America's Small Businesses, Helping Them **Recover from the COVID-19 Pandemic**

While the holidays may still look a little different this year, the U.S. has made significant strides to ensure Americans can safely congregate with their loved ones for the Thanksgiving holiday and take part in celebrations to shop local and small on Small Business Saturday. Last year, shoppers came together in full force to support their local communities, and Small Business Saturday hit a record high with an estimated \$19.8 billion in reported spending. This year, holiday consumer spending is projected to break new records.

Under Administrator Isabella Casillas Guzman, the U.S. Small Business Administration (SBA)

has been at the forefront of the recovery effort, equitably delivering economic relief to small businesses along Main Streets - from the momand-pop restaurants and retail shops to the contractors and small manufacturers. While much progress has been made to get Americans back to work, back to business, and back to normal, the Administration and the SBA have continued to make equity a priority by increasing access to government resources, lowering the barriers to opportunity, and helping expand the reach of the customers we serve.

The U.S. Small Business Administration (SBA)'s implementation of President Biden's American Rescue Plan (ARP) and other traditional loan programs have helped the smallest of small businesses survive, and the work continues. In the midst of a global pandemic, under Administrator Guzman, the SBA delivered a record number of its traditional loans to our nation's small businesses while also scaling up to meet the immense demand for COVID-related economic relief. 

The debt is expected to top \$20 billion by the end of the year and if not repaid, the federal government will raise payroll taxes on California employers until it is paid, with interest. That's what happened after California borrowed about \$10 billion during the 2007-12 recession.

In this case, however, the recession resulted from Newsom's order to shut down businesses

to battle COVID-19. Therefore, the debt should be fairly shouldered by the state as a cost of fighting the pandemic, rather than by employers still struggling to recover from recession.

It may lack political sex appeal, but it's the right thing to do.

## Can younger generations spur corporations to divest from fossil fuels?

Bulging gray rain clouds threatened to open up on a crowd of protesters on a recent Friday morning in Seattle. A few hundred people, mostly high schoolers and university students, held banners and hand-painted signs that read: "Youth demand climate justice," "Stop the money pipeline" and "It's our turn to lead."

They marched six blocks, from Pier 62 on Seattle's waterfront to the corner of Second Avenue and Union Street, where they unfurled a long banner and staged a die-in — lying on the ground to dramatize the deadly stakes of the climate fight. In many ways, the actions and rhetoric mirrored previous youth climate protests, but this one differed in one notable regard: Instead of standing in front of City Hall and appealing to elected officials, the protesters were lying in front of the Pacific Northwest headquarters of the JPMorgan Chase bank.

The "Fossil Free Future" campaign aims to engage a growing number of young people to boycott banks, insurers and other companies that fund fossil fuel projects, not just by withholding their money, but also their future labor.

"Why not just go to the source if we know that corporate actors are the issue?" asked Sof Petros, a 24-year-old climate activist who helped organize the Seattle protest. "We have power as current and future customers, employees and the public to push these banks to move towards bet-

ter positions and be held accountable for past, current and future financing of fossil fuel projects."

Seattle's protest — one of dozens in cities and towns across the U.S. — came in the wake of national struggles to pass policies that experts say are needed to keep the U.S. on track to meet its climate targets. It also coincided with the start of the 2021 United Nations Climate Change Conference, or COP26, an international gathering of governments around the world that many have said will be "the whitest and most privileged" assembly yet.

Over the past two decades, these conferences have largely failed to achieve the greenhouse gas reductions needed to keep the world from reaching dangerous levels of warming. It's this growing disillusionment with government action that has motivated youth to follow the money instead, said Petros.

The International Energy Agency and Intergovernmental Panel on Climate Change both released alarming reports this year showing that if the world is going to stay below 2.7 degrees Fahrenheit (1.5 degrees Celsius) of global warming, no new fossil fuel projects can be built.

Yet major banks and insurance companies continue to underwrite and insure new coal and oil and gas extraction and infrastructure. A report released in March found that since the Paris Agreement in 2015, the world's 60 biggest banks have funded almost \$4 trillion worth of new fossil fuel projects. The new youth campaign includes pledges not to bank or work for

financial institutions that finance fossil fuel projects, as Chase does.

"You're more likely to divorce than you are to switch your bank," Petros said. "Banks know that, and they are courting youth as lifelong customers. And we represent decades of a future customer base."

The high school and university students join a growing number of climate campaigns, from shareholder activism to university divestment campaigns, that are calling for institutions to stop financing fossil fuel projects. But the power that they hold over companies goes beyond just their money. As baby boomers retire, the U.S. faces a growing recruitment crisis.

According to a survey by ManpowerGroup, one of the world's largest staffing firms, the number of employers struggling to fill positions has tripled from 14% in 2010 to 69% today. COV-ID-19 sparked a wave of resignations and made the ongoing labor shortage worse. Financial services and the insurance sector in particular are in the midst of what some have called a "crisis" to recruit new talent.

"Skilled workers are in control, and companies need to understand people's priorities to compete," Becky Frankiewicz, president of ManpowerGroup North America, told Forbes this year. The priorities of the younger generations are obvious. Polls regularly show that climate change is one of the top concerns of Gen Z. And almost three-quarters of millennials would take a pay cut to work with a company that is environmentally responsible.

Aedan McCall, who spoke outside of Liberty Mutual during the Seattle march, is one example. The University of Washington student is studying computer science and grappling with how to enter a workforce and industry that directly and indirectly contributes to climate change, not just through emissions, but also by supporting the extraction of fossil fuels through their products, such as helping develop algorithms to find new oil reserves.

McCall says that when students enter the labor market in the next few years, evidence that a company takes climate change seriously and shares key values will influence everything from where they decide to work to where the recruits bank and what kind of life or property insurance they choose.

nomically disadvantaged-owned (\$6.7 billion) small businesses.

- The Shuttered Venue Operators Grant has awarded grants to nearly 13,000 live venues, theaters, and other entertainment and cultural hubs. Since the inception of the SVOG program, more than 90% of the grants have supported venues with fewer than 50 employees or the smallest of small businesses a key priority of this Administration.
- The retooled COVID EIDL Targeted and Supplemental Advance programs have provided almost 500,000 small businesses approximately \$6.3 billion in financial relief, focused on supporting those from lowincome communities who were especially hard-hit and are still reeling from the pandemic.
- And the Community Navigators Pilot Program has awarded nearly \$100 million in funding to 51 organizations that will work with hundreds of local groups to connect small business owners to government resources and help level the playing field for America's entrepreneurs. ## Lamees Dahbour, Mama Lamees

Most Americans have sampled hummus, that creamy Middle Eastern blend that is the perfect complement for vegetables and crackers.

Well, the Bay Area is now excitedly trying new items like musakhan: pita bread with onions, almonds, and sumac. That's due to Lamees Dahbour's burgeoning catering business and food stand, Mama Lamees. She is serving unique, homemade food that she creates lovingly from scratch. It's a veritable feast from the Middle East. In this case Ramallah, Lamees' ancestral Palestinian village located in the West Bank, just six miles north of Jerusalem. She has fused her cuisine with food from the Middle East's Gulf States region. She spent a few years there while working as an employee of the United Nations Relief and Works Agency.

Many recipes are from her grandmother and mother – dishes rarely found in restaurants or markets in the U.S. Lamees has long shown a love for cooking. It all began when her mother had a medical issue and had to recuperate away from home for a month. This circumstance left the 10-year-old to step in and cook for the family, which she gladly did.

Cooking has continued to be a way to show love, and thanks. Even after Lamees permanently settled in San Francisco a decade ago.

#### Coming together to help

Her Mission District building manager, Lupe Gomez, echoed this sentiment, counseling Lamees

to start her own business. So she went to La Cocina, who concurred that this business idea had legs. Now all Lamees needed was a business plan. That's when she went to MEDA for help.

Business Development Coach Teresa Garcia began working with Lamees a little over a year ago. The budding entrepreneur participated in MEDA's seven-session core training. The program teaches everything from marketing strategies and lease negotiation to personal finances and access to capital. Then, the main need was for Teresa to help Lamees refine her business plan and streamline financials.

After discussing what the best type of entity would be for Lamees, Teresa connected her to Legal Services for Entrepreneurs (LSE). The project is an economic justice and community empowerment arm of the Lawyers' Committee for Civil Rights. LSE matches experienced business attorneys from a variety of law firms with individuals who generally would not have access to specialized legal services. All work is done pro bono. In Lamees' case, that match was Craig Miller, a partner with Mannat, Phelps & Phillips, LLC.

Once she secured her business and catering licenses, Lamees was off to the races. She hired her daughter Lubna to set up Mama Lamees' social media presence. She also plans to make it a family enterprise by hiring her sisters Eman and Mayada.

#### Showing her food to the world

Mama Lamees' food has been in high demand, having catered events for Opportunity Fund, La Cocina, and eatwith.com. In 2019, La Cocina helped Lamees secure a kiosk at the Emeryville Public Market. There, she's been serving delicious Palestinian food even through the COVID-19 crisis. Two of her recipes were also featured in La Cocina's cookbook, We Are La Cocina: Recipes in Pursuit of the American Dream.

"La Cocina, LSE and Teresa from MEDA worked really hard to create my business. I am excited to be offering my unique food to San Francisco," said Lamees, grateful to the community of support that made her small business dreams a reality.
