The State of U.S. Infrastructure

The \$20 trillion U.S. economy relies on a vast network of infrastructure from roads and bridges to freight rail and ports to electrical grids and internet provision. But the systems currently in place were built decades ago, and economists say that delays and rising maintenance costs are holding economic performance back. Civil engineers raise safety concerns as well, warning that many bridges are structurally deficient and that antiquated drinking water and wastewater systems pose risks to public health. Meanwhile, Americans' international peers enjoy more efficient and reliable services, and the U.S. lags behind other developed countries in infrastructure spending.

Skeptics of federal spending have pushed for new models of private sector involvement, which they say is more efficient and cost-effective. Others argue that increased public spending will be necessary to meet the country's growing needs. With the COVID-19 pandemic delivering a major economic shock, President Joe Biden has rolled out a sweeping plan to overhaul the nation's infrastructure. In November 2021, Congress approved the largest federal investment in decades.

How important is infrastructure to the U.S. economy?

Economists argue that robust investment in infrastructure in the twentieth century set the foundation for the nation's strong growth in the aftermath of World War II. And as engineer and historian Henry Petroski explains in his book The Road Taken: The History and Future of America's Infrastructure, poor infrastructure can impose large costs on the U.S. economy. In addition to the threat to human safety of catastrophic failures such as bridge collapses or dam breaches, inadequately maintained roads, trains, and waterways cost billions of dollars in lost economic productivity.

According to Petroski, the delays caused by traffic congestion alone cost the economy over \$120 billion per year. Airports are another choke point: air transportation services support 1.4 million U.S. jobs, and international tourism brings in hundreds of billions of dollars of tax revenue. But some studies have found that delays and avoided trips due to the poor state of the nation's airports cost the economy over \$35 billion per year.

Many analysts say that investing in both new infrastructure and current maintenance would stimulate the economy. By increasing efficiency and reliability and lowering transportation costs, it would boost long-term U.S. competitiveness,

\$1 million in grants to support the local economy and workers impacted by the closure of California Correctional Center in Susanville

The Newsom Administration – through the Labor & Workforce Development Agency (Labor Agency), Governor's Office of Business and Economic Development (GO-Biz) and Governor's Office of Planning and Research (OPR) – announced state assistance to support workers and communities impacted by the closure

of the California Correctional Center (CCC) in Susanville, plan for changes in the region, and strategically invest in job creation and opportunity. Assistance includes a \$1 million Rapid Response grant to support an action plan for the local economy, while also connecting it to aligned regional planning efforts and statewide funding opportunities through the \$500 million Community Economic Resilience Fund (CERF).

These include transfers of employees to the neighboring High Desert State Prison and other options in the geographic area, as well as connecting impacted employees to various State processes that allow them to transfer to vacancies throughout the State's prison system.

The assistance announced today will further support the Lassen County community in mitigating the impacts of the CCC closure.

The Northern Rural Training and Employment Consortium (NoRTEC) will serve as the lead agency for the Rapid Response grant, working in collaboration with a variety of existing entities such as the City of Susanville, Lassen County, economic development and America's Job Centers of California partners, business leaders,

community-based organizations, environmental and social justice groups, labor leaders, and expert consultants.

"This new State investment will greatly assist in helping dislocated workers transition to new employment as quickly as possible, and will help the community prepare for and manage the economic change," said Michael Cross, Executive Director of NoRTEC. "We look forward to working with Lassen County, the City of Susanville, and other partners to align these resources with the community's needs."

NoRTEC and its partners will:

 Identify the factors, industry clusters and other opportunities to influence the local economic conditions and identify sustainable ways to track changes to key economic indicators within Lassen County.

Case Study: Three Tips for Training and Retaining a New Generation of Craft Workers

We have all seen the stats: The industry needs hundreds of thousands more craft workers to meet demand in the next year alone. Currently, more than a third of the industry is over 50 years of age and, according to NCCER, approximately a third of the workforce will retire by 2026. This crisis is prompting everyone in the industry to place a renewed focus on workforce pipeline development.

Mortenson has been working for a number of years on refining strategies for recruiting, training and keeping a thriving craft workforce. The result is a 90% overall retention rate and a more diversified workforce than the industry average. This is not said to boast but rather to demonstrate the success of prioritizing the following key elements in craft recruitment, training and career development, engagement, and retention.

1. Recruiting: Widening the Pool and Tapping into the Workforce

Right now, women make up just 10.9% of the construction workforce, despite making up 46.6% of the overall U.S. workforce. Just 10.7% of construction industry professionals are Black and 2.7% are Asian. The opportunity—and the imperative—here is clear. In addition to broadening outreach so more people understand the many possibilities for building a rewarding and lucrative career in this industry, it's vital to have policies in place (such as equal pay for equal work) that demonstrate transparency and foster a welcoming environment for people of all backgrounds, race and gender. People want to know they're coming into a workplace that will value their contributions and support their development

Creating this kind of workplace is an ongoing effort. It might start with a concrete and actionable DEI plan, but it must extend to the daily experience of being on the jobsite. Several weeks

ago. Mortenson and many other construction firms nationally celebrated the second annual Construction Inclusion Week, an event dedicated to facilitating important conversations in the office and on the jobsite around difficult topics such as unconscious bias, and providing tools and resources to promote greater accountability. Putting in the real work to create a sense of belonging for all people on a jobsite leads to greater retention and unlocks one of the most powerful recruiting tools any construction firm has: its people. When a workforce feels supported, they're more likely to recommend people they know to the company. Right now, most of Mortenson's craft team members come to the company on the recommendation of a current team member. Once an employee is in the door, its goal becomes spotting talent and drive and ensuring that each and every team member understands the path to achieving their goals in the organization.

2. Training and Development: Investing in Potential

Recognizing that people thrive in environments where they are challenged and supported, the investment a company makes in its craft team members—in terms of training and mentor-ship—typically has a direct correlation with their ultimate performance and retention.

Many times, when a craft team member joins a team as a laborer, they aren't aware of the full spectrum of growth opportunities available to them in this industry—or how to get there. While career development will be unique to each team member and can take different directions over time, depending on the person's interests and skills, Mortenson has found that providing a visual guide, in English and Spanish, to the many possible roles and salaries when someone starts a new role can be invaluable in helping people set goals for themselves.

African American trio announce the launch of a state-of-the-art mixed-use affordable housing complex in the City of Long Beach

Community Economic Development Corporation (CEDC,) Innovative Housing Opportunities (IHO,) and Curtom Building and Development Corporation jointly announced the development of a mixed-use affordable housing complex to be built in the City of Long Beach. The venture is being led by three entrepreneurial African American businesswomen who are based in Southern California.

The .5-acre parcel in Long Beach, also referred to as 7th and Pine, is projected to be a mixed-use building constructed with approximately 109 state-of-the-art affordable housing/workforce units with a smart city technology overlay de-

signed by Cassie Bates, president and CEO of Made in South LA.

"I'm thrilled to announce the partnership we have created with two other trailblazing African American women to create an opportunity for local residents to access high-quality affordable housing," said Delores Brown, president and chief executive officer of CEDC. "We aim to help close the housing crisis which disproportionately affects communities of color."

A study released by the City of Long Beach reported to a housing crisis. According to the results, 43% of all households are cost-burdened – paying more than 30% of their monthly income

toward rent or a mortgage. Rent has increased by 20% over the past 10 years.

"As we push through the necessary steps to begin groundbreaking in 2023, we are eager to work in cooperation and coordination with local partners, stakeholders, city officials, and residents of the city," said Rochelle Mills, president and executive officer of IHO. "The future of affordable housing is within reach, and we are honored to bring innovative solutions to this problem."

Earlier this year, California Gavin Newsom approved more than \$923 million in awards for affordable housing projects across the state as part of the California Housing Accelerator, a \$1.75 billion investment to provide bridge funding to shovel-ready projects.

"I'm enthusiastic about our partnership and the collaboration with local stakeholders. It is a privilege to participate in the efforts to provide high-quality affordable housing in Long Beach," said Brenda J. Curry, president of Curtom.

In addition to the collaboration between Brown, Mills, and Curry, Michael Wylie, president of FAMCO and long-time affordable housing advocate, is a contributor to the project.

"When my great uncle originally built the tower in 1972, he had the aspirations of building an additional tower next door," said Wylie. "I am honored to be able to make his vision a reality.

The State of U.S. Infrastructure

insulate the economy from shocks, and create jobs. Economists generally see infrastructure spending as having a significant "multiplier effect," meaning that the economic gains are greater than the amount spent. A 2014 University of Maryland study [PDF] found that infrastructure investments added as much as \$3 to gross domestic product (GDP) growth for every \$1 spent, with a bigger effect during a recession.

What is the overall state of the nation's infrastructure?

The U.S. population has more than doubled since the 1960s, when most of the country's major infrastructure systems were designed. Many are reaching the end of their lifespan, and are dangerously overstretched, experts say.

The American Society of Civil Engineers (ASCE) has compiled regular "report cards" on the state of U.S. infrastructure since the 1980s. In its 2021 report [PDF], the ASCE found that the nation's infrastructure averaged a "C-," up from a "D+" in 2017 and the highest grade in twenty years. Still, the group estimated that there is an "infrastructure investment gap" of nearly \$2.6 trillion this decade that, if unaddressed, could cost the United States \$10 trillion in lost GDP by 2039.

Other analysts agree that the shortfall is large. McKinsey researchers say that \$150 billion per year will be required between 2017 and 2030 to keep abreast of all the country's infrastructure needs

Transportation will require the largest chunk of funding needs. The U.S. Government Accountability Office finds that nearly one in four bridges are deficient, with 10 percent categorized as structurally deficient and 14 percent categorized as functionally obsolete. While America's airports carry the most passengers of any country in the world, its aviation infrastructure is also overburdened, with some 20 percent of all arrivals and departures delayed in 2019, according to the Department of Transportation's Bureau of Transportation Statistics.

The country's rail systems are a mixed bag. U.S. commercial rail, a large portion of which is owned by the private freight industry, is among the most developed in the world, moving nearly 40 percent of the nation's goods. At the same time, the focus on freight rail has relegated passenger rail to a lower priority.

Central WA is eyeing nuclear power again — but on a smaller scale

It could be the next big thing in power plants.

Or actually the next big little thing: small prefabricated nuclear reactors.

An Oregon company wants to provide a quick, flexible way to power the region by building modular nuclear units that can be built in a factory and then transported to the power-plant site for final assembly.

Not only would these new units be carbon-free — although not likely controversy-free — but they're also less expensive to build than traditional nuclear power plants.

Each modular unit would be a mini-reactor capable of generating 50 to 300 megawatts of energy. (One hundred megawatts could power 120,000 houses.) Small modular reactors are supposed to be designed so extra modules can be added as needed, with 12 modules being the theoretical maximum. This concept is supposed to lead to lower costs, faster construction times and more flexibility in tailoring a reactor complex to its customers' needs.

The nation's first small modular reactors will likely show up in the Pacific Northwest, possibly in Idaho and Central Washington's Grant County, with a target online date of roughly 2030.

Some U.S. and world leaders are pushing this new sort of nuclear reactor as a carbon-emissions-free measure to combat climate change.

The front runner in setting up a small modular reactor in the United States is NuScale Power of Corvallis, Oregon.

But its prominence has brought extra scrutiny. Does NuScale's design create more radioactive waste than a conventional reactor?

In August 2020, NuScale became the first, and so far only, small modular reactor developer to receive approval for its 60-megawatt design by the Nuclear Regulatory Commission. The company plans to submit an improved follow-up version of that design to the commission this December. These design changes include having the proposed reactors produce 77 megawatts each. By comparison, the Columbia Generating Station reactor north of Richland generates 1,200 megawatts.

- Forecast displacement of current jobs based on the rate of transitions within the county based on the prison closure.
- Identify emerging industries that can utilize Lassen's existing competitive advantages to thrive.
- Identify skills gaps in the existing workforce that are barriers for transitioning into new industries.
- Identify ways to train and transition workers to emerging industries.

NoRTEC's efforts in Lassen County will tie into the State's Community Economic Resilience Fund (CERF) regional planning efforts. Led by Chico State Enterprises and Sierra Institute for Community and Environment, and encompassing a 10-county region, the CERF North State multi-stakeholder effort, known as a High Road Transition Collaborative, will align resources and activities to NoRTEC at a regional scale, centering on climate initiatives, land stewardship, identification of high-growth sectors, and connection to sub-regional initiatives to build capacity and strengthen the region's economic and workforce backbone. The regional plan will support projects and policies that equitably advance regional and community needs.

The CERF Program—a collaboration between the Labor Agency, OPR and GO-Biz—will have available approximately \$500 million statewide to invest in projects identified by these regional plans, including \$50 million for economic diversification pilots (available in January 2023) and \$450 million (available starting in summer 2023) for projects identified out of planning processes.

Akiko-Ayalla Cooks (Akiko) left her native California after completing training as a psychiatric technician, settling in Las Vegas, Nevada. She thought that she found her calling as the founder, owner, and operations executive of two large behavioral treatment facilities there until an unexpected wake-up call roused her.

In 2019, photographs of Akiko's teenaged son Corey Landrum, along with eight other Black children, were circulated on social media targeting them for what was called "Columbine Two" by three other students at the school. The school's and local law enforcement's lethargic responses thrust Akiko into action and onto her present trajectory.

Organizing with parents of the other targeted youth, Akiko and another parent, Jshauntae Marshall, co-founded NO Racism in Schools #1865, an organization developed to include community voices in ongoing conversations with the school district in an attempt to move more aggressively in addressing long-simmering, systemic racism. Following the sentencing of two of the three student offenders, she further galvanized the community into maintaining pressure on local government to continue and expand the struggle.

Akiko's high visibility brought her to the attention of other organizations, several of which solicited her skills in related areas of equity, inclusion, and anti-racism. Jointly, American University and the Southern Poverty Law Center hired her as an administrator for their restorative justice program, based in Washington, D.C., as part of the Polarization and Extremism Research Innovation Lab (PERIL). When COVID-19 delayed implementation of the program, the Progressive Leadership Alliance of Nevada (PLAN)

hired her as an organizer where she coordinates bail-out efforts in several states with the Mass Liberation Project and the National Bail-Out (Black Mama Bailout). Additionally, Akiko supports local municipal candidates for public office and works with other parents in effecting structural changes at the school board level.

Akiko and her work were featured in the Spring 2020 issue of the social justice magazine, Teaching Tolerance. She is a sought-after speaker on topics of anti-racism, systemic racism, inclusion, and social justice, appearing on panel discussions and on-air with local media with increasing regularity.

Among Akiko and Jshauntae's most recent accomplishments is the leap from a \$0 budget in 2019 to a forecast budget for 2023 of over a million dollars, with a portion earmarked for their office, teaching facility, and furnishings, garnered through a grant received in 2022 for which they were invited to apply.

As Akiko put it when interviewed recently, "Success comes from having a viable vision and putting in intelligent work to realize it. And an excellent team. Jshauntae and I are fortunate to have all of those."

Welcoming Veterans into Construction is a Win-Win Situation

Veterans make up 13% of the Canadian and US population.

Every year around 250,000 people leave the US military and begin the process of integrating back into civilian life. This transition is difficult for a number of reasons. Reconnecting with family and friends can be hard after serving. Daily routines are completely changed. Many veterans struggle with what to do next. 65-80% of veterans return home with no job lined up, making this transition even more stressful.

With the value we place on our military and their service, it's surprising that it would be so hard for them to find jobs after returning home. More than half of veterans who are looking for work say that they struggle to find employment. The value placed on education and practical experi-

ence, and the stereotypes about ex-military people deter employers from placing them on their list of "must have new hires".

The construction industry is in a unique position to change this for veterans everywhere. The similarity in valuable skills, development programs and workstyle make construction a natural career fit for military veterans returning home.

Why Is It Hard for Veterans To Find Jobs?

It's hard for veterans to find jobs because modern workplaces value education and experience over soft skills. Most people who serve in the military join directly after high school and their only work experience is in the military. The kinds of skills developed during their military career do not naturally translate into experience in civilian life. Military Skills Translator is a tool which helps to bridge this divide. It connects military careers and experiences to the civilian equivalent. It also helps to show veterans how

their skills can translate and what their career possibilities could be. However, this is just one small tool for a broken machine that constantly works against veterans.

Stereotypes linked to military personnel work against them before they even have the chance to present themselves. Employers question their ability to adapt to a corporate work structure and to follow "civilian" orders. Veterans are viewed as being formal and rigid. According to a recent survey, 40% of civilians believe that the majority of post-9/11 veteran suffer from a mental health condition. Veterans are viewed as difficult to manage, "broken" from deployment and as having anger management issues and post-traumatic stress.

The reality is that only 17% of employers believe hiring veterans can be an asset to a company. One survey found that 53% of employees believe that veterans will not have a successful career after the military. It's surprising that their return home is not met with as much faith and

belief as we have in them during their military service. The reality is that hiring veterans is an asset for your business.

What Construction Can Gain From Valuing Veterans

Construction has been facing a labour shortage for years. There are major gaps in skilled labourers and operators. Because of this the industry is already seeing rising costs, a slower progression towards completion in projects, an inability to keep up with demand, and difficulty managing and controlling teams. A lack of leadership is causing major problems. For the future of the industry, workers with a strong work ethic and leadership skills are needed.

Materials Pricing Inflation and Uncertainty: How Contractors Can Better Manage the Bottom Line

The construction industry faces a major problem: Inflation is squeezing contractors and subcontractors

- Overall inflation is causing the cost of everything to skyrocket, from food to fuel to office supplies and rent.
- Vital construction materials have seen some of the most volatile prices.
- Continued supply chain issues are still adding to the cost of materials.
- Overall economic uncertainty and fears of an upcoming recession are rising.

How these construction professionals address and resolve these challenges could be the difference between a bright future for their businesses or a continued rough road ahead.

Inflation and The Industry

Rising materials and other costs, such as labor, fuel and maintenance costs, are simply crushing contractors and subcontractors. The pandemic devastated supply chains across the globe, the U.S. homebuilding boom swallowed up lumber, concrete and other essential materials as fast as they could be produced and now rising interest rates are further impacting construction budgets.

Contractors and subcontractors are caught in a vise of rising materials costs, a serious and growing skilled labor shortage and ongoing supply chain issues that drive up costs and delay projects. For instance, the price of steel, a major component of data center construction, fluctuated dramatically, rising over 200% from March 2020 to mid-2021 before finally easing this summer. Other critical inputs have also risen. In fact, the cost of key building materials has risen 19.2% year over year and 35.6%

since the beginning of the pandemic. Thankfully, supply chain bottlenecks that plagued the industry have eased, and some prices have even fallen, but contractors and subcontractors continue to face severe materials cost challenges.

Another challenge is rising fuel costs. For a subcontractor with a small fleet of three Ford F-150s, at \$3.70 a gallon (the current national average), simply filling up those vehicles twice a week could lead to over \$2,000 a month in out-of-pocket costs. In key markets in California, the Pacific Northwest and across the eastern seaboard, those costs are as much as 35% higher. Increasing diesel prices are an even greater concern. In early 2022, diesel costs rose 33% in just five weeks, driving the price to an all-time high of \$5.78 per gallon in June. According to EIA, diesel prices have jumped 141% since the pandemic began.

The cost of construction materials is about 35% to 60% of the overall construction cost. For the last three years, record inflation has driven up the cost of construction projects while also creating new risk management challenges for contractors. The construction industry weathered the pandemic economic slowdown better than most industries, but significant barriers to success remain.

Inflation is so detrimental to contractors and subcontractors because of the nature of the industry. It leads to cash flow management problems, declines in sales volume, longer production timelines and exacerbates other construction operations challenges.

First-ever California offshore wind auction nets \$402 million — so far

The first auction for leases to build massive wind farms off California's coast netted bids reaching \$402.1 million today, signaling the beginning of a competitive market for a new industry producing carbon-free electricity.

The auction — the first on the West Coast — includes five sites about 20 miles off Morro Bay and Humboldt County, totaling 583 square miles of deep ocean waters. The leases from the federal government are the first step in a years-long regulatory process that could culminate in the nation's first commercial-scale floating wind turbines off California's coast.

After 20 rounds of bidding, today's top bid stood at \$100.3 million for a 125-square-mile area off Morro Bay, while the lowest leading bid so far is \$62.7 million for a 98-square-mile area off the coast of Humboldt County. Bidding will resume on Wednesday at 7 a.m and winners will be released that afternoon.

So far, the total bids are considerably smaller than the record-breaking \$4.37 billion paid for six offshore wind leases off New York and New Jersey's coasts in February. That was the largest amount ever paid for U.S. offshore energy leases — including for oil and gas. The funds are paid into the U.S. Treasury's General Fund.

The results of the auction offer the first key signs for gauging how strong the market is for producing offshore wind energy off California. Forty-three companies, including industry leaders like the Danish company Ørsted, are eligible to bid on the leases offered by the U.S. Bureau of Ocean Energy Management, which oversees offshore energy and mineral projects.

The offshore waters included in the auction have the potential to host several hundred turbines that produce more than 4.5 gigawatts to power about 1.5 million homes.

Offshore wind projects are considered critical to meeting California's goals to provide a new source of electricity, end reliance on fossil fuels and battle climate change.

"Today's auction is great news for California's offshore wind industry, workers, and electricity ratepayers," said Adam Stern, executive director of Offshore Wind California, a trade group for industry developers and technology companies. "It's the most consequential milestone yet for the Golden State's efforts to make offshore wind a key part of its diverse clean energy future."

Experts say construction is at least five to six years away, and an array of unknowns must first be addressed by the companies: the high costs of construction, the logistics of producing the energy and bringing it to shore, and the environmental risks to marine life and commercial fisheries.

"There's a lot of opportunities, but there's also some challenges," said Habib Dagher, executive director of the University of Maine's Advanced Structures and Composites Center, who is helping develop the first offshore floating wind turbines in the U.S.

"California has deeper waters than any other areas with these floating turbines so far in the world," he said. "How do you protect the environment, protect local stakeholders, protect the fisheries, protect indigenous communities, while also speeding up permitting so we make a difference with global climate change?"

Unlike current offshore wind turbines fixed to the ocean floor off the East Coast, California's turbines — the first of their kind in the nation — would float on platforms anchored by cables in waters reaching about half a mile deep.

The turbines are hundreds of feet tall with blades that are bigger than a football field, but they would largely be out of sight from the shore, about 20 miles away. The Morro Bay lease area covers 376 square miles, while Humboldt's is 207 square miles.

The state's ambitious offshore wind targets build off President Joe Biden's 2021 pledge to deploy 30 gigawatts of offshore wind nationally by 2030. Gov. Gavin Newsom hopes to add between 2 to 5 gigawatts of offshore wind off California's coasts by 2030.

The state's ultimate goal is to produce at least 25 gigawatts from offshore wind sources by 2045 – the boldest commitment any state has made. That could supply electricity for 25 million homes.

"Offshore wind is a critical component to achieving our world-leading clean energy goals and this sale is an historic step on California's march toward a future free of fossil fuels," Newsom said in a statement. "Together with leadership from the Biden-Harris Administration, we're entering a new era of climate action and solutions that give our planet a new lease on life."

How do offshore wind farms work?

Offshore wind turbines work similarly to landbased ones. Wind makes the turbine's blades spin around a rotor, which then turns a generator to produce electricity. The turbines send energy through cables under the seabed to an onshore substation, where the energy is converted to a higher voltage before being fed into the grid that provides electricity.

California's offshore wind farms would be the first in the country constructed with floating platforms at a large scale. Europe has long been a leader in developing offshore wind technologies, including a few existing floating offshore wind farms.

The U.S. hopes to soon become another world leader in developing the technology, said Dagher of the University of Maine.

"The U.S. still has an opportunity to lead in floating technologies," he said. "But we need to move forward on the technology side and keep investing in research and development."

The first offshore wind turbines in the U.S. are rooted to the sea floor in relatively shallow waters on fixed structures, which are unsuitable for deep waters. California's floating turbines, however, will be located about 20 miles offshore and will need to be anchored by cables that reach to the ocean floor at depths of several thousand feet.

To date, the federal government has held ten competitive lease sales and issued 27 commercial wind leases in the Atlantic Ocean, spanning from Massachusetts to North Carolina, according to the U.S. Bureau of Ocean Energy Management.

The two offshore wind farms operating in U.S. waters are capable of generating a combined 42 megawatts of electricity. The country's first offshore wind project, off the coast of Rhode Island, launched in 2016 with five turbines, followed by a project in Virginia with two turbines. More projects are on the way, including off the coasts of Massachussetts, New York and New Jersey.
