

SBA Administrator Guzman Announces Nearly \$43 Billion in Funding to Small Businesses Through Signature Capital Programs

Administrator Isabella Casillas Guzman, head of the U.S. Small Business Administration (SBA) and the voice for America’s 33 million small businesses in President Biden’s Cabinet, announced that the Agency reached nearly \$43 billion in funding to small businesses, providing more than 62,000 traditional loans through its 7(a), 504, and Microloan lending partners and over 1,200 investments through SBA licensed Small Business Investment Companies (SBICs) for Fiscal Year (FY) 2022.

“While still managing billions in COVID relief, the SBA also delivered record lending in FY22, helping tens of thousands of entrepreneurs across our nation get the needed funding to start, grow, and build resilient businesses,” said SBA Administrator Guzman. “Our work at the SBA, under the Biden-Harris Administration, addresses entrenched inequities in capital markets and throughout our economy. We continue to make progress expanding our network of SBA lenders and removing barriers to capital for small businesses – the foundation of a competitive global economy.”

Despite ongoing, structural challenges that exist for small business owners when seeking capital, the SBA’s efforts in helping them pursue their American dream showed signs of progress. Notably, the SBA’s low-interest 504 loan program grew in volume to \$9.2 billion, a record level of lending for the 504 program. In addition, the 7(a) program saw an increase in small-dollar loans, evidence of the SBA’s prioritization of startups and businesses hampered by gaps in credit markets.

While the general pace of U.S. private funds capital raising and deployment slowed in 2022, SBA committed nearly \$4 billion to Small Business Investment Companies (SBIC) licensees who then, in turn, deployed nearly twice that amount in financing to U.S. small businesses and startups. Underpinning this growth was a focus on deploying capital to groups that have previously been underrepresented in the investment ecosystem. In 2022, the SBA increased the number of financings to women-owned, minority-owned, and veteran-owned small businesses by 29 percent compared to the previous year, and 62 percent of the private funds that received an

Why California’s revised proposal to reform rooftop solar program deserves support

For a few moments this year, California was powered by 100% clean energy.

This first-of-its-kind milestone was the result of two decades of investment in renewable energy, especially in solar power. Almost 40% of our solar power comes from customers who

have rooftop solar and get paid for the electricity they produce and provide back to the grid.

California needs to build on that success. As a part of the path to the state’s clean energy future, the California Public Utilities Commission rolled out a much-anticipated update to the state’s rooftop solar program last month. It will be considered by CPUC commissioners on Thursday.

This update makes necessary and important changes to this decades-old policy. Unfortunately, the way the policy is currently structured incentivizes homeowners to make solar power during the day but does little to address when the state burns more fossil fuels on hotter nights.

The CPUC’s new proposal addresses this issue and closely aligns the rates paid for excess energy from residential rooftops with the value it provides the grid.

For instance, the price for electricity provided during the day – when sun power is bountiful

– is about 5 cents per kilowatt-hour. During the evening, the price can increase more than 20-fold. This new structure encourages homeowners to prioritize installing solar systems with batteries so they can collect the solar energy during the day, store it, and put it back on the grid when the sun goes down. With this advance, clean energy, not dirty fossil fuels, will help power the electricity system during evening hours.

The proposed update also reduces the growing costs of the program and benefits all consumers. Net energy metering is effectively funded by ratepayers that do not have solar, and the tab makes up about 10% to 20% of the average cus-

PUBLIC POLICY

New California Construction Laws for 2023

The California Legislature introduced more than 4476 bills in 2021-2022 sessions, with 1726 coming in the second session, down from the 2750 in the first session.

This article summarizes some of the more important bills affecting contractors in their roles as contractors, addressing issues such as payroll liability and reporting, construction delivery and contracts, licensing, design-build, best value, and dispute resolution¹. These new laws are effective January 1, 2023, unless otherwise noted. Not addressed here are many other bills that will affect contractors in their roles as businesses, taxpayers, and employers. Each of the summaries is brief, focusing on what is most important to contractors. Because not all aspects of these bills are discussed, each summary's title is a live link to the full text of the referenced bills for those wanting to explore the details of the new laws.

LICENSING ISSUES

Contractors Who Violate Requirements for Permits May Be Fined Up to \$30,000 (AB 1747, Quirk)

Under existing law, willful or deliberate disregard and violation by a licensed contractor of various state building, labor, and safety laws

constitutes a cause for disciplinary action by the Contractors State License Board. Violators may be fined up to \$8,000 for most violations and \$30,000 for certain other violations, such as willful or deliberate violation of worker's compensation insurance requirements, building codes, health and safety laws, subcontractor listing laws, contracting with or aiding and abetting an unlicensed contractor, pest control license requirements, and requirements for contracting for service and repair work. This new law adds to that list willful or deliberate disregard and violation of any state or local law relating to the issuance of permits.

Veterans Supported by Expedited Application Processing and License Fee Discount (AB 2105, Smith)

The Department of Consumer Affairs by this measure is required to grant a 50% fee reduction for an initial license or registration fee and expedite and assist in the initial licensure process for an applicant who supplies satisfactory evidence to the board that the applicant has served as an active-duty member of the Armed Forces of the United States, including the National Guard or Reserve components, and was not dishonorably discharged.

Time of Public Disclosure of Letters of Admonishment May be Extended to Two Years (AB 2916, McCarty)

The CSLB is required to disclose complaints against a licensee, except those complaints resolved in favor of the licensee. Previously, complaints resolved by a letter of admonishment would be disclosed for a period of one year. This measure permits the CSLB to disclose a complaint resolved by a letter of admonishment for either one year or two years, depending on (i) the gravity of the violation, (ii) the good faith of the licensee or applicant for licensure being charged, and (iii) the history of previous violations. In contrast, citations against licensees are disclosed for five years.

RETENTION

"Substantially Complex" Retention up to 10% Extended Indefinitely (AB 2173, Petrie-Norris)

This measure extends indefinitely existing law that allows public entities to withhold retention in excess of 5% from any payment by an awarding entity to the original contractor, by the original contractor from any subcontractor, and by a subcontractor from any subcontractor, when (i) the director of the applicable department has made, or the governing body of the public entity or designated official of the public entity has approved, a finding prior to the bid that the project is substantially complex and requires a higher retention and (ii) the department or public entity includes both this finding and the actual retention amount in the bid documents.

Construction Managers and Others Now Have Rights to Handling of Retentions in Escrow (SB 1192, Ochoa Bogh)

Under existing law, certain public works invitations for bid and related contract documents must include provisions permitting the substitution of securities for any moneys withheld as retention by the public agency, and, at the request and expense of the contractor, requires securities equivalent to the amount withheld to be deposited with the State Treasurer or an approved escrow agent. Alternatively, the amount withheld may be paid to the escrow agent. Subcontractors whose contracts make up 5% of the prime contract are entitled to their share of any interest paid on such retention. This amendment allows any individual, firm, partnership, corporation, association, or other legal entity permitted by law to practice the profession of architecture, landscape architecture, engineering, environmental services, land surveying, or construction project management to avail themselves of this process.

tomer's monthly bill. This proposal aims to create a fairer rate structure.

Solar systems with batteries come with upfront costs, but the return on investment is attractive. The simple payback for a solar system is nine years or less under the new proposal, according to the CPUC's Public Advocates Office. With battery storage, it would take less than seven years. These payback periods will continue to drop as solar costs continue their precipitous decline and electricity prices increase.

What's more, the CPUC calculates the proposal saves a residential solar customer \$100 per

month on average, and a residential solar plus battery storage customer at least \$136 per month on average.

The proposed update encourages battery storage, a key technology and growing industry that helped California through this summer's grid emergency. The proposal continues to ensure solar panels are affordable and builds on the solar industry's growth and success. The day the new proposal was announced, for example, the value of the solar company Sunrun saw a jump of more than 25%.

The CPUC's net energy metering proposal, which has justified critiques, is a huge step forward. Other improvements are needed, such as a

battery credit and rate structures for those with existing solar systems to encourage them to add a battery to their systems.

But in the state that helped build the U.S. solar industry, it is time to embrace the proposal that is before us. The new rooftop solar proposal incentivizes people to install solar, which is good for the industry and good for the grid. Plus, it provides affordable rates for consumers and helps with energy reliability.

Nearly \$43 Billion in Funding to Small Businesses

SBIC license in 2022 were managed by general partnerships inclusive of women, minority, or veteran investment principals.

“The SBA continues to make headway in helping startups and small businesses access much-needed capital, but much more work remains to be done,” said Patrick Kelley, Associate Administrator for the SBA’s Office of Capital Access. “Our flexible, low-interest 504 loan program grew in loan volume by 12 percent, and the SBA team is already at work for FY23 to support job and entrepreneurial growth across the country.”

Bailey DeVries, Associate Administrator for the SBA’s Office of Investment and Innovation added, “FY22 set SBIC program record highs of \$7.9 billion in small business financings which, in turn, created and sustained ~130,000 U.S. jobs, and the SBIC portfolio grew to approximately \$38 billion in public and private capital. With the SBA’s proposed regulatory reforms, we’ll build on the exciting momentum by diversifying and expanding this important public-private investment program and collaborating with industry to stimulate the flow of capital to small businesses in underserved communities and undercapitalized industries critical to our national security.”

“Ninety-five percent of the world’s consumers live outside the U.S.,” noted Gabriel Esparza, Associate Administrator for the SBA’s Office of International Trade. “Yet, the challenges U.S. small business exporters face in expanding to foreign markets include longer sales cycles and heightened country and currency risk. Our export financing volume grew by over 28 percent (vs. FY’21) and we remain committed to closing the trade finance gap with an increased focus on export working capital solutions.”

By the Numbers: Overall Funding and Impact

In the execution of commitments made under Administrator Guzman to address persistent gaps that remain for certain communities in accessing capital, the SBA continues to innovate and retool its programs, while deepening outreach efforts to better reach business owners across the nation, particularly from traditionally underserved communities. FY22 regular business lending and investment programs data of note includes:

- **\$25.7 billion in 7(a) loans:** Returning to pre-pandemic levels, nearly 47,700 7(a) loans worth \$25.7 billion were provided to small businesses. In total, 68 percent of the loan volume (32,152 loans) were small dollar loans of \$350,000 or less, with the program originating more loans under \$150,000 in FY22 than in both FY21 and FY20. Lenders also reported that minority business owners received over \$8.3 billion in 7(a) loans and women business owners received nearly \$7.3 billion in 7(a) loans in FY22.
- **\$9.2 billion in 504 loans:** Working with authorized Certified Development Companies (CDCs), the SBA’s 504 program delivered 9,254 fixed-rate loans for equipment and real estate worth more than \$9.2 billion to small businesses, the highest lending level in the program’s history. According to reporting by CDCs, the program provided

\$2.5 billion in lending to minority business owners and almost \$900 million to women-owned businesses, while the number of rural small businesses served increased by nearly 15 percent.

- **\$82.6 million in microloan funding:** Up from FY21, \$82.6 million in Microloan funding went to 5,055 small businesses, with 76 percent of loans going to underserved communities, including Hispanic-owned and Black-owned small businesses, per lender reporting.
- **\$7.9 billion in funding through private debt and equity funds licensed as SBICs:** In an increase over FY21, financing was provided to 1,217 small businesses and startups, of which 26 percent were women-owned, minority-owned, and veteran-owned small businesses or located in underserved geographic areas.
- **\$584.4 million in export-related trade finance:** Reversing a four-year downward trend, and despite a strengthening U.S. dollar environment, the SBA underwrote \$275.3M in Export Express and International Trade term loans, while simultaneously expanding its Export Working Capital portfolio to \$309.1M.

Closing the Capital Access Gap by Ensuring Small Businesses Have Products to Meet Today’s Needs

The SBA’s existing traditional loan programs serve an important role in credit markets for small businesses, particularly entrepreneurs with collateral and demonstrated revenue who are denied a commercial loan or market terms or those who lack established relationships with traditional lenders. These products also remain extremely attractive to those small businesses still navigating various economic challenges along their entrepreneurial journey.

Under Administrator Guzman’s leadership, the SBA has committed to expanding access to its core lending programs and better meeting the needs of entrepreneurs to achieve more successful outcomes in job creation, U.S. exports and GDP.

- **Reducing costs for those who need relief:** To make its 7(a) program more cost effective for borrowers and lenders, the SBA reduced 7(a) fees to zero in FY23 for borrowers and participating lenders on loans up to and including \$500,000.
- **Addressing systemic gaps in access to capital for the smallest, underserved businesses:** Administrator Guzman authorized the expansion of the Community Advantage program to increase the number of mission-based lenders, and further provided revised guidance that streamlines eligibility and underwriting requirements to simplify the delivery of small-dollar loans through the program. Changes included providing increasing the threshold for required collateral to only loans above \$50,000, to further support small-dollar loans.

A Matter of Trust: Stephen M. R. Covey

Stephen M.R. Covey is a big fan of trust. It's right there in the titles of both his 2006 best-seller, "The Speed of Trust: The One Thing That Changes Everything," as well as his newest book, "Trust and Inspire: How Truly Great Leaders Unleash Greatness in Others."

"It undergirds and is foundational to everything we are trying to do," Covey says. "We're like fish who discover water last; we're so immersed in it, we're not even aware of it until we lose it. Everything hinges on trust and works better with trust, and yet we're underestimating it by a factor of 10—or maybe by a factor of a hundred. It's that significant."

The son of legendary business educator and author Stephen Covey, Stephen M.R. Covey formerly served as president and chief executive officer of the Covey Leadership Center, where he helped develop the strategy that made his father's "The 7 Habits of Highly Effective People" one of the most influential business books in the world before merging the organization with Franklin Quest to form FranklinCovey. He went on to co-found CoveyLink, a leadership consulting practice that eventually was folded into FranklinCovey, creating the Speed of Trust Practice, which Covey now leads.

In a keynote presentation at ABC Convention 2023 in March, Covey will share his vision

for "trust-and-inspire" leadership. Recently, he offered Construction Executive a preview interview.

Q: What will you be talking about at ABC Convention?

A: I'm going to point out how the world has changed all around us in so many different ways—through technology, through the changing workplace, through the changing workforce—and yet our style of leadership has not. Too many of us are still leading in the old model, which is more of a traditional, hierarchical, authoritative, talk-down type of approach. I call it "command and control." We've become more advanced, more sophisticated, more enlightened in our command and control, but our paradigm

is still too much coming out of the old model of leadership.

We need to update it with a new way to lead in a new world. I'm calling it "trust and inspire" as opposed to command and control. The premise is that this is a more relevant approach to leadership that works better in our new world today to attract people, to retain them, to engage them, to even inspire them so they want to be with our teams and our companies—and to also be able to collaborate better. You can't command and control your way to collaboration, but you can through trust and inspire.

Mayor London Breed Issues Budget Instructions to City Departments

Mayor London N. Breed today issued Budget Instructions to department heads to guide the budget process for Fiscal Years 2023-24 and 2024-25. This is the first step in the budget cycle, with Departments scheduled to submit proposed budgets in late-February 2023.

Over the next two years, the City is projecting a budget shortfall of approximately \$728.3 million with a \$200.8 million deficit in the first year and \$527.6 million in the second year. This is out of an annual general fund budget of approximately \$6.8 billion. The shortfall is the result of slowed revenue growth, specifically the City's largest tax revenues that include property and business tax, and loss of temporary federal COVID-19 funding.

To help address this shortfall, the Mayor instructed departments to propose reductions of approximately 5% in the first year and 8% in the second year from their General Fund budgets. Additionally, she directed department heads to prioritize filling vacant positions for core City services that will support San Francisco's recovery. The last time the City projected a shortfall around this size was two years ago, a year after the pandemic hit. Prior to that, the two-year deficit has not been over \$600 million since around the time of the Great Recession over a decade ago.

"We know the challenges facing San Francisco are significant and we have a lot of work ahead of us to maintain the City's recovery efforts," said Mayor Breed. "As we work to close this deficit, it will require tough choices and real trad-

eoiffs. The continued impact brought on by the pandemic certainly has slowed our recovery, but we are making progress. I know we can do the hard work to keep this City moving forward."

The Mayor's Budget Instructions direct departments on how to prioritize their proposed budgets for the upcoming two-year budget process. The Instructions are informed by the estimated two-year deficit for the upcoming budget cycle and delivered by the Mayor annually in December. The two-year deficit is based upon the five-year budget forecast, which is projected for long-term financial planning by the Mayor's Budget Office, the Controller, and the Budget and Legislative Analyst's Office. The detailed full Five Year Financial Plan report will be available in early January 2023.

Mayor Breed directed City departments to continue to focus on top priorities like public safety and police staffing shortages, the City's downtown economic recovery, and supporting homelessness and mental health investments. To help meet these needs while also addressing the deficit, the Mayor also directed departments to:

- Propose ongoing reductions of 5% of adjusted General Fund support, and an additional 3% in the second year;
- Prioritize filling or reclassifying vacancies for core departmental functions and Mayor priorities; and propose remaining vacancies for budget savings;

- Maintain Mayoral initiatives and recommend ways to fund them more efficiently;
- Prepare for outlook to worsen and instructions to be revised given the uncertain economic outlook

Budget proposals from departments are due on February 21. Following submission of the budget proposals, the Mayor's Budget Office will evaluate the requests and develop the Mayor's proposed balanced budget to submit to the Board by June 1, 2023. At that point, the Board of Supervisors then considers the budget and must send a balanced budget back to the Mayor for signature by August 1, 2023.
