5 Cost-Efficient Innovations To Improve The U.S. Infrastructure

Much has been written about the poor state of infrastructure in the world's wealthiest nation. From its roads and bridges to waterways and rail systems, the United States has issues requiring hundreds of millions of taxpayer dollars to fix.

Innovation in the form of recycling or repurposing is being implemented as a cost- and environmentally-friendly way to improve segments of the U.S. infrastructure. Some companies and government entities are supporting the turning of outdated materials into useful pieces to the infrastructure equation. Amazon, for example, recently invested \$10 million in a Closed Loop Fund project, which targets recycling infrastructure in the U.S.

"In this area of innovation, you consider a product's whole life cycle, from cradle to grave," says **Barry Breede** (www.koppersuip.com), author of *Transforming the Utility Pole* and chief innovation officer at Koppers Utility & Industrial Products. "It's a closed-loop process, and the promise of these developments exemplifies the value and the validity of this kind of innovation."

"For smaller and mid-sized companies, corraling the resources to build a lasting innovation effort is not always an easy task. However, one potential upside is transforming how the business operates. You're bringing value to the customers and, by contributing to the greater good through helping the infrastructure, you're bringing value to the general public as well. A win-win."

Here are five recycle/repurpose innovations that can assist the public infrastructure:

- **Spinning old tires into better roads.** Many states don't have the funding to maintain and repair roads. Magdy Abdelrahman, a civil engineering professor at North Dakota State, is experimenting with using recycled rubber from scrapped tires to help preserve asphalt on existing roads. This would also help the environment; "tire dumps," which contain roughly 300 million discarded tires annually, can pose environmental concerns.
- **Building walls out of old utility poles.** Old poles can be recycled and used as both agricultural and/or building materials. Fence

Mayor Garcetti announces \$2.5 Million in Funding for 'Great Streets Challenge'

Mayor Eric Garcetti today invited community organizations to apply for \$2.5 million in street improvements and community outreach to reimagine public spaces in their own neighborhoods.

"The Great Streets initiative empowers Angelenos to envision a brighter future for their neighborhoods — and gives them the tools to bring those ideas to life," said Mayor Garcetti. "These grants will allow community groups to transform

streets across Los Angeles into thoroughfares of opportunity, create corridors of open space, and build safer, healthier communities."

The Great Streets Challenge, now in its third round, empowers Angelenos to transform streets and urban corridors across Los Angeles into vibrant, walkable spaces that reflect the unique character of their communities. To apply for the grant, please visit <http://lagreatstreets.org/2019-great-streets-challenge/>.

Applications will be accepted through April 1, 2019. The City will then select up to ten award recipients to receive access to an urban planning consultant and funding to solicit community input for the projects. After six months of outreach, the City will select up to four projects to receive infrastructure investments totaling approximately \$2 million. These investments will be awarded over the course of 2020.

"Los Angeles's center of gravity is creativity and innovation," said Los Angeles Department of Transportation General Manager Seleta Reynolds. "The Great Streets Challenge lets residents transform one of our greatest assets — streets — into a canvas to tell their community's story."

Non-profits, business improvement districts, chambers of commerce, faith-based institutions, and schools are encouraged to apply. Finalists will be selected according to their organization's capacity to conduct outreach as well as their proposed project's alignment with citywide policies,

including the Vision Zero Action Plan, Mobility Plan 2035, Plan for a Healthy Los Angeles, Purposeful Aging Action Plan, and the LA River Revitalization Master Plan.

"Our streets consist of more than just asphalt and pavement," said Department of City Planning Director Vince Bertoni. "They are where people come together to experience art, performances, and special events. Creating safe, accessible, and welcoming public spaces for our communities speaks to the importance of this initiative — and our role in transforming L.A.'s streets into vibrant centers for all to enjoy."

Ensuring Construction Worker Safety in Extreme Cold

In light of last week's polar vortex in the US, worker safety concerns have come to the forefront. In the construction industry, where deadlines are strict and the demand is high, extreme weather conditions may not phase some project managers.

While working in the -70°F temperatures that swept parts of the Midwest last week is out of the question, that doesn't stop project managers from demanding attendance in more tolerable, albeit still sub-zero, temperatures.

So, when should workers report to the jobsite during frigid winters? And what measures should they take to prevent frostbite or hypothermia?

Putting Your Foot Down

During last week's record-breaking polar vortex, government agencies were advising people to not stay outside for longer than two minutes. If you are scheduled to report to an outdoor construction project during a government advisory, you are entitled to exercise your rights.

Most project managers won't want to risk an OSHA investigation or workers' comp case for a few hours' worth of progress. OSHA standards generally advise that when temperatures hit -30° to -34°F or below with more than 10-20 mph winds, nonemergency construction work should cease. A table with these temperature and windchill standards can be viewed on their website.

Construction workers should keep this table handy, particularly during rough weather events like blizzards and polar vortexes.

Taking Necessary Precautions

Any temperatures below zero, particularly where a windchill is involved, should be taken seriously. If required to work, construction workers must take the following precautions—and managers should enforce them:

- **Wear the right gear.** Lined hard hats, thermal-lined gloves, waterproof boots, layered socks, and fleece-lined bomber jackets are absolutely necessary. Frostbite almost always begins at the extremities, so keeping these parts warm is crucial. Everyone is vulnerable to cold stress, and it can occur in temperatures as low as 50°F

- **Schedule work accordingly.** OSHA suggests scheduling work for the afternoon during periods of extreme cold. This is when the winds are most likely to ease up, and temperatures are most likely to be warmer.

Knowing the Risks

There are three kinds of cold stress that can occur. Having the proper gear, taking frequent breaks, and avoiding work during peak temperature drops can prevent against these. Nonetheless, it's still important to know the signs:

- **Hypothermia:** This occurs when your body temperature drops below 95°F. Symptoms will include uncontrollable shivering, loss of coordination, confusion, slurred speech, blurred vision, and slowed heart rate.
 - **Frostbite:** This happens primarily in extremities (fingers, toes, nose, ears). Symptoms include tingling, numbness, redness, or blistering in these regions.
 - **Trench foot:** Temperatures don't necessarily have to be freezing for this to occur. When feet are exposed to cold and wetness, they will turn red, go numb, swell, and tingle. These are signs you may be suffering from trench foot. Remove wet footwear and warm up your feet right away.
- Awareness and preparedness are half the work of enduring construction work in cold temperatures. Nonetheless, know when it's okay to tell your employer "No." If you are being forced to work in significantly freezing temperatures, approach your employer with the necessary OSHA resources.
- Chances are, if temperatures are reaching record lows, construction work should come to a screeching halt.

- **Monitor & prioritize work.** In extreme cold, surfaces will be icy. It's important to note and label icy areas, and avoid work on rooftops or upper levels in these conditions. Otherwise, workers are vulnerable to slips and falls, which could be deadly from an elevated surface.
 - **Encourage teamwork.** The "buddy system" is something most of us were taught in primary school, and is relevant throughout our entire lives. Working in pairs on the construction site will allow workers to tackle cold hazards together, and make note of one another's weakening condition should any form of cold stress set in.
 - **Encourage frequent breaks.** Once temperatures hit below -25°F and winds are present, the maximum work periods become shorter. The American Conference of Governmental Industrial Hygienists recommends more frequent breaks, with anywhere between 30-75 minute intervals between breaks. Workers should use these breaks to rest, warm up, and change out of any wet clothing.

Ready to Grow Your Business?

Business Owners are Happiest with This Kind of Financing

If you're looking to grow your business operations in 2019, you're not alone. Small businesses frequently earmark Q1 of the new year to launch new initiatives, hire additional employees, and expand into new markets. Of course, all of that takes funding, and not any old line of credit will do. Business owners tend to be an innovative bunch, spreading their financing loyalties around to credit card issues, micro-lenders, traditional banks, and even their peers. So, which type of lending leads to the highest rate of satisfaction? The answer may surprise you.

What Businesses Turn to for Financing

The stats show that businesses owners have some go-to favorites for loans, and they may not be what you think. The trends vary by demographic, including age, gender, and nationality. This SBA report breaks it down in a detailed way, but some things really stick out:

Overall, small business lending increased in 2018, largely due to traditional and large institution funding, such as traditional banks. Fixed rate borrowing (such as short-term loans) was slightly more popular than variable rate (such as credit cards and lines of credit.)

Additionally, the Federal Reserve reports:

"Application approval rates varied from 81 percent at small institutions to 51 percent at large institutions during the third quarter. Compared with the second quarter, approval rates were higher for large and midsized banks, but lower for small banks."

So, businesses can reasonably assume that a smaller bank is more likely to say "no" to a traditional loan. They perhaps can't afford to take on the risk that a larger bank can. Interestingly, the most common reason for denying an application for a traditional was financial stability of the applicant, along with a lack of credit history.

But traditional loans aren't always the popular choice. Credit cards, microloans, and even P2P loans are increasing in favor, especially among

startups and those without the big revenue numbers and solid history mentioned above. The order of business funding, by most popular, is:

- Small business loans
- Non-bank lending
- Mezzanine and buyouts
- Venture capital
- Angel investing

Additionally, credit cards are more popular for expansion capital (making up 5 percent of funding) but are rarely used in startups. Where a business is at in its life cycle influences, the type of funding pursued.

Utilization Doesn't Always Mean Satisfaction

While there some clear winners in those numbers, that's doesn't imply that everyone is happy with their choice. Some businesses may gravitate toward credit cards, for example, because that's all they can qualify for under current lending requirements. Others choose to borrow from family and friends due to a lack of credit history.

Still, others pick microloans as their only options for startups with no proven revenue trends. Don't assume that the lending vehicle most common for your business type is always going to be your clear favorite. What works for other businesses isn't always the best choice for you.

Personalized Lending Is Best

It seems cliché to say that the superior lending product is the one that works best for your unique business needs, but it's an accurate statement. Directing all small businesses to SBA loans, for example, because of their stellar reputation and opportunities for large loan amounts is short-sighted. Not every small business qualifies, and still others don't need access to that much capital. Likewise, insisting that company founders get the most satisfaction from credit cards is an incorrect generalization. The flexible, unsecured credit lines they offer are perfect for short-term spending but can introduce businesses to high-interest rates and inflexible repayment terms.





posts and retaining walls are some of the common applications. "If a utility company is stockpiling whole poles, this could be a valid solution," Breede says. "This is perhaps the most environmentally responsible wood disposal method - and at the same time it's a boon for building."

- **Turning bottles into bridges.** Places in Europe have been constructing bridges with recycled plastic for a decade. The U.S. has two bridges made of 100 percent recycled plastics. "It makes sense to replace worn-out wood with plastic," says Breede. "Plastics in construction generally have a longer lifespan. Plastic costs more initially but in the long run it pays for itself."
- **Converting railroad ties and wood pallets into biomass fuel.** "Untreated wood waste, as from pallets and reels you see all over America, makes for excellent biomass fuel," Breede says. "Local and regional energy providers use biomass facilities as do energy-intensive private industries." An energy plant in northwest Michigan, powered by renewable biomass fuel, produces much of it from used railroad ties.
- **Drawing methane from landfills.** Landfills are not a forgotten wasteland. Breede says landfill recovery gas (LFG), an option in which methane gas is captured from landfills, helps produce electricity while reducing harmful emissions. "The methane gas is an energy source to power turbines and, in turn, the turbines generate electricity for the grid," Breede says.

"Seemingly mundane products can be the backbone of our infrastructure system," Breede says. "They may be taken for granted and forgotten, but the job of the innovator is to think about the questions others don't ask, and hopefully develop solutions."
