Mayor Garcetti: LADWP will phase out Natural Gas Operations at Three Power Plants

LADWP will phase out natural gas operations at three existing coastal plants — Scattergood, Haynes, and Harbor — within a decade to accelerate end of reliance on fossil fuels.



Mayor Eric Garcetti took a powerful step forward in L.A.'s movement toward renewable energy, announcing today that the Los Angeles Department of Water and Power (LADWP) will not repower three coastal natural-gas power plants.

The repowering of natural gas units at three major Once-Through-Cooling natural-gas plants — Scattergood, Haynes, and Harbor — had been previously planned by LADWP. Mayor Garcetti was joined in the announcement by Councilmembers Nury Martinez, Mike Bonin, Paul Krekorian and Paul Koretz, along with senior LADWP leadership.

“This is the beginning of the end of natural gas in Los Angeles,” said Mayor Garcetti. “The climate crisis demands that we move more quickly to end dependence on fossil fuel, and that’s what today is all about.”

The decision to phase out the units — which together represent 38% of the city’s current natural gas portfolio — by 2029 will accelerate L.A.’s transition to 100% renewable energy and put the city on track to meet its carbon-neutral target of 2050.

“Science increasingly shows that the days of seeing gas as a bridge fuel are coming to an end,” said Michael R. Bloomberg, UN Special Envoy for Climate Action. “We need to accel-

erate the transition to clean energy, and L.A.’s commitment to helping to lead the way is an important sign of progress.”

In order to more quickly discover clean options to replace the power generated by the three plants, Mayor Garcetti directed LADWP to shift focus from its previous Strategic Long Term Resource Plan to the current 100% Renewable Energy Study — a \$10 million, comprehensive analysis launched in 2017 with the National Renewable Energy Laboratory to determine a feasible path to 100% clean energy.

“LADWP’s local generation and transmission system has served the City well for over a century,” said Mel Levine, LADWP Board President. “But it’s time to reimagine it and reconfigure so that, while we maintain reliability and affordability, we transition away from reliance on natural gas as quickly as possible. Climate change demands our vigilance and bold action.”

LADWP will also allocate financial resources to explore innovative alternatives — including public-private partnerships, new and upgraded transmission and distribution systems, microgrid technologies, and enhanced energy storage projects over the coming years.

“This announcement is nothing short of historic. Today’s advanced renewable energy technologies — like smart solar and energy storage — can do an even better job of powering our lives reliably, safely and affordably, all while creating local jobs and cleaning up the air,” said Bernadette Del Chiaro, executive director of the California Solar and Storage Association. “On behalf of California’s clean energy manufacturers, software entrepreneurs, contractors and builders, we applaud Mayor Garcetti’s and LADWP’s leadership and look forward to working together in harnessing all of our abundant sunshine into clean energy.”

Since Mayor Garcetti took office in 2013, he has led L.A. to pursue one of the world’s most aggressive sustainability agendas — helping L.A. to be named the #1 Solar City in America as well as the City with the most energy-efficient buildings. Recent efforts to help Angelenos cut energy consumption and shrink their bills include the development of the Shared Solar Program, which opens access to renewable energy more accessible to renters, and the commitment of an additional \$100 million toward energy efficiency programs specifically

Federal Judge to Rule on 30-Year-Old Pentagon Test Program in American Small Business League Case

In a case filed by the American Small Business League against the Pentagon, Federal District Court Judge William Alsup stated, “The purpose of the Freedom of Information Act is so the public can see how our government works. Congress passed this law to make sure the small businesses have access to some of these projects, and here is the United States covering it up.”

In a second hearing in the five-year legal battle for data submitted by Sikorsky Aircraft to the Pentagon’s 30-year old Comprehensive Subcontracting Plan Test Program (CSPTP), Judge Alsup described the ASBL legal battles with the Pentagon with the statement, “So it would be more like a David and Goliath. You get to come in there and be the underdog again against the big company and against big government”.

In referring to the Pentagon’s opposition to releasing the small business subcontracting data Judge Alsup stated, “They are trying to suppress the evidence and all that.”

Judge Alsup is expected to rule this month whether the Pentagon can continue to withhold any data on its largest prime contractors’ compliance with federal law mandating small business subcontracting goals and if communications between the Justice Department, the Pentagon and Sikorsky will be released to the ASBL.

The Pentagon established the Comprehensive Subcontracting Plan Test program in 1989. The stated goal of the CSPTP was to “increase subcontracting opportunities for small businesses.”

The CSPTP had two provisions, prime contractors were exempt from any penalties such as “liquidated damages” for non-compliance with their small business subcontracting goal and

prime contractors would no longer be required to submit any reports on their compliance with their small business subcontracting goals that had been available to the public.

American Small Business League President Lloyd Chapman stated, “Think of the absurdity of operating a test for over 30 years to determine if removing any and all penalties for non-compliance with federal small business subcontracting goals and eliminating all transparency will actually increase subcontracting opportunities for small business. I think Judge Alsup was correct when he accused the federal government of trying to “suppress the evidence” and “covering it up”.

In 2014 the Pentagon acknowledged the CSPTP had actually reduced small business subcontracting opportunities and asked Congress to end the program. Nationally recognized legal expert

Professor Charles Tiefer described the Pentagon’s CSPTP as a “sham” that had significantly reduced subcontracting opportunities for legitimate small businesses. Despite evidence that the CSPTP had reduced the dollar volume of federal subcontract to small businesses by as much as 50%, Congress has renewed the CSPTP until 2027.

“This is information the public has the right to know,” said ASBL attorney Karl Olson, who specializes in freedom of information law. “The government shouldn’t be spending taxpayer dollars trying to keep evidence from the public.”

Smart Ways TO WORK by Odette Pollar

The Fine Art of Questioning

The door closes behind your staff person and you wonder if anything was accomplished in your meeting. You have attempted to keep the lines of communication open, but no matter how often or how much you talk, you do not seem to get any closer to understanding. When you are seeking suggestions to improve operations, feedback about a new project, or to discover what has been bothering a key employee, asking questions is the obvious answer. The trick is to ask the right types of questions or you may find yourself with less than you hoped for.

Broadly stated, there are two types of questions with variations within each. Open ended or

closed questions. Closed questions allow only yes/no or true/false answers. “Aren’t you ready yet?” “Do you like the new artwork?” Although these can be quite useful in narrowing a conversation, or for intentionally preventing answers that are too detailed, these are not the best choice when your purpose is to hear another’s opinion. Open-ended questions allow many possible answers. They solicit more in-depth and thoughtful answers. “What do you think of the new policy?” “How would you feel about changing your shift times?” These are particularly useful with people who might be reticent to state an opinion.

It is easy to confuse an open-ended question with a directive question or even a disguised closed question. “This new promotion is really great, don’t you think so?” It would take a very strong or brave person to answer in the negative. The question itself telegraphs the expected response. If you really want to know what is troubling an employee or why their performance is not up to par, consider a question that would require a more detailed answer such as: “You looked frustrated during that last phone call. Did you run into some kind of problem?”

“Don’t you think you would enjoy learning some new skills?” This may sound open, yet it really is not. There is no other intelligent way to answer that except to say yes, even if this is not your feeling. If you are trying to find out why training classes have not been well attended, this does not allow the person to tell you the underlying issues. Perhaps they are overworked or three people were out sick or the classes are too advanced.

Some questions are described as loaded. They are emotional in content, accusatory or in some other way potentially damaging to the listener. “Don’t you think you should be willing to travel more?” This question implies that he or she may not even be trying. A more effective inquiry is: “Help me understand what is making it difficult for you to take out of state assignments.” This will open the door to a fruitful conversation rather than a confrontational one.

When your purpose is to get an idea of an employee’s perception of work, their environment or any hindering factors, “Why don’t you make as many sales calls as our more successful reps?”

will probably open you up to an argument about whether he or she is making as many calls as other reps or a discussion about how circumstances are different for them. Once people become busy defending themselves, you lose the thoughtful answers that you were initially looking for. A better choice might be: “Is there a way that I can help you increase your call ratio and close more sales?”

Asking good questions is a skill that takes a little practice. Once mastered, it will ease your interactions and improve the quality of your communication. You might be surprised by what you hear.

SBA 504 Loans vs. SBA Export Loans

The SBA strives to reduce risk for lenders and make it easier for small businesses to obtain financing. To accomplish this, the SBA has created several loan programs specifically tailored to certain businesses. While this makes for a wide variety of great loan options for small businesses, with so many choices, you may find yourself in a state of paralysis analysis.

To help unstick your decision-making process, we'll break down and compare the SBA 504 and SBA Export Loans based on the application processes, eligibility requirements, and use of funds for each program.

Comparing the SBA 504 Loan and SBA Export Loan:

Application Process

While the application process for an SBA Export Loan is similar to the process for other non-SBA Export Loans, the SBA 504 Loan application process isn't.

With an SBA Export Loan, you simply apply with a participating lender who then forwards

your request to the SBA for the eligibility determination. However, due to the way SBA 504 Loans are structured, you'll work with both a lender and a Certified Development Company (CDC). This means there's an extra step in the application process because, in addition to securing approval from a lender and the SBA, you must secure approval from a CDC.

Eligibility Requirements

As with any SBA-backed loan, both loans are only available to small businesses with:

- Tangible net worth of \$15 million dollars or less.
- Net income after taxes (not including carryover losses) of \$5 million dollars or less over the previous two years. Applicants must also have strong credit, minimal existing debt, and a clean financial history.

However, that's about all these two loans have in common when it comes to eligibility requirements. This stark contrast is mainly due to the differences in the stated goals of each loan program.

For example, 504 Loans are meant to provide business financing to promote growth and job

creation. On the other hand, SBA Export Loans are meant to provide working capital to support small businesses' export sales.

For this reason, you must be an exporter or plan to export goods or services to be eligible for an SBA Export Loan. In addition, to be eligible for a 504 Loan you'll need to use the funds to create or retain a certain number of jobs or support the SBA's or CDC's policy goals.

Use of Funds

There are three different types of SBA Export Loans: Export Express, Export Working Capital Program, and the International Trade Loan Program. Your use of funds will depend on which program you choose. Regardless of the program, though, you'll generally need to use the funds for export-related expenses.

The SBA 504 Loan program's use of funds requirements are broader, but not necessarily easier to satisfy. For each \$65,000 of your loan amount, you must create or retain one job. If you're a manufacturer, you'll need to create or retain one job for each \$100,000 of your loan amount.

If your business plan won't create or retain jobs, you must show that your plan satisfies an SBA

public policy goal or a CDC goal. You can find a list of CDC goals and SBA public policy goals here.

Conclusion

Like any other SBA-guaranteed loan, obtaining an SBA 504 or Export Loan is no walk in the park. You'll need to provide plenty of paperwork for either loan, and both programs have strong restrictions on what constitutes an eligible use of funds.

That said, if either program fits your business financing needs and you think you may be eligible, it's at least worth a closer look.

Since these loans are backed by the SBA, you'll receive relatively favorable terms that will be hard to match. Just remember to do your due diligence and talk to an expert to find out if you may be eligible. Otherwise, you could end up spending lots of time to complete the application process only to be disappointed in the end.

for multi-family and low-income households over the next 5 years.

The effort to phase out natural gas is the latest in a long list of ambitious actions taken by Mayor Garcetti to set Los Angeles on a path to carbon-neutrality. Under the Mayor Garcetti's leadership, LADWP reduced greenhouse gas emissions to 47 percent below our 1990 emissions level at the end of 2017 — surpassing the state's 2030 target a full 14 years ahead of the deadline.

“The commitments we make today, and moving forward, need to be part of a larger narrative. We will take on Climate Change head on,” said Councilwoman Nury Martinez. “And we will do so with a strategy where the fight against climate change and the path to a clean energy future begins and ends in our frontline communities. It's our kids who suffer from asthma. It's our young women and men being left out of the Green Economy. But most importantly, it's our communities that have the solutions and commitment to protecting the environment. Neighborhoods like Pacoima, South LA, and Wilmington, will be the places where solutions will come from, where solutions will be implemented, and where residents will have immediate benefit from.”

“Today we are sending a clear and unmistakable signal that the people of Los Angeles are determined to fight climate change,” said Councilmember Mike Bonin, who represents the coast and is active with the Sunrise Movement. “We refuse to condemn our children to a world of extreme heat and cold, freak storms, drought, wildfires, and a diminishing food supply. For the health and safety of our kids, we insist on getting off fossil fuels and moving aggressively to clean and renewable energy.”

“There is no more urgent goal to save the planet from climate catastrophe than weaning the world off fossil fuels, and here in Los Angeles, we are taking the tangible steps necessary to do exactly that,” said Councilmember Paul Krekorian. “Because of the Council's mandate, the DWP is working in partnership with the National Renewable Energy Laboratory to develop the 100% clean energy roadmap that will be a model for the rest of the country and other cities around the world. The expectation to keep up with technology



“The Bay Area provides some unique challenges when it comes to construction. Most of our client base is in the tech sector, and they're moving fast. They don't have time for contractors that don't move at the same speed. From a preconstruction perspective, our ability to provide the appropriate amount of resources to help them make timely decisions is critical. From an operations standpoint, we need to be prepared to deliver our product in a timely fashion that meets that same critical schedule. It's not easy to do.”

“Of course, being in the Bay Area, we also have issues with respect to labor and materials. It's expensive to build in the Bay Area, and our clients know that it's a challenge to meet their budgetary goals. Since our client base is predominantly in the tech sector, there's an expectation that we will be technologically advanced with the systems we provide and how we execute our construction process. They expect that we will come to the table with the appropriate tools to deliver the product in a timely fashion and on budget.”

“Building in the Bay Area is as big of a challenge as it's ever been. There is a lot of demand in this market for construction. A lot of companies here are growing very fast and expanding. A Slow Beginning for 2019 Construction Starts

ConstructConnect announced today that January's volume of construction starts, excluding residential work, was \$27.8 billion, a change of -6.7% compared with December 2018's level of \$29.7 billion. The latest month-to-month adjustment was in close alignment with the usual shift in starts volumes between December and January, due to seasonality, of -8.5%.

Nonresidential starts in January 2019 relative to the previous five-year average for January, i.e., from 2014 through 2018, were -4.5%. January 2019 compared with January 2018 was -20.6%. At \$35.0 billion, January 2018 managed an abnormally high volume of starts activity.

The starts figures throughout this report are not seasonally adjusted (NSA). Nor are they altered for inflation. They are expressed in what are termed 'current' as opposed to 'constant' dollars.

'Nonresidential building' plus 'engineering/civil' work accounts for a larger share of total construction than residential activity. The former's combined proportion of total put-in-place construction in the Census Bureau's latest report, for November, was 59%; the latter's was 41%.

ConstructConnect's construction starts are leading indicators for the Census Bureau's capital investment or put-in-place series. Also, the reporting period for starts is usually one month ahead of the reporting period for the investment series. The normal one-month lag in the timing of data releases has currently been stretched out. Census Bureau workers were off the job for 35 days due to the partial shutdown. Now that they have returned to work, the put-in-place numbers have been updated through November, which leaves them two months behind the starts data.

The U.S. construction sector (+52,000 jobs) undertook exceptionally strong hiring in January, according to the latest Employment Situation report from the BLS. The year-over-year change in construction jobs was +4.7%, a faster pace of gain than for any other major industrial subsector. 'Transportation and warehousing' (+4.1%) firms were next quickest to add staff. By sub-categories of construction work, the year-over-year climb in jobs was +7.2% for both residential and heavy/civil engineering concerns. Nonresidential builders were more restrained, at +2.9%.

Construction's NSA unemployment rate in January was 6.4%, which marked a continuation of tightening (i.e., improvement) versus January 2018's figure of 7.3% and January 2017's 9.4%.

January 2019's year-over-year payroll changes in other pockets of the economy important to construction were as follows: 'machinery and equipment rental,' +6.9%; 'oil and gas extraction,' +6.2%; 'real estate firms,' +3.3%; 'architectural and engineering services,' +2.5%; 'cement and concrete product manufacturing,' +0.9%; and 'building material and supplies dealers,' -0.3%.

The month-to-month decline (-6.7%) in total nonresidential starts in January was caused by a fall in industrial (-23.3%) and similar-sized drops in institutional (-11.0%) and commercial (-13.3%). Only the heavy engineering type-of-structure category (+9.3%) managed a gain.

The more substantial year-over-year (y/y) decrease (-20.6%) in total nonresidential starts in the latest month (i.e., January 2018 versus January 2017) was due to shortfalls in commercial (-39.7%), heavy engineering (-19.2%), and institutional (-17.3%). Industrial (+125.3%), on the other hand, chose to dance to a different drumbeat and more than doubled.

For every month of the year except January, the narrative in this Industry Snapshot report would now move along to a discussion about year-to-date results. But January is unique in that its individual monthly numbers and its year-to-date (ytd) statistics are exactly the same.

The -23.3% drop in industrial starts m/m in January 2019 was due to the absence of a project as large as Micron Technology's plant expansion in Virginia, estimated at \$3.0 billion, which appeared in December 2018's starts. January 2019 groundbreakings did, however, include several notable industrial projects, led by an ethane exporting facility in Texas, valued at \$1.5 billion. On a y/y basis, January 2019 industrial starts were +125.3%.

The two primary contributors to 'heavy engineering/civil' starts in January 2019 were 'roads and highways' (a 38% share) and 'water and sewer' works (a 28% slice). Groundbreakings on the former in the latest month were +6.1% m/m, but -1.1% y/y; on the latter, they were a more robust +36.5% m/m, but faltered as well y/y, at -4.7%. Bridge starts, which have been setting a torrid pace over the past couple of years, cooled a bit in the latest month: -4.4% m/m and -12.3% y/y.



ConstructConnect announced today that January's volume of construction starts, excluding residential work, was \$27.8 billion, a change of -6.7% compared with December 2018.

The latest month-to-month adjustment was in close alignment with the usual shift in starts volumes between December and January, due to seasonality, of -8.5%. January 2019 compared with January 2018, however, was -20.6%.
