# Key Factors to Consider in Bid/No-Bid Decision Making

"To bid, or not to bid, that is the question." It ain't exactly Shakespeare, but the decision to bid on a project shouldn't be taken lightly. You invest a great deal of time and resources into putting together a bid, so it's important to make sure you are carefully identifying the right projects to go after. One way to do this is by conducting a thorough bid/no-bid analysis that meets your company's goals and is in line with your longterm strategy.

In order to make the bid/no-bid decision, there are a number of factors to consider to make an objective, rather than subjective, decision.

Profitability – The bottom line is if you can't make a profit on a project, you have no business bidding on it in the first place. Make sure you have an accurate and comprehensive account of your annual labor and equipment costs so you can correctly estimate your job costs. When calculating labor costs, be sure to include taxes, insurance, workers' comp, vacation pay, tools and equipment and any and all additional benefits you provide to your employees.

Once you determine what it will cost you to complete the project, you need to consider other variables like location, contract requirement, planned method of construction, etc. and determine if the job will be profitable should you submit the winning bid.

Capability – Okay, now that you've determined that you can make some money on the project, you need to determine if your company is capable of doing the work. Review your current backlog of upcoming projects to make sure you can provide the manpower, equipment, staff and other resources to commit to the project when construction is expected to commence and complete it within the required timeline.

You also need to ensure your company is financially capable of completing the project, meaning you have the bonding capacity and adequate cash flow to perform the work without jeopardizing any of your other obligations. There is such a thing as having too much work. Know your limits so you don't extend beyond what you are capable of performing.

Historical Analysis - In order to submit better bids and win more work, you should keep re-

## Mayor Garcetti and Councilmember Harris-Dawson break ground on new bridge housing in South L.A.

Mayor Eric Garcetti and Councilmember Marqueece Harris-Dawson broke ground on a new emergency bridge housing facility that will provide beds for 100 homeless Angelenos at a time, and offer on-site supportive services to help them transition into permanent housing. The project will be the first of Mayor Garcetti's "A Bridge Home" sites to open in South L.A. "We are investing on an unprecedented scale to build the supportive and affordable housing that will end this crisis. But our homeless neighbors can't wait — they need a place to sleep right now, and that's why we're pushing hard to provide them with A Bridge Home," said Mayor Eric Garcetti. "This new facility will add badly needed emergency beds and services for Angelenos in South L.A. I am grateful to Council-

The new bridge housing site on St. Andrews Place in South L.A. will continue utilizing the place-based emergency housing model that defines the Mayor's A Bridge Home program. The beds will be filled through exhaustive outreach in the area immediately surrounding the facility. Residents will have access to resources like mental health services and addiction counseling on site, and storage space for their possessions.

"Chesterfield Square and Hyde Park have long had many families and individuals living in cars and RVs - this is the prime location to launch our first Bridge Home facility to provide a safe and secure location to receive services while being connected to permanent housing," said Councilmember Harris-Dawson. "Later this year, we're slated to break ground on several PSH developments throughout the district as well as a Navigation Center that will act as a one-stop shop in service provision, life skills training, counseling, laundry and restroom facilities."

Services at the facility will be provided by the County through funding from Measure H, the landmark homeless services initiative approved by voters in 2017.

"Thanks to the services provided at this site, about 100 women and men who currently sleep on the streets of South LA will be put on a path to stable and supportive housing," said Supervisor Mark Ridley Thomas. "This is Measure H at work and public-private partnership at its best, bringing Everyone In and transforming lives."

The is the first of four A Bridge Home sites that will break ground in South L.A. Three sites are already open in locations across the City, with several more expected to open in the coming

### How federal 'opportunity zone' tax incentive can help California build an inclusive economy

Judging by frequently quoted numbers, California's economy is vibrant and its future is bright. In 2017, the state's gross domestic product rose to nearly \$2.8 trillion, making the California economy the fifth-largest in the world.

But the impressive economic output hides shrinking opportunities for millions of residents. Although high-wage jobs are increasing in the tech and entertainment centers of the Bay Area and Los Angeles, a third of the state's labor force make do with low-wage, and often low-skill, employment. When a higher-than-average cost of living–including rising housing costs–are factored in, California has the highest poverty rate in the nation.

### How did we get here?

Housing construction is less than half the rate from 1955 to 1989. The education system has failed to keep pace with the demand for skilled workers. And we have neglected our infrastructure. California would have to spend almost \$900 billion every year for a decade to offset the last 10 years of underinvestment. Rebuilding educational, social, and physical infrastructure requires a multi-pronged effort by state and local governments.

The federal opportunity zone program created by the 2017 tax overhaul, enables investors to defer capital gains taxes on funds invested in designated communities. Opportunity zones offer one path forward that relies on private capital to bear the cost. The program is designed to attract investors holding \$6.1 trillion in unrealized capital gains, according to the Economic Innovation Group.

To draw investment to the 879 Opportunity Zones in California, state and local leaders must decide where they are willing to compromise. That means balancing taxation, rigid land-use policies, and strong environmental protections against access to private capital to provide affordable housing, jobs, business growth, and infrastructure.

The clock is ticking. Most participants are looking to invest by the end of this year to receive the greatest 10-year benefit from the program.

As the federal rule-making process develops, state and local leaders should proactively determine what their communities need–jobs, housing, new business–and design an opportunity zone framework that will support those outcomes.

The framework might include, for example, additional tax incentives to offset the typically low returns provided affordable housing investments.

Leaders must look beyond the traditional transactional dynamic of investing in economic development, and instead focus on the benefits of addressing the needs of the 3 million people living in California's opportunity zones. Only then can we begin to foster increased economic equity.

Partisanship, fear of displacement, or concerns about public-sector inefficiency will make some people skeptical that the public-private cooperation involved in opportunity zone investments will contribute to a more inclusive, equitable economy. They shouldn't be.

By aligning state and local incentives with financing tools, investors and civic leaders can focus on the economic needs of residents.

Regardless of how regulations unfold at the federal level, state and local jurisdictions should begin setting standards, determining priorities, and aligning incentives to compete for investments. Ideally, this will generate a pipeline of projects guaranteed to be shovel-ready that achieve the expected level of profit, allowing both investors and neighborhoods to benefit.

In this sense, the role of state leaders primarily rests in developing a framework that supports and insulates the local pipeline. Participants can use the framework to manage all aspects of deal flow, from aligning incentives, funding, and local capacity to helping local jurisdictions build marketable project portfolios.

Californians should reflect on the type of economy we hope to build. Our economic health will hinge on embracing inclusive development strategies that lead to high-paying jobs, adequate housing, and sustainable infrastructure–goals that opportunity zones can help achieve.

### A Little Ergonomics Goes a Long Way

The recent rash of workplace violence statistics aside, the average office workplace has not been considered particularly unsafe. After all, what can happen? Maybe a stumble coming off the elevator, or a particularly vicious paper clip wound. But now with the recognition of the importance of ergonomically correct workspaces, worker safety takes on a new meaning. Ergonomics has come a long way from simply having a chair that adjusts up and down. Making an environment truly comfortable, and therefore productive, includes consideration of air circulation and quality, lighting, sound control, furniture layout, computers and monitors.

Whether you are the purchasing agent for your company, a department manager with a budget for new furniture, or a home-based businessperson trying to decide what to purchase, ergonomic considerations are important. To avoid painful injuries, increased costs, more absenteeism, and various aches and pains use these following guidelines:

#### Furniture

Ergonomically correct furniture must conform to the needs of the individual. This often goes against the trend when organizations buy 150 identical work cubicles. People are not uniformly shaped nor is the work they do identical. When faced with a pre-designed cube explore whether you can adjust the height of work surfaces. Look at the placement of equipment and never accept that "the cord isn't long enough" to allow rearrangement. If you have very little workspace and you need to spread out, then consider moving the computer to its own stand.

### Chairs

Adjustable chairs, both in height and along the back for lumbar support are very important. So is having your feet comfortably placed on the floor. If you sit for long periods with your feet hooked to the rungs of the chair or crossed, it reduces blood circulation and throws your body posture out of alignment. If your feet don't reach the floor comfortably, then be sure to use a foot rest for long spells at the keyboard. This will also help reduce backaches. Adjust the height, so that when you write, your arm is in a comfortable position.

### **Computers and Monitors**

As computers become more sophisticated and designers more in tune with the needs of users,

over long periods. Flat screens are easier to read than curved screens, and brightness is always a concern. Ideally, screens should be in 90-degree angles to windows or other strong light. If making manual adjustments for brightness does not ease the strain on your eyes, you can purchase a monitor cover which cuts down on glare. Placement of the monitor is also important. Many people put it wherever there happens to be space in their cubicle or inherit the positioning from an earlier occupant. The center of the monitor should be just below eye level. It is a good idea to sit a bit distant from the screen, but not so far that it causes you to strain to see the words. Be sure to sit comfortably, with spine straight and directly in front of the monitor and keyboard.

### Keyboards

Computer keyboards are now being designed in what at first glance may appear to be weird

### How to Check if a Loan Company is Legitimate

If you're trying to expand your business, getting a business loan might feel like a necessity. But if your credit isn't in great shape, you might not have a wide selection of lenders from which you can choose.

While bad credit business loans exist, there are plenty of scammers who are out to take advantage of business owners they think might be desperate. As a result, it's important to know how to check if a loan company is legitimate. Here are some tips to help you spot potential red flags.

### How to check if a loan company is legitimate

Before you apply with a lender, think about these steps to make sure you don't get caught up in a scam.

### Check for an online presence

If you get an offer for a bad credit business loan, ask yourself if you've ever heard of them before. If not, do an internet search for the company name. Even if it's relatively new, it should have a profile on websites like Crunchbase or Owler and possibly even reviews from existing customers. If you can't find anything — or worse, you find information that points to a potential scam you'll likely be better off passing on the offer.

### Check with the Better Business Bureau

Even if the loan company has an online presence, that doesn't necessarily mean that its operations aren't predatory. Check the Better Business Bureau website to learn more about whether the lender is worth working with. You'll typically see a letter grade from A+ to F, along with reasons for the grade.

In some cases, you'll also be able to read customer reviews, which can give you a better idea of what to expect. If you find that the lender wouldn't be a good fit, you can also use the website to find one that might be a better one.

### Check your comfort level

Lenders want your business, but they're not desperate for it. If you feel like your contact with the company is overly aggressive or manipulative, it might be a sign that they're trying to fluster you and make you feel like you need to make a decision before you get all the facts.

If you feel uncomfortable about the process at any time, take a step back and consider why you feel that way and whether you should continue.

### Check with the state's attorney general

If most everything checks out, but you want to be entirely sure, contact your state's attorney general office. Lenders and loan brokers are required by law to register with state agencies before they can do business there, so if the attorney general has no record of the company you're dealing with, run in the other direction.

### Other tips to consider

In addition to taking the above steps, there are some other small things to think about as you learn how to check if a loan company is legitimate. Here are some questions and answers to help:

### Do loan companies ask for money up front?

Some lenders charge what's called an origination fee to process your loan. However, this fee is typically deducted from your loan disbursement. No legitimate lender will ask you to pay them the fee directly before you can get access to your money.

### Do loan companies check your bank account?

In some cases, a lender might ask for your bank information to know where to send the loan funds after your application has been approved. However, it's not normal for a bank to ask for your online banking login information to check your account. If this happens, it might be a scammer looking to get access to your account to make a withdrawal or transfer to their own account.

### How do I spot personal loan frauds?

Some personal lenders will allow you to use personal loan funds to start or fund a business, but there are also plenty of scams to watch out for. In general, you can use the same steps as you would with a business lender to find out if the loan offer is fraudulent.

#### Are bad credit loans legitimate?

There are several legitimate business lenders who specialize in working with borrowers with bad credit. However, it's important to take your time when comparing bad credit business lenders to make sure you not only avoid scams but also improve your chances of getting favorable terms on your loan.

### The bottom line

If you're trying to get capital to grow your business, knowing how to check if a loan company is legitimate can save you from losing money and potentially your business. As you consider these tips and learn where to look to compare legitimate lenders, you'll be able to get the help you need without being worried about getting taken advantage of.

weeks. The site in L.A.'s historic El Pueblo neighborhood, which has been open the longest, has already demonstrated the success of the model. Since the facility opened in October 2018, crime has dipped in the surrounding area by two thirds, and the number of encampments has diminished from 100 to 37.

shapes. These are an attempt to eliminate or reduce the repetitive stress injuries that come from using the traditional flat, rectangular keyboards. Repetitive-motion disorders have increased because using the keyboard -without the pauses that occurred with typewriters - to add paper or return the carriage, means that the users' hands remain in the same position and the unrelieved repetitive motions can cause injury.

The new keyboards combined with adjustable keyboard stands help operators arrange the work surfaces so they are in better alignment with individual requirements. The most comfortable

height for a writing surface is about six inches too high for your keyboard. Under the surface mounts that pull out are an easy way to get your keyboard down in the proper location. Adjustable trays also help reduce stress and fatigue

To avoid personal pain and discomfort, pay attention to ergonomic considerations and seek advice from professionals. These considerations are not frivolous, and ignoring them can result in lost work time, labor problems, disability payments, higher health insurance premiums and compensation, and potentially higher turnover. As people spend more and more time at work, creating a comfortable place to be is a winning combination for all

### The Public Charge Rule: An Obstacle to Immigrant Families Like Mine

To determine who is eligible for admission into the United States, U.S. Citizenship and Immigration Services (USCIS) uses "public charge" to refer to an individual who is likely to become primarily dependent on the government for support. The current rule defines public benefits as cash assistance programs, including Temporary Assistance for Needy Families (TANF), and Supplemental Security Income (SSI), as well as long-term institutional care paid by the government.

On October 10, 2018, the Trump administration proposed a new rule that would completely change how USCIS defines a "public charge." In an attempt to reduce the number of immigrants entering the United States and limit those who are applying to change their status, the proposed rule sought to expand the types of services considered to be public benefits to include the Supplemental Nutrition Assistance Program (SNAP), Medicaid (called Medi-Cal in California), the Medicare Part D Low-Income Subsidy Program, and several housing programs.

In response, over 200,000 public comments – nearly four to one in opposition to the controversial proposal – flooded the Department of Homeland Security. Opposition to the proposed public charge rule was so strong that by the time the public comment period closed on December 10, 2018, the on-line portal of the federal register temporarily shut down.

I led The Greenlining Institute's efforts to submit public comments on this ruling and organized my colleagues to submit comments of their own. We strongly oppose the proposal because it paints families of color as undeserving of having their basic needs met when they apply for the same government assistance that many low- to moderate-income white families receive.

As a daughter of Afro-Caribbean immigrants and an advocate for communities of color, this issue is deeply personal. My story would not be possible had this proposal been in effect when my mother immigrated to Brooklyn, New York from The Republic of Trinidad and Tobago. My mother and her younger sister migrated to Brooklyn with two education visas and little money. Public benefits like Medicaid helped my mother receive necessary medical care while juggling a challenging graduate program in social work.

The professional skills she acquired during that process prepared her to successfully apply for U.S. citizenship later on. Access to essential health and nutrition through public benefits provided a necessary stepping stool for my mother in her early stages of building her professional career. Today, my mother is a senior-level director of social work in New York City. My mother's success reflects the determination that immigrants across the world bring to the United States. Caribbean and African immigrants like my mother fuel the New York state economy as well as the vibrant social and cultural life of the city.

Nationwide over 19 million or one in four children live in a family with an immigrant parent, and nearly nine in ten of these children are citizens Black families with at least one immigrant member make up over 9.1 million of the total Black families in the nation. There is no way to target individual immigrants without harming children, families, and communities. Even though it's just a proposal and hasn't taken effect, the proposed rule has already created a chilling effect amongst some immigrant families who are deciding to forgo participation in essential health and nutrition services in fear of government repercussions. This means people literally go without food or medical care for fear it will hurt their chances of becoming a citizen. If passed, the public

charge rule will undermine the health and well-being of the United States.

While my family no longer relies on the 'stepping stool' of public benefits, I will always remember the story of how critical that extra help was during my mother's early years in the U.S. I would not have the passion to advocate for communities of color without the support of my mother and the essential health services that propelled her.

The Department of Homeland Security (DHS) is legally required to review every single unique comment submitted before publishing a final rule. Due to the magnanimous amount of comments submitted, we are unsure of when a final rule will be made. The proposed public charge rule will not be retroactive if it becomes final. It will not punish past use of newly included public benefits programs if they were used before the final rule goes into effect.

If and when a final rule is published, there will be at least 60 days before it takes effect. If the proposed rule goes into effect, families will have this 60-day period to dis-enroll from a program, if they determine that it is necessary for their immigration case. We recommend following the Protecting Immigrant Families Coalition site to keep up to date on the status of this proposed rule.

cords on all your bids, both the successful ones and the ones you didn't win. It's important to have a clear understanding of what caused you to lose out on a bid whether it was a lack of experience or if you simply weren't low enough on price. Don't be afraid to ask the client for feedback after the bidding process is complete.

You should also take a look at your performance on the projects you did win and complete. Did you underperform or were you able to successfully manage the project or identify areas to improve productivity to complete the project under budget? By analyzing historical data, you can better identify which bids you should be going after.

Long-term Strategy – Consider whether or not the project you are looking to bid on fits in with the long-term strategy and goals of your company. Are you looking to maintain your current level or are you trying to grow your business? Are you looking to expand into new geographic locations or new markets? Maybe you want to start tackling more private work or you want to start taking on larger projects like hotels or hospitals.

Regardless of what your company's long-term strategy is, make sure you are identifying and going after projects that align with those goals. Risk Assessment – Before deciding to bid a project you should carefully identify all the potential risks that could arise on the project. Review the bidding documents, plans, and specifications for the project and rely on historical data from similar projects you've completed to identify risks. Common risks include incomplete construction documents, unknown site conditions, accelerated timelines, safety concerns, etc.

Prioritize the risks, taking into account how much time, money and work each risk will require to manage effectively. If you've identified a large number of high impact, high probability risks it might be time to walk away and move on to your next opportunity.

Other factors to consider when making your bid/ no-bid decision include project location, duration, size and scope, competition, client and designer. Once you've determined which factors and criteria are most important to your company you need to create a grading matrix and a threshold score for making the decision to bid or not. By taking a data-driven approach, you will be able to make smart, informed decisions on what projects to pursue in the future.

### Construction Employment Rises By 16,000 In March And 246,000 For The Year As Weekly Hours Hit New High And Unemployment A New Low For March

Hiring Rebounds from Losses in February, Suggesting Demand for Construction Remains Strong; Association Calls for Career Training Funding and Immigration Reform to Continue Growth

Construction employment increased by 16,000 jobs in March and by 246,000 jobs, or 3.4 percent, over the past year, according to an analysis of new government data today by the Associated General Contractors of America. Association officials called on federal officials to double funding for career and technical training programs and facilitate immigration for workers with construction skills before a worker shortage stalls future infrastructure projects.

"Construction employment rebounded in March, indicating that the dip in February was probably related to extreme weather conditions and not the beginning of a slump," said Ken Simonson, the association's chief economist. "In fact, the construction industry has added jobs at twice the rate of the overall economy in the past year."

Construction employment totaled 7,447,000 in March, an increase of 246,000, or 3.4 percent, since March 2018. The growth rate was double the 1.7 percent gain in total nonfarm payroll employment, the economist noted. Average hourly earnings in construction – a measure of all wages and salaries – increased 3.3 percent over the year to \$30.45. That figure was nearly 10 percent higher than the private-sector average of \$27.70.

"The average workweek in construction is at a record high for March and the number of unem-

ployed jobseekers with construction experience is at all-time lows," Simonson added. "These data suggest that contractors are having a hard time finding qualified workers even though the industry pays better than the private sector as a whole."

All construction industry employees averaged 39.9 hours of work per week in March, the highest March rate in the 14-year history of the series, Simonson observed. Meanwhile, the number of unemployed jobseekers whose last job was in construction totaled 490,000 in March, a steep decline from the 696,000 such workers in March 2018 and the lowest March total since the series began in 2000. The unemployment rate for those jobseekers amounted to just 5.2 percent, down sharply from the 7.4 percent rate a year earlier. The economist said the lack of experienced workers to hire results in longer-thanusual hours for short-handed construction crews.

In a survey the association released in January, more contractors reported they expect the dollar volume of projects available to bid on to expand than to shrink in 2019 in each of 13 project categories. In addition, 79 percent of respondents reported that they expect to add employees in 2019. However, nearly as many—78 percent reported they were having trouble filling some positions and 68 percent said they expected that hiring would remain difficult or become harder.

Association officials said that growth in the construction industry was dependent on finding qualified construction workers and that a lack of skilled workers would hold back businesses and



infrastructure projects. They called on federal officials to double investments in career and technical education programs to expose more high school students to construction opportunities and to allow a contractor to bring in foreign workers for specific projects when the firm can demonstrate it was unable to hire U.S. workers.

"Our member firms continue to worry about finding enough workers to fulfill the demand

for construction." said Stephen E. Sandherr, the association's chief executive officer. "The only way to ensure that the construction industry continues to grow is to develop more skilled domestic workers that contractors need and to allow construction firms to seek qualified workers from outside the United States."
