# 6 Ways to Improve Your Construction **Company's Profitability**

Construction companies are in business to do two things: build things and make a profit. So why do so many excel at the first thing but struggle to be profitable?

Part of the reason is the way bids are solicited and contracts are awarded. Many clients, especially in the public sector, award projects to the lowest bidder, with the contractor's expertise, experience, and quality of work an afterthought. That's what contracts are for after all, right?

That seems to be changing as we are seeing more Request for Proposals, Design-Build, and prequalification requests for bids. Rather than just focusing on price, these methods of solicitation focus more on a contractor's qualifications and quality of work than the ability to build the project as cheap as possible.

Stiff competition and fewer opportunities during the last recession led many companies to lower bids to be competitive, surviving on razor-thin margins to maintain enough work to stay in business. Now that the economy and construction industry has recovered, labor shortages are forcing some contractors to offer higher wages to recruit and retain experienced workers.

The cost of building materials had been steadily increasing even before factoring in the effects of trade negotiations and tariffs. All of these can eat into a company's profit margin, but for the most part are outside of a company's control.

Instead of focusing on things you can't control, take a look at ways your company can reduce costs, submit better bids, and delivering quality work. Here are a few tips on how you can improve profit margins on your projects.

Put simply, productivity is the measurement of the effectiveness of effort. Productivity rates are measured as total output per unit of input. In construction, an example of output could be cubic yards of earth excavated or square footage of roofing installed, with the input typically measured in man-hours

Maximizing productivity on a jobsite means working efficiently to control costs and stay on schedule. Projects that are completed under budget and ahead of schedule usually result in higher profit margins which are why construction firms are always looking to improve productivity.

Improving productivity requires careful planning and scheduling of work. General contrac-

## Support SB 534 To Ensure Diversity in California's Insurance Industry

The California State Senate is set to consider Senate Bill 534, authored by Senator Steven Bradford (D-Gardena), a bill that will ensure diversity in California's insurance industry.

## Ensuring Diversity in California's Insurance Industry

According to the California Department of Insurance, in 2018, California had the largest insurance. market in the United States, a \$310 billion industry that covered housing, automobile, health, and life insurance – just to name a few. Given the rapid growth of California's insurance sector, it is vital that state leaders push for greater diversity, equity, and inclusion across this sprawling industry.

If you think this isn't a big issue, think again. In 2016, Greenlining opposed two proposed insurance industry megamergers – between Anthem and Cigna, and Aetna and Humana – in part because they had no plan for addressing their woeful records on diversity. When questioned about whether either company had a plan addressing this gap, they responded, in essence, "Ask us after you approve the merger." This is unacceptable. Fortunately, both mergers were blocked by the federal government.

SB 534 ensures that California's insurance providers don't relegate diversity to being an afterthought. This bill, which is being championed by two of California's foremost diversity leaders. Sen. Bradford and Insurance Commissioner Ricardo Lara, will take important steps to guarantee that diverse communities continue to play a key role in how the insurance industry serves all Californians. Specifically, this bill will require the largest insurance providers in the state to permanently report their supplier diversity and governing board diversity goals, as well as their spending with minority-, LGBT-, women-, disabled veteran-, and veteran-owned businesses. Moreover SB 534 will institutionalize the California Department of Insurance Diversity Task Force, which has played a key role in supporting the department's efforts to increase diversity.

In recent years, diversity initiatives have sparked contentious debates about the merits of these regulations, despite the proven benefits of such statutes. Here are three reasons why SB 534 is in California's best interest: 1) The data is clear: Diversity benefits ALL Californians

Research shows that data transparency drives investment in diverse businesses. In 2012, California passed AB 53, which enacted the state's first supplier diversity disclosure requirements on the largest insurance providers. As a result of this bill, insurance industry spending with diverse businesses increased by 93 percent – from \$930 million to \$1.8 billion – from 2012 to 2018. This was a significant boon for diverse businesses across the state that offered legal services, office supplies, advertising services, food delivery, and other important resources to insurance providers and their clients.

According to the United States Census Bureau, in 2012, California led the nation with the most minority-owned, women-owned, disabled veteran-owned, and veteran-owned businesses – which means there is no excuse for insurance providers (or any large company) not to prioritize diversity. SB 534 will make these requirements permanent, allowing California to reap the benefits of increased partnerships between large insurers and diverse suppliers.

### 2) Large companies must represent California if they want to do business in California

In 2017, insurers across the state reported to CDI that nearly 80 percent of governing board seats were held by men and only 12 percent were held by people of color; of the nearly 2,400 board seats, only 14 members self-identified as LGBT; and out of 792 insurance companies, at least 13 percent reported zero women and 35 percent reported zero persons of color on their governing boards. In the most diverse state in the nation, these numbers are unacceptable.

By formalizing a voluntary process for insurance providers to develop governing board diversity goals and regularly assess their progress, insurers will be able to better serve our state by increasing representation of marginalized populations among the most important decision-makers in the insurance industry.

3) California's insurance industry diversity standards are a model – and we should celebrate that!

The success achieved by California's insurance diversity initiative has not gone unnoticed. Ear-Continued on page 6

### Filing It and Finding It Again

How long has your "to file" pile been sitting there, calling out for attention? Are the items at the bottom old enough to be considered archives? Have you needed something that you could not put your hands on quickly? Setting up and maintaining your personal files is the cornerstone to getting organized. It is also the area where it is the most tempting to throw up your hands in frustration.

#### **Common Filing Mistakes**

#### Do any of these sound familiar?

- Creating a separate file for every type of document. This is the culprit when you have lots of files with only a few pieces of paper in each one.
- Not remembering how you categorized something. Wondering, "Where would I have put that?"
- Creating a perfectly good system but not keeping up with it. "It works when I use it."
- Filing indefinitely. Having no provision for purging files is the equivalent of saying, "If it was good enough to file then, it is good enough to stay now."
- Creating an overly complex system. A mini-Dewey Decimal System for the 30 files you keep in your immediate workspace is unnecessary.

Information retrieval is a key component to peace of mind. Your filing system should be simple, easy and manageable. Consider your major areas of responsibility. Although you probably wear different hats, most jobs have an administrative element as well as a project component.

Your Personal Files

Start by creating working project files. They may be client or customer files—key projects, committees or contracts. If you are a recruiter, you may have a group of resume submittals and open requisitions. Your other main category will contain your ongoing operational files which deal with administrative activities. These can include budget, newsletters, travel, vendors, staff meetings. If you have a third component to your job, create a section for those as well. The goal is to have a few, hopefully not more than four broad areas. Each section represents a logical division and should contain a number of individual files. Filing Principles

**Principle 1:** File papers in the broadest possible category. Thick files are easier to deal with than thin. Consolidate all related materials under the most general category that is practical.

**Principle 2:** Head files with a noun. To help make Principle #1 easier, find a key subject area and use that to label the file. Avoid labeling a file with a number, date or adjective. A more effective label than "How to negotiate contracts" is "contract negotiation."

**Principle 3:** After dividing files into broad areas, group each subject area together. Then alphabetize within each grouping. That will make retrieval smooth and easy.

**Principle 4:** File articles by the subject they discuss. When you tear out or copy interesting information, place that with related materials according to how you use it, not where you

# **Business Loans for Veterans**

Those that serve our country deserve to be supported both before, during, and after service. What if their dream is to start or grow a business? Fortunately, there are loans designed to do just that. While the majority of the opportunities provided to veterans are listed through the entrepreneur portal on the Veteran's Administration (VA) website, they are actually managed by the Small Business Administration (SBA) - through the Office of Veteran's Business Development (OVBD).

The SBA claims that "Veteran-owned businesses are one of the fastest-growing and significant segments of the U.S. economy." Are you ready to join them? See what small business loans may be available to vets - along with tips for applying - in our guide below.

#### SBA 7(a) Loan

This loan isn't specifically aimed toward vets, but it is the most popular and widely-used loan program through the SBA. Like most loans through the program, an SBA 7(a) loan requires applicants to be U.S.-based, meet size standards (the smaller, the better), operate for profit, and have something of their own equity or assets to invest or use for collateral. The SBA also likes to see that you've tried getting other kinds of funding or have used up your own personal financial resources before you apply.

Once approved for an SBA 7(a) loan, you can use it for a variety of business-related projects, including (but not limited to): buying land or property, making repairs, refinancing your debt, buying materials or equipment, growing your business operations through new hires or product launches

While the business loans through the program are open to everyone who qualifies - not just vets - the perks are notable. Loan repayment terms are generally more gracious, allowing borrowers to take more time to pay and, ultimately, accepting lower payment amounts per month. Since banks offer unique terms to their specific loan product, the rates will vary; some banks offer fixed-rate and other only offer variable-rate.

Within the SBA 7, (a) loan program is several, more-specific loan products. Some are specifically-designed to serve underrepresented groups, such as vets. They include:

SBA Express - This program guarantees a 36hour turnaround for applications for funds. Loans must not be over \$350,000; loans under \$25,000 may not require collateral. Revolving lines of credit are often offered through this program, for a term of up to seven year.

Export Express - If you are in the export business, you'll need to apply for a loan specific to your needs. The Export Express loan offers funds of up to \$500,000 for qualified applicants; decisions are made within 24 hours. Collateral requirements are similar to non-SBA loan programs. (Be prepared to have some!)

#### How Veteran's Advantage Helps

While veteran-specific loans aren't common, there is a distinct advantage to having veteran status when applying for most all of the widely-available SBA-backed loans. The Veteran's Advantage program works to ensure that vets are fairly represented and given opportunities to start and grow businesses. Among the perks of the program are reduced fees for applying for loans, which can significantly lower the cost of taking out credit for those who qualify. To be eligible for the discount, the business must be at least "51 percent owned and controlled by someone in one of the following groups:

- Honorably discharged veterans
- Active Duty Military service member eligible for the military's Transition Assistance Program (TAP)
- Service-disabled veterans
- Reservists and active National Guard mem-
- Current spouse of any veteran, active duty service member. Reservist. National Guard member, or the widowed spouse of a service

member who died while in service or as a result of a service-connected disability.

The lender is ultimately responsible for approving or denying an application, however. To keep status with the SBA, banks must meet qualifications. The only way to truly know what VA-focused loans are available is to go through the SBA lender match portal for small business lending. You won't be given a list of VA program participants, but rather will be asked to fill out general information, and your info will then be passed along to the programs you are best-suited for (which will include VA programs, if applicable.)

#### **Disaster Relief**

One other way to get funding as a veteran is through what the SBA calls "disaster relief" programs. The Military Reservist Economic Injury Disaster Loan (MREIDL) is made specifically to military reservist business owners who get called into active duty and need help keeping their business afloat in the meantime. Like other SBA offerings, businesses are expected to look elsewhere for funding first and are only allowed to apply if they can fund their own recovery. If they are eligible for a loan or other business credit line - and it won't cause undue hardship to pursue these - federal law requires vets to start there, first.

found it. A resource file items titled "articles" is not helpful.

#### **Filing Tips**

- Avoid nonspecific file labels, such as "General," "Miscellaneous," "Overall Information" or "Pending." These are traps for loose paper.
- Keep extra file folders close at hand. Create a new file as soon as you receive documents related to a new project.

Place the most recent document in the front of the file. This will save much searching time.

- Resist the impulse to copy papers and place them in different files. Place papers in the category most likely to come to mind when you think of the subject.
- Maintain your filing system. Keep it simple and remember to file regularly. Backlogs become procrastination traps. Purge files frequently of excess information, old notes and out of date items.
- Do not bother to file every business card you receive, information you already have in another form, duplicates, or items other people simply insist you take.

lier this year, the Illinois state legislature drafted a bill that would enact very similar requirements to those initially passed in AB 53. SB 2623 seeks to follow California's successful model by requiring the largest insurance providers in Illinois to report their supplier diversity as well.

This type of success should be celebrated – and expanded! As more states catch on to what California is doing, it is vital that state leaders continue to innovate, which is why CDI's Diversity Task Force must continue to function and thrive. This body, which SB 534 would make permanent, will allow the Insurance Commissioner to continue working with diverse businesses and advocates to ensure diversity across all aspects of the insurance industry. Other states – and other sectors – should follow this model.

The insurance industry represents a vital part of California's economy, and state leaders must ensure that diverse communities benefit from the continued success of this sector. The funds through this program max out at \$2 million and can be used for "ordinary and necessary operating expenses" that the military reservist can no longer meet because of deployment or active duty activities. If the business owner has business interruption insurance (many do), the insurance needs to pay out first before the loan program can step in and help. The 2 million dollar threshold may also be waived if the business employs a significant number of people; business failure would have a ripple effect on a community, for example. Money can be used to keep the business going, as usual, not to be used

as a substitute for regular commercial debt or to expand the business.

Military reservists can apply once they get notice of their call-up, and they can file for up to one year after they are discharged or released from active duty. Collateral is required for large loans (over \$50,000.) The interest rate is currently 4%, and repayment is usually up to 30 years. The SBA can change terms, however, and FED rates may affect the final APR for any loan.

The application process for this loan is a bit different since it's through a disaster program. The SBA handles it, not the banks.

For those veteran's (and their spouses) who are looking for business funding, remember that certain banks, credit unions, and community groups may have their own programs to help vets expand their companies. Inquire about local resources available to you, as well as reach out to your local Chamber of Commerce or Veteran's group for details on what may be new and outside of the government's jurisdiction.





tors and trade contractors must work together to make sure that work is completed in a logical sequence that focuses on maximizing the efficiency of everyone working on the project.

Because your field workers are an essential part of productivity, it's important that your workers know how to properly and safely complete assigned tasks. This means making sure each worker has received the proper training and are equipped with the tools and resources needed to effectively do their jobs.

Keep in mind that your workers' efficiency, or lack thereof, is only one aspect of productivity. Other factors that can negatively impact productivity, and by extension profitability, include supply chain management, poor scheduling, accidents, and unnecessary rework.

#### **Know Your Costs**

In order to be profitable and improve profitability, you need to understand the costs associated with completing each project. This includes not just your job costs but also your overhead costs. If you don't have a sense about what your projects cost to complete, there's no way of knowing how profitable you are on each job.

Job costs include everything directly needed to complete a project. These include labor, materials, supplies, equipment rental costs, bonding premiums, fuel, permits, etc. Basically, anything that pertains to costs on the actual jobsite is part of your job costs.

These can vary greatly by region and type of project, so it's important to stay up to date on your job costs especially if you do work in multiple states. Having to pay prevailing wages on a job or dealing with fluctuating material costs can skew your job costs in a way that greatly affects your profitability. Overhead costs are the expenses needed to operate your business. Overhead items include support staff payroll, tools, insurance, utilities, office rental or mortgage, equipment, debt payments, owners' salary, legal fees, IT, etc.

When calculating and reporting overhead costs, be sure to capture all costs and be as accurate as possible because your estimators will need these to submit better bids.

#### **Estimate for Profit**

When you bid a project, you expect to win. When you win a bid and are awarded the contract, you expect to make a profit. For that to happen, your estimates need to be realistic and as accurate as possible. If your estimates are too low, no amount of project management or productivity gains will get you profitable.

This is why having an accurate account of your job costs and overhead is so important. It allows your estimators to add in the proper markups to hit your profit margin goals. A good bid is based on concrete data, not guesswork. Be sure to consider the risk factors on each project and build in a contingency line to your bid that can absorb additional costs when risk becomes reality.

Estimators also need to know the productivity levels of your field workers, so they can create realistic job costs. Keep track of actual versus estimated job costs on each project, especially labor costs and productivity rates, so your estimators can determine how accurate their estimates were and what adjustments might need to be made on your next bid.

Avoid racing to the bottom by always trying to be the lowest bidder. If you undercut your bids to win, you'll always struggle to be profitable. As you go through your bid/no bid decision making, profitability should be your top consideration along with a risk analysis and your firm's capability to perform the work. Bottom line: don't sacrifice profit just to win more work.

#### Set Profitability Goals

If you want to improve the overall profitability of your company, you need to set profit margin goals. Where does your company want to be in the next year? Five years? Ten years? Maybe you're looking to grow your business or expand into new markets and territories. Perhaps you're wanting to tackle larger projects or make the jump from public projects to the private sector.

Knowing your long-term business plans will allow you to set achievable revenue and profitability goals to get you where you want to be. It will also help shape the types of projects you take on and guide your estimators on the markup percentage they should shoot for on each project to help you hit those goals.

#### Manage for Profitability & Track Costs

Good project management is key to improving profitability. If you want to hit your profit goal on a project you have to keep your costs down and finish the project within the scheduled completion date. Be sure to keep track of costs on any change orders so that they can be billed properly and increase your profit margin. Don't do additional work on a project until a price has been agreed upon and it has been approved by the client.

Avoid having workers milling about with nothing to do. Stay on top of materials management and stage the jobsite in a way that helps your workers be as productive as possible. Each worker should have proper safety training and be provided with necessary personal protective equipment to avoid accidents and prevent injuries. A safe construction site benefits both productivity and profitability. A good project manager should be able to spot the red flags of an impending issue and make the necessary adjustments to keep the project on schedule and within budget. They should be constantly looking for ways to reduce waste and improve productivity.

Be sure to keep accurate accounts of all your job costs. You don't have to keep track of every screw and nail, but you'll need to be able to compare your actual job costs to what was budgeted so you can complete a thorough analysis once the job is finished.

#### Analyze Your Results

Once you've completed a project, there's still some work to do. Gather your team and conduct a postmortem analysis of how close your estimated profit was to your actual profit. Did your estimated job costs match up with what was estimated? Was overhead accounted for properly in your bid? Did issues occur on the jobsite that resulted in productivity losses or caused you to go over budget?

Take a hard look at your estimates versus your actual costs. Make note of costs that were over or under what you expected so you can do better next time. If you had productivity issues consider providing additional training to your workers and look for ways to reduce downtime when you start planning and scheduling your next project.

In construction, profits don't just happen. The industry isn't built to operate that way. There are too many things that can go wrong and sink what would otherwise be a profitable project. It takes diligence and hard work to go from eking by on razor-thin margins to being profitable enough to grow your business and meet your business goals.
