The table and maps accompanying this article feature comparisons of highway, street and road-work construction starts in all the states, plus District of Columbia, in two ways: (1) by dollar-volume level, taking the annual average over the past two years (2017 and 2018); and (2) per capita (i.e., the dollar volume in (1) divided by each individual state's population).

In some states, there can be considerable variation in the dollar volume of roadwork starts from one year to the next. Therefore, it seems only fair to smooth the series out a bit, and hence the reason for utilizing a latest-two-years average.

On the left-hand side of Table 1, there is a ranking of all states and D.C. according to their level of roadwork construction starts. Sixteen states have exceeded an annual average of \$1.0 billion over the past two years and they are highlighted in Map 1. Washington state, at \$995 million, and New Jersey, at \$980 million, just missed the cut.

There is a tight correlation between population and the dollar volume of roadwork starts. For 13 of the 16 states shown in the map, their rankings for roadwork starts are either identical with, or quite close to, their rankings according to population (calculated as of July 1, 2018). For example, Texas is number 1 for starts and number 2 for population; California is 2 for starts and 1 for population; Florida is 3 and 3; New York, 4 and 4; Pennsylvania, 5 and 5; Illinois, 6 and 6; Ohio, 7 and 7; and so on.

There are, however, three outliers. Minnesota is ninth for roadwork starts but only 22nd for population; Wisconsin is 11th for starts, but 20th for population; and Iowa is 16th for starts, but 31st for population. It might be concluded that those three states are taking their roadbuilding commitments seriously.

As for large-population states that have been bumped out of the Top 16 for roadwork starts, they all appear between positions 17 and 25 in the rankings. New Jersey is 11th for population and 18th for starts; Washington state is 13th for population and 17th for starts; and Massachusetts is 15th for population and 25th for starts.

# U.S. EPA Announces Availability of \$210.7 Million in New Funding to Improve Water Infrastructure in California

The U.S. Environmental Protection Agency (EPA) announced the availability of nearly \$2.6 billion in new funds to assist states, tribes and territories with improving drinking water and wastewater infrastructure across the country. California is eligible to receive a total of \$210.7 million. This funding advances President Trump's efforts to rebuild the country's aging water infrastructure, create local

jobs, and ensure all Americans have safe and clean water.

"EPA is delivering on President Trump's commitment to modernize our nation's water infrastructure and improve public health and environmental protections," said EPA Administrator Andrew Wheeler. "EPA's \$2.6 billion contribution to the State Revolving Funds will enable more communities to make the

"EPA is investing in drinking water and wastewater infrastructure in California communities," said EPA Pacific Southwest Regional Administrator Mike Stoker. "With our state and local partners, we'll continue to improve the safety and reliability of our water resources for all."

California will receive a \$97.1 million capitalization grant to provide low-interest rate financing for drinking water infrastructure. Between \$25 million and \$53 million of the grant can be used at the state's discretion for further reduced-rate financing such as zerointerest loans or principal-forgiveness loans. California will also receive \$113.6 million of clean water funding for sewage treatment and stormwater infrastructure projects.

The State Revolving Funds (SRFs) require state match, loan repayments, and interest earnings that flow back to the funds. With more than 30 years of federal capitalization grants and state contributions, approximately \$80 billion has been invested into these programs. According to the agency's estimate of national drinking water and wastewater needs, over \$743 billion is needed for water infrastructure improvements. Through loan repayments and investment earnings, the SRFs have leveraged these contributions to provide more than \$170 billion in financial assistance to over 39,900 water quality infrastructure projects and 14,500 drinking water projects across the country.

This year, EPA is making available more than \$1 billion in new federal grant funding for the

### Managing the Mail

Mail is an inescapable fact of life. Faxes, email, and overnight delivery services have not, it seems, reduced the amount that arrives from your postal carrier. The quantity of bills, junk, letters, catalogues, journals, and general correspondence can be overwhelming. If you let yourself fall behind, a day's worth of mail can be startling, but a week's worth can seem overpowering. It piles up everywhere: on the desk, on a table, on the top of the computer, stacked in boxes on the floor, with some of it even in your briefcase. When bills are paid late or invoices not processed quickly, then the phone calls begin. Here is a process for keeping mail under control.

1 Throw away as much as you can unopened. Your most important ally is the waste basket.

- 2. Open the mail by slitting open all envelopes in the stack first. Pull out the contents and lav them flat. Do not bother to put anything back into its envelope. For bills, throw away the envelope that it came in along with the other junk mail attached to it. Paper clip the bill, along with the return envelope, and lay it flat on your desk
- Sort the remainder. When you sort, make a 3. firm decision about what you are going to do with the item. Do not set things aside to decide later. If correspondence is related to a client, customer or project file, place it there immediately.

For all the other items which do not have another home, here are two options for sorting the mail: by priority or by action. If you sort by action, sort into four categories-to dictate, to sign, to do today, to read. (Feel free to choose your own headings that best suit your purposes.) Place all items into one of these 4 categories.

Do not allow exceptions or else your "unclassifiables" will take over.

Integrate these four groups of documents into your schedule. The writing or "to-dictate" group will require some concentration. Plan for that time The "to-sign" items can be done in between other activities or while on hold on the phone. The "to-do today" items are added to your daily task list and worked according to their priorities. The "to-read" items go along with you while commuting, waiting for appointments or traveling. This system, which sorts by task, rather than by time, lets you know what your day holds.

Your second choice of sorting paperwork is using an A, B, C and D priority system. The A priority file contains items of high value and must be done today. B priority items are of high value but have a longer lead time—three or four days. C priority items are less important. They may or may not have a deadline attached. Some of these items you will do and some can be given to others to handle. Some will die a natural death. D priority items are to file or to distribute.

These four groups of documents are then integrated into your work schedule. A priority items will be completed by the end of the day, sometimes before noon. The B priority items are worked next, and the C's fit in as time allows. The fourth group, the D's, gets distributed or delegated promptly. This is a good system for jobs that require quick turnaround and are timesensitive

#### Success Tips

Both techniques work well, but choose one option, not both. Use no more than four or five folders into which you sort your mail-not ten or twelve. The more choices about where to put something, the greater the confusion and possibility of lost or misplaced items. With either system, the mail can be sorted by another person. The best way to eliminate the excess is to alert the sender that you do not want the items. # Common Pitfalls in Business Loans and How to Avoid Them

If you're hoping to launch a new product, expand your workforce, or upgrade equipment, a small business loan can offer leverage and wiggle room for even the most cramped budget. For those who qualify, it can add liquidity in as little as 24 hours, as most business loans have online applications. Unfortunately, the application isn't always the most difficult part of the process. See what struggles other business owners have experienced when getting funding and what you can do to avoid some of the less desirable consequences.

#### 1. Collateral

Many business loans require you to put a little skin in the game – usually in the form of collateral. Securing a loan through your own home or property, liquid business assets, future invoices, or even the equipment paid for with the loan funds are all things a bank may ask for before coughing up the cash you seek. Collateral amounts will vary by the type of loan you are requesting; more traditional lenders usually require it more frequently. The loan amount is also a factor. If you plan to go with a specifically-branded small business loan in the tens of thousands of dollars, expect to show a list of things you're willing to give up if the loan isn't paid back satisfactorily.

#### 2. Liquidity

Once you get the loan, it can feel incredibly freeing, especially if you're using the money to pay off high-interest debt or scale your business in a way that can increase sales down the road. Not all loans give a business financial breathing room, however; money borrowed to buy tangible assets (such as real estate or fleet vehicles) will add to your monthly expenses. Loan payments can cause strain on an already tight profit and loss sheet and reduce your liquidity significantly. Money used to pay back small business loans is money you can't use for other things.

#### 3. Credit Score

Many of the online small business loans will let you peek at the amount and rate you qualify for without resulting in a "hard" inquiry on your credit report. To follow through with the loan process, however, you'll need to permit bank access your credit history, and this will almost always ding your score by a few points. Add in a creeping total debt load, and this new loan has the potential to put your creditworthiness in a worse place than it was before you applied. If you're looking to maintain good credit for an even bigger loan or merchant credit down the road, you'll want to utilize loans and loan applications sparingly. (One silver lining to taking out money, however, is if it adds to the variety of loans you'll have outstanding. A good mix of revolving and traditional credit lines can put your score in a sweet spot compared to just having one or the other.)

#### 4. Equity

Unlike credit cards, which let you access the full line of credit at any point in repayment, small business loans don't let you borrow any more until you've paid off what you initially borrowed. A \$10,000 business credit card stands as an option to borrow as little or as much as you want as long as you never go above the limit. If you want more cash from a small business loan, you'll have to pay off the original note, then see if you qualify for a second, separate loan (which you may or may not qualify to get.) Small business loans are, for that

reason, not ideal for those needing the most flexible lending choice.

5. Rules on Business

Very few loans for consumers will tell you what to do after you cash the check. They simply want to be paid back according to terms of the banknote. A small business loan, however, may come with more strings attached. A bank may require a business to check in with the lender and update on how the business is doing, and if debt to available debt is in a good ratio. Red flags that indicate the business isn't doing well could cause the bank to call off the loan and order repayment immediately. For this reason, it's wise to read up on all the requirements a bank demands before borrowing money. You may not find the terms agreeable for your business' longterm goals.

#### 6. Approval

Finally, this wouldn't be an accurate list of pitfalls and setbacks without mentioning how hard it can be to get a small business loan in some instances. While some lending platforms, such as those for crowdfunding and P2P lending, can offer shorter, more streamlined ways to get funds, traditional loans still ask applicants to give up a lot of financial, tax, and marketing plan info to get in the door. Most business loans ask that you be profitable, have two to three years of sales or profit records, and are willing to demonstrate continued growth for the life of the loan. For a new startup, this can be almost impossible. This is why some startups choose to look into an alternative method of funding - or perhaps a microloan - instead.

With so many obstacles to overcome, does it still make sense to apply for a small business loan? The answer is that it depends. The Small Business Administration reports some pretty big numbers for cash given out to businesses, and not all of it went to established, profitable companies. Over \$219 million is earmarked for companies less than two years old in 2019, and \$341 million is destined for brand new startups.

Getting even a small portion of that money could make a big difference for your venture. By preparing for your loan application in advance, researching all the options available for your industry, and being careful about the types of debt you take on, it's possible to make the risks well worth the rewards. Many businesses are taking on new debt to fund their dreams. Will you?

# Mayor Garcetti proposes fiscally responsible 2020 budget with record reserves, investments in homelessness and infrastructure



Mayor Eric Garcetti today unveiled his \$10.6 billion spending plan which strengthens the City's finances and includes record spending to end homelessness and improve Los Angeles' infrastructure.

"Through a sound budget, we achieve a strong bottom line and strengthen Los Angeles from the bottom up," said Mayor Eric Garcetti. "This proposed budget is a blueprint illustrating how we'll achieve our highest ambitions — from ending homelessness to improving our infrastructure while maintaining a commitment to fiscal responsibility that has helped to drive Los Angeles' economic recovery."

Mayor Garcetti's proposed budget continues to bolster the City's fiscal foundation: For the first time since the recession, reserves exceed 8%, which makes Los Angeles fiscally resilient and better able to weather an economic downturn. The Reserve Fund is increased to \$399 million, and includes a Budget Stabilization Fund of \$110.9 million and an Unappropriated Balance of \$20 million.

The proposed budget calls for a record \$940 million to improve and update the City's infrastructure — \$140 million more than the previous year. Also included is \$348 million for street repairs and maintenance, and \$117 million for Vision Zero and traffic and pedestrian safety projects. It allocates funding to advance the Mayor's sustainability goals with \$38 million in Measure W funds going toward clean water infrastructure, and \$3 million for the City's innovative Cool Pavement Program and investments in tree planting. The proposed budget includes the City's largest-ever investment to end the homelessness crisis — with \$457 million in permanent housing, temporary shelter, services, and facilities to help homeless Angelenos find their way off the streets. The budget anticipates spending \$36 million in Homeless Emergency Aid Program (HEAP) funds that Mayor Garcetti advocated for, and received, from the state last year. As part of funding from the Prop. HHH initiative, \$281 million will go toward 27 new permanent supportive housing and affordable housing projects providing more than 2,126 units.

Mayor Garcetti's proposed budget also calls for:

- Increasing police overtime by approximately 40 percent to cover all critical duties.
- Spending \$3 million to help improve dispatch reliability and effective communications for public safety officers.
- Expanding the Advanced Provider Response Units and Fast Response Vehicles to more efficiently dispatch fire resources and emergency medical services.
- Installing electric vehicle chargers and related infrastructure at Police and Fire Stations, as well as streetlight poles.
- Increasing programming and capital improvements at cultural hubs.

## \$210.7 Million in New Funding to Improve Water Infrastructure in California

#### Continued from page 1

Drinking Water State Revolving Fund (DWS-RF). This funding can be used for loans that help drinking water systems install controls to treat contaminants such as PFAS and improve distribution systems by removing lead service lines. In addition, more than \$50 million in DWSRF grant funding is available to tribes, U.S. territories, and the District of Columbia to use for drinking water system upgrades.

EPA is also providing approximately \$1.6 billion in new federal grant funding for the Clean Water State Revolving Fund (CWSRF). This funding is available for a wide range of water infrastructure projects, including modernizing aging wastewater infrastructure, implementing water reuse and recycling, and addressing stormwater. More than \$64 million in CWSRF grant funding is available to tribes, certain U.S. territories, and the District of Columbia for infrastructure projects.

#### **Background:**

Under the Clean Water and Drinking Water State Revolving Fund programs, EPA pro-

vides funding to all 50 states and Puerto Rico to capitalize SRF loan programs. The states and Puerto Rico contribute an additional 20% to match the federal grants. The 51 SRF programs function like infrastructure banks by providing low-interest loans to eligible recipients for drinking water and clean water infrastructure projects. As the loan principal and interest are repaid over time, it allows the state's DWSRF or CWSRF to be recycled or "revolve." As money is returned to the state's revolving loan fund, the state makes new loans to other eligible recipients.

In 2018, the SRFs committed \$9.6 billion in drinking water and clean water infrastructure loans and refinancing and disbursed \$8.8 billion for drinking water and clean water infrastructure.
