

Contractors are increasingly adopting new technologies to give themselves an edge over the competition. According to a recent study from USG Corp. and the U.S. Chamber of Commerce, 74% of contractors expect to adopt advanced technology within the next three years. The majority of them are doing so to increase labor productivity.

What kinds of technologies are these contractors adopting? Here are some of the most common current and emerging trends, whether construction firms are looking to embrace tried-and-true efficiency boosters or explore the cutting edge of construction technology.

Current Technologies

Some of the most common current technologies include:

Building Information Modeling

Using the building information modeling (BIM) process can help contractors on larger construction projects more efficiently plan their projects and keep them organized. The BIM process uses

3D modeling to help gather information and make it easier to visualize a project. BIM can be used in the design, construction, and operation of a building. As the amount of data we can collect increases, technologies like BIM become more useful.

Project Management Software

One software tool contractors can embrace is project management software. It can help firms complete day-to-day tasks more efficiently to help improve project delivery. You can use it to manage documents and resources and enhance communication and collaboration between partners.

Project management software may be cloudbased or web-based, which enables contractors to access documents from anywhere with any internet-connected device. This means contracting teams can use it whether they're on-site or in the office.

Estimating Software

Estimating software is another useful tool for contractors. As compared to spreadsheets and manual methods of estimating costs to inform

Call to Action: Support AB 962, The Hospital Supplier Diversity Act

Diversity matters in health care, and in more ways than you might think. The California State Assembly is currently considering a bill – Assembly Bill 962 authored by Assemblymember Autumn Burke (D-Inglewood) – that would further promote diversity by requiring all hospitals with annual operating budgets above \$25 million to report their supplier diversity – that is, contracting with minority-, women-, LGBT-, and veteran-owned businesses .

The data is clear: Increasing supplier diversity will benefit all Californians. Large corporations and government agencies across the nation buy billions of dollars in goods and services, and when diverse businesses get their fair share of these contracts, it builds jobs and prosperity in communities that otherwise may be left behind. Many firms are proactively embracing supplier diversity as a means towards maximizing their

impact; however, hospitals have remained notably silent, mainly because they haven't had to share this information with the public. This raises serious questions given the rapid growth among hospitals in the state and nation over the past decade.

And don't take our word for it; take theirs: According to the American Hospital Association, hospitals in California contributed over \$230 billion to the total state economy in 2016. While some hospitals have bought into the value of supplier diversity, most hospitals in the state haven't dedicated the necessary time and attention to increasing or tracking their supplier diversity.

Therefore, as state leaders assess the merits of this bill, here are three important reasons why California needs AB 962:

1) Supplier diversity benefits ALL Californians

Diversity is NOT a zero-sum game. When the California Public Utilities Commission began tracking supplier diversity among utility companies in 1986, diverse businesses only received

a paltry \$2.6 million in contracts; by 2017, that amount had grown to over \$10 billion – simply as a result of reporting and transparency. Moreover, after the California Department of Insurance began surveying the supplier diversity of the state's insurance providers in 2012, investments and partnerships with diverse small businesses increased by 93 percent over a five-year reporting period, from \$930 million in 2012 to \$1.8 billion in 2017.

The success from these policies has been resounding: According the U.S. Census Bureau, in 2012, California boasted the largest market of diverse businesses in the nation. California should celebrate these achievements and ensure that other growing sectors – like hospitals – monitor their supplier diversity as well.

2) Diverse businesses serve California's most vulnerable populations

Minority-owned businesses represent 42 percent of all firms in California, with women, LGBT, and disabled veteran-owned businesses comprising 32 percent, 1.7 percent, and 2 percent, respectively. These businesses are more likely to operate as small businesses and hire people from diverse backgrounds, providing people from marginalized communities with a pathway to financial security and upward mobility. These enterprises play an especially critical role in times of economic downturn and increasing income inequality.

Hospitals are a vital part of California's success, and it's time they start supporting diverse businesses too. AB 962 will finally allow health care, business, and government leaders to engage in an honest and transparent discussion about leveraging the rapid growth of the health sector to benefit marginalized communities across the state. Smart Ways
TO WORK

Helping a Grieving Colleague

You get the news Wednesday morning. A colleague has just had a death in her family. What should you do or say? What is the correct etiquette in the workplace, and what can you do to ease the pain and transition for your fellow worker?

You might send a card or wish to say something to express sympathy. In looking for the "right words" avoid platitudes. It will be better received if you sincerely express your concern or, better yet, if you share a memory about the person who

has died. That is more meaningful than an easily dropped cliché. Remember to look at the person that you are talking to rather than at your hands or away. It is their child or spouse that died, not them. Survivors often feel as though they are invisible to others.

What to Say

Be aware of your tone. You do not have to be continually solemn. Some humor, particularly in difficult times, is welcome. However, telling jokes, raucous laughter and being excessively chipper are grating on the nerves.

It is common for people to be uncomfortable in this situation and therefore tempted to avoid any awkwardness. This can mean that the lost one is never mentioned, when all the survivor wants to do is talk about the person. It is quite helpful to let people talk if they express a desire to do so. This is not to say that you suddenly become a grief counselor or that work ceases. For many people, continuing to work helps them get through the most trying times.

Let them be Sad

Try no to bow to the temptation to quickly switch the subject when the survivor talks about how bad they feel. No matter how uncomfortable you may be with pain or sadness, it is not nearly as difficult as it is for the person going through the loss. She will be sad and likely to have extreme emotional swings for a number of months as she goes through the grief cycle. Although there are often situations in life from which you learn great lessons, be very cautious about asking the survivor what lessons they are learning from this, what messages the universe is giving them or what positive things they are getting from going through the grieving process.

Nothing you can say will eliminate the other person's grief. All you can do is help soften it for a little while. Whether the loved one was ill for a long time or died unexpectedly, there is no real way for the survivor to prepare for this event. In the case of a sudden death, a well-meaning comment such as, "Well at least he didn't suffer like my mother who had cancer" can trivialize the death.

Help Later

Immediately after a death, the survivor receives a great deal of attention and support. But after a time, maybe a couple of weeks or months, other people move on with their lives. One of the worst things that colleagues do is seem to forget that the person has experienced such a significant loss. It is really important to be supportive for a number of months after a death. The loss is still fresh for the survivor. Continue to take the person to lunch, ask how they are doing and offer support. This is also a good time to share a memory or to write a note. Notes and kind words even months later are still highly appreciated. Saying something about the lost one is painful to hear, but going through the pain is part of the process.

Be Accommodating

Do not be surprised at changes in behavior and sometimes in the performance of work. The culture in the United States does not support mourning as do some other cultures. People are expect-

ed to take three days off for bereavement and then come back to work and perform at maximum potential right away. Grief comes and goes in waves. There are better days and worse days for the person. This is the time to be understanding and lenient. If you supervise this person, ask them what they need. Is it a lighter schedule for a while? Or a heavier one so they can distract themselves? Will they need some flexibility for time off for the bad days, or maybe go home early occasionally? Be understanding and allow the person room to breathe. If performance suffers too much, a referral to an Employee Assistance Program may be warranted. Ultimately, only time will make the difference and supportive, understanding colleagues will help the process.

How to Transition Into Your Own Construction Business

For those who like to work and are self-motivated, starting your own construction company can be very satisfying. Yes, there are challenges—it is a lot of work and has its share of headaches—but the rewards can far outweigh those things.

With different levels and types of contracting to go after, there isn't a cookie-cutter method for where to start. You may begin with small residential remodels and building decks, or you might have the opportunity to start in a larger commercial setting as I did, building a chain of grocery stores. Regardless of where you start, there are several basic principles that will help lay the foundation for a successful construction business.

Listed below are some principles from my own experience that I would like to share with you.

. When you are starting out, stick with what you know and what you are familiar with. You want to show you are an expert in what you are doing. This will also help prepare your company for future expansion.

- 2. Get a mentor. If you are serious about starting a construction company, you probably realize when looking back that you had help getting your skills to where they are now. A mentor is someone who has already walked your path and can share knowledge, experience, and pitfalls. Whenever I see an opportunity to have a mentor, I will always choose the mentor over the possibility of making a mistake.
- 3. Put a business plan together. It does not have to be elaborate or expensive. It is a snapshot of your business and touches on your profile and goals. Include your company's description, marketing and sales, service and product line, management structure, and goals. If you need help, get someone to ask you the right questions. Get it down on paper—you can always tweak it later.
- 4. An accountant can help structure your company for the best tax advantages and protection. Should you be an S or C corporation, an LLC, or a sole proprietor? This is an important decision at the beginning of your journey.

- Working with a bank or other financial institution can help your company when cash flow is tight. A bank that does a lot of business with contractors can help you set up an available line of credit you can easily access. Even though you want to move toward self-financing your projects, access to credit is a must.
- 6. Finding and obtaining good skilled employees can be challenging—especially when the construction industry in your area is booming. This can include employees in the field as well as office management. Realizing this is an ongoing search, you should keep your eyes open for potential employees. I always had a few young employees I would train and develop to my standards for the scope of work I wanted them to perform.
- Getting good legal advice can avoid a host of problems. Sitting down with an attorney who specializes in construction can give you direction and protect you in ways you are not aware. Have your business plan reviewed yearly and keep your company protected.

- Safety always starts at the top of the chain. If management is concerned and promotes a safety culture within the company, that will flow down to the rest of the employees. Start developing safety practices and procedures to put in place that will set the tone for your employees from the start.
- 9. We all need insurance, but it must be the right insurance. Having an insurance carrier who not only understands construction insurance but has firsthand knowledge of the construction industry is critical for your business to be protected. bid prices, estimating software can help contractors save time and improve the accuracy and consistency of estimates. Furthermore, it helps smaller contracting operations keep track of less tangible "soft costs," which can account for about 30% of the total budget for a typical construction project.

With more efficient estimation, business owners have an increased ability to focus on the project itself. In addition to performing calculations for estimations, estimating software also often allows access to cost databases and templates for documents such as proposals, cost reports and cover letters.

Customer Relationship Management Software

As with any business, happy customers are the key to success for contractors. CRM software helps general contractors keep track of all the information related to their interactions with customers to help improve relationships with them. They can store contact information, data from past projects, data from sales calls and much more in a CRM. Keeping this information organized in one place can help deliver on projects and better focus on meeting the client's needs.

Equipment Monitoring

On larger construction projects, condition monitoring technologies—including fluid analysis and electronic data—minimize wasteful fuel

consumption and downtime. Construction contractors with access to electronic means for monitoring issues like idling can save on total fuel usage, getting the most out of expensive equipment.

Contractors have begun using radio frequency identification, more commonly referred to as RFID, to keep track of equipment, tools, and inventory. Attaching an RFID tag to an item enables you to scan it to get information, such as a model number or when it was last inspected.

Emerging Technologies

Some contractors are ahead of the pack and are trying out emerging technologies. Most of these are just starting to see use in the industry, but will likely become more common — and available for more applications — in the years to come.

Augmented and Virtual Reality

Augmented reality overlays digital objects over the real world, while virtual reality creates an immersive digital experience. Both typically involve the use of high-tech goggles or glasses. You've probably heard of these technologies, but you're more likely to have witnessed them in the context of gaming than construction.

However, the technologies have many applications in the industry. Contractors can use these technologies to practice skills in the digital world before trying them in real life. They can also be useful for visualizing construction plans, allowing project stakeholders to interact with the design in an immersive way.

Drones

Drones, also called unmanned aerial vehicles, were the most popular technology among contractors who said they use advanced technology in the USG Corp. and U.S. Chamber of Commerce survey. Contractors can use them to fly over job sites to create a map to assist in planning. They can also fly a drone over a location to help monitor the project's progress.

Automation and Robotics

Automation and robotics are transforming all sort of industries, including construction. Contractors can use robots, self-driving construction vehicles and other technologies to increase productivity. One example of such a robot is the Semi-Automated Mason, which deploys a conveyor belt and robotic arm to lay 3,000 bricks in eight hours, about six times more than the average human mason could do on their own.

Rather than replacing masons, this robot takes over some of the repetitive, mundane parts of bricklaying, leaving humans to do tasks that require more skill.

3D Printing

3D printers, which produce physical objects layer by layer, could be extremely useful for con-

tractors. These devices enable construction firms to quickly and cost-effectively print parts used for a project, as well as tools and replacement components for equipment, from anywhere. Teams could potentially have a 3D printer onsite, reducing the downtime caused by broken items. 3D printers can also print unique designs, helping solve complex construction challenges.

Wearables

Wearables, including smart sensors, boots, and clothing, could help contractors increase safety, efficiency and productivity. These device keep track of worker location and can automatically detect falls. People can also use it to report incidents or hazards themselves. Wearables have started to make their way into the industry and will likely continue to become more popular.

Contractors across the industry have started to adopt advanced technology because of the productivity, efficiency, safety and cost benefits it brings. If you want a competitive edge, consider how new technologies may be able to help you.

Concerns About Homelessness, Infrastructure On The Rise; General Business Outlook Wanes

The 11th annual poll of Los Angeles County Business Federation (BizFed) shows that business owners share the same concerns that most Californians have around homelessness and crumbling infrastructure. The general business outlook has also dipped for the first time in four years, with caution up and optimism slowed.

Homelessness is the fastest rising concern for business owners.

In the list of top concerns, homelessness saw the biggest jump from last year's poll, reaching the #3 spot this year after peaking at #9 in 2018. It was cited by 24% of respondents as one reason why businesses and jobs are moving out of Los Angeles and California. Only 10% of respondents countywide are satisfied in the way local government is reducing the number of homelessness.

When asked about their satisfaction with their local government's performance on a number of issues, business owners were most disappointed with housing affordability and homelessness. 90% of business owners said they were dissatisfied with their local government's performance on reducing homelessness, while 94% cited housing affordability as the area were local government is performing the worst.

Pathways out of poverty identified as technical training and child care.

LA County has the highest poverty rate of any California County, according to Stanford's CA Poverty Measure. In 2018, BizFed announced an initiative to lift 1 million people out of poverty in LA County by 2028. In this year's poll, 66% of business leaders identified "career technical training and industry specific apprenticeships" as the best way to address poverty in LA. 38% pointed to increased childcare options for working families.

Roads and Freeways in dire need of repair in order for business to grow.

66% of respondents said roads and streets are the infrastructure that need attention most critically in Los Angeles County, followed by highways and freeways at 55%. Technology and communications rounded out the top three at 29%. Street repairs were cited as the number one infrastructure investment that would help LA businesses grow. With their major concerns about transportation infrastructure, it's easy to see why three times as many respondents (59% vs. 18%) said they oppose Governor Newsom's proposal to withhold Gas Tax funds from cities who don't meet their housing goals.

Business Optimism lowest in four years.

34% of poll takers forecasted significant or slightly better business outlook for 2019. This

is a sharp drop over the last three years. Since 2016, positive business outlook figures have been in the mid-60%. The number of business owners who say they expect growth to be flat this year has doubled from 22% in 2018 to 46% in 2019.

Threat of split roll causes nearly half of business owners to consider leaving CA

Taxes and fees remain the number one concern of business owners in California for 9 years straight. They are particularly concerned with proposed changes to Proposition 13, which would increase property taxes for industrial and commercial lands. A ballot initiative has already qualified for the November 2020 ballot, causing 40% of survey respondents to say that if passed, it may cause them to consider relocating their business outside of the state. 35% of business owners said that if the initiative passes, it may cause them to consider cutting payroll expenses.

80% of respondents blame high taxes and fees for businesses leaving in California already, far beyond the 59% who cited the state's rapidly changing regulatory environment. Traffic congestion/transportation and housing costs are cited as the 3rd and 4th reasons that businesses leave the state, respectively.

"The recent failure of Measure EE in Los Angeles proves that voters are starting to feel the same frustration that business owners have" said Tra-

cy Hernandez, BizFed's Founding CEO. "When our elected officials are not good stewards of public resources, it seems the first thing they do is turn to property owners to raise funds. But increasing taxes on homeowners only makes housing more expensive and less attainable. Raising taxes for business means they can't invest that money in their workforce, and it increases costs for customers."

"California is an important marketplace but it's not like businesses don't have other options," points out BizFed Board Chair Steve Bullock. "We've seen many major employers move to Texas, Florida, Virginia – the taxes are lower not just for their businesses, but for their employees. Their employees find that housing is more attainable, and traffic is less soul crushing in places that have growing economies and well performing schools."

Most and Least Business Friendly Cities for 2019

Santa Clarita, the City of Industry, and Torrance were selected as the most business friendly of LA County's 88 cities. The Cities of Los Angeles and Santa Monica were for the second year in a row to be the least business friendly cities, followed by Carson.

my. Monitoring how hospitals engage with these enterprises makes moral and financial sense.

3) Transparency in supplier diversity builds trust and accountability

AB 962 will finally allow health care, business, and government leaders to engage in an honest and transparent discussion about leveraging the rapid growth of the health sector to benefit mar-

ginalized communities across the state. Without this information, all we can do is speculate about the health sector's engagement with diverse businesses and the communities they serve. Making this information public is the only way to accurately evaluate the market the hospitals operate in, and it's the best way to guarantee these discussions occur equitably.

As a result of AB 962, California can expect increased engagement and partnerships between hospitals and diverse businesses across the state, just as happened with previous supplier diversity legislation. By requiring disclosure of this vital information, California can leverage the expansion of the growing health sector to benefit small businesses and enterprises that employ people of color, women, LGBT people, and veterans.

Hospitals are a vital part of California's success, and it's time they start supporting diverse businesses too.
