Why Your Construction Company Needs a Payments Strategy

I've written about the importance of a vendor payments strategy for companies in today's business climate. But the reality is it's twice as imperative for construction companies to implement this process because the industry's payment challenges are bigger—and so is the opportunity. Payments are at the center of two critical areas of the construction business—vendor relationships and job progress. So getting strategic about how you pay can make a big impact.

What exactly is a payments strategy? In the check-centered world of the past, it meant managing float, capturing early-pay discounts, and/ or shifting some payments to credit cards in order to get rebates. Today it means using intelligent payments automation to get the most leverage from every payment you make.

Beyond Replacing Checks

It starts with eliminating paper checks—but it doesn't end there. You have to think strategi-

cally about how you're going to replace them.

First, you want to encourage as many vendors as possible to take virtual card payments. Designed specifically for accounts payable (AP), virtual cards offer the convenience and rebates of credit cards along with an extra level of security.

You can sign up any vendors that won't accept a credit card for automated clearing house (ACH) payments. After that, only holdouts that absolutely won't take any form of electronic payment should get a paper check.

Workflow Changes Can Mean Extra Work

For years, businesses have tried to eliminate paper checks, with only moderate success. Simply adding a card product or bank-provided ACH hasn't gotten them across the finish line because those solutions only move money electronically. They don't help reduce the necessary front-end work to get to the point of payment. Ironically, introducing payment types like card and ACH solutions on their own can actually add more workflows and complexity to the process.

That's one reason construction companies are still mostly check-based. They're already managing lien releases, progress payments and job-cost accounting on top of the usual AP process. Adding more workflows for electronic payments is the last thing they need.

The Vendor Enablement Challenge

The other factor that's kept businesses from going electronic is the task of vendor enablement. All you need to pay any vendor by check is their name and address. But electronic payments require you to know who will accept a card or ACH—and getting that information is a lot of work.

Besides that, in order to pay vendors who agree to accept ACH, you need to collect, securely store and maintain their banking information. Most AP departments don't have the resources to add comprehensive, ongoing vendor enablement and data security to their workload.

Construction companies face even bigger vendorenablement challenges. Every job is almost like a mini-company, with different owners and different business entities, localized vendors, and an ever-

Poor Planning Could Lead To 5 Big Retirement Problems

Ideally, retirement is a time someone anticipates eagerly – a reward for a lifetime of hard work and solid financial planning. But nearly half of workers who haven't reached retirement yet aren't that excited about the so-called golden years. In fact, they have big concerns.

A Gallup poll showed 46 percent of those not yet retired expect they'll be financially strapped when they do retire. Gallup's tracking of that metric has reflected persistent concerns with retirement through the early 21st century. Fifteen years ago, only 36 percent of workers said they wouldn't have enough money to be comfortable in retirement.

"A lack of sufficient retirement savings is a common problem, but there's a lot more to the pie chart of a comfortable retirement," says Chris Hobart, (www.hobartfinancialgroup.com), a financial professional and CEO of Hobart Financial Group. "Even people who have saved and invested wisely don't factor in enough of the costs in retirement, from health care to single living and taxes." Hobart notes five common retirement-planning mistakes:

Underestimating health-care costs. It's estimated that the average 65-year-old couple will need \$280,000 in today's dollars for health-care costs, and that number doesn't include long-term care. "Typically, we look at longevity as a blessing, but the longer we live, the more likely we are to have health-care issues," Hobart says. "The No. 1 solution is being intentional about segmenting a portion of money to address long-term healthcare issues and studying the applicable insurance products. Many Americans ignore this problem and hope they don't have to deal with it, and then when they do, it's too late."

Not having a plan for the surviving spouse. On average, women outlive men. "But for either spouse, the main factors to consider for a surviving spouse plan are the potentially reduced income, taxes as a single filer, where they'll live, and paying for the deceased spouse's final expenses," Hobart says. "Another problem results if the surviving spouse was never engaged much in the couple's financial planning. It pays for both spouses to have a good working knowledge about it." **Counting on Social Security to cover expenses.** The monthly Social Security check usually won't pay the bills, especially if you still have mortgage payments. "You'll need to make up the shortfall with other sources of income," Hobart says. "The important thing to look at here is, in a world where few people have pensions anymore, the onus on saving is on the individual retiree. It's more important than it's ever been."

Thinking you can dictate when you retire. One study showed that 51 percent of retirees retired earlier than they planned – and less than half did so by choice. "You have to expect the unexpected and plan for it well ahead of time," Hobart says. "Many things can happen – downsizing, health issues, taking care of a family member."

Signing up late for Medicare. The initial enrollment period is three months leading up to your 65th birthday, during the birthday month, or three months later. But if you don't enroll, your Medicare premiums can increase by 10 percent for each year you were eligible and didn't enroll. "Whether you like Medicare or not, you don't want to pay more for something when you didn't have to," Hobart says.

changing roster of local and specialty subcontractors. I've sold AP solutions for over a decade, and I've never seen an industry with as much payment complexity as construction.

At the same time, construction also faces low profit margins and scarce IT resources, and sees fit to spend most technology investment on field operations. Further, with many construction companies run by founding families, the tradition of the owner signing every check dies hard.

Not Just for Consumers

Here's the good news: just as they did with consumer payments, technology companies have stepped up to go beyond moving money electronically. Automated payment solutions enable you to make every type of payment from a single interface. There's just one workflow—deciding which invoices to pay and clicking the "pay" button.

You don't even have to know how a vendor wants to get paid. Solution providers now use cloudbased networks to handle vendor enablement and information management at scale—and a lot of your vendors are probably already part of their networks. Plus, the cloud lets providers integrate their solutions into your ERP or accounting system with just a few hours of IT time. These new fintech systems can help most businesses reach 80 percent or more electronic payments. It's a project that pays for itself quickly and frees up AP time for other initiatives.

Early electronic-payment adopters in construction have found that being able to pay vendors on time consistently with full remittance data helps them attract top subcontractors to bid on their jobs. They can also enable field supervisors to approve payments in the cloud while on their jobsites, which saves tons of time and really helps keep jobs moving.

Positioning for the Future

Although construction lags other industries in adopting technology in general, it's not far behind in terms of payment automation. Many companies are often slow to adopt electronic payments because they're simply unaware of new automation solutions. For years, bank and card products have been the only game in town, even though they haven't solved for all the complexity surrounding payments. Things have changed, and there's a lot coming down the pike, including innovations in accounts receivable, trade finance, and dynamic discounting.

As payments become automated in the cloud, companies are gaining enough visibility and

speed in invoicing and payments to leverage these advanced programs. Even if you're still heavy into checks, you're not a long way from being able to capitalize on new technology solutions.

So it's time to start thinking strategically about payments—not just as paying bills or shifting from paper to electronic. Think about payments as an area where you can leverage technology to increase value and get out on the leading edge of back-office innovation.

"There is no reason you should trip over these things that you can avoid early on," Hobart says.

1. Financial assessment: if you don't do it, it's time to start

SDI carriers need to see a formalized approach toward financial vetting. Solvency issues are a primary contributor in many subcontractor default claims, and the vast majority of these losses might have been preventable if a basic financial assessment took place. Access to capital, or liquidity, remains the most important area to focus on in analysis, especially on projects where slow pay cycles and cash flow could become a major concern. Understanding a subcontractor's capacity, both from a single and aggregate basis, is key.

The financial assessment will also reveal some important clues into how a company manages its assets. In cases where the subcontractor's company is behaving largely as a pass-through entity (think LLC or S-Corp), it's important for general contractors to recognize this as exposure and review who they are signing the agreement with. An additional guarantee from a parent company or individual may be appropriate.

2. Aggregation: understand their exposure

This is the topic we hear about the most in the SDI space, from carriers and contractors alike. Subcontractor aggregation, otherwise described as the concentration of awards made to the same contractor or vendor (usually within a particular region), is hugely important because it represents the total amount of exposure to a single company.

We have made several product enhancements to TradeTapp to help track exposure and monitor subcontractor aggregation, both internally as well as across the marketplace. Carriers view aggregation across their multiple clients as compounded risk, and it's important to understand a subcontractor's committed backlog, including the breakdown of projects by type and region. This may have a profound effect on work quality, manpower, or production in the field.

Measuring and managing aggregation is a function of monitoring your own awards made to a single subcontractor, as well as staying up to date on their backlog position. Like a bonding company, you should consider each subcontractor's backlog commitments in comparison to their capital position when evaluating their ability to meet the demands of current and future projects. It may make sense to hold back on giving one contractor more work until they've completed some of their existing pipeline.

Aggregation is of further concern as the current economic marketplace continues to indicate increased construction spending, while the availability and supply of qualified bidders continue to decrease. Evaluating personnel, project team, and individual experience of your contractors is equally important when backlog becomes a concern.

3. Quality: find a way to monitor and measure it

Work quality is a major concern for the SDI marketplace because not all defaults occur during the project operations phase. In fact, some of the largest SDI losses on the books have resulted from defective installations which resulted in substantial "rip and tear" rework claims after the project had already been completed. This is why extended coverage — often referred to as the policy "tail" — becomes such a significant factor in premium calculations. Very often, the contractor who installed the defective work has no capacity to repair or fix the issue without being put into default, resulting in an insurance claim.

Coming up with reliable metrics to predict the quality of a subcontractor's work is actually pretty difficult, but as a best practice, we recommend making sure project history and reference checks are part of the qualification process. Consider prior completed work, internal reviews, frequency and volume of change orders on projects they've performed for you in the past, and follow-ups on recently completed work references. Of course, it's best to perform a thorough de-scope during bidding (especially on complex packages), to review personnel and assess the subcontractor's job experience.

4. Timing: "prequal" is dead

Timing is crucial when qualifying subs, so we think it's time to put the term "prequal" to bed. Carriers want to see that you have a continuous annual qualification process in place, and vetting subs should occur before long before the start of a new project and continue at least once per year, even if the sub is still working. If qualifications become core to your business model, you'll have time to implement an effective risk mitigation strategy and level bids with consideration of the risks subs pose to your projects. If done too late, all leverage is lost, and now you are forced to live with what could be significant risk. Aside from lump-sum projects where awards are strictly based on low bid, it's key to evaluate risk prior to or in parallel with the bidding process.

In addition, "point in time" data like backlog position, financial assets/liabilities, or safety performance can vary greatly on a year to year basis. Using the most up to date information when considering several bids is key towards selecting subcontractors intelligently.

5. Accountability: being consistent

Insurance carriers underwrite prospective clients based on a combination of past performance, key personnel/internal protocols, and market conditions. One of the biggest challenges we've encountered for companies seeking to utilize an SDI policy for the first time is how to create internal protocol for when the award process is handled remotely by project teams.

As a GC entering the SDI space, it's important to consider the following questions:

• What is your internal protocol for reviewing qualification applications?

• Who should review the riskiest subs, and when should these decisions get elevated?

In many cases, centralizing the review process (to a risk management group, a CFO, a controller, etc.) creates a foundation for greater consistency in risk mitigation decisions, less bias or subjectivity, and a clear audit trail of accountability for decisions.

Wrap up

It's important to understand these trends in order to gain favorable treatment from the insurance marketplace. When leveraged into an effective program to manage and mitigate risk, a shared commitment to these five topics can result in a successful SDI program both for you and your carrier.
