

Top 25 U.S. Cities for School Construction Starts

There are 51 metropolitan statistical areas (MSAs) in the United States with population levels above 1 million. Drawing from ConstructConnect's data pool for those 51 cities, Table 1 ranks the Top 25 markets in America for educational facility construction starts last year. (Map 1 showcases the Top 20.)

Leading all cities was the Big Apple, New York, with groundbreakings on school projects valued at \$3.4 billion. In second place, not far behind, was Dallas-Ft. Worth, at \$3.1 billion. The Dallas portion of the \$3.1 billion was two-thirds (67%) and the Fort Worth portion, one-third (33%).

Near the summit of the rankings, also, were: Los Angeles and Houston, each at \$2.6 billion; and Seattle-Tacoma, \$1.6 billion. In the latter dualcity combo, Seattle was 70% and Tacoma 30%. There was another twin city result that was noteworthy. In San Francisco-Oakland (8th spot), the former's piece of the pie was only 37% while the latter's slice was a more taste-satisfying 63%.

Among the 25 MSAs in Table 1, significantly large year-over-year percentage change gains were recorded by: Portland, +202%; Sacramento, +193%; Las Vegas, +129%; Providence, +80%; San Diego, +67%; Cleveland, +59%; and Raleigh, +54%.

While they wouldn't have made it into the Top 25 cities in Table 1, several smaller centers with populations of less than 1 million each also managed high levels of educational facility starts in 2018: Madison, Wisconsin, \$476 million; New Haven, Connecticut, \$464 million; and El Paso, Texas, \$407 million.

Educational facility construction work is carried out at four different levels of learning: 'preschool and elementary'; 'junior and senior high school';

'college and university'; and 'special and vocational schools'. (Schools for the sight and hearing impaired are included among the 'special' category.)

For the entire U.S., 'junior and senior high school' starts accounted for the biggest portion of the total dollar volume of educational facility starts in 2018, at 43%. The shares taken by 'preschool and elementary schools' and 'colleges and universities' were almost the same, 28% and 27% respectively. 'Special and vocational schools' were only a small part of the mix, 2%.

With respect to dollar volumes in 2018 versus 2017, and across the whole nation, 'junior and senior high school' starts were +14.1%; 'preschool and elementary' school starts, +1.8%; 'special and vocational school' starts, -1.8%; and 'college and university' starts, -15.5%.



ConstructConnect announced that January's volume of construction starts, excluding residential work, was \$27.8 billion, a change of -6.7% compared with December 2018's level of \$29.7 billion. The latest month-to-month adjustment was in close alignment with the usual shift in starts volumes between December and January, due to seasonality, of -8.5%.

Nonresidential starts in January 2019 relative to the previous five-year average for January, i.e., from 2014 through 2018, were -4.5%. January 2019 compared with January 2018 was -20.6%. At \$35.0 billion, January 2018 managed an abnormally high volume of starts activity.

The starts figures throughout this report are not seasonally adjusted (NSA). Nor are they altered for inflation. They are expressed in what are termed 'current' as opposed to 'constant' dollars.

'Nonresidential building' plus 'engineering/civil' work accounts for a larger share of total construction than residential activity. The former's combined proportion of total put-in-place construction in the Census Bureau's latest report, for November, was 59%; sion about year-to-date results. But January the latter's was 41%.

ConstructConnect's construction starts are leading indicators for the Census Bureau's capital investment or put-in-place series. Also, the reporting period for starts is usually one month ahead of the reporting period for the investment series. The normal one-month lag in the timing of data releases has currently been stretched out. Census Bureau workers were off the job for 35 days due to the partial shutdown. Now that they have returned to work, the put-in-place numbers have been updated through November, which leaves them two months behind the starts data.

The U.S. construction sector (+52,000 jobs) undertook exceptionally strong hiring in January, according to the latest Employment Situation report from the BLS. The year-over-year change in construction jobs was +4.7%, a faster pace of gain than for any other major industrial subsector. 'Transportation

and warehousing' (+4.1%) firms were next quickest to add staff. By sub-categories of construction work, the year-over-year climb in jobs was +7.2% for both residential and heavy/civil engineering concerns. Nonresidential builders were more restrained, at +2.9%.

Construction's NSA unemployment rate in January was 6.4%, which marked a continuation of tightening (i.e., improvement) versus January 2018's figure of 7.3% and January 2017's 9.4%.

January 2019's year-over-year payroll changes in other pockets of the economy important to construction were as follows: 'machinery and equipment rental,' +6.9%; 'oil and gas extraction,' +6.2%; 'real estate firms,&rsquo, +3.3%; 'architectural and engineering services,&rsquo, +2.5%; 'cement and concrete product manufacturing,&rsquo, +0.9%; and 'building material and supplies dealers,&rsquo, -0.3%.

The month-to-month decline (-6.7%) in total nonresidential starts in January was caused by a fall in industrial (-23.3%) and similarsized drops in institutional (-11.0%) and commercial (-13.3%). Only the heavy engineering type-of-structure category (+9.3%) managed a gain.

The more substantial year-over-year (y/y) decrease (-20.6%) in total nonresidential starts in the latest month (i.e., January 2018 versus January 2017) was due to shortfalls in commercial (-39.7%), heavy engineering (-19.2%), and institutional (-17.3%). Industrial (+125.3%), on the other hand, chose to dance to a different drumbeat and more than doubled

For every month of the year except January, the narrative in this Industry Snapshot report would now move along to a discusis unique in that its individual monthly numbers and its year-to-date (ytd) statistics are exactly the same.

The -23.3% drop in industrial starts m/m in January 2019 was due to the absence of a project as large as Micron Technology's plant expansion in Virginia, estimated at \$3.0 billion, which appeared in December 2018's starts. January 2019 groundbreakings did, however, include several notable industrial projects, led by an ethane exporting facility in Texas, valued at \$1.5 billion. On a v/v basis, January 2019 industrial starts were +125.3%.
