

## EPA Announces \$250 Million WIFIA Loan to Modernize Water Infrastructure in San Francisco Bay Area

At a virtual press conference held earlier this week, the U.S. Environmental Protection Agency's (EPA's) Regional Administrator for the Pacific Southwest, Martha Guzman, announced a \$250 million Water Infrastructure Finance and Innovation Act (WIFIA) loan to the Union Sanitary District in Union City, California. EPA's WIFIA loan will help fund upgrades to the District's aging water infrastructure to provide better wastewater treatment, reduce nutrient discharges to the San Francisco Bay, and increase resiliency to impacts of climate change. In the first year of the Biden-Harris administration, EPA closed 29 WIFIA loans that are investing over \$5 billion in communities across the country to protect public health and the environment while creating over 36,000 jobs.

"Through the WIFIA program, we are improving California's water infrastructure to better deliver safe drinking water, protect our natural resources, and build stronger, more resilient local economies," said Martha Guzman, EPA's Regional Administrator for the Pacific Southwest. "We are happy to support Union Sanitary District and their project, which will help protect our cherished San Francisco Bay, and we look forward to accelerating investments in water infrastructure under the Bipartisan Infrastructure Law."

Union Sanitary District operates a 33-acre wastewater treatment facility that serves over 357,000 customers in Fremont, Newark, and Union City. The District's Enhanced Treatment and Site Upgrade Phase 1 Projects will support implementation of the San Francisco Bay Nutrient Management Strategy by improving treatment quality for up to 33 million gallons of wastewater per day. The project will reduce 50 percent of the facility's nitrogen discharges and 90 percent of its ammonia discharges to the San Francisco Bay on an annual basis. In addition to improving water quality in the Bay, the projects are also designed to bolster the facility's resilience to wet weather events and the impacts of climate change.

"This federal support is the financial cornerstone of USD's Enhanced Treatment and Site Upgrade (ETSU) Phase 1 program, a multi-year improvement project that provides significant engineering, operational, and environmental benefits," said General Manager Paul Eldredge. "USD is proud to collaborate with the EPA to proactively improve water quality in the San Francisco Bay through enhanced wastewater treatment processes



and nutrient removal as we renew and replace aging infrastructure for the 21st century. The EPA's low-cost financing will help ensure modernized, reliable, cost-effective service to customers and will deliver benefits to the San Francisco Bay Area for many years to come."

"I greatly appreciate our Board of Directors' foresight regarding the District's infrastructure planning as we carefully developed a long-term strategy to meet today's challenges while preparing for Fremont, Newark, and Union City's wastewater needs for the next 40 years," said Eldredge. "The Board's guidance and counsel are vital as we move forward with ETSU's essential projects."

With EPA's WIFIA loan, the Union Sanitary District will save approximately \$50 million over the life of the project, which will support regional efforts to protect water quality in the San Francisco Bay. Project construction and operation are expected to create an estimated 1,630 jobs and construction is expected to be completed in 2028.

"Federal support will help Union Sanitary improve water quality for thousands of Californians living in the Bay Area," Senator Alex Padilla said. "I have been proud to support this project, as it's a necessary investment in important regional infrastructure."

"For decades, the Union Sanitary District has provided first-rate wastewater collection, treatment, and disposal services throughout California's 15th Congressional District and the Eastern Bay," said Congressman Eric Swalwell. "I was proud to help support their application for a Water Infrastructure Finance and Innovation Act loan to support its Enhanced Treatment and Site Upgrade

program that will upgrade and replace critical infrastructure, help manage the effects of a changing environment, and create jobs."

President Biden's leadership and bipartisan Congressional action have delivered the single-largest investment in U.S. water infrastructure ever. The Bipartisan Infrastructure Law invests more than \$50 billion through EPA's highly successful water infrastructure programs. With this funding and EPA's WIFIA loans, states, Tribes, and localities have a once-in-a-lifetime opportunity to strengthen and rebuild America's water infrastructure. EPA will ensure that all communities get their fair share of this federal water infrastructure investment—especially disadvantaged communities. This funding will put Americans to work in good-paying jobs and support a thriving economy.

### Background

Established by the Water Infrastructure Finance and Innovation Act of 2014, the WIFIA program is a federal loan and guarantee program administered by EPA. WIFIA's aim is to accelerate investment in the nation's water infrastructure by providing long-term, low-cost supplemental credit assistance for regionally and nationally significant projects.

The WIFIA program has an active pipeline of pending applications for projects that will result in billions of dollars in water infrastructure investment and thousands of jobs.

Also, construction brands need to develop a distinctive identity that will highlight their product, reliability, service quality, value, delivery time, warranties, and service offerings to stay competitive.

### Investment in Facilities and Technology

There is increasing digitization and tech deployment is happening in construction firms at a rapid pace. The construction site is more likely to become capital-intensive in the future and robotics, drones, advanced automation equipment,

and research and development (R&D) spending is likely to go on increasing. This will surely lead to the development of innovative, new products and give a boost to the increasing adoption of newer technologies to shape the more productized construction firms.

### Increasing Need for Specialization

Construction firms will invest heavily in innovation and on new facilities, including new materials and technology on a much larger scale than what it is today. A higher degree of repeatability and standardization is being forecasted if builders are looking to scale their businesses. This will lead to greater consolidation with higher standardization and the need for specialization when it comes to construction offerings.

house. This will compel players to invest more in human resources and will need to have dedicated digital talent that will raise excitement about future business models. The next normal in construction expertise will force employers to invest and attract diverse players to deal with future challenges.

### Product-Based Approach

The future will witness an increasing need for services and structures that will market standardized products. Construction will be no different and modular construction where components will be produced in off-site factories and designs becoming more customizable, one can imagine a totally different approach to construction, and it will certainly be more product-based.

### Way Forward

The next normal in construction is all about developing smart strategies for construction to deal with the disruption ahead. It is all about planning for the shifts that are happening and review the value chain so that construction managers know how to play and defend their core business.

Construction firms must fundamentally be prepared to reinvent themselves as they start operating in a new setup. Moreover, they will have to defend their core business and embrace construction technology to become agile and enablers to evolve in the face of transformation.

So, contractors that familiarize themselves with the next normal will maintain a competitive edge as they will be prepared with better solutions. Hence construction businesses must begin optimizing logistics, strengthening customer relationships to be better positioned at creating value, and focus on supply chain capabilities.

To successfully ride the wave called next normal, construction players must use foresight to anticipate significant shifts to generate above-market returns. All drivers namely, digitalization, industrialization, and globalization are hitting construction at the same time. Thus, agile moves and bold steps to maneuver sequential waves demand an action-based approach for incumbents to stay on top of the competition.

In the face of this transformation, it is best to understand what will affect the bargaining power of construction firms and have a contingency plan in place by observing trends. The process has already begun, and wheels are set in motion but the question before construction firms is if they are ready to take sizeable risks and embrace the next normal.

## Sierra College's New Instructional Building Progresses in 2022 with Ceremonial Beam Signing Modern and Comfortable Classrooms Made Possible by Measure E

On Tuesday, January 18th, Sierra College held a ceremonial beam signing for its New Instructional Building which broke ground last fall on the Rocklin campus. This new three-story classroom building, scheduled to open in Fall 2023, will replace and consolidate classrooms from several smaller inefficient buildings into one larger efficient building with modern and comfortable classrooms and gathering places.

Sierra College President/Superintendent Willy Duncan, together with Sierra College Board of Trustees President Carol Garcia and Board of Trustees members Bob Romness and Scott Leslie, welcomed the campus community to join them in signing the beam. The beam will be placed in the building's framework later this year.

When complete, the New Instructional Building will provide approximately 75,000 gross square feet of classrooms, teaching laboratories, and office space.

The new building will be located directly north of Weaver Hall and west of the new parking garage on the northern edge of the Rocklin campus.

This project is funded by Measure E, which was approved by voters in 2018. Measure E is a demonstration in the vote of confidence in the future of the community, and the future of Sierra College. Sierra College is using the funds provided with Measure E as a base and, along with state facilities bond funds, and other funds from our strong fiscal management updating our campus with new facilities to keep pace with the workforce training and education needs of our community.

Sierra College improvement projects made possible by Measure E include the recently completed Parking Garage with 1,501 parking spaces, and the Student Union Kitchen Renovation.
