

Construction Adds 15K Jobs in June403403

The construction industry added 15,000 jobs on net in June, according to an Associated Builders and Contractors analysis of data released by the U.S. Bureau of Labor Statistics. On a year-over-year basis, industry employment has increased by 121,000 jobs, or 1.5%.

Nonresidential construction employment expanded by 9,200 positions on net, with growth

registered in just 1 of 3 major subcategories. Nonresidential specialty trade added 12,400 jobs, while heavy and civil engineering and nonresidential building lost 2,800 and 400 jobs, respectively.

The construction unemployment rate fell to 3.4% last month. Unemployment across all industries declined from 4.2% in May to 4.1% in June.

"Virtually every economist has been waiting for indications of stagflation," said ABC Chief Economist Anirban Basu. "The wait continues. June's employment report, coupled with recent inflation data, indicate that the U.S. economy continues to demonstrate solid momentum, stable unemployment and declining inflation. Construction added jobs for a second consecutive month.

"While many will cheer this jobs report, some construction firm leaders may not be among that group," said Basu. "While abating fears of recession are comforting, these data effectively slammed the door shut on a July Federal Reserve interest rate cut. A growing fraction of contractors is experiencing weakness in backlog as projects are postponed in an uncertain economic environment coupled with stubbornly elevated borrowing costs.

"At the same time, construction materials prices have begun to edge higher, in part because of substantial tariffs on steel, aluminum, Canada, Mexico and China," said Basu. "All things equal, that will drive up construction delivery costs, render more projects uneconomical and diminish contractor margins. Shifting immigration policy stands to reinforce these dynamics. Close attention should be paid to the profit margins component of ABC's Construction Confidence Index in the coming months, which should reflect how these higher costs are affecting contractor operations."

Reined in by cost and a hostile president, California ponders next move to clean its air pollution

At an electric vehicle showcase in Anaheim, Christopher Grundler — one of the top executives in California responsible for cleaning the air — said despite all the setbacks his agency has faced this year, he's confident the state can keep making progress.

"This president, this Congress, will not kill the electric car," said Grundler, a deputy executive officer of the state Air Resources Board. "They won't kill the electric truck, and they certainly won't kill the California spirit."

Despite that optimism, California officials — now reined in by the Trump administration and growing concerns about affordability and costs — are struggling to come up with new ways to clean up the nation's most polluted air.

Lacking federal permission to set aggressive emission standards for the first time in almost 60 years, California may be left mainly with voluntary agreements with the auto, trucking and rail industries, and subsidies to entice consumers into buying electric vehicles.

Congress last month revoked the state's authority to implement three landmark rules that ban sales of new gas-powered cars by 2035 and phase out diesel trucks. In addition, California was forced to abandon four other ambitious rules for zeroemission trucks, locomotives and commercial harbor craft because the Trump administration's Environmental Protection Agency would be unlikely to grant waivers.

Those seven mandates, now unenforceable, were key to cleaning up the pollutants that leave about 34 million Californians regularly breathing unhealthy air. In another blow to California's efforts, Congress and President Donald Trump eliminated tax credits for consumers who buy electric cars.

At the same time, California's air quality rules are facing growing pushback from the public, industry — and even some Democrats in the Legislature — because of the impacts on gas prices and other economic concerns.

Air Resources Board Chair Liane Randolph, in an interview with CalMatters, did not offer any

details on how the agency will make up for the voluminous tons of smog-causing gases and soot those rules would have eliminated.

"There's no one strategy that's going to work. It's really going to need to be a suite of different things," Randolph said. The governor and Legislature will help decide "what strategies are going to be the most effective, the most cost effective, the most likely to be able to scale up," she said.

The air board is hosting four meetings in the coming weeks to hear ideas from industry groups, environmentalists and community members about how the state should now approach clean air regulation.

In an executive order last month, Gov. Gavin Newsom directed the air board to develop a new zero-emission car mandate — apparently in preparation for when the state either wins its lawsuit against Trump or when he leaves office.

Newsom also ordered the air board to develop a plan by Aug. 11 to keep expanding California's market for electric cars and trucks. As part of the plan, the state agency must consider ways to improve charging infrastructure and offer incentives. "We know that the federal government is going to be completely useless in our efforts to clean the air, despite rhetoric claiming they care about clean air. State and local governments are going to have to do more," said Adrian Martinez, an attorney with the San Francisco-based environmental group Earthjustice.

"We just have to go it alone."

Heart and lungs at stake

It's been a long, bumpy road to cleaning up exhaust from California's 36 million vehicles. Gaspowered cars and diesel trucks remain the state's largest sources of smog and soot despite decades of cutting emissions.

Much of that pollution is inhaled by the most vulnerable Black and brown communities near ports, highways and warehouses, particularly in Southern California. Ozone, a smog-causing gas, and fine particles of soot are linked to premature deaths from heart attacks and respiratory diseases, and increased emergency room visits.

Mayor Bass Joins City Attorney To Announce Legal Action Against Unlawful Raids in LA

Mayor Karen Bass joined LA City Attorney Hydee Feldstein Soto and regional mayors in Los Angeles County to announce new legal action that the City will take to put a stop to the unconstitutional reckless raids in the LA region.

"The Administration is treating Los Angeles as a test case for how far it can go in driving its political agenda forward while pushing the Constitution aside," said Mayor Bass. "The City of Los Angeles, along with the County, cities, organizations and Angelenos across L.A., is taking the Administration to court to stop its clear violation of the United States Constitution and federal law. We will not be intimidated - we are making Los Angeles the example of how people who believe in American values will stand together and stand united.'

"The federal government has concentrated thousands of armed immigration agents, many of whom lack visible identification, and military troops in our communities, conducting unconstitutional raids, roundups and anonymous detentions, sowing fear and chaos among our residents," said Los Angeles City Attorney Hydee Feldstein Soto. "Today's motion to intervene shows we will not stand by and allow these raids to continue or to become the standard operating procedure in our communities.

Central to this effort is a request to intervene in a class action lawsuit "Perdomo v. Noem," which was brought on behalf of people who have been unlawfully stopped or detained by federal agents. The lawsuit alleges that federal agencies, including U.S. Immigration and Customs Enforcement and U.S. Customs and Border Protection have engaged in unconstitutional and unlawful immigration raids by targeting Angelenos based on their perceived race and ethnicity

and also denying detainees constitutionallymandated due process.

Today's announcement comes after federal agents marched through MacArthur Park and militarized vehicles were deployed to the streets as children were attending a summer camp with the seemingly sole purpose of bringing fear to Los Angeles. Mayor Bass and other elected officials will not accept the presence of federalized troops and military-style vehicles on our streets becoming normalized behavior, and will use every resource available to bring an end to these reckless raids.

Floods Are Increasingly Common. Our Water Infrastructure Is Unprepared

The deadly floods in Central Texas, which had killed more than 100 people as of Tuesday afternoon, have become a flashpoint for discussions of government preparedness for flood emergencies. Kerr County abandoned efforts to build a more robust warning system, reportedly due to budget issues; officials also appear not to have issued evacuation orders at the start of the flood.

But one expert tells Governing that local officials across the country should also be using this moment to reflect on the need for updated water infrastructure, the first line of defense for communities experiencing extreme rain events.

A 2024 report from the American Society of Civil Engineers and the Value of Water Campaign estimated that the country is billions of dollars short in investments needed to update water infrastructure for 21st-century needs, including a new normal of extreme rainfall events.

Floods are the most common and expensive natural disaster, and the warmest years since record keeping began in 1850 are all in the last decade. Warmer air holds more moisture; higher temperatures increase evaporation.

Emily Simonson directs the Value of Water Campaign for the U.S. Water Alliance, a nonprofit organization that focuses on water challenges.

Water leaders are in Pittsburgh this week for the One Water Summit. The event gathers some of the brightest minds across disciplines and communities working to elevate needs, spread what works, and test new approaches, Simonson says. The Texas disaster will be top of mind for attendees. Simonson spoke to Governing from Pittsburgh about the importance of keeping focus on infrastructure needs amid post-event controversies. The conversation has been edited for length and clarity.

What do you hope people will take away from recent events?

Tragedies like these are moments where you want to not just ask what we can do better but to actually see lessons learned and implemented. We need to have that conversation in a way that can bring people together to get it done, rather than turn this into me versus you, Republican versus Democrat.

In our 2025 polling, we were surprised to see that 1 in 5 Americans reported experiencing an extreme weather event that affected them in a water-related way in the past five years.


We also asked whether they were concerned about weather-related water impacts in the future. Seventy-four percent of voters — red, blue, women, men, rural, urban — said yes, they are concerned. And 70 percent believe that it's extremely important for the federal government to reduce the likelihood of water challenges in future national disasters.

Water is often out of sight, out of mind until something goes wrong, until your basement floods, a water main breaks, until you get a "boil water" alert on your phone. Despite similar levels of need and complexity — perhaps even greater complexity — water receives so much less funding than things that we do see: roads and bridges, just to name a few.

Utility Water and Wastewater Needs and Requirements (billons of dollars)

A March 2025 McKinsey analysis found that the gap between the funds available to upgrade aging infrastructure and the need could almost double by 2030, from \$110 to \$194 billion. It's unknown at present how much shifts in federal funding, including decisions not to disburse Bipartisan Infrastructure Law allocations, might affect these numbers.

Available Funding Funding Required



There is a catch phrase in the community of people who are responsible for thinking about water, wastewater, stormwater and floods on a day-to-day basis. The shorthand is "value of water."

The Value of Water Campaign seeks to build public and political will [for more investment] by elevating the needs and the consequences if we don't invest, if we don't get serious about water challenges.

Some pots of funding that were appropriated in the Infrastructure Investment and Jobs Act (IIJA) have been targeted to be cut, and there are legal fights about whether that's allowed. But the primary programs that fund water and wastewater infrastructure were not affected by those attempted clawbacks.

But once that funding is gone, there's a huge cliff if Congress doesn't appropriate more. At the time that the IIJA passed, it was only about 5 percent of the federal funding we need to keep water systems in a good state of repair.
