# How to Build an Effective Multi-Channel Marketing Strategy

One of the biggest challenges building product manufacturers struggle with is having an effective, multi-channel marketing strategy. The complexity of the commercial construction industry has been underestimated as far back as I can recall and seems to be multiplying. For BPMs, the complexity is the highest it's ever been. For most BPMs to realize sustained success, creating and maintaining a combination of strategic and tactical approaches with the entire building team is essential.

Building product manufacturers can vary significantly in their products. However, no matter what you make, or the size of your revenue footprint, there are shared fundamentals relevant to all BPMs. We share the same disciplines: engineering, IT, HR, finance, manufacturing, distribution, procurement, marketing, sales, etc. The two disciplines that we will focus on in the next two installments of this series are marketing and sales and how data analytics can improve those areas

Marketing: The marketing function is probably one of the most misunderstood and underdeveloped in the BPM space. Given that most of us work in small to medium-sized companies, resources are precious, yet, for some reason, the marketing department often becomes something less than it should be, only limited to graphic design, website maintenance, etc.


In the academic sense, marketing should be the strategic conscience of the BPM enterprise, leading the way in market analysis and research, identification of sales channels and processes, product development, maintenance/management, branding, and communications. The most incredible tool in the marketing department is continuous market analysis of their products.

Market Analysis: Market analysis is critical in assessing the potential market size for the manufacturer's current and future products, setting baseline models for market penetration, sales and sales partner allocation, and performance measurement. This assessment is done by using quantitative and qualitative data types.

Simply defined, the quantitative data set will tell us how much, how many, and the level of frequency or how often, and the qualitative data set will provide us with the who, what, and where. (Gener-

ally speaking, if it's a number, it is quantitative, and if it's a noun, a person, place, or thing, it's qualitative. Knowing these two terms can set us up to build our models.)

### The Value of Having Quantitative Data—Analyzed Thoroughly

For this segment, I will focus on the value of quantitative data, how to acquire it, and build applicable models for your company. You can chart trends, yours and the industry's, with the right data product. Also, with the right quantitative data product, we can assess sales potential.

A priority is to determine your place in the industry. To assess sales trends as compared to the industry, your sales data needs to be compared in either monetary value or another unit of measurement, such as linear feet or weight. (Most manufacturers use dollars since we generally do not record sales in the other units of measurement. The key is consistency and availability in which unit types are used.)

External data sources are necessary to compare our sales to the broader construction industry metrics and market and will be needed for quantitative and qualitative analysis. For our first focus of performing quantitative analysis, we have choices of data series, the most popular being: 1. Construction Starts, and 2. Construction Put in Place.

Construction Starts (quantitative data): The definition of a construction start is when the shovel is in the ground and foundations are ready to be poured. This data is represented in the number of units, value, and square footage, and is segmented by project type, this data is available from ContructConnect.

Construction Put in Place (quantitative data): is an estimate of projects that are assumed to be completed. Like ConstructConnect's Starts series, the ConstructConnect PIP data covers the United States from the national level down to the state and county levels, which widens geographic analysis possibilities over the U.S. Census Bureau data, which only has minimal geographic pliability. PIP products can be acquired through ConstructConnect, the U.S. Census Bureau, and others.

There are advantages of starts data over PIP data for the BPM. Contrary to PIP, starts data provides the BPM with many more strategic forecasting options. Given that a construction start can be recorded many months to even years before breaking ground (and depending on the project type and size), this data series can be used to measure product potential or demand, market share, and sales performance down to sales regions and territories, because it is available at the county level.

## 6 Key Marketing Strategies for Specialty Contractors

Most small specialty contractors have 'bootstrapped' themselves up in the industry, often learning their trade on the job before branching out on their own. That means they often tackle their own marketing programs.

Consider these six ways to get your name out and business coming in.

### 1. Do The Website Thing (but make it professional)

Nine in 10 people research products and services online. Three-quarters of B2B buyers rely on internet searches in the early stages of shopping for business products and services. As the pandemic drags on and people avoid face-to-face interactions, the internet is likely to figure even more prominently in the sales cycle.

Regardless of how your website fits into your marketing, consider using complementary technologies during the pandemic.

For most specialty contractors, a website serves as their brochure. It features some of their completed projects and provides information about the company. Maintain a professional site to get the most from your effort. Use top quality photos and text, post blog posts regularly, follow page speed guidelines, and use designs that work on all screens.

Don't forget to make it friendly for local search by setting up a Google My Business profile. This is especially important for contractors serving consumer markets. For instance, specialty trade contractors work in local markets, and 86% of consumers find local businesses on the internet.

If you work for general contractors or owners and want your website to work harder, plan on getting help or fast-tracking an in-house webmaster. Trade contractor transactions are much larger than those for consumer purchases, so your website needs to look the part.

The average online B2B purchase is between \$9,000 and \$31,000, while the average online consumer purchase—between \$47 and \$57. B2B transactions also require multiple decision-makers. If you want your website to land you new business, you need an informed investment in content marketing and active efforts in analytics.

Regardless of how your website fits into your marketing, consider using complementary technologies during the pandemic. Quick-start video meetings mean you can take a phone call and switch to a

Note that because of the lag in time between a start and the project being put in place (or as turn-key, handed over to the owner), the starts series can also forecast raw material purchases, head-count, and inventory. Starts combined with other supply chain applications are helpful for application in sales & operations planning exercises.

### **Quantitative Analysis Interpreting Sales Vs. Industry Trend**

As I stated before, many of the manufacturers that I have worked with over the years do not even use analytics at its most rudimentary level, but why? Is this because they do not understand or appreciate the significance of knowing market share? Is this because they do not have or know how to acquire the tools and data to complete their market share analysis?

We need to know how we are tracking according to trends in our industry:

- Are sales of my products keeping with an upward trend?
- Can we explain our slowed sales due to an overall industry downward trend?


Equally important is knowing what percent of the industry sales is owned by us versus our competitors. In marketing and sales, our initial BPM question is, "How are we tracking in the U.S. construction industry?" Below, I cite a case study to exemplify the importance and help understand market analysis to determine our position within the industry trend. It is not just watching sales revenue increase year after year.

### A Case Study with Actionable Examples

As a prior BPM executive, my company had historically enjoyed a dominant position in the single-product hardware category. Our growth in the ten years from 1990 to 2000 increased some 13%. If you are old enough to remember or studied economics in college, the decade of the 1990s was one of the most significant economic expansions in U.S. history.

We were proudly standing tall after a decade of double-digit growth. Still, upon my deeper analysis, using construction starts data to peg how we were doing against our industry, I discovered we had lost a significant share, mainly at the tail end of the decade, as illustrated in the chart on page #1.

This realization led us to find out why: In surveying our distributor customers, we learned they were still using our product on new construction because we dominated the specification market, but, due to the price sensitivity in the renovation and retrofit market, we had lost most of our share to less expensive imports.



With this answer, we decided to create a new, lower-cost product under a different brand so as not to cannibalize our specified flagship brand. Not utilizing analytic modeling, we only saw our increasing and upward trend in sales revenue. To summarize, we are flying blind without industry analytics, and with it, we find the commercial truth to take corrective action.

It is simple to perform the market analysis as was done in this case study. You need only three things.

- Sales data for the products that you plan to analyze
- Third-party industry starts data to compare your sales to current and future market conditions
- A tool, like Excel or Access, for more custom analysis beyond what the data vendor or provider includes in a subscription

To begin your company's quantitative analysis, my recommendation would be an investment in a starts series like ConstructConnect Forecast. Starts will provide your enterprise with the most scalable measurement and forecasting options. (Remember, PIP data does not allow for effective cross-disciplinary planning and forecasting exercises such as Raw material procurement head-count/labor/inventory levels.)

In the prior "Product Sales Trend vs. Industry" graph, you can see how, with just some data, you can position your company going forward or track your company on a comparative level with trends and competitors.

Quantitative Analysis for Sales Personnel Assignment and Performance Measurement

In addition to these marketing and operations functions, quantitative analytics can be invaluable to those in sales leadership functions. The quantitative trend analysis is undoubtedly a statement of a macro level sales performance. Still, to improve, it is important to identify the sales strengths and weaknesses.

For example, we see high sales dollars with one sales rep in a region. This result is a good starting point. Is it because of the rep's personality and sales approaches? Is it because of extra overtime and effort? Or could it be the salesperson is working in a territory with more sales potential than one representative can cover, a shooting fish in a barrel scenario?

video call almost immediately. Build a library of short videos showing you and your crews in action so people can see your skills. Do an explainer blog post or video covering the essential steps in each of the services you offer.

### 2. Networking is Still Alive and Well in Construction

You know people who know other people. Don't overlook those valuable connections. Whether you assist your brother-in-law on a home improvement project or give your neighbor some friendly advice about handling a DIY problem, you are actually networking. And sometimes, a little time spent helping those you know can bring in new business from people they know.

Next, think about local designers and architects. If your local area has an American Institute of Architects chapter, check if they welcome guest speakers. You can then talk about your specialty from a design perspective. Many architects and designers never worked on the 'doing' side, so your view on bringing design to life can shed some light on the construction process. With these meetings now going virtual, you can do this without leaving the house or office.

Set up your own virtual, after-work event for relaxation and socializing. These times require fresh approaches to the everyday things we've often taken for granted.

### 3. Sign up With the Local Builders Exchange

Many communities have a Virtual Builders Exchange featuring construction news and construction opportunities. The firm's staff locates, verifies and tracks local construction. The company claims that 90% of the membership renews every year.

### 4. Introduce Yourself to Local Government

While local governments expect to be challenged for funding in the coming months because of tax revenue losses from the pandemic, many aspects of municipal and county management require ongoing maintenance and repairs. Specialty trade contractors have just the skills they need. While stopping by the offices might be discouraged, you could do a mailing or phone call inviting the right person to a virtual meeting.

Local governments are also looking for solutions to problems caused by the pandemic. Cooperative purchase agreements let local governments piggyback their contracts, and you'll find these purchasing vehicles active in many states. Getting on board could give you a springboard to

serving a wider geographical area and potentially a share of government business.

### 5. Share Your Expertise Publicly

Specialty contractors have the knowledge that the public craves, and serving up some of your expertise on local radio or podcasts can get your name in front of a large audience. You can escape dealing with the technical aspects by getting on shows that have an interview format.

### 6. Try Online Ads

If you've spent the time and money to get your website set up right, having it keyword optimized and tapping into local search, it might be time to try some advertising.

A well set up and well managed Google Ads campaign averages a return of \$2 for every \$1 spent. Facebook ads are also a top choice. Facebook clicks are cheaper and can yield impressive results if done correctly. How does a \$4 return for every \$1 spent sound?

- Begin with the basics. Start with the first step in your action plan. When bidding work to drawings and specifications, give the customer what they want. This will come in the form of a base bid. - Offer value engineering services. As specialty subcontractors, we all have unique experiences under our belt. We're equipped with the knowledge of the tricks of the trade. It's our responsibility to help general contractors through the building process every step of the way.

### The Heat Is On -Construction and Global Warming

Every year, NASA and the National Oceanic and Atmospheric Administration (NOAA) team up to assess global temperatures and climate trends. (Yes, that NASA. A big part of the space agency's mission is focused on Earth science, with the goal of better understanding the planet's interconnected systems.) The two groups released their findings for 2021 this past January, with several predictably alarming highlights:

- 2021 was the sixth-warmest year on record, with the average global surface temperature about 1.5°F over the 20th-century baseline periods that the agencies use for comparison and nearly 2°F higher than in the late-19th century.
- The surface temperature in the Northern Hemisphere was also the sixth-highest on record, at nearly 2°F over baseline, with the land temperature exceeding the baseline by 2.8°F.
- Extreme climate events included an aboveaverage Atlantic hurricane season, with 21 storms, and a severe heat wave in the northwestern United States and western Canada in June during which Canada recorded its highest temperature ever, at 121°F.

### **Summer in the City**

One of the results of these developments is the "urban heat island effect"—a phenomenon that directly affects construction professionals working in heavily built-up and populated areas during warmer months. "Cities and urbanized areas that we might not even classify as cities tend to be warmer than surrounding rural areas that have less built materials—roads and buildings, pavement, asphalt, sidewalks," says Christian Braneon, a climate scientist and civil engineer with the Climate Impacts Group at NASA's Goddard Institute for Space Studies.

"That's because these built materials are impervious; they don't allow water to infiltrate them," Braneon says. "A lot of times, these materials end up paving over vegetation, or the creation of these materials involves removing vegetation. As a result, they're absorbing energy from the sun during the day, and then they're releasing that energy all the time. During the day, at night—they're releasing heat that warms the local air temperature."

With cities and metropolitan areas becoming larger and more densely populated across the country and around the world, the urban heat island effect will only become more pronounced. "A lot of folks don't realize that extreme heat is actually the deadliest weather hazard in the United States," Braneon says. "More people will die due to extreme heat than due to flooding or tornadoes each year."

### **Lowering the Temperature**

Braneon sees direct implications for several aspects of the construction industry, including worker safety and performance, equipment and materials. By being aware of them, companies can plan projects accordingly—and even become part of the solution.

Worker safety and performance: Prepare not just for hotter weather but for hotter weather that lasts longer—a five-day heat wave instead of a two-day heat wave. "There are going to be project delays because workers are experiencing heat stress," Braneon says. "It's been well-documented that there have been deaths in the construction industry due to heat stress. This is going to be a huge issue for companies at all levels, and frankly may involve litigation and insurance ramifications."
