

## Bad Start to Small Business Week



### NATIONAL SMALL BUSINESS WEEK

May 5 – 11, 2019



The workweek part of the U.S. Small Business Administration's National Small Business Week, May 5-11, is off to a rocky start today in California thanks in part to a 9th U.S. Circuit Court of Appeals decision handed down Thursday in San Francisco.

"What California is doing to its small businesses can only be great news for Arizona, Idaho, and Nevada, which truly believe in the importance of Main Street enterprises and have policies aimed at welcoming our state's mom-and-pop firms," said John Kabateck, California state director for NFIB, America's leading small-business association.

Kabateck listed four, big issues California is hurting itself with that are doing, or will soon do, the most damage.

**Independent Contractors**—In a matter that should have been handled legislatively, not judicially, the California Supreme Court's Dynamex decision last year has now imperiled the working fate of two million Californians who freely choose to be their own bosses offering their services on their own terms. Thursday's federal court decision making Dynamex retroactive now muddies the waters more. "If it weren't a bad decision there wouldn't be legislative efforts trying to blunt the force of Dynamex," said Kabateck, who pointed to Assembly Bill 5 as the example.

**Consumer Privacy Act**—Passed with great fanfare last year and signed by former Gov. Jerry Brown,

the California Consumer Privacy Act was another initiative hurried into law without proper consideration and debate about all of its potential consequences. Coming into the CCPA's crosshairs, when it takes effect next year, will be tens of thousands of small businesses that have been able to use their scarce resources to advertise their goods and services on the internet. Senate Bill 561, if it passes, would exacerbate the situation by permitting lawsuits for any violation of the CCPA, eliminate the 30-day time period businesses have to fix a CCPA violation before a lawsuit could be filed, and would prohibit small businesses from seeking guidance on the Act from the attorney general. That's why small businesses are supporting Senate Bill 753, an ameliorative measure that ensures the goals of the CCPA are kept without its needlessly punishing effects.

**Sales Tax on Services**—The services of everyone from your doctor, dentist, gardener, barber, beautician, and other occupations would now come under a sales tax just like your groceries and other tangible goods are. Senate Bill 522 purports to "realign the state's outdated tax code with the realities of California's 21st century economy." But in reality, the measure will have an inflationary effect, drive business to border states that have no sales tax (Oregon) or lower rates. If passed, SB 522 would become law immediately.

**Split Roll Property Taxes**—A 2020 ballot initiative overhauling the split roll property tax system created by Proposition 13 would allow the state to start boosting rates on business property. This

would be a disaster not only for small business startups but also for small businesses currently benefiting from low rental rates.

"It's a fair question to ask why our economy, particularly our small business economy, is the hottest it's ever been, setting record highs in everything from job openings to employee compensation, if things are so bad for small business in California," said Kabateck. "The answer is we have – gratefully! – a Congress that doesn't think and act the way California's Legislature and judiciary do. It knows and appreciates the centrality of small businesses to the nation's economy and believes in nurturing that centrality with laws like the Tax Cuts and Jobs Act. Smarter states are looking at ways to leverage the benefits of the TCJA with policies that can sustain all the good it has wrought. Not California. We believe it's more fun to step on Superman's cape than to let him soar to the aid of others."



# 5 concrete innovations that will rock your future projects

Concrete — a material that can be traced back over 2,000 years — still remains the most popular choice for builders today. But if you think you've seen it all when it comes to concrete products, think again. From self-healing to Martian, we've gathered five innovative concrete technologies with the potential to completely transform the construction industry.

## 1. Self-healing concrete

No matter how carefully it's mixed or reinforced, all concrete eventually cracks — and those cracks can lead to collapses. That's why scientists at the Delft University of Technology invented bioconcrete, a concrete that uses bacteria to heal itself. The bacteria generate crystals that enclose their cells, and when mixed with other secretions (like proteins and sugar), they generate a glue-like substance. If the concrete cracks, the bacteria seal any gaps by forming either limestone or calcite.

It's still in the research and trial phases, but the market for self-healing concrete has already been forecasted to reach \$1,375 billion globally by 2025.

## 2. 3D-printed concrete

Recent developments in 3D printing have showcased an untapped potential to build affordable communities. Today, 3D-printed concrete can be

used to quickly produce homes for the displaced or homeless, and the technology can often handle geometries that traditional construction techniques can't.

3D printing concrete also gives builders more creative freedom: projects ranging from a backyard castle to a house built in just 24 hours have already been constructed using the technology.

## 3. Eco-friendly concrete

Traditional concrete is not an environmentally friendly material to make or use. However, scientists at London-based Novacem claim to have developed a new, more eco-friendly form of concrete using magnesium sulfate, which requires much less heating than typical concrete components. While concrete usually generates a large amount of carbon, Novacem claims that their concrete actually absorbs CO<sub>2</sub> as it hardens.

This development could have a huge impact once it hits the market, especially as the demand for sustainable building materials continues to grow.

## 4. Pervious concrete

Another eco-friendly concrete solution gaining traction within the construction industry is pervious concrete. Traditionally, concrete is impervious (meaning water runs off of it), requiring architects to direct its flow in focused ways. Design flaws and unanticipated weather patterns have unfortunately led to many cases of urban flooding, erosion, pollution, and other serious ecological issues.

Sometimes called porous pavement, pervious concrete is made of larger particles than traditional concrete. The larger particles create voids within the concrete that allow for the gradual infiltration of rainwater into the ground below, providing a safer and more environmentally friendly alternative.

## 5. Martian concrete

Though it sounds like the stuff of science fiction, this concrete is real (and it may even be the best building material in the Solar System).

In response to scientific interest in building on Mars, a research team at Northwestern University created a form of concrete that can be made with materials native to the Red Planet. The team tackled the challenge of limited water by turning instead to sulfur: it's readily accessible on Mars, and when heated to 240 degrees Celsius, it melts into a liquid. At twice the strength of traditional concrete, their creation is also durable enough to withstand meteorite impacts — a key element needed to create viable shelters for humans.

## Wrap-up

These innovations are just a few being tested by research teams today. Concrete has been evolving for more than 2,000 years, and we can't wait to see how it continues to transform in the years to come.
