What Construction Workers Could Teach Other Industries About Mental Health Awareness

In the 14 years since I started my career as a psychotherapist, I've seen some shifts in the way society views mental health. Slowly, the stigma attached to mental illness seems to be decreasing. And each year during the month of May-Mental Health Awareness Month-I'm always happy to learn about organizations and industries who are working hard to promote workplace mental health.

Although the construction industry may be about the last place you'd expect workers to talk about depression or anxiety, they're becoming industry leaders in mental health awareness. They're doing some incredible work to reduce the stigma attached to mental health and they're saving lives.

The Construction Industry Recognized the Need

A lot of talk about workplace mental health focuses on office workers. There's a notion that employees who bring their work home with them might be at a greater risk of mental health problems, burnout, and high stress levels.

But stress affects more than just the high salaried executives. The working conditions for many blue collar workers also contributes to mental health problems.

Recently, the construction industry took notice. They realized that their workers weren't just at a high risk of mental health problems, but they're also at a high risk of suicide.

Here are the facts:

- · Construction jobs are still made up predominantly of young males. Suicide is the second leading cause of death for men in the United States between the ages of 25 and 54.
- Men in high stakes and high skill occupations are almost 1.5 times more likely to die by sui-
- People in occupations that don't require any education after high school are at a higher risk of suicide.

Of course, the culture that exists in most construction companies doesn't lend itself to talking about feelings either. Many construction workers pride themselves on being tough, which prevents them from admitting there's a problem and stops them from seeking help.

Seasonal unemployment, long hours, and exhaustion can also trigger mental health issues. Unfortunately, many workers go undiagnosed and untreated, making the construction industry in the top nine occupations at risk for suicide.

What the Construction Industry is Doing

The Construction Industry Blueprint was created to help managers put protective factors into place to reduce the risk of suicide. The blueprint offers strategies for employers for educating and supporting its employees.

The blueprint is available online and is filled with useful tips to help construction managers change the culture of their workplace so they can reduce the stigma associated with mental health problems.

Supervisors are given scripts to help them talk to someone they believe might be at risk of suicide. Additionally, they're given ideas about how they can lead the conversation and mental health.

They're making suicide prevention a top priority in the industry. By educating employees, offering resources to support them, and intervening when a problem exists, it's likely they're saving lives.

What You Can Do In Your Organization

Don't assume mental health problems aren't an issue in your organization. The National Alliance on Mental Illness estimates one in four adults experiences a mental illness. Here's what you can do in your organization:

- Start a conversation about mental health. Talk
 about issues like stress management in your
 meetings. Be willing to mention the importance of self-care and living a healthy lifestyle.
 Your employee's emotional state has a big impact on their productivity and overall life satisfaction.
- Help employees detect mental health problems early. Many mental health problems go undetected, which causes people to suffer in silence.

Encourage employees to access free online screening tools and provide in-service trainings with mental health professionals. Statistics show most people will seek treatment once they recognize they may have a problem.

• Support employee's efforts to get help. Ensure an employee can get to therapy once a week during work hours and provide the workforce with an employee assistance program. With treatment, 65% to 80% of individuals with mental illness see improvements, so make sure you support people's efforts to get the help they need.

Highlights From New Census Population Estimates

Seven of the nation's fastest-growing cities are in Texas, according to new data. See how population changes in your city compare to others.

By Mike Maciag



The Census Bureau published new population estimates on Thursday, providing an updated snapshot of the size of U.S. cities.

Of cities with at least 500,000 residents, Denver registered the most growth, expanding 2.8 percent over the 12-month period ending last July. Last year's estimated gain of 18,582 residents mirrored that of recent years. Austin, Texas; Charlotte, N.C.; Fort Worth, Texas; San Antonio; and Seattle also all recorded annual increases exceeding 2 percent.

While slight, Chicago was the only city with more than a million residents to lose population. Detroit lost about 3,100 residents over the 12-month period -- an improvement over annual declines of 9,700 and 8,700 the past two years.

Most areas with the strongest gains are concentrated in the southern U.S. and parts of the West Coast. The Sun Belt, in particular, is experiencing an uptick in migration after a slowdown following the recession.
