# White House Rolls Out New Private Infrastructure Finance Plans

#### By Tom Ichniowski

The Obama administration has unveiled a new batch of proposals and initiatives aimed at drawing more private money to invest in U.S. infrastructure, with a particular focus on water projects.

The new plans, announced on Jan. 16, flesh out President Obama's Build America Investment Initiative, unveiled last July, which seeks to spur additional public-private infrastructure financing ventures.

Vice President Joe Biden, who outlined the plan in a speech at the site of a Washington, D.C., water tunnel project, noted that only 3% of U.S. infrastructure investment comes from the private sector, compared with 30% in Great Britain. He added, "So we've got to think of new ways in which to get people in the game."

A key part of the program is a proposal for new "qualified public infrastructure bonds," or QPIBs. The White House describes it as similar to private-activity bonds but aimed at public-private partnerships (P3s), to provide such ventures with the benefits of municipal bonds.

Biden said, "We're going to extend the same advantages to public-private partnerships that exist now [for] projects that are only entirely run by the government."

Another element of the program is a new Environmental Protection Agency Water Finance Center, which is to work with water agencies and private firms to use federal grants to spark more private financing for drinking-water and wastewater-treatment projects.

In addition, the Agriculture Dept. is setting up a new Rural Opportunity Investment Initiative, which is charged with helping to match private investors with rural water, energy and broadband projects.

Engineering and construction groups welcomed the administration's latest infrastructure ideas but see them as a supplement to strong, direct federal funds

Stephen Sandherr, Associated General Contractors of America CEO, said in a statement, "The steps being taken by the administration should make it easier for state and local officials to finance a wide variety of projects designed to upgrade aging clean water systems, improve power transmission networks and keep our roads and bridges of a"

But Sandherr added that the initiatives won't solve all U.S. infrastructure needs and said AGC will work for long-term federal infrastructure legislation. The big bill on the horizon is a surface-transportation reauthorization to succeed the current stopgap measure, which expires at the end of May.

Terry O'Sullivan, Laborers' International Union of North America general president, hailed the administration's new proposals and programs. But he added that "public-private sector approaches must remain a supplement for public investment, not a substitute."

O'Sullivan urged Congress to develop and approve a multi-year surface transportation bill and legislation to authorize building the Keystone XL oil pipeline from Canada to Nebraska.

American Society of Civil Engineers President Robert D. Stevens also praised the administration's programs. He said the new EPA center and Agriculture Dept. initiative "are both strides that will help maximize the benefits from investments to improve our nation's infrastructure."

In a summary of the new plan, the White House agreed with Sandherr and O'Sullivan, saying, "Private capital is not a substitute for public investment."

It also noted that Obama last spring proposed a \$\$302-billion, four-year surface-transportation bill. But Congress didn't embrace the proposal, so, the White House said, Obama has been focusing on ways to attract private dollars to roads, bridges and other types of infrastructure.

Fred Kessler, a partner with law firm Nossaman, Los Angeles, pointed to the new infrastructure bond as something that is likely to increase the use of Pas

Kessler said in an email: "Fully tax-exempt, QPIBs would put private borrowers on the same footing as traditional government purpose bonds."

He added, "From a public policy perspective it makes a lot of sense. Regardless of who the borrower is, the purpose of the financing is to fund delivery of projects that are government owned and serve the general public."

The 2005 SAFETEA-LU transportation law made highway and freight-transfer facilities eligible for private-activity bonds, or PABs, but capped the total amount of such bonds at \$15 billion.

According to the White House summary, the new QPIBs, if Congress authorizes the program,

# A Small Business Solution to Shrinking Workforce - Hire Seniors

#### By Mark Taylor

As the U.S. economy heats up and successful companies consider expansion and new hiring, competition for reliable, experienced and skilled employees will grow more intense, labor market experts predict.

They caution small businesses against ignoring one source of potential employees: older Americans.

#### Older Americans

Millions of seniors who have retired or are approaching retirement from lengthy careers still need to work to maintain their families and lifestyles. Others crave the social interaction and sense of purpose employment delivers.

Peter Cappelli, professor of management and the director of the Center for Human Resources at the Wharton School of the University of Pennsylvania, said increased life expectancy and the maturing of the largest generation in American history—the Baby Boomers— will account for increased numbers of older Americans in the workplace. Cappelli, the co-author of Managing The Older Worker, (Harvard Business Review Press, 2010) said today's seniors are staying older longer.

"If we think of old age as a period when people are no longer able to work, that group is shrink-

ing," he said. "Today's seniors don't want to just sit around. They want to work and they have a lot to offer. This trend is not going away."

He said that small businesses should consider hiring seniors for a variety of reasons validated by research. "They don't need much training. Business owners don't have to worry about their conscientiousness and they're less likely to switch jobs," he explained.

He said studies confirm that seniors score higher on reliability and interpersonal skills and experience lower rates of tardiness and absenteeism. And he said research dispels several myths: that seniors incur higher healthcare costs and are more prone to accidents. "Because they are older, don't have babies anymore and have fewer dependents, they have lower healthcare costs. Besides, most are on Medicare."

And Cappelli said seniors also suffer fewer safety incidents because they are more careful.

Greg O'Neill, director of the Washington, D.C.-based National Academy on an Aging Society, said research lags behind on some trends surrounding the employment of seniors.

"We know anecdotally that turnover is lower among senior workers and that some jobs are performed better by people with experience," O'Neill said. He pointed out that changing ergonomics in workplace and to accommodate older workers has shown increases in production.

"Someone transitioning out working with new engineers and sharing knowledge can be very effective," he said. Most companies don't think about all the knowledge walking out their doors. But they should."

#### Experience

O'Neill said that one of the benefits of older age is that people move into positions using crystalized

versus fluid intelligence. "That's code for experience," he said. He added that small businesses can benefit from hiring seniors in customer contact positions.

Thus far, across the United States, over 2,000 small businesses have participated in 10,000 Small Businesses. In order to understand the potential long-term impact, the program is committed to the rigorous tracking of outcomes from the time participants enter the program, through graduation and at regular intervals thereafter. This report focuses on the first nearly 1,300 small business owners to have completed the education component of the program. #### Small Businesses in the United States Drive Economic Growth and Job Creation

Entrepreneurship is increasingly recognized around the world as a critical force in creating a strong, stable economy and society. This is true in the United States, where entrepreneurship is an important component of economic development, and where small businesses are the primary source of new job creation. However, exactly which U.S. small businesses create jobs is less well understood.

The actual economic context for the United States is quite different than what is commonly believed. Despite the prominence of large corporations, the vast majority of companies that comprise the U.S. economy are small and medium-size businesses.

In fact, less than 1% of the 28 million firms in the U.S. have more than 500 employees.

Below that level, firms are classified as small and medium-sized businesses according to the U.S. Small Businesses Administration. Overall, 22 million firms (78%) have no employees other than the business owner; an additional 13% employ between one and four people and another 8% employ between four and 20 people. In summary, the majority of businesses in the U.S. economy (approximately 98%) have fewer than 20 employees. Together, these small businesses make up the overwhelming majority of U.S. firms and also account for the majority of job creation in the U.S.

In 1979, economist David L. Birch first asserted that small businesses are the job creators and consistently create the majority of net new jobs.10 A variety of reports from the U.S. Small Business Administration support that assertion, showing that since the 1970s, small businesses have accounted for 55% of all jobs and 66% of all net new jobs.11

And while the much-publicized, high-growth "start-up" enterprises may, often deservedly, claim headlines for creating jobs, the U.S. Small Business Administration reports that about 60% of the private sector's net new jobs were created by existing establishments, with the remaining 40% attributed to start-up companies.12

However, whether they be existing or start-up companies, "growth companies" are rare. While the definition of a so-called company" varies, annual revenue benchmarks for "growth companies" typically range between 30% and 50%. Regardless of the absolute definition, most experts agree that these firms are relatively rare, representing only 2% to 3% of U.S. employer firms.13 Goldman Sachs 10,000 Small Businesses supports the development of these growth companies, as well as those seeking any measure of growth, as the U.S. economy and labor market rely on them. Any job creation, be it one new job or five hundred new jobs, is to be celebrated and contributes to overall economic growth.

Data about the U.S. economy, small businesses and growth companies is shared with every 10,000 Small Businesses participant during the pro-

gram's orientation. Rarely do participants arrive to the program aware of the crucial role they play in the national or global economy. It is a role to be understood, supported and celebrated.





Before taking public office, Mayor Johnson led a diverse career as a professional athlete, entrepreneur and nonprofit executive. Johnson served as Chief Executive Officer of St. HOPE (Helping Others Pursue Excellence), a nonprofit organization he founded in 1989 and led until January 2008. Originally focused around providing afterschool programs to at-risk youth in the Mayor's native Oak Park neighborhood, St. HOPE expanded to pursue a broader program of urban revitalization through public education, civic leadership, economic development, and the arts. Today St. HOPE consists of three divisions: St. HOPE Academy, St. HOPE Development Company, and St. HOPE Public Schools.

In his prior career, Johnson played professional basketball in the National Basketball Association. After earning a B.A. in Political Science from the University of California at Berkeley, he was drafted as the 7th pick in the 1987 NBA Draft by the Cleveland Cavaliers. He went on to play twelve seasons with the Cavaliers and Phoenix Suns, earning honors as a three-time All-Star, and five-time selection to All-NBA teams. The Mayor was inducted into the Phoenix Suns Ring of Honor in 2001, and is a member of the UC Berkeley Athletic Hall of Fame, Pac-10 Hall of Honor, Sacramento Sports Hall of Fame, Bay Area Sports Hall of Fame, Sac-Joaquin Section Hall of Fame, National High School Hall of Fame, and World Sports Humanitarian Hall

Mayor Johnson has served on the Board of Directors for LISC National, the California Charter School Association, the UC Berkeley Foundation, Teach for America, the Institute of Governmental Studies National Advisory Council and the Harvard Divinity School SLI Advisory Board. His concern and compassion for children and education prompted President George H. W. Bush to honor Johnson with the 411th Point of Light. Walter Kennedy Citizenship Award, the Good Morning America Award from Sports Illustrated, NCAA Silver Anniversary award, and the "Most Caring American" award by the Caring Institute.

Mayor Johnson has appeared on several national television programs including CNN Newsroom, The Oprah Winfrey Show, Dateline NBC, Larry King Live, The Colbert Report, Fox Business Network, and Tom Brokaw's "American Character.'

# 6 Capital Funding Sources for Minority Businesses

#### By Carolyn M. Brown

It takes money to make money. That is the plain and simple truth in business. A shortfall of capital is one of the most commonly cited reasons why a company is unable to expand business and succeed. The prospect of getting financing for a start-up even in a growing economy is very difficult due to the fact that business owners lack operating experience and solid credit history.

America's credit crunch environment is making it tougher than ever for entrepreneurs to raise money to start or grow their businesses, particularly minority-owned firms. A study released by the Minority Business Development Agency found that minority-owned firms are less likely to receive loans than non-minority-owned firms, especially businesses with gross receipts less than \$500,000. The tightening of lending standards on traditional loans means minority businesses have to become more vigilant about their funding sources.

Today, only 59 percent of small businesses are able to obtain adequate financing, reports the National Small Business Association (NSBA). That number has steadily decreased in the last five years. Banks don't finance dreams, says Todd McCracken, president of NSBA. They finance businesses that are likely to be successful. Your company has to have a good financial track record and a solid business plan, he adds.

Business owners must look past the SBA and beyond traditional lending sources, says Kedma S. Ough, business director of AVITA Business Center, a small business consulting firm headquartered in Portland, Ore., which offers targeted funding resources and grant opportunities. When working with its clients AVITA often examines nontraditional funding sources first, says Ough. For instance, minority entrepreneurs can consider participating in business plan competitions or industry specific contests.

Take Leah Brown, founder and president of A10 Clinical Solutions in Cary, N.C. In 2007, Brown was named a Make Mine a Million \$ Business winner. In addition to a cash prize, her award package included marketing and technology tools, mentoring and coaching to help grow her business. Make Mine a Million \$ Business is powered by OPEN from American Express and Count Me In for Women's Economic Independence, a national not-for-profit provider of resources, business education and community support.

Brown's innovative-driven firm manages clinical trials to get drugs approved by the FDA for Merck, GlaxoSmithKline, and other clients. Brown's company also does work for the National Institute of Health and other government agencies. The 48-year-old onetime lawyer was inspired to start the company in 2004 when a close relative passed away from AIDS. A10 focuses on ailments prominent within minority communities and has started opening medical "check-up centers" at businesses, airports and bus stations.

What's more, A10 ranked first on Inc. Magazine's 5000 Fastest-Growing Companies' list of the Top 10 Black-Run Companies in the country and placed in the top 500 of the list of Fastest-Growing Privately-Owned Companies in America at No. 92 overall, with a three-year growth rate of 2,714.3 percent. The firm employs more than 300

people, generating nearly \$20 in revenues reportedly in 2010. Brown is among thousands of women entrepreneurs to benefit from the Make Mine a Million \$ Business and M3 Race contests. Since its inception, the program has hosted over 20 "elevator pitch" competitions in cities around the country. Cash awards have ranged from \$1,000 to \$100,000.

Ough suggests checking out competitions or grants that are specific to a particular minority group, industry, sector, or region. For Native American entrepreneurs, some tribes provide grants up to \$100,000 towards a business, Ough explains. "Women and minority business owners should examine their background to see how that may play a role." For example, "you might have a disability and struggling to get a loan. In that instance, we would look at collaboration to piece a couple of things together to get multiple funding. Various agencies, everything from vocational agencies to the Veterans Administration, have funding sources for small businesses," she explains. In addition, check with your state economic development agency to see if there are specific programs or grants associated with your particular industry cluster, adds Ough.

## Here are five other funding sources worth investigating.

#### 1. Individual Development Accounts (IDAs)

These are grants with strings attached. The way it works is that IDAs are savings accounts that match the deposits of individuals with modest financial means. For every dollar saved in an IDA, savers receive a corresponding match. Savers agree to complete financial education classes and use their savings for an asset-building purpose such as to capitalize a business. There is no limitation on how long you can be in business but there income requirements which vary by county. Typically revenues for business owners fall under \$50,000. In addition to earning matching dollars, savers learn about budgeting and receive additional training before purchasing an asset. For example, programs in Oregon let participants save \$3,000 and the agency can match them with \$9,000, allowing them to use a combined total of \$12,000 towards building their business and without having to repay the funds. For more info, review the IDA directory.

#### 2. Capital Assistance

The U.S. Department of Commerce's Minority Business Development Agency (MBDA) recently announced \$7.8 million in funding for 27 MBDA Business Centers (MBCs). These centers help minority firms with access to markets, contracts, capital and other strategic business consulting services. MBCs interface directly with minority business owners and managers at the local level. Whether it's securing working capital from a lender, applying for an SBA loan, or responding to a grant proposal, MBCs help business owners prepare a funding package. Last year, MBCs helped their clients gain access to more than \$800 million in financial packages, including working capital, equity investments, and bonding.

#### 3. Forgivable Loans

This type of a loan is made with the understanding that if the borrower meets certain requirements, repayment of the loan will not be required. A forgivable loan is actually a grant, says Ough, "because if you do everything right you don't have

to pay the money back." A stipulation may be that you are required to hire and train employees, Ough explains. She cites for example a particular forgivable loan program that allowed recipients to hire up to five employees. "For every employee you hired you were given \$5,000 for each. So, you had up to \$25,000 you could use for anything related to supporting the growth of your business." As a growing business, you are going to be hiring employees anyway. This program gives you an incentive to do so, adds Ough. The Regional Investment Board manages lottery funds in Oregon which are used for economic development purposes. These monies are available to entities in the form of grants or loans to support projects that will create jobs in the region. Just as well, you may be able to take advantage of other state loans programs and loan guarantees.

#### 4. Micro Loans

Poor credit history is a barrier for many entrepreneurs seeking traditional financing. "If you have not positioned your personal credit such that a bank will find you to be a strong enough credit risk, they won't lend to you," says Jennifer Spaziano, vice president of business development at AC-CION USA, a microfinance institution that lends to 48 states across the U.S., providing loans to upstarts, especially women and minority businesses. ACCION New York is one of hundreds of regional and national nonprofit groups that make micro loans from as little as \$500 up to \$35,000. Many of these groups are funded by The U.S. Small Business Administration. Cities like San Francisco and New York City have expanded or introduced their own microfinance programs. Each organization has its own lending requirements. ACCION USA has provided over \$119 million in over 19,000 micro loans since inception in 1991. To learn more, visit the Association for Enterprise Opportunity's

#### 5. SBIR Grants

There is a lot of talk and excitement around technology, particularly coming from the Obama Administration. Review the possibility of obtaining a Small Business Innovation Research (SBIR) grant or Small Business Technology Transfer Program (STTR) funding. You might not be in a position to go after venture capital, yet you may need initial funding for early stage research and development, says Ough. For instance, "we are working with a client who has developed a new process for providing a better educational tool for kids with autism. We pulled out an application to apply for the grant through the National Institute for Health." The SBIR program was established

by Congress in 1982 as a means of stimulating innovation with more than \$ 2.2 billion dollars set aside annually with first phase funding of up to \$100,000. Phase two is a \$750,000 award. The SBIR/STTR program reaches out to socially and economically disadvantaged firms. The participation rate of minority- and women-owned firms in SBIR/STTR just within the Department of Defense is roughly 21 percent. Two sites to check out are Zny and SBIR.gov.

#### 6. New Market Tax Credit

For companies looking for commercial ownership or to own their own facility, Ough suggests exploring new market tax credits. This federal program is administered by the U.S. Department of Treasury Community Development Financial Institutions Fund. Designed to provide investments to projects and businesses in low-income communities, the program has expanded to include investments in minority business. NMTC permits taxpaying investors to receive a credit against their federal income tax liability for making qualified equity investments in designated Community Development Entities (CDEs). The credit is spread over seven years, amounting to roughly 39 percent of the investment made in a qualified entity. Many states have passed a tax credit for minority business. The provisions and limitations of these credits vary from state to state. Many of them resemble the New Market Tax credit and give tax credits against state income tax to investments that are used to support minority building projects or encourage minority business ownership, which includes women-owned businesses. However, these credits are extremely tough to get and are highly competitive.

In addition, contact your National Chamber of Commerce. There are a number of national chambers of commerce specific to women and minority sectors that offer access to funding sources, including the National Women's Chamber of Commerce, the Hispanic Chamber of Commerce, the National Black Chamber of Commerce and the Native American Chamber of Commerce.

"To find all the funding sources available in your community, you need to become a great connector so that you get familiar with all the programs available for starting and growing your business," says Ough. "If that's not possible, then the next best thing is to find those connectors that can guide you." Connectors are the top ten businesses, organizations or key players in your community that you get referred to when you are trying to find resources and funding for your specific business.

could also be used for a wider range of projects, including airports, ports, mass transit, solid waste, sewer, water and surface-transportation projects.

The envisioned QPIBs would have no expiration dates, no volume caps and their interest wouldn't be subject to the alternative minimum tax.

QPIBs would have some limitations—they could not be used for privately owned facilities or privatizing public facilities.

The bonds would require approval from Congress, but the Obama administration can adopt much of the rest of the collection of plans by presidential executive order or administrative actions by individual or multiple federal agencies.

The plans spotlight water infrastructure. Biden said that the new EPA center will not provide "a whole lot of new money."

He added, "What it is, is the one thing the federal government can do better than any municipal or local or state government-It can find and pull together the best practices in the country and it can make them available to people in other states

EPA Administrator Gina McCarthy, who also spoke at the D.C. Water event with Biden, noted that water infrastructure needs are estimated at \$600 billion over 20 years. Biden said the new office could attract \$6 billion to \$28 billion "off the sideline.'

The Agriculture Dept., Biden said, has devoted \$10 billion to rural water projects since 2009 and the new office will allow the department agency to "be more proactive" regarding projects in local communities
