Bloomberg Assists Black Medical Students

In December 2018, Mike Bloomberg traveled to Tulsa, Oklahoma, to announce that the city had won Bloomberg Philanthropies' Public Art Challenge. The winning proposal honored the neighborhood of Greenwood—once known as Black Wall Street, and the site of one of America's worst tragedies: The 1921 Tulsa Race massacre. While there, he was moved by the story of how a predominantly Black neighborhood had become one of the country's most prosperous communities and was appalled and angered to know that its destruction at the hands of a racist mob had been whitewashed from history books.

The Greenwood Initiative

In the spring of 2020, during his campaign for president of the United States, Mike announced an ambitious plan to accelerate the pace of wealth accumulation for Black individuals and families and address decades of underinvestment in Black communities. In remembrance of the hundreds killed in Greenwood, and in recognition of how racism has prevented Black families from building wealth, he called the plan The Greenwood Initiative and returned to Tulsa to lay out its proposals in a speech.

We have since carried the plan's objectives over to Bloomberg Philanthropies, where we're supporting and working with partners and institutions that have a proven track record of increasing economic and social mobility to fulfill Greenwood's mission of reducing wealth disparities in Black communities.

\$100 Million to Historically Black Medical Schools

The initiative's first major investment was an historic \$100 million gift to America's four historically Black medical schools: Meharry Medical College in Nashville, Tennessee, Howard University College of Medicine in Washington, DC, Morehouse School of Medicine in Atlanta, Georgia, and Charles R. Drew University of Medicine and Science in Los Angeles, California. Bloomberg Philanthropies' gift to the medical schools will allow them to provide debt relief up to \$100,000 to approximately eight hundred medical students



who are currently enrolled and receiving financial aid over the next four years.

This is the largest-ever individual philanthropic gift received by these medical schools, and it helps to address the connection between Black health and

The work involves design-build of a new tunnel and approach structures for a grade-separated crossover, including modification of the underpinning pier(s) and construction of new pier(s) for the existing Honeywell Street bridge, demolition of existing track work and installation of new track, including special track work, and demolition of existing and installation of new traction power elements such as the cabling, contact and messenger wires, feeder cables and their supporting structures. The work will be performed in an active railroad interlocking and will require close coordination with the ongoing train operations and force account work performed by Amtrak, LIRR, and other East Side Access contractors.
